2. Commander's Narrative Summary of Significant Events

During the month of December 1966, the major artillery effort was directed toward providing supporting fires for the defense of the Chu Lai and Da Nang TAOR's and support of infantry operations in both areas. Additionally supporting fires were provided for elements of the 1st and 3d Reconnaissance Battalion inserted deep in Viet Cong controlled territory, CIDG/Special Forces Camps, Government of Viet Nam Armed Forces (GVNAF), and units of the Republic of Korea Marine Corps (ROKMC).

In the Da Nang area, four search and destroy operations were conducted by the 9th and 1st Marines supported by artillery comprising the 11th Marine Regiment. Operation "Trinidad" was conducted on 7 December 1966. Operation "Trinidad II" was conducted during the period 8-11 December 1966. Operation "Glenn" was conducted during the period 17-21 December 1966. Operation "Shasta II" was conducted during the period 20-21 December 1966.

In the Chu Lai area, three search and destroy missions were conducted by the 5th and 7th Marines supported by elements of the 11th Marine Regiment. Operation "Sutter" was conducted during the period 1-2 December 1966. Operation "Quant Tin" #122 (an ARVN operation supported by 11th Marines) was conducted during the period 1-2 December 1966. Operation "Sierra" began on 12 Dec 1966 and had not terminated on 31 December 1966. These operations are narrated in detail in enclosure (2).

Also in the Chu Lai area, the requirement for maintaining Battery F(-), 2nd Battalion, 11th Marines at Tien Phuoc (BT 106142), the provisional 155mm How Battery (4 155mm How TD) at Quang Ngai (BS 607720), as well as observation post at Nui Tron (BS 515780) and An Hoa (BS 574863) continued through this reporting period.

In the Da Nang area, this Regiment exercises operational control of the 2nd Battalion, 12th Marines; the 1st 8" Howitzer Battery (SP) FMF, and the 1st Armored Amphibian Company, FMF; the 2nd Battalion, 12th Marines and the 1st 8" Howitzer Battery (SP), FMF are submitting their command chronologies via their administrative command channels.

Battery E, 2nd Battalion was moved to An Hoa (AT 876472) in direct support of 2nd Battalion, Fifth Marines and is under operational control of the 11th Marines.

b. Civic Action

During the month of December MEDCAPS were continued in the Hamlet of Da Son. These MEDCAPS included the treatment of one elderly man for tuberculosis and having him admitted to the hospital in Da Nang.

The groundwork was laid for future projects to include refurbishing the hamlet school and repairing several roads and trails in the hamlet.

c. Intelligence. The Intelligence Section since arrival in Da Nang TAOR assumed additional responsibilities; these include the following:

1. Assistant Coordinator Northern Sector, Division Rear Area Defense. Intelligence capabilities were enhanced during this period through the use of listening/observation posts, patrols, ambushes, defense positions, etc. Under control of this section periodic tests of reaction forces were conducted to test the capability to counter any enemy attack within or close to this Tactical Area of Responsibility.

2. Supervision of Combined Action Company/Platoon (CAC) assigned to this Regiment for operational control. This unit is located in the close proximity of the 11th Marines in the Hamlet of Da San. Continuous wire and/or radio communications along with daily patrols and occasional conferences with Civilian Leaders have assisted greatly in maintaining local security.

3. Establishment of a "Tenant Unit" Courtesy Patrol was initiated and handled through this office by assignments, briefings and debriefings.

This section was relieved of the above responsibilities on 15 December 1966; however all aspects of intelligence, gathered from the above, are procured through close coordination through the S-5A Staff.

On 11 December 1966 this section began submitting daily INTSUMS to Division G-2, this report was previously being made by the S-2 Section (Rear) in Chu Lai.

d. Command and Control. The location of command post and battery position areas are shown on the overlays attached as Appendix (c) tab (1).

e. Close Combat. During the period 1-31 December 1966, the Viet Cong continued their efforts to harass, penetrate, and destroy artillery positions as manifested by a series of probes and attacks against the Battalions and separate Batteries of this Regiment. For details see enclosures (2) through (9).

f. Logistics. Logistics operations for December 1966 were characterized by aerial resupply of committed units (hampered to some extent by weather conditions), the movement of the remainder of the 11th Marines Headquarters and E-2-11 from Chu Lai, and the continuing effort to improve the status of M109 Howitzers.

Resupply of a two section detachment of A-1-13 in support of reconnaissance operation early in the month was delayed several times due to weather. The aircraft lifting classes I and V supplies were also utilized to effect replacements of individuals who were suffering to varying degrees from exposure.

Airlift of organic supplies and equipment to E-2-11 from Da Nang was hampered by lack of air transport resulting from other cargo having higher priority and extremely poor flying conditions.

The movement of the remainder of the 11th Marines Headquarters and E-2-11 rear elements from Chu Lai to Da Nang was accomplished by sea lift without significant incident. There was, however, some delay in embarkation at Chu Lai because of heavy seas.

Command attention continued to be focused on the availability of the M109 SP 155 Howitzer, and concurrently, the replacement and evacuation of 2-M109's, 1-M53 S.P. 155mm Gun and 1-M55 SP 155 Howitzer. During the month, the 4 weapons mentioned were received at FLSG-B but had not yet been placed into operation because required checks had not been performed. Special Critipak for the M109 produced 46 of 51 high priority 3rd and 4th echelon repair parts. In addition, some of the most critical parts (Seal for recuperator, FSN 3210 - 806 - 0324) were received incomplete and parts to complete these were fabricated locally.

g. Aerial Observation. During the month of December 1966 the Aerial Observation Section of the 11th Marines flew 48 missions for a total of 107.9 hours. Missions flown were in support of the Tactical Area/Reconnaissance Zone. Aviation support was provided by H&MS-16, Officer-in-Charge Detachment, 220th Aviation Company, and 20th Tactical Air Support Squadron, all based at Da Nang.
