PART IINarrative Summary

During the month of February 1967, the major artillery effort was directed toward providing supporting fires for the defense of the Danang and Chu Lai TAOR's and support of infantry operations in both areas. Additionally supporting fires were provided for elements of the 1st and 3d Reconnaissance Battalions inserted deep in the Viet Cong controlled territory, CIDG/Special Forces Camps, Government of VN Armed Forces (GVNAF), and units of the Republic of Korea Marine Corps (ROKMC). Operations supported during the period included Operations STONE, LAFAYETTE, SEARCY, and INDEPENDENCE.

In the Danang area this Regiment exercises operational control of 2d Battalion, 12th Marines; 1st 8" Howitzer Battery (SP) FMF; and the 1st Armored Amphibian Company. 2d Battalion, 12th Marines and the 1st 8" Howitzer Battery are submitting their command chronologies through their administrative command channels.

Battery E, 2d Battalion, 11th Marines remains in direct support of 2d Battalion, 5th Marines and under the operational control of this regiment.

Events during this month in the Chu Lai TAOR are detailed in TAB E, First Field Artillery Group Command Chronology.

During the month, Forward Observer classes were conducted for Division snipers units and Division scout units.

2. Enemy, Weather and Terrain

Operation of OP EAGLE on Hill 364, grid AT 933761, began on 5 February 1967. This OP is manned by 11th Marines on a continuous 24-hour watch each day. Communications are maintained direct with the Northern Sector Division Rear Area Defense Command.

During the month of February, this section made preparations for the Quarterly G-2 Technical Inspection of the 11th Marines S-2 Section. The inspection was conducted on 1 March with satisfactory results.

On 28 February, some of the requirements for aerial photography of the Thuong Duc CIDG Camp were met. This photography will be used for planning artillery support to Thuong Duc CIDG Camp when it is required.

Terrain analysis of aerial photography within a ten-kms range of the Danang Airfield has been initiated.

3. Organization and Operations. Units of this Regiment participated in four (4) operations in the Danang TAOR during the month of February. These were:

- a. Operation STONE, in which the 1st Battalion, 11th Marines supported the 1st Marines, and the 2d Battalion, 12th Marines supported the 4th Marines.
- b. Operation LAFAYETTE, in which the 1st Battalion, 11th Marines supported the 1st Marines.

c. Operation SEARCY, in which the 1st Battalion, 11th Marines supported the 1st Marines, and the 2d Battalion, 12th Marines supported the 4th Marines.

d. Operation INDEPENDENCE, in which the 2d Battalion, 12th Marines supported the 4th Marines.

(6) 3d 155 Gun Btry SP FMF and 3d 8" How Btry SP FMF are OpCon 4/11 for purposes of:

(a) Coordination of local security at collocated positions

(b) Coordination of Camp construction, messing, and billeting at collocated positions

(c) Coordination of maintenance areas at collocated positions to assure efficient and economical use of shop space, common usage items, and work effort. Tools and equipment will not be mixed but will be maintained in such a manner that the batteries can be immediately released from OpCon if necessary.

(d) Submission of SitReps, FireReps, FireCaps, Mustang, SpotReps.

(e) Coordination of combined FDCs where appropriate.

(f) CO 8" and 155 Gun Btry SP FMF responsible for OpStats, CasReps, Cmd Chronology, gun down reports, and all logistic reports sent to CO 11th Marines with copy to CO 4/11. Backlash reports handled by separate batteries with assistance from 11th Marines

(g) Personnel assignments to 3d 8" and 3d 155 Gun Batteries SP FMF by Eleventh Marines.

(7) (a) Tactical fire direction 3d 8" How Btry SP FMF, 3d 155 Gun Btry SP FMF, and Battery A, 2d Battalion, 94th Artillery, USA by 1st FAG.

(b) Requests for fire from Battery A, 2d Battalion, 94th Artillery by 2d BDE ROKMC will be passed to 1st FAG.

Northern Sector Defense Command defends the Northern Sector, Division Rear Area by directing and controlling the resources of all tenant units located within the Northern Sector. Coordination within the Northern Sector, Division Rear Area is effected by three mutually supporting Subsectors with Subsector Commanders responsible for the coordination of the defense of all tenant units within their respective sectors. Internal security of individual camps within each sector is the responsibility of the Camp Commander. Strike forces are available, on call, in each sector as a reserve for employment by the Commander, Northern Sector, Division Rear Area. The Commander, Northern Sector, Division Rear Area also coordinates defenses, directs and controls the patrols, listening posts, observation posts and ambushes of units within

Subsector B to ensure adequate coverage and mutual support. On February 21, the Strike Company from Subsector B in coordination with the 116th Bridge Company, ARVN conducted a search and clear operation in the hamlets of Da Son (AT960766) and Phuoc Ly (AT968760). The hamlets were cordoned by the Strike Force Company while the ARVN unit conducted the sweep. Of 26 detainees, 9 VC were forwarded through ARVN channels and one (1) was sent to ITT by Marines. A patrol from CAC E-2 (H&S Bn, 1st FSR, FLC) received small arms fire from an unknown number of VC. Return fire resulted in one (1) VC KIA (Confirmed), one (1) USMC WIA MedEvac. To enhance intelligence collection capability, OP EAGLE (AT941762) was established and manned 24 hours daily. The NCO in charge is a qualified forward observer and has a BC scope on a surveyed site. On 8 February 1967, TET celebrations began with numerous sightings of tracers, flares, and fire works. This continued until past midnight and was reported on the 9th and 10th. CAC E-1 patrol received approximately 10 rounds small arms fire from the hamlet of Khanh Son. Patrol returned two (2) rounds 7.62 and searched the area with negative results. On 270315H Feb 67, 1st Recon Bn Op (AT969746) reported that the Danang Airfield was being mortared. All units were alerted to observe for mortar flashes. At 0320H Feb 67, OP EAGLE reported gun flashes at Azimuth 2800 mils (flashes were from rockets being fired at the Airbase at Danang). Personnel on perimeter defensive positions at MASS-2 and Hq Bn, 1st MarDiv also observed firing of rockets. MASS-2 personnel described the firing as follows: There was a large flash at the launch positions before liftoff, the rockets sounded like jet airplanes as they flew by. There were initially two (2), followed in moments by about eight (8) more. The men recognized them immediately as rockets. Shopping Centers at AT 947787 and AT 950787 (7th Engr Bn) cordoned by Strike platoon from 1st FSR, FLC while search was conducted by 116th Bridge Co, ARVN. Of 50 detainees apprehended, six (6) were forwarded through ARVN channels. In addition to the above, patrols, OPs, and LPs continued to report movements in front of positions, incoming rounds and rocks.

4. Training. The cross-training program for Field Artillery Firing Batterymen (0811) between light and medium artillery battalions was continued. This program improves the proficiency of gunners on all weapons.

5. Logistics. Primary logistic attention for the month of February was focused on maintaining the maximum number of artillery weapons in an operational status. To this end, one (1) LVTH-6 was drawn from the maintenance float and placed into operation, one (1) Howitzer, 155mm, towed, M114 was prepared for removal from float to provide a means to rotate M114s from An Hoa for necessary maintenance, overdue because of untrafficable roads. Six (6) of the eight (8) 4.2" mortars received from 3d MarDiv placed into service by expedient of using Howitzer section gear and sight equipment. Condition of these weapons is so poor that by the end of February only four (4) were serviceable, two (2) being in need of parts and repairs and two (2) having

been evacuated as beyond the repair capabilities of the Maintenance Battalion, 1st FSR. Availability of SP 155mm How, M109, continues to be excellent and a program was instituted to replace those tubes having the greatest wear. Availability of Howitzers, SP, 8", M55, and Gun, SP, 155mm, M53, remains good with some continuing parts problem. The Regiment was alerted late in February to anticipate receipt of multi-fuel trucks, M35A2, but these had not been received by the end of the month. Availability of M35 vehicles during the month reflected the age and wear from long in-country use and has deteriorated accordingly. Three hundred and thirty-three (333) rounds of beehive ammunition were received and distributed on the basis of 4.0 rounds per towed 105mm howitzer and 3.75 rounds per LVTH-6. Improved weather has facilitated re-supply problems in all areas.

#### 6. Civic Action

- a. During the month of February 1967, MEDCAPs were continued in the hamlet of Da Son.
- b. Work is continuing on the repair of the hamlet elementary school.
- c. It is tentatively planned to commence English language classes in the hamlet of Da Son on 1 April 1967.
- d. Scrap lumber from the 11th Marines CP and 1st AT Bn CP was delivered to the hamlet chief of Da Son for distribution to needy members of hamlet.
- e. Five hundred (500) bars of soap have been received for distribution to the population of Da Son. This will be accomplished in conjunction with the MEDCAP Program.

7. Aerial Observation. During the month of February 1967, the Air Observer Section of the 11th Marines flew 33 missions for a total of 105.7 hours. Missions flown were in support of the Tactical Area/Reconnaissance Zone. Aviation support was provided by the O1C Detachment, H&MS-16, MAG-16, 220th Aviation Company, USA and the 20th Tactical Air Support Squadron, USAF; all based at Danang, RVN. The following is a breakdown of missions flown:
