PART IINarrative Summary

During the month of March 1967, the major artillery effort was directed towards supporting fires for the defense of the Danang and Chu Lai TAORs and support of infantry operations in both areas. Additionally, supporting fires were provided for elements of the 1st Reconnaissance Battalion (Rein) inserted deep in the Viet Cong controlled territory, CIDG/Special Forces Camps and units of the Republic of Korea Marine Corps (ROKMC). Operations supported during the period included Operations LAFAYETTE, NEWCASTLE, EARLY, GULF, AND "X".

In the Danang area this Regiment exercises operational control of 2d Battalion, 12th Marines; 1st 8" Howitzer Battery (SP) FMF; and the 1st Armored Amphibian Company. 2d Battalion, 12th Marines and the 1st 8" Howitzer Battery are submitting their command chronologies through their administrative command channels.

Battery E, 2d Battalion, 11th Marines remains in direct support of 2d Battalion, 5th Marines and under the operational control of this Regiment.

Events during this month in the Chu Lai TAOR are detailed in TAB E, First Field Artillery Group Command Chronology.

During the month, Forward Observer classes were conducted for Division sniper units and Provisional Reconnaissance units.

2. Enemy, Weather, and Terrain

During the reporting period, a motor reconnaissance was made of waterways and streams in the Northern Sector Defense Command (Rear Area). Spot checks were made at bridges and culverts and a study prepared of those waterways considered navigable to small watercraft. (S-2 Memo 2/JCH/ceg, 3100.5 dated 13 March 1967). There were relatively few such navigable areas and those considered of greatest potential use by the VC were listed in the study and forwarded to the Northern Sector Defense Command (Rear Area) on 13 March 1967 for further study and possible improvements of security in those particular areas.

Liaison trips were made to OPs FALCON, EAGLE, CONDOR, AND HAWK. A study is being made of these OPs for the purpose of improving the positions, equipment, and operations.

A further study has been made of OPs MARBLE MOUNTAIN and CROWNSNEST. The missions of both OPs can possibly be consolidated into one OP and a recommendation is being made to deactivate the MARBLE MOUNTAIN OP.

3. Organization and Operations. Units of the Regiment participated in five (5) operations in the Danang TAOR during the month of March. These were:

a. Operation LAFAYETTE, in which the 1st Battalion, 11th Marines supported the 1st Marines.

b. Operation NEWCASTLE, in which Battery E, 2d Battalion, 11th Marines provided direct support with Battery H, 3d Battalion, 12th Marines, 1st 8" Howitzer Battery, and 1st Armored Amphibian Company providing reinforcing support for the 2d Battalion, 5th Marines.

c. Operation EARLY, in which 1st Battalion, 11th Marines, Battery A, 1st Battalion, 13th Marines and Battery L, 4th Battalion, 12th Marines supported the 1st Marines.

d. Operation GULF, in which 1st Armored Amphibian Company, 1st 8" Howitzer Battery and Battery L, 4th Battalion, 12th Marines supported the 2d Battalion, 26th Marines.

e. Operation "X", in which 1st Battalion, 11th Marines supported the 1st Marines.

f. During the month of March, the following events, which are of significance, occurred within the TAOR of the Northern Sector Defense Command:

Two new OPs were established, within the first two days of March. On 1 March 1967, OP FALCON became operational and is located at AT 932778. It is manned by personnel from Battery B, 1st Battalion, 13th Marines. On 2 March 1967, OP CONDOR was established at AT 941742 and manned by personnel from Headquarters, 11th Marines.

At 042045H March 1967, a patrol from CAC-E-2 was ambushed by approximately ten (10) VC. In the following firefight, one (1) PF was killed. As the patrol moved forward, the VC broke contact and disappeared into the surrounding villages. On 6 March at 2100H, CAC-E-2 again made contact with an undetermined number of VC at AT 926813. There were no friendly casualties and a search of the area revealed nothing.

On 102000H March 1967, the units of Subsector B were informed that Northern Sector Defense Command was conducting a drill and all members of the strike force company were to muster at 11th Marines. All units mustered at 102036H.

During the morning of 15 March, a squad of Marines and approximately fifty (50) PFs from 1st FSR conducted a sweep of grid squares AT 9281 and 9282; however, nothing was found.

Another sweep was conducted by 1st FSR on 18 March which included eighty-five (85) Marines of the security guard of the H&S Battalion, CAC-E-2, and a reinforced squad from Company F, 2d Battalion, 26th Marines. The sweep took place in the area of Xuan Thien (AT 935823) for suspected launching sites of VC rockets. Nothing of this nature was found; however, 1000 pounds of rice was uncovered.

During the night of 18 March at 2300H, 1st FSR reported that the Headquarters of the Village Chief in the village of Namo (AT 934833) was attacked by several VC armed with grenades. Fourteen (14) Vietnamese were wounded by grenade fragments and one (1) VC was confirmed killed.

At approximately 2135H on 22 March, some villagers of Da Son came to the position of CAC-E-1 and reported that there were two (2) ARVN Rangers in one of the bars terrorizing everyone there. Members of CAC-E-1 apprehended the two (2) Rangers who were believed to be AWOL. They were turned over to MPs.

4. Training. The cross-training program for Field Artillery Firing Battery-men (0811) between light and medium artillery battalions was continued. This program improves the proficiency of cannoneers on all weapons.

5. Logistics. The phase-in of M30 mortars as replacements for M98 howtars was begun and completed, except for distribution of the last four (4) mortars received. Delay was caused by receiving incrementally the sixteen (16) new (rebuilt) M30s throughout the month. On completion of phase-in, sixteen (16) rebuilt mortars and two (2) old mortars previously received from 3d Marine Division will be in operation. Sixty-three (63) trucks, 2½-ton, M35A2C were received as replacements for M35 trucks. Of these, thirty-four (34) were delivered to 1st Battalion, 11th Marines, nine (9) were retained at Headquarters, 11th Marines, and the remaining twenty (20) kept in storage at Headquarters, 11th Marines. The twenty (20) kept in storage are destined for 2d Battalion, 11th Marines, but operational commitments precluded sending to Chu Lai by convoy, and by the end of the month plans were made to ship these twenty (20) by LST to Chu Lai. The Borescope Team condemned eleven (11) of eighteen (18) 105mm howitzers in 1st Battalion, 11th Marines and tubes were replaced. The Army Calibration Team under Captain RUNDQUIST, USA, calibrated all howitzers and guns of the Regiment in the Danang TAOR and proceeded to the Chu Lai TAOR to calibrate there. A USMC helicopter crashed on three (3) M30 mortars and one (1) M98 howtar at Nui Loc Son; but no significant damage occurred and all were placed back into operation after serviceability checks. Battery G, 2d Battalion, 29th Artillery, USA, began arriving with thirty-six (36) Xenon 18" searchlights and associated equipment. Although still under OpCon III MAF, they are now billeted in 11th Marines CP area. Three (3) 60" searchlights, M1942A, were received during the month, but were unable to be placed into service due to shortage of parts.

#### 6. Civic Action

a. During the month of March 1967, MedCaps were continued in the Hamlet of Da Son.

b. Work is continuing on the construction of a two (2) room classroom addition to the Hamlet elementary school.

c. It is planned to commence English language classes in the Hamlet of Da Son sometime in April.

d. Five (5) graves were removed from the 1st Recon Battalion's area so that construction could be started on a helopad. This organization furnished lumber and transportation to assist in the moving of the graves and the Civic Action office of this Regiment Coordinated the move.

7. Aerial Observation. During the month of March 1967, the Air Observer Section of the 11th Marines flew twenty-five (25) missions for a total of 58.2 hours. Missions flown were in support of the Tactical Area/Reconnaissance Zone. Aviation support was provided by the O1C Detachment, H&MS-16, MAG-16, 3d Platoon 220th Aviation Company, USA, all based at Marble Mountain Air Facility, Danang, Republic of Vietnam. The following is a breakdown of missions flown.

During the above missions, six (6) artillery missions and eight (8) air-strikes were controlled for a total damage assessment of two (2) KIA (Probable) and forty-seven (47) structures destroyed. Two (2) missions were flown in support of NEWCASTLE and one (1) in support of Operation EARLY.
