PART IINarrative Summary

During the month of April 1967, the major artillery effort was directed towards supporting fires for the defense of the Danang and Chu Lai TAORs and support of operations in the surrounding areas. Additionally, supporting fires were provided for elements of the 1st Reconnaissance Battalion (Rein) inserted deep in the Viet Cong controlled territory, CIDG/Special Forces Camps, elements of the 2d ARVN Division and units of the Republic of Korea Marine Corps (ROKMC). Operations supported during the period include Operations UNION, GRAND, CANYON, DIXIE, YELL, and HUMBOLDT.

During the first part of April, this Regiment exercised operational control of 2d Battalion, 12th Marines and 1st 8" Howitzer Battery (SP) FMF. Control of these units was passed to the 3d Marine Division when they left the Danang TAOR.

As a result of Operation OREGON, 2d Battalion (-), 11th Marines; 3d Battalion, 11th Marines; 4th Battalion, 11th Marines; 3d 8" Howitzer Battery (SP) FMF; and 3d 155mm Gun Battery (SP) FMF moved to the Danang Area of Operations.

Forward Observer classes were conducted for 1st Marine Division sniper units, Provisional Reconnaissance units, and elements of the 1st Reconnaissance Battalion. These classes along with practical exercises greatly enhanced the support of these units.

2. Enemy, Weather, and Terrain

During the reporting period, liaison trips were made to OPs, improving the positions, equipment, and operations. Liaison was conducted with the 2/7 S-3 concerning observation requirements in the 2/7 TAOR and methods of improvement suggested.

The reporting procedures for Counter-Rocket Fire were reviewed and instructions for improvement procedures prepared.

Also during the reporting period, a Regimental Order was published on procedures for reporting map errors. Several reports of map corrections have been received and reported to higher headquarters.

During the month a new emergency destructions plan was prepared.

3. Organization and Operations. Units of the Regiment participated in six (6) operations in the Danang area during the month of April. These were:

a. Operation UNION, in which the 2d Battalion, 11th Marines supported the 5th Marines.

b. Operation GRAND, in which 3d Battalion, 11th Marines and 2d platoon, 1st Armored Amphibian Company supported the 7th Marines.

c. Operation CANYON, in which 1st Battalion, 11th Marines and 3d platoon 1st Armored Amphibian Company supported the 1st Marines.

d. Operation YELL, in which 1st Battalion, 11th Marines supported the 1st Marines.

e. Operation HUMBOLDT, in which 1st Battalion, 11th Marines supported the 1st Marines.

f. Operation DIXIE, in which Battery E, 2d Battalion, 11th Marines; 1st 8" Howitzer Battery; and 3d Platoon, 1st Armored Amphibian Company supported the 5th Marines.

4. Training. The cross-training program for Field Artillery Firing Battery-men (0811) between light and medium artillery battalions was continued. This program improves the proficiency of cannoneers on all weapons.

5. Logistics

a. April 1967 was marked primarily by the continued movement of 11th Marines' units from the Chu Lai TAOR to the Danang TAOR; support of 2d Battalion, 11th Marines in Operation UNION; continued phase-in of M35A2C multifuel vehicles and the replacement of a significant number of tubes for 105mm howitzers.

b. During April, all of 3/11, 3d 8" Howitzer Battery (SP) FMF (-) (Rein) and 4/11 (less Btry L) arrived in the Danang TAOR. By assembling what motor transport assets were available (initially 1/11 and Regt. Hq.), the units were moved from dockside to their position areas. Organic transport of these units proved inadequate due to high deadline rates primarily.

c. Although 1/11 initially was the only element of the Regiment involved in Operation UNION, later the 2d Battalion, with B/1/11 took part and these units were supplied by helilift from Danang, primarily from Ammunition Supply Point One. From 25 April to 30 April, about 338,000 pounds of ammunition, rations, and water were supplied to Operation UNION.

d. The 1st, 2d, and 3d Battalions had received 34, 31, and 36 M35A2C multifuel trucks by the end of the month. Although not complete replacement for the gasoline driven M35-2½ ton trucks, they significantly improved the deadline rate and improved the mobility of the Regiment.

e. Seventeen (17) of eighteen (18) 105mm howitzers, belonging to 3/11 had new tubes installed during April. In addition, three (3) tubes were installed in howitzers in Battery E 2/11 at An Hoa. Operational commitments precluded replacing howitzers belonging to the remainder of 2/11. Howitzer tubes for 1/11 had been previously replaced.

f. The month of April was probably the most active month logistically since October 1966. Although weather did not hamper logistic operations appreciably, limited availability of transport delayed the movement of units to Danang and restricted availability of helicopters for resupply on Operation UNION caused a continuous reassessment of priorities of resupply.

6. Civic Action

a. A daily MedCap was held for the people of Da Son hamlet at the CAC-Echo 1 platoon compound.

b. Completion of the two (2) classrooms in the school at Da Son hamlet was hampered by lack of heavy lumber for beams in the roof. Completion is expected in late May or early June.

c. Upon completion of classrooms, English classes will begin. Books I and II have already been received.

d. Due to movement of 1st Marine Division units, some graves had to be moved, others fenced. A payment of 6000 \$VN was made to the hamlet chief of Da Son, also cement was provided for repairing damaged tombs.

7. Aerial Observation. During the month of April 1967, the AO unit of the 11th Marines flew 66 missions for a total of 120.5 hours. Aviation support was provided by the O1C detachment, H&MS-16; MAG-16; and the 3d Platoon, 220th Aviation Company, USA, both based at Marble Mountain Air Facility, RVN. The following is a breakdown of missions flown:

Observation support was provided for Operations CANYON, DIXIE, HUMBOLDT, YELL, GRANDE, and UNION. During the missions flown, 17 airstrikes were controlled for a total damage assessment of 4 KIA (Probable), 18 structures destroyed, 13 damaged, 9 boats sunk, 2 bunkers destroyed, 4 caves collapsed, and 10 meters of trench destroyed.

The air observation section was manned by one (1) officer until the 24th of April and then brought up to total four (4) officers during the last week of the month. The continuing problem of limited aircraft availability from Marine Corps sources will preclude observation aircraft being available for strictly artillery missions and cause a continuance of the present method of operation. This finds the artillery air observers utilized as members of the G-2 observer section and allows artillery registrations to be conducted when the aircraft is not required to cover a committed ground unit or there are no other priority missions remaining for the observer.

8. Northern Sector Defense Command

Northern Sector Defense Command defends the Northern Sector, Division Rear Area, by directing and controlling the resources of all tenant units located within the Northern Sector.

Coordination within the Northern Sector, Division Rear Area is effected by establishing three (3) mutually supporting Sub-Sector Commanders responsible to the Commander, Northern Sector (who is also the 11th Marine Regimental Commander) for the conduct of defenses of all tenant units within their respective zones. Internal security of individual camps within each zone is the responsibility of the camp commander. Each sub-sector commander insures that appropriate patrols, outposts, listening posts and ambushes are conducted in areas not physically occupied by US or RVN forces.

Strike forces are available, and on-call in each sub-sector as a reserve for employment by the Commander, Northern Sector Defense Command, Division Rear Area.

Significant events which occurred during the month of April.

On the 9th of April, H&S Co, H&S Bn, FLC Provisional Rifle Company with ARVN forces swept the village of Ap Phuoc (AT 944787) and vicinity. Detained 75 females and 50 males. Following initial screening, 20 females and 15 males were forwarded to Danang Special Sector.

A reaction drill was conducted in Sub-Sector B on 13 April for the mustering of the Provisional Rifle Company. All platoons reported within 40 minutes.

OPs and LPs of the tenant units in the Northern Sector Defense Command participated in Counter-Mortar/Counter-Rocket drills conducted by 11th Marines FDC.

In the month of April, most remaining units of the 3d MarDiv have moved out. Units of the 1st MarDiv have moved in and have taken over defense of vital areas in the Northern Sector of the Division Rear Area. Included is the 1st Engineer Battalion, tenant unit of Sub-Sector B, and the 1st Shore Party Bn. The Commanding Officer of the 1st Shore Party Bn has been tasked with the security of Sub-Sector C.

Azimuth indicators supplied by the S-3 section of the 11th Marines are being positioned on all OPs. These will be used for rapid acquisition of azimuths to mortar/rocket firing positions.
