PART IINarrative Summary

During the month of May 1967, the major artillery effort was directed towards supporting fires for the defense of the Danang TAOR and support of operations in the surrounding areas. Additionally, supporting fires were provided for elements of the 1st Reconnaissance Battalion (Rein) inserted deep in the Viet Cong controlled territory, CIDG/Special Forces Camps and elements of the 2nd ARVN Division. Operations supported during the period include Operations UNION, UNION II, DUVAL and WEBSTER.

As a result of Operation OREGON, the 11th Marines were consolidated within the Danang TAOR with the arrival from Chu Lai of the 1st Field Artillery Group and "L" Battery, 4th Battalion, 11th Marines.

2. Enemy, Weather, and Terrain

a. Liaison trips were made to Artillery Battalion S-2 sections and Separate Artillery Batteries during the month to review the G-2 Technical Inspection questionnaire and determine the needs of subordinate units. Discrepancies have been noted and action taken to correct them.

b. The assignment of an Intelligence Chief and two ARVN Interpreters to this unit will increase the intelligence collection capabilities and improve relations with the local Vietnamese officials. Additional Intelligence personnel and ARVN Interpreters are desired to further improve these capabilities and relations.

c. On 6 May 1967, information from Photographic Reports was compiled and disseminated to subordinate units to update previous Tactical Area Studies and for the purpose of preparing Targeting Files. In addition, this unit has incorporated TPQ-10 targets for H&I fires during the month.

d. Enemy Artillery attacks during the reporting period included an attack on H/3/11 with 140MM rockets on the early morning of 16 May and a mortar attack on D/2/11 that included 20 120MM mortars on the early morning of 17 May. A crater analysis was conducted and fragments of 120MM mortars were found and reported by MORT/REP on 17 May.

e. During the 140MM rocket attack, 14-16 VC harrassed OP EAGLE with small arms fire and grenades. It is believed this may have been for the purpose of diverting the OP's attention from observing the terrain for rocket flashes.

f. Regimental Order 03120.3 spelling out instructions for OP assignments, responsibilities and reporting procedures was published on 17 May 1967. Liaison with OP's, senior, adjacent and subordinate units has continued to improve the Artillery Counter Mortar/Counter Rocket Fire Plans.

3. Organization and Operations. Units of the Regiment participated in four (4) operations in the Danang area during the month of May. These were:

a. Operation UNION. A 5th Marine operation supported by Headquarters, 1st Field Artillery Group and 2nd Battalion, 11th Marines. For details, see Tabs (E) and (G).

b. Operation UNION II. A 5th Marine operation supported by 2nd Battalion, 11th Marines, 3rd 8" Howitzer Battery and 3rd 155mm Gun Battery. For details, see Tab (G).

c. Operation DUVAL. 3rd Platoon, 1st Armored Amphibian Company supported the 2nd Battalion, 7th Marines. For details, see Tab (L).

d. Operation WEBSTER. A 7th Marine operation supported by Battery "K", 4th Battalion, 11th Marines from its primary position area.

4. Training. The cross-training for Field Artillery Firing Battermen (0811) between light and medium artillery battalions was continued. This program improves the proficiency of cannoneers of all weapons. During the month of May, a FMFPac Contact Team arrived and conducted classes/FAM Firing on the M-16 rifle throughout the regiment. A contact team from LFTU, Coranado, California conducted classes on waterproofing vehicles and waterproofing communication equipment throughout the regiment.

5. Logistics.

The emphasis of the logistic effort for May was directed primarily at support operations for 2/11 in Operation UNION and support of the C.I.D.G. Camp at Tien Phuoc. Over 640,000 pounds of supplies-primarily ammunition-were lifted by helicopter and fixed wing aircraft to Tien Phuoc, Que Son, Thang Bien and Viet An. Float weapons, both 105 and 155 were helilifted into units on Operation UNION to maintain maximum weapons availability. Condition of 155 HOW Toweds made necessary an unusually high number of contact team visits. M109 status deteriorated during the month, though improved sharply after direct contact was made with 3rd FSR to obtain critical parts. Unusual occurrences included a round jammed in the tube in Battery "D" which required explosive ordnance disposal personnel to blow out with demolition, saving the tube. The input of 20 more CH53's near the end of the month largely eased the re-supply/support problems for units inaccessible by road. 4th Battalion was inspected by the Inspector, Fleet Marine Force, Pacific, with satisfactory results. One Rawin Set, AN/GMD-1B was received on the FY 67 R&E program and was allocated to Regt. HQ. Btry, to replace a set to be evacuated. All other operations considered routine. No other significant occurrences during May.

6. Civic Action.

a. During the month of May 1967, MEDCAPS were continued in the hamlet of Da Son plus efforts in areas of Psychological Operations such as movies, posters and leaflets. Support of this type has been furnished by 244th Psychological Operations Company.

b. Work is continuing on the construction of a two (2) room classroom, as an addition to the hamlet elementary school. The Elementary School has been painted and the classrooms started. There have been a total of sixteen benches constructed and painted for use at the school.

c. It is planned to commence English Language classes in the hamlet of Da Son sometime in June. This project has been held up because of difficulty in obtaining materials for construction of a roof for the two new classrooms.

d. There were lights (one each) installed in the village Chiefs' house and the village police Chiefs's house. Power is furnished by a small generator within CAC E-1 compound. This organization continues to furnish materials and assistance in the interest for improvements to the hamlet of Da Son.

7. Aerial Observation. During the month of May 1967, the AO section flew 51 missions for a total of 109.1 hours. Aviation support was provided by the 3rd Platoon, 220th Aviation Company, USA, based at Marble Mountain Air Facility, RVN, and the 20th Tactical Air Support Squadron, U.S.A.F. based at the Danang main airfield, RVN. The following is a breakdown of missions flown:

Observation support was provided for Operation UNION and UNION II. During the missions flown, 25 airstrikes were controlled for a total damage assessment of 6 KIA (Confirmed), 1 WIA (Confirmed) and 3 WIA (Probable).

The air observation section was manned by three (3) officers during May. Aircraft availability became even more limited with the only aircraft used coming from Army or Air Force sources. No aircraft were available for strictly artillery missions or use. Artillery Air observers are utilized as members of the Division G-2 observer section which necessitates their fulfilling infantry units and intelligence gathering requirements primarily, working in artillery registrations as low priority operations when commitments permit.

8. Northern Sector Defense Command

The Northern Sector Defense Command defends the Northern Sector, Division Rear Area by directing and controlling the resources of all tenant units located within the Northern Sector.

Coordination within the Northern Sector is effected by the establishment of three mutually supporting Sub-Sector Commanders responsible to the Commander, Northern Sector for the conduct of defenses of all tenant units within their respective zones. Internal security of individual camps within each zone is the responsibility of the camp commander.

Strike forces are available, on call, in each zone as a reserve for employment by the Commander, Northern Sector, Division Rear Area.

Specific events which occurred within the Northern Sector Defense Command, Area of Responsibility, from 1 May 1967 to 31 May 1967.

052110H: 1st Engineer Battalion reported that their defensive position in Dai La Pass, grid AT 937758, fired one flare when a tiger approached their position.

112030H: A reaction drill was conducted in Subsector B for its Provisional Strike Force Company. One platoon was sent to reinforce Dai La Pass, grid AT 937758. The platoon arrived 32 minutes after being alerted.

152210H: OP Eagle was probed by an undetermined number of VC who were crawling under the protective wire. The VC were engaged with small arms fire and grenades. A reaction squad from the Provisional Strike Force Company (Headquarters Battery, 11th Marines) was called out and inserted by helicopter at 152245H to reinforce the OP and to provide a resupply of ammunition. The OP received approximately 70 rounds small arms fire, and 2 grenades. Marine personnel at the OP returned 1500 rounds 7.62mm and thirty-six M-26 grenades. Results; Six USMC WIA (One Med-evac), three VC KIA (probable).

162045H: OP Eagle received small arms fire and one hand grenade. Returned 40 rounds 7.62mm and three M-26 grenades. One USMC WIA (non-med-evac).

171500H: A jeep mounted searchlight from "G" Battery, 29th Artillery, USA, was heli-lifted to OP Eagle. The hill proved to be steep for the use of infra-red light in its defense; however, the white light has been used extensively by other Division Rear Area units.

251035H: A working party from 1st Reconnaissance Battalion, improving positions at their OP, grid AT 968745, discovered a bamboo mine, two inches by eighteen inches, with bamboo sticks across the ends. EOD notified, bamboo contained composition B with an instantaneous firing mechanism.
