PART II

Narrative Summary

During the month of August 1967, the major artillery effort was directed towards supporting fires for the defense of the Danang TAOR and support of operations in the surrounding areas. Additionally, supporting fires were provided for the elements of the 1st Reconnaissance Battalion (Rein) inserted deep in the Viet Cong controlled territory, CIDG/Special Forces Camps and elements of the 2d ARVN Division. During the latter half of August H&I fires were increased by one half to counter increased enemy activity aimed at the disruption of GVN elections scheduled for 4 September 1967. Operations supported during the period include Operations PIKE, COCHISE, and YAZOO. A total of 29,356 missions were fired and 166,710 rounds expended during the month.

During the month, Armed Reconnaissance Over-flights of the Rocket Belt were increased to three (3) flights per day with a varying of time each day. A continuation of the Roving Gun program concept to confuse the enemy as to the exact location of artillery units, deny his safe areas outside of existing artillery firing capabilities and to strike specific targets continued throughout the month. OpCon of Battery B, 8th Battalion, 4th Artillery (USArmy) passed to the 11th Marines. During the latter part of the month, one (1) platoon was emplaced at grid AT 92147989 and the other platoon displaced to grid AT 882582 (Hill 65) to increase the depth to which artillery support may be provided for reconnaissance inserts, operations, and H&Is.

On 2 August 1967, four (4) M-30 mortars from Mortar Battery, 1st Battalion, 11th Marines were helilifted to PHU BAI and placed under operational control of 12th Marines, mortars returned OpCon 11th Marines on 4 August 1967.

At 1000 on 16 August the 11th Marines fired their 1,000,000th round in Vietnam. The round was fired by Major General ROBERTSON using a 105mm Howitzer belonging to Battery H, 3d Battalion, 11th Marines.

There were two (2) incidents within the Division TAOR involving 140mm rocket attacks. The first incident occurred on 27 August at 0220 against the artillery units occupying positions within the First Battalion, First Marines perimeter. The second incident occurred on 28 August at 0129 against the Marble Mountain Marine Air Facility. The First Battalion, 11th Marines took the rocket site under fire expending 120 rounds before cease fire, for troop safety, was given.

2. S-2 - Intelligence

a. Liaison with the Regimental OPs has continued with emphasis placed on rapid and accurate reporting procedures and the improving of defensive bunkers and living conditions. OP PLAID has been established to provide additional surveillance against enemy mortar/rocket attacks and operations. A target list for deep areas, and Reports of Extracts from Captured Documents were published.

b. The enemy conducted two (2) rocket attacks during the reporting period. Crater analysis and equipment found at both launch sites revealed that 140mm rockets were fired at the artillery positions of A/4/11, L/4/11, and 3d 8" Howitzer Battery on 27 August, and the same type rockets were fired at Marble Mountain Air Facility on 28 August.

c. Cultural change information received earlier from District DIOCC's has been transcribed onto a 1:50,000 tactical map. This information includes classification of villages as to GVN controlled, VC controlled, or contested; destroyed hamlets, and newly constructed areas, including both military and RD areas. Plans are to produce overlays for distribution in the near future.

3. Organization and Operations. Units of the Regiment participated in three (3) operations in the Danang area during the month of August. Regimental Headquarters Battery FDC, Communication and Logistical personnel participated in each operation. These were:

- a. Operation PIKE, 1 - 3 August 1967. APPENDIX 2 to TAB (C).
- b. Operation COCHISE, 11 - 28 August 1967. APPENDIX 3 to TAB (C).
- c. Operation YAZOO, 27 - 31 August 1967. APPENDIX 4 to TAB (C).

4. Training. The cross-training for Field Artillery Firing Batterymen (0811) between light and medium artillery battalions was continued. A third increment of five (5) Marines were sent to the 12th Marines for a refresher training course on the Counter-Mortar Radar Sets MPQ-4 and MPQ-10. This course of instructions lasted some twenty (20) days and will continue on a monthly basis until all personnel in the occupational field of 0842 and 5931 have had the refresher training. Extensive training on the M-16 rifle was continued throughout the Regiment. This training will continue during the month of September. Three (3) separate Forward Observer schools were conducted during the month for personnel of the 1st Engineer Battalion by Lt CZARNECKI, KHAM DUC Special Forces Camp by Captain HALL, and for personnel of the 1st Reconnaissance Battalion by Captain MILLER. A total of sixty-one (61) personnel were trained during these three (3) classes. A school on Embarkation was conducted late in the month for eight (8) members of this command. Officers and SNCUs school was conducted during the month of August.

5. Logistics. Primary logistic effort this month has been in resupply of ammo to Hill 63, resupply of OPs, continued support to the 2d Battalion, and support of the move of 3d Battalion to their new position. Increased firing this month, and the continued shortage of 3d echelon repair parts, increased the average number of down weapons this month to approximately twice that of the previous month. Continuing problems with the M30 necessitated replacement of one (1) additional M30 with an M98 HOWTAR. Repair parts for recoil mechanisms, and obturator spindles for the M109 continue to be the major cause of down weapons.

6. Civic Action. (Regimental Headquarters only, for unit civic action see unit chronology).

a. During August, 11th Marines conducted MEDCAPs at the dispensary in DA SON (H) on 28 days. A total of 2,045 civilians were treated during this period. Efforts were continued to improve the dispensary with concentration towards hygenic improvements. Water was delivered approximately every other day to the dispensary for washing patients prior to treatment.

b. Two (2) additional schoolrooms which were constructed in July were painted and blackboards erected. Desks were built in sufficient quantity to provide seating for thirty (30) children in each room. English classes were conducted at the DA SON school on Monday, Wednesday, and Friday evenings for adults and on Friday afternoons for children.

c. A meeting was conducted on 21 August with the Civil Affairs officer and the hamlet officials and elders of DA SON. Plans were discussed for future projects to be undertaken at the completion of those projects presently in effect. The major project desired by the elders of DA SON at the meeting was the construction of a community building adjacent to the hamlet temple. The elders are to present this project to the citizens of DA SON for their approval.

7. Aerial Observation. The 11th Marines AO unit flew a total of 155 missions during the month of August for a total of 283.8 hours of flight time. They were supported with aircraft from the following agencies:

- a. (UH1E) VMO-2 USMC based at Marble Mountain Air Facility
- b. (UH1E) VMO-6 USMC based at Chu Lai
- c. (O1C) O1C Detachment USMC based at Marble Mountain Air Facility
- d. (O1D) 220th Aviation Company, 3d Plt USA, based at Marble Mountain
- e. (O1G) 20th Tactical Air Support Squadron, USAF, based at Danang.

8. Northern Sector Defense Command. The Northern Sector Defense Command defends the Northern Sector of the Division Rear Area by coordinating the defenses of all tenant units located within the assigned sector. The Northern Sector is commanded by the CO, 11th Marines. Coordination is effected through the establishment of three (3) subsectors within the sector. Subsector A is the northern subsector and contains the Force Logistics Command, MCB 30, MCB 1, and MCB 74. The Commanding Officer, H&S Bn, 1st FSR is assigned as the Commander, Subsector A. Subsector B is comprised of Headquarters Bn; 11th Marine's Headquarters; 4th Bn, 11th Marines; 1st Reconnaissance Bn; 1st Engineer Bn; 7th Engineer Bn; 11th Motor Transport Bn; MASS-2; 1st Medical Bn; and Detachment, MCB-1. Subsector B is commanded by the CO, 11th Marines and occupies the central area of the Northern Sector. The southern sector is subsector C, commanded by the CO, 1st Shore Party Bn, and is comprised of the Shore Party Bn, and MCB-4. Subsector Commanders are responsible to the Commander Northern Sector Defense Command for the conduct of all defenses within their respective subsectors. This is accomplished through established perimeters, coordinated patrolling, observation posts and listening posts. Each unit within the Northern Sector retains the responsibility for internal security.

A Reaction Force is task organized from each unit within the subsectors and is comprised of an overall force of 1 company each (-) from Subsectors B and C and two (2) platoons from Subsector C. The Reaction Forces are on call and are to be used primarily in defense of the parent subsector although the capability exists to commit and force within any subsector.

9. Psychological Operations. The 11th Marines are assigned the responsibility for the overall coordination of psychological operations within Subsector B of the Northern Sector Defense Command. Battalions of the 11th Marines conduct psychological operations in coordination with infantry TAO and report results through those channels. Units performing psychological operations in Subsector B are Headquarters, 11th Motor Transport Battalion, 1st Reconnaissance Battalion, 1st Medical Battalion, and Headquarters Battalion. 1st Dental Company, although not located in Subsector B has been assigned to the 11th Marines for administrative reporting purposes.

The area of psychological operations by these units is pacified and psychological efforts are aimed at improving health and sanitation and strengthening the Vietnamese loyalty to the Government of Viet Nam.

Wide distribution is made of health and loyalty posters and leaflets, Vietnamese language TU DO newspapers are distributed throughout the hamlets in the subsectors, and movies are presented periodically with assistance of the 244th Psychological Operations Company (USA) attached to the 1st Marine Division.

A resume of operations conducted in Subsector B during the reporting period is as follows:

11th Marines conducted psychological operations in DA SON (H) HOA KHANH (U). 300 TU DO newspapers were distributed, 150 miscellaneous health and loyalty posters were displayed and two (2) hours of movies. One additional movie scheduled for late August was cancelled due to inclement weather.

1st Medical Battalion conducted operations in PHUOC TUONG (H) HOA PHAT (U) in conjunction with MEDCAP. 775 health leaflets and 100 TU DO newspapers were distributed.

Headquarters Battalion conducted operations in HOA MY (H) HOA MINH (U). The efforts of this unit were centered around the presentation of four (4) hours of movies with accompanying verbal presentations with recordings.

11th Motor Transport Battalion has responsibility for KHANH SON (H) HOA KHANH (U). 100 health leaflets and 75 TU DO newspapers were distributed during August.

1st Dental Company, although not responsible for a specific area, performs DENTCAPS in the villages of HOA THAI and HOI LAI. In conjunction with this activity, psychological operations are carried out through the distribution of leaflets and newspapers, during August 100 TU DO newspapers were distributed.

1st Reconnaissance Battalion was assigned the responsibility for PHUOC LY (H) HOA MINH (U) late in the reporting period. Efforts from that time until the end of the reporting period have been toward the establishment of a good program with personnel assigned becoming familiar with the area and established psychological operations procedures. A full program will commence 1 September 1967.
