PART II

Narrative Summary

During the month of September 1967, the major artillery effort was directed towards providing supporting fires for the defense of the Danang TAOR and in support of operations in the surrounding areas. Additionally, artillery fires were provided for teams of the 1st Reconnaissance Battalion (inserted deep into Viet Cong controlled territory), CIDG/Special Forces Camps, and elements of the 2nd ARVN Division. Operations supported during this period included: Operations YAZOO, SWIFT, BALLISTIC CHARGE and SHELBYVILLE. A total of 28,387 missions were fired and 154,653 rounds were expended during the month.

Operational highlights of the month included the development of a Counter-Rocket plan in the northern portion of the Division AO. Since September 4th, general support units have laid nightly on potential rocket launching sites in pre-cleared areas. Units are triggered to commence barrage fires immediately upon sighting rockets or receiving reported sightings from observers. The barrage fires are intended to be suppressive in nature and to continue until accurate data on the firing site location(s) is obtained. Nightly, four to twelve drills are conducted by the Regimental FDC; the drills have served to increase the responsiveness of general support fires while delivering harassing and interdictory fires in possible launch areas.

The foregoing plan was primarily stimulated by a new technique employed by enemy rocket units in the Danang area on 2 September 1967. On that date, the enemy delivered simultaneous rocket attacks from three widely separated locations. Targets included the Danang Airfield, the Force Logistic Command,

and the 8" artillery complex in the northern part of the Division area of operations (artillery casualties were light; 3 WIA, 2 trucks destroyed and 1 building damaged). The three pronged attack resulted in a plethora of target information at the FDCs tended to slow artillery reaction time. Although one site was identified and taken under fire within five minutes, the other two sites were not accurately located for about five minutes and, with time required for clearance, were not fired upon until about 11 minutes had elapsed. The current counter-rocket plan provides for suppressive fires on deep rocket site targets while FDCs concentrate on locating the unit firing into the vital area.

During the month, Armed Reconnaissance Over-flights of the rocket belt were continued at the rate of three (3) flights per day, weather and aircraft availability permitting.

On 25 September 1967, Battery B, 8th Battalion, 4th Artillery, US Army was consolidated into position (grid AT 985675) in order to increase the speed and volume of fires available for Recon inserts and to simplify logistics.

On 19 September 1967, Major General Charles P. BROWN, USA, Commanding General, U.S. Army Artillery and Missile Command, Fort Sill, Oklahoma, visited the Regiment to assess artillery training needs and the quality of the Fort Sill product.

As the month drew to a close, the 11th Marines were in receipt of orders requiring the displacement of the 1st Battalion (-), 11th Marines to QUANG TRI for support of the 1st Marines (-) also scheduled for movement. The 2d Battalion (-), 11th Marines were scheduled to displace northward in the Division AO to occupy positions to be vacated by 1st Battalion, 11th Marines.

2. S-2 Intelligence

a. Artillery ground observation was analyzed during September and resulted in the increase of Regimental O.P.'s from five to seven. In addition, two battalion O.P.'s were entered into the Regimental O.P. communication net for the purpose of reporting rocket sightings and locations.

b. Liaison with the Regimental O.P.'s has continued with emphasis placed on rapid and accurate reporting procedures and the improving of defensive bunkers and living conditions.

c. Map of villages and district boundaries was published and distributed during the reporting period.

3. Organization and Operations. Units of the Regiment participated in four (4) operations in the Danang area during the month of September 1967. These were:

- a. Operation YAZOO. 1 - 5 September 1967. APPENDIX 2 to TAB (C).
- b. Operation SWIFT. 4 - 15 September 1967. APPENDIX 3 to TAB (C).
- c. Operation BALLISTIC CHARGE. 16 - 22 September 1967. APPENDIX 4 to TAB (C).
- d. Operation SHELBYVILLE. 22 - 28 September 1967. APPENDIX 5 to TAB (C).

4. Training. Cross-training for Field Artillery Firing Batterymen (0811) between light and medium artillery battalions was conducted. A fourth increment of five (5) Marines was sent to the 12th Marines for a refresher training course on the Counter-Mortar Radar Sets AN/MPQ-4 and AN/MPQ-10. This course of instruction lasted twenty (20) days and will continue on a monthly basis until all personnel in the occupational field of 0842 and 5931 have had the refresher training. Extensive training on the M-16 rifle was continued throughout the Regiment. Forward observer training of non-artillery personnel was held one day a week throughout the month for units within the 1st Marine Division. A total of 87 students were trained, each receiving two (2) hours of classroom instructions and four (4) hours of practical application in adjusting artillery fire. Officer and Staff NCO classes were conducted throughout the month within the Regiment. A school on Embarkation was conducted by Division for eight (8) members of this Command.

5. Logistics. Receipt of obturator spindles and pads from Army and Marine Corps sources eliminated the major cause of deadlining of M109's. Receipt of 155mm gun barrels (3d echelon item) eliminated immediate problem causing deadline of M53's. Shortage of repair parts for motor vehicles and artillery weapons continues to exist. Primary logistical effort involved resupply of ammunition to Hills 63 and 65, resupply of O.P.'s and support of dis- placements of the 4th Battalion CP and 155mm Gun Battery CP.

6. Civic Action

a. During September, 11th Marines conducted MEDCAPS at Da Son on 14 days. A total of 1,604 civilians were treated during this period.

b. To commemorate the completion of construction and the beginning of operation of two classroom additions to the Da Son Elementary School, a ceremony was held on 11 September. This ceremony was planned and conducted by the Hamlet Chief and elders of Da Son and featured the Village Chief and Commanding Officer, 11th Marines as guest speakers. The 1st Marine Division Band provided music for the ceremony and refreshments were provided by the 11th Marines.

c. The construction of an archway and school sign is presently in progress at the school grounds.

7. Aerial Observation. The 11th Marines Aerial Observation Unit, consisting of four (4) officers flew a total of 147 missions in the month of September for a total of 225.8 hours flight time. The unit was provided with aircraft support from the following agencies:

- a. 01-C Detachment of H&HS-16 based at Marble Mountain (01-G a/c) USMC.
- b. 3rd Plt, 220th Aviation Company, U.S. Army based at Marble Mountain (01-D a/c).
- c. 20th Tactical Air Support Squadron, U.S.A.F. based at Danang Air Base (01-G a/c).
- d. VMO-2 Squadron based at Marble Mountain (UH-1E a/c) USMC.
- e. VMO-6 Squadron based at KY HA near CHU LAI (UH1-E) USMC.

There were eleven (11) small arms ground fire incidents and one (1) automatic weapons ground fire incident with no aircraft hits taken. The unit flew a total of 23 night missions experiencing very poor visibility and negligible results.

8. Psychological Operations. The 11th Marines are assigned the responsibility for the overall coordination of psychological operations within Subsector B of the Northern Sector Defense Command. Battalions of the 11th Marines conduct psychological operations in coordination with Infantry TAOR and report results through those channels. Units performing

psychological operations in Subsector B are Headquarters Battery, 11th Marines, 11th Motor Transport Battalion, 1st Reconnaissance Battalion, 1st Medical Battalion, Headquarters Battalion and 1st Dental Company. Although not located in Subsector, the latter reports to the 11th Marines for administrative reporting purposes. The area of psychological operations by these units is pacification and psychological efforts aimed at improving health and sanitation and strengthening the Vietnamese loyalty to the Government of Vietnam. A resume of operations conducted in Subsector B during the reporting period is as follows:

a. 11th Marines conducted psychological operations in Da Son (H) Hoa Khanh (V). 585 TU DO newspapers were distributed, 550 health and loyalty leaflets were distributed. Two movies were shown for a total of 5 hours to 500 people.

b. 1st Medical Battalion conducted operations in Phuoc Tuong (H) Hoa Phat (V) in conjunction with MEDCAP. 200 TU DO newspapers and 200 health leaflets were distributed.

c. Headquarters Battalion conducted operations in Hoa My (H), Hoa Minh (V). They showed 2 movies for a total of 5 hours to 3300 people. They handed out 2000 rural farmer pamphlets and 1000 health leaflets.

d. 11th Motor Transport Battalion has responsibility for Khanh Son (H) Hoa Khanh (V). Two movies were shown for a total of 5 hours to 500 people. They handed out 375 TU DO newspapers and 525 health leaflets.

e. 1st Dental Company, although not responsible for a specific area, performs DENTCAPS in the villages of Hoa Thai and Hoi Lai. They handed out 450 TU DO newspapers and 1000 dental health leaflets.

f. 1st Reconnaissance Battalion has been assigned the responsibility for Phuoc Ly (H) Hoa Minh (V). At this time they are involved in establishing their MEDCAP/PSYOPS program. In order to preclude interference with elections, PSYOPS work in the subsector was halted over the election period from 2-4 September inclusive.

9. Northern Sector Defense Command

a. There have been no changes to subsector task organizations except Subsector B is now commanded by CO, Hq Bn and 7th Eng. Bn is now in Subsector A. During the period 1 - 30 September 1967, the following activities took place in the NSDC.

b. The following significant contacts and events occurred within the NSDC:

Subsector A - FLC received 12 rounds 122mm rockets and small arms fire; one (1) KIA, 29 WIA. NSDC was alerted to condition red on this occasion. There were 7 other incidents of units of Subsector A receiving small arms fire.

Subsector B - 7 incidents of units receiving small arms fire.

Subsector C - No contact.

There were 24 detainees apprehended during the month of September. Weapons and equipment found or turned in during the month include three bear traps, blasting caps, one M-14 rifle and one M-26 grenade.

c. There were no incidents which required activation of reaction forces.
