PART II

Narrative Summary

During January the Eleventh Marines continued to provide supporting fires for the defense of the Danang vital area and for search and destroy operations in the 1st Marine Division Tactical Area of Operations. Fire support was continued for Rough Rider convoys, reconnaissance teams, Combined Action Platoons, ARVN and ROK forces and elements of the U.S. Americal Division operating to the South of the 1st Marine Division. Three forward observers were provided for ARVN convoys from the Regimental Headquarters. Two forward observers were provided to the 1st Reconnaissance Battalion to assist recon teams in fire planning and forward observer procedures. They were utilized as members of teams "CHILI PEPPER" and "ICE-BOUND".

In conjunction with the Division's continued northward movement, Battery "E" and Headquarters, 2nd Battalion, 11th Marines displaced to the vicinity of PHU BAI (YD 8812). Provisional Battery QUEBEC was activated at AN HOA (AT 876472) to provide fire support for USMC, ARVN and Reconnaissance forces. The 3rd Platoon, 1st Armored Amphibian Company (5 LVTH-6) displaced to vicinity of HOI AN (BT 110581) in direct support of the ROK Marines. The Eleventh Marines assumed operational control of the 1st

Field Artillery Group, 1st Battalion, Eleventh Marines and the 1st 155mm Gun Battery (SP) from the Twelfth Marines.

A total of 34,088 missions were fired by the 11th Marines expending a total of 122,829 rounds. Elements of the Regiment supported Operation AUBURN.

Counter-rocket firing drills were continued six to twelve times nightly on pre-cleared suspected positions. Additionally, an average of eight chart drills were conducted unannounced each night by the OP's in our southern area to test the abilities of the three participating FDC's to quickly compute accurate coordinates of rocket firing positions.

Four 122mm rocket attacks against the Danang Vital Area were instigated by the communist insurgents during the month.

On 3 January, 620 rounds of accurate counter rocket artillery fire was delivered on the rocket firing site within two minutes. Inspection of the firing site revealed four NVA KIA.

On 7 January, rockets were fired at the 8" Howitzer Complex (AT 92-79) and the Force Logistic Command (AT 9579). A total of 235 rounds were fired on the firing site and 2,257 rounds were expended interdicting routes of egress. An inspection of the remote firing site revealed four large blood spots, bandages, bloody clothes and parts of one body.

A total of three rocket attacks from three different firing sites occurred on 30 January. Accurate artillery fire was delivered on two of the firing sites which later revealed nine rocket motors and twelve warheads abandoned. The third attack was launched from a firing site approximately 500 meters from an Infantry Company patrol base and fires from the infantry manned crew-served weapons immediately terminated the attack.

The final rocket attack occurred on 31 January. A five ray intersection was obtained and accurate artillery fire was delivered on the site within five minutes.

2. S-2 Intelligence

During the month of January the enemy increased his attacks against artillery positions of this Regiment. Increased activity was encountered by units moving to the PHU BAI/PHU LOC area and enemy activity in the DANANG area increased greatly at the end of the month. There were a total of 15 mortar, 4 rocket, 3 mine, 2 recoilless rifle, 3 satchel charge, 2 grenade and small arms attacks recorded.

On 3 January 1968, there were 3 attacks reported. At 030100H Battery G, 3rd Battalion, 11th Marines received approximately 30 rounds of 82mm mortar fire. Counter-mortar fire was fired at grid AT 915674 resulting in two secondary explosions. At 030445H, Battery I, 3rd Battalion, 11th Marines was hit by three satchel charges and at 030430H Headquarters Battery, 2nd Battalion, 11th Marines received two unknown caliber mortar

rounds, impacting 30 meters outside of their wire.

On 7 January 1968 there were 6 attacks reported. At 070100H, Battery L(X), 4th Battalion, 11th Marines received 15 rounds 82mm mortar fire, coming from the west of their position. .50 caliber was fired at flashes. At 070315H, Battery D, 2nd Battalion, 11th Marines received 20 to 25 rounds 81mm mortar fire and 4 to 5 rounds 57mm recoilless rifle fire. At 070330H, Battery L, 4th Battalion, 11th Marines received 7 rounds recoilless rifle fire and small arms fire. Battery L returned direct fire and destroyed recoilless rifle site. At 070845H, Battery D, 2nd Battalion, 11th Marines received 4 rounds 82mm mortar fire and returned direct fire and counter-mortar fire. At 070900H, Battery L, 4th Battalion, 11th Marines received 10 rounds mortar fire. At another position at 072200H, Battery M, 4th Battalion, 11th Marines received 4 rounds 122mm rockets and 20 rounds of unknown caliber mortar. Battery H, 3rd Battalion, 11th Marines, at 072200H, received 12 122mm rockets in and around their position and returned counter rocket fire.

On 10 January there were 4 separate incidents. At 101625H, a 2nd Battalion, 11th Marines vehicle moving from Battery F to forward position was ambushed at grid AT 997631 by 7 VC with automatic weapons. One VC was shot and run over by the vehicle. At 101915H, Battery L(X), 4th Battalion, 11th Marines received 3 B-40 rockets from high ground west of position. Returned direct fire and small arms with results of 1 secondary explosion. At 102245H, Battery L, 4th Battalion, 11th Marines received 4 unknown caliber rounds and small arms fire. Small arms fire was returned and counter-mortar targets were fired. At 102330H, Battery I, 3rd Battalion, 11th Marines received grenades and illuminated area with negative results.

On 11 and 12 January, artillery positions near PHU LOC again came under mortar attack. At 110728H, Battery D, 2nd Battalion, 11th Marines received 4-60mm mortar rounds and at 112215H, Battery L, 4th Battalion, 11th Marines received 3 incoming mortar rounds and small arms fire. Counter-mortar fire was returned in both cases. On 12-0730H, Battery L, 4th Battalion, 11th Marines received 20 rounds 60mm and 82mm mortar fire and returned counter-mortar fire. At 121635H, Battery L, 4th Battalion, 11th Marines received 6 rounds unknown caliber mortar fire in perimeter wire.

On 151030H, a Battery B, 1st Battalion, 12th Marines vehicle detonated a mine at grid BT 069696 and the vehicle was destroyed.

At 260100H, Battery K, 4th Battalion, 11th Marines observed 2 explosions vicinity grid AT 881576. Investigation in morning found trench 20 meters long, 4 feet deep with 11 evenly spaced 1 foot square niches. There were satchels charges in 8 of the niches and 1 dud charge near perimeter wire. On 260130H, 1st 155mm Gun Battery (SP) received approximately 30 rounds 82mm mortar fire. Fire was returned with twin 40's and 81mm mortars. At 282145H, 11th Marines O.P. (AT 941742) received several rounds small arms and observed movement 50

meters to front. Small arms fire was returned and area was illuminated. On 282150H, Battery F, 2nd Battalion, 11th Marines received 1 propelled satchel charge. The area was illuminated with negative results. On 300145H, Battery M, 4th Battalion, 11th Marines received approximately 15 rounds of 122mm rockets. Counter rocket targets were fired. At 300525H, Battery K, 4th Battalion, 11th Marines received 6 or 7 mortar rounds.

On 31 January there was a great increase in activity in all parts of the TAOR and 7 incidents were reported. At 310101H, Battery W, 3rd Battalion, 11th Marines received approximately 20 rounds 82mm mortar rounds about 50 meters outside wire. Fire was returned with secondary explosions seen. At 310340H, 1st Field Artillery Group reported estimated 18 rounds of rockets fired on PHU BAI. At 310345H, Battery K, 4th Battalion, 11th Marines received approximately 15 rounds 82mm mortars. Counter-mortar fire was returned. At Battery L(X), 4th Battalion, 11th Marines, 4 mortar rounds were received at 310750H and a Battery L(X), 4th Battalion, 11th Marines lead vehicle in convoy 2 miles north of Battery L, 4th Battalion, 11th Marines CP detonated a mine at 311100H. At 311230H, a 1st Battalion, 11th Marines ammunition convoy on resupply run vicinity of grid YD 715197 received small arms fire and explosions 25 meters from lead vehicle. The convoy returned to CP. At 311335H, 1st Field Artillery Group received 4 to 5 rounds 122mm rockets. Counter-rocket fire was returned.

3. Organization and Operations. Units of the Regiment participated in one (1) operation in the DANANG area during the month of January 1968.

a. Operation AUBURN. 1 - 3 January 1968. APPENDIX 1 to TAB (C).

4. Training

a. Forward Observer training of non-artillery personnel continued for the month for the 1st Reconnaissance Battalion. A total of 13 students were trained receiving two hours of classroom instructions. Practical application in adjusting artillery fire was not held due to operational commitments.

b. A class on the AN/PPS-6 radar set was held for one officer and four enlisted members from Headquarters Battery, 11th Marines for a period of ten days. Class was held on operations and maintenance.

c. Communication-Electronic classes were held throughout the Regiment by a team from III MAF.

d. A Motor Transport Maintenance Assistance Course was held at the Force Logistic Command for members of this command by a team from FMFPac.

e. Newly arrived personnel assigned to the Regiment were issued M-16 rifles with familiarization firing and zeroing of the weapon accomplished within the prescribed time. Weekly classes were held by sections on weapons safety.

5. Logistics. Assistance in resupply of ammunition for 3rd Battalion 11th Marines continues with no great problems. Receipt of ten (10) obturator spindles from FLC reduced the constant number of guns in a down status. On 14 January 1968, amphibious movement from DANANG to PHU GIA area for one platoon from 3rd 8" Howitzer Battery was accomplished. On 16 January, amphibious evacuation of an M109 from the PHU GIA area was completed. Aerial resupply of ammunition to units in the PHU LOC/PHU GIA area was accomplished on several occasions. The major logistics problem continuing is the extreme shortage of M501A1 fuzes for separate loading illumination rounds.

6. Civic Action. Medcaps and emergency medical aid were offered in the hamlet of DA SON. Medcaps were conducted three times a week and medical aid was offered on an on-call basis. The guest house has progressed to the state that all materials are in the possession of the hamlet. Construction will start at the termination of the TET holidays. The project to build a fence around the school yard met with a serious setback when a vehicle crashed into the concrete posts of the gate. Materials are being procured for the reconstruction of the posts.

7. Aerial Observation. The 11th Marine Regiment Aerial Observer unit flew 89 missions for a total of 135.6 hours. The unit was supported with aircraft from the following units:

a. 01-C Detachment of H&MS-16, USMC based at Marble Mountain Air Facility (01-C and 01-G).

b. VMO-2 Squadron, MAG-16, USMC based at Marble Mountain Air Facility (UH-1-E).

c. 3rd Platoon, 220th Aviation Company, U.S. Army based at Marble Mountain Air Facility (01-E and 01-D).

d. 20th Tactical Air Support Squadron, USAF based at DANANG Air Base (01-G).

The unit encountered eight ground fire incidents with one aircraft hit resulting in one aircraft downed with no casualties.

8. Northern Sector Defense Command

Northern Sector Defense Command is a rear area defense organization commanded by the Commanding Officer, 11th Marines. During the month of January, alert condition GREY was executed 14 times, and condition YELLOW was executed 3 times due to intelligence reports of increases in enemy activities and enemy attacks within the Northern Sector Defense Command. One night reaction drill was held in the Northern Sector Defense Command with satisfactory results. The reactionary forces were mustered seven times. Subsector A reaction force was deployed at CAP Q-4 to reinforce CAP Q-4.

There were 32 detainees reported being picked up during the month of January. Two were classified as POW by 5th CIC. There were 529 night recons, ambushes, security patrols and 66 day time patrols conducted during January. There were 47 incidents or contact with the enemy in the Northern Sector Defense Command area. There were 7 USMC KIA's, 3 were from the 1st Military Police Battalion, and 4 were from Division Headquarters Battalion. There were 9 USMC WIA's, 7 USMC from Division Headquarters Battalion and 2 USMC from CAP-Q4.
