## PART II

NARRATIVE SUMMARY

During November 1968, the 11th Marines continued to provide supporting fires for the 1st Marine Division in its defense of the Danang vital area and in operations in the Quang Nam and Southern Thua Thien Provinces. In addition, continued support was provided to Division Reconnaissance Teams, Combined Action Platoons, USA, USN, CIDG, KMC, and ARVN forces. Forward observers again accompanied USMC, USA and ARVN convoys traveling as far south as Quang Ngai and North to Hue.

On 19 November the 1st Field Artillery Group consisting of Group Headquarters, 1st 155 Gun Battery and Kilo Battery, 4th Battalion, 13th Marines displaced from Phu Bai (YD 881130) to the Danang TAOR, arriving on 23 November.

Artillery fires accounted for 460 of the 976 enemy killed within the Division Area of Operations. Of these, 269 were the results of missions fired for Division Reconnaissance Teams operating in the 1st Marine Division TAOR. A total of 181,823 rounds were expended on 30,561 missions.

In the month of November three operations were terminated. Operation Sabine Draw was terminated on 1 November. The operation was supported by the 3rd Battalion, 11th Marines in support of the 2nd Battalion, 7th Marines and elements of the 51st ARVN Regiment. Operation Garrard Bay, supported by the 1st Battalion, 11th Marines in support of the 26th Marines was terminated on 16 November and Operation Nicollet Bay, initiated on 7 November, was terminated on 14 November with the 1st Battalion, 13th Marines in direct support of the 26th Marines.

Two operations continued during the month, Operation Henderson Hill supported by the 2nd Battalion, 11th Marines in support of the 5th Marine Regiment and Operation Meade River being supported by the 1st Battalion, 11th Marines.

Improved conventional munitions (FIRECRACKER) continued to be employed throughout the 1st Marine Division TAOR. The Regiment fired 65 FIRECRACKER missions during the month accounting for 150 VC/NVA KIA. All surveillances represent confirmed KIA's and do not include additional probable KIA. Total FIRECRACKER expenditures for the month was 1262 rounds.

On 18 November at 0900 Batteries E, F, and T, 2nd Battalion, 11th Marines fired on 50 NVA at grid AT 801483, resulting in 20 KIA. At 1515 Battery F, 2nd Battalion, 11th Marines fired on VC at grid AT 806479, resulting in 28 VC KIA. Both missions were observed by Recon Team (LUNGA POINT). On 19 November at 1455 Batteries E, F, and T, 2nd Battalion, 11th Marines; 3rd 155 Guns and 1st Platoon, 3rd 8" Howitzer Battery fired a FIRECRACKER mission on 55 NVA at grid AT 804483, resulting in 33 NVA KIA. At 1630 Batteries E and F, 2nd Battalion, 11th Marines; 1st Platoon, 3rd 8" Howitzer Battery and 3rd 155 Guns fired a FIRECRACKER mission on 30 VC with packs and rifles at grid AT 803486, resulting in 23 KIA. Both missions were observed by Recon Team (LUNGA POINT).

Counter-rocket drills continued during the month. Chart drills were conducted unannounced each night to exercise the ability of participating FDC's to compute accurate grids of rocket positions. In addition, counter-rocket firing drills were conducted nightly on possible rocket positions.

The enemy initiated nine rocket attacks during the month. The targets included the 1st Marine Division CP, Force Logistics Command, Deep Water Pier, RVN Ammunition Supply Point, Marble Mountain Air Facility and the 11th Marines CP. The average artillery reaction time for counter-fire during these attacks was approximately three minutes. Clearance continues to delay counter-rocket response time in some portions of the Division Area.

2. Intelligence

a. During the month of November, enemy attacks against artillery units decreased from the previous reporting period. A total of 1 rocket, 2 mortar, and 2 small arms fire incidents were recorded during the month.

b. The following significant incidents took place during the month of November 1968:

- (1) 011700H: 11th Marines AO (BT 003670) received small arms fire from 15 to 20 NVA.
- (2) 031410H: 1/11 paid 800P to VN boys for small arms ammo.
- (3) 061435H: 11th Marines paid 200VN\$ to VN boys for 40 rounds of small arms ammo.
- (4) 121050H: T/2/11 (AT 868472) received 2 rounds of small arms fire.
- (5) 170510H: C/1/11 (AT 987714) received 10 rounds of mortar fire.
- (6) 171000H: 11th Marines Rocket Inspection Team (AT 923874) found 6 launch positions, two 122mm rockets without fuzes, and rocket debris. 14 to 20 rockets had been fired.
- (7) 171030H: 11th Marines Rocket Inspection Team (AT 962689) found 48 mud ramps of 6 groups of 8 ramps each. Twenty 140mm rockets left on site. 4 to 6 rockets had been fired.

- (8) 182100H: D/2/11 (AT 923525) received 18 rounds of mortar fire from AT 894543.
- (9) 201030H: 11th Marines Rocket Inspection Team (BT 041681) found 3 launch sites. Thirteen rockets had been fired, two 122mm rockets left on the site.
- (10) 210725H: 11th Marines CP (AT 953758) received 2 rounds of 140mm rocket fire.
- (11) 210745H: 11th Marines AO (AT 885706) found rocket site with 24 mud ramps of 2 groups of 12 each.
- (12) 221100H: 11th Marines Rocket Inspection Team (AT 952694) found 2 mud ramps, wiring, and two 140mm rockets had been launched.
- (13) 250845H: 11th Marines Rocket Inspection Team (BT 068675) found 15 mud ramps and 122mm rocket debris.

- e. Operation NICOLLET BAY, 7-14 Nov 1968. APPENDIX 9 to ANNEX C.

4. Training

a. Forward observer training of non-artillery personnel was again conducted this month. Recipients of this training were personnel from the 1st, 2nd, 3rd and 4th Combined Action Groups, 1st Reconnaissance Battalion, Division Scout Snipers School, 7th Engineer Battalion and Headquarters Battalion, 1st Marine Division. A total of 458 students received two hours of classroom instruction and from four to six hours of practical application.

b. During the month of November, the 11th Marines conducted NBC exercises. Instructions were given on masking techniques, proper maintenance and care of field protective mask and included gas chamber exercises.

c. The month of November saw a continuation of an on-the-job training program for ARVN soldiers with a view toward qualifying them as 105mm and 155mm howitzer (towed) gunnery. During the month, 136 ARVN soldiers have completed the training.

d. Two officers and twenty-nine enlisted Marines attended in-country Division level schools and five officers and thirteen enlisted Marines attended schools out of country.

5. Logistics

a. During the reporting period, this Regiment was augmented with ninety-three tractor trailers and seventeen M54 trucks with dolly converters from Division to transport ammunition in support of 11th Marines operational commitments. One low bed was furnished to transport an EIMCO tractor from the Sea Bee Ramp to Hill 55 and four low beds were provided to augment 1st FAG move from Phu Bai to Danang.

b. This Regiment provided Division with six 5 ton trucks on 20 Nov 68 in support of 1st Marines operation, in addition to sixteen 5 tons to 1st FAG to augment movement from Phu Bai to Danang on the same date.

c. Other logistical problems occurring during the month were minor and assistance was rendered as appropriate.

6. Civic Action Report for Headquarters Battery, 11th Marines

MedCaps and emergency medical aid were offered in the hamlet of Da Son AT 960765, Hoa Khanh (V), Hoa Vang (D), Quang Nam (P). Emergency medical care is maintained on an On-Call status. MedCaps were provided five times a week. Approximately 723 Vietnamese civilians were treated at the MedCap unit.

MedCap and Civic Action supplies were requisitioned from III MAF. Medical supplies for MedCap and assorted bath soap for the hygienic program were requisitioned for the dispensary.

DenCaps were offered once a week. Approximately 33 Vietnamese people were treated this month.

Two students were selected for the General WALT Scholarship program. The scholarships were awarded to the students by a representative from this Headquarters.

Project Submittal Forms have been completed and sent via appropriate GVN/CORDS Officials, requesting a new school for the hamlet of Da Son.

Headquarters Battery has continued to provide food waste for supporting the pig project in Da Son (H). Nine piglets were born during the last reporting period; four of the nine piglets were used for new pig projects in other hamlets.

7. Air Observation

The 11th Marines Air Observation section flew 112 missions for a total of 154.8 hours. The unit was supported by aircraft from VMO-2 and MAG-16, based at Marble Mountain Air Facility.

The unit also had light observation helicopters attached from the 11th Infantry Brigade, 198th Light Infantry Brigade and 196th Light Infantry Brigade, Americal Division, USA.

The unit encountered two ground fire incidents with three aircraft hit. The aircraft were Army aircraft. While in the process of lifting on an early morning VR of the Rocket Belt, the 11th Marines helopad came under a rocket attack, resulting in 2 KIA (1 pilot and one crewchief), 1 WIA (A.O.), 2 planes hit (1 destroyed and the other damaged). The third aircraft was hit while in flight over a hot zone.

8. Northern Sector Defense Command

Northern Sector Defense Command is a rear area defense organization commanded by the Commanding Officer, 11th Marines. During the month of November, Condition 4 was set 6 times, Condition 3M was set 13 times and Condition 3 was set 11 times.

There were 105 day time recons and 63 day time combat patrols. There were 44 night time recons, 183 night time combat patrols and 93 night ambushes. The total patrols for the month was 508.

(4) Highlights of Missions Fired and Summary of Artillery Support

- (a) On 11 November 1968, Battery "A", 1st Battalion, 13th Marines fired on 3 enemy moving away from a village; 1 enemy KIA was credited to the artillery for these fires.
- (b) The majority of the fires during this operation consisted of preparation, counter mortar, and unobserved fires directed against known and suspect enemy locations.
- (c) The selective positioning of firing elements of 1st Battalion, 13th Marines proved invaluable during the conduct of the operation. Mortar Battery (-) occupied a position within a fire base in the vicinity of 3d Battalion, 26th Marines CP, and this position provided a significant degree of flexibility in available fire support. Two howitzers of Battery "A" were displaced to the Hill 190 complex in order to extend fire deeper into enemy territory and to decrease the response time necessary to react to the fluid tactical situation.
- (d) Battery "M", 4th Battalion, 11th Marines reinforced the fires of 1st Battalion, 13th Marines during the operation and provided the longer range and more destructive fires that were required.
