NARRATIVE SUMMARY

The month of March found Headquarters, "E" and "W" Batteries continuing to provide the 5th Marines with direct artillery support from positions at Baldy Combat Base while "D", "F", and "K" Batteries continued preparations for embarkation at Camp Faulkner. On 2 March, "W" Battery (-), 1st Battalion, was helolifted from Hill 381 in the Que Son Mountains to Baldy Combat Base to occupy "E" Battery's position on 3 March. At 0800 3 March, the remaining 2nd Battalion, 11th Marine units commenced standdown and moved by road march to Camp Faulkner. Operational control of "C", "CX", "W"(-) and "WY" Batteries, 1st Battalion, 11th Marines was returned to ist Battalion, 11th Marines at 0800 3 March. "B", "F", and "K" Batteries departed RVN for CONUS by ship on 3 March. Headquarters, "E" and "W" Batteries continued preparations for embarkation from 3 March through 19 March at Camp Faulkner, moved to Deep Water Staging Facility on 19 March and were embarked and sailed for CONUS on the evening of 21 March.

b. INTELLIGENCE

On 3 March 1971 the S-2 stood down with the remaining portion of 2nd Battalion, 11th Marines. OP Freedom Bird was secured on the same day and the Battalion packed up and headed for Camp Faulkner. Enemy activity had increased somewhat with several rocket attacks on Da Nang Air Base and terrorist incidents in acattered locations.

C. TRAINING

2nd Battalion, 11th Marines conducted no training during the month of March. All personnel were utilized full-time in preparations necessary for embarkation and redeployment to CONUS.







Logistics: During this reporting period, three (3) Batteries of the Battalion, Fox, Delta and Kilo departed from RVN enroute to Conus by ship on 3 March. On 3 March the remaining three (3) Batteries, Head-quarters, Echo and Whiskey departed Combat Base Baldy and moved by Convoy to Camp Faulkner to commence stand-down. Whiskey Battery 1st Battalion occupied Echo Battery position at Combat Base Baldy during the withdrawal. Upon relocation of the three (3) Batteries at Camp Faulkner work begun immediately to agriculturally clean and prepare vehicles and equipment for movement to Conus. Efforts are also underway to upgrade 1st & 2nd Echelon maintenace of equipment. Some equipment has been LTI and Code H, and various other peices of equipment has been redistributed within RVN and Units of 3rd Marine Division.

Communications: During this reporting period the following communications equipment was redistributed as follows: Four (4) PP-2953, eight (8) BC-5, five (5) RL-31E, one (1) TS-183, thirty three (33) RC-292, One (1) TV-7PU, thirty four (34) AN/PRC 25, six (6) AN/GRC 125, eleven (11) RL-159 eleven (11) DRS, fifty six (56) TA-312, eleven (11) AN/PRC 77, and three (3) TA-125 all above items were distributed to units in RVN.

The following items were distributed as MCMOA equipment: Sixty one (61) TA-312, thirteen (13) TA-1, two (2) AN/PRC 41, eight (8) AN/PRC-47, seventeen (17) CE-11, thirteen (13) AN/GRA-6, twenty three (23) AN.PRC-25, twenty two (22) AN/PRC-77,. The following items were Code H: two (2) MRC 110, radio jeep, five (5) TA-312, and one (1) AN/GRA-6. The remaining equipment was cleaned and prepared for embark.

Motor Transport: During this reporting period this unit redistributed motor transport equipment through the redistribution program in RVN and through MOMOA. The following equipment was invoiced to ARVN units in RVN: Two (2) M105 cargo trailers and five (5) M151 trucks utility. Following items of equipment was invoiced to MOMOA: Ten (10), M151A1 trucks. This unit turned into salvage the following items of obsolete equipment: Eleven (11) M105 cargo trailers and fourteen (14) M101 cargo trailers. The following equipment was Code H: twenty seven (27) M416B1 cargo trailers, ten (10) M151A1 truck utility, seven (7) M37B1 personel carrier five (5) M149 water trailer, two (2) MRC-110 Radio jeep and three (3) JOM-1 high pressure cleaning unit. The remaining motor transport equipment has been tagged by PMU. All first and second echelon maintenance has been done. At this report vehicles are staged and awaiting embarkation.

Engineer: During this period the remaining Eimco tractors have been agriculturally cleaned for embark to Conus. Of the Two (2) 100 K.W. Generators this unit held at Combat Base Baldy, one (1) was turned in and one (1) was invoiced over to 1st Battalion, 5th Marines who remained at Baldy.

Ordnance: All the battalion ordance has been cleaned, inspected and boxed for return to Conus. The six (6) 105mm Howitzer belonging to Echo Battery have been invoiced to ARVN. Of the four (4) 155mm Howitzer, two (2) were invoiced to 1st Battalion 11th Marines and two (2) were invoiced to FLC.
