The month of June was characterized by several training events of special note. On 1 June, LtCol G. E. Shelley, III, S-2, 11th Marines and Lt J. C. Guymon, Assistant S-2, 11th Marines, visited LZ BALDY to present a special class to the battalion on enemy rockets currently in use against installations of the 1st Mar Div. In order to maintain operational capabilities the class was presented twice, once in the morning and once in the afternoon. A large percentage of Headquarters Battery, Battery H, and Mortar Battery were able to attend by sending fifty percent of available personnel to each session.

Following close on the heels of the rocket class, HM1 Kania of the 1st Mar Div Preventive Medicine Unit visited LZ BALDY for a day on 3 June and gave presentations to Headquarters Battery, Battery H, and Mortar Battery on drug abuse. Through an all out effort by supervisory personnel, maximum attendance was achieved commensurate with operational requirements. These classes were particularly well presented and seemed to be well received by all personnel attending.

The third major training event of the month was a presentation by Major Alec Lee, S-3, 1st Bn, 7th Mar on sensors. Due to the classification of the material presented the class was attended by the officers and SNCO's of the battalion. The presentation included the history of the Marine Corps' development and use of sensors of all types in Viet Nam as well as the characteristics of equipment currently in use. The material presented enhanced the understanding and abilities of battalion personnel to utilize sensors in local defense as well as improve firing effectiveness when providing artillery fire on sensor acquired targets.

These efforts at mass instruction of a large percentage of the battalion at once proved fairly successful but pointed up the need for detailed planning and maximum use of ingenuity due to the lack of training facilities. The outdoor stage and movie screen completed in May as a recreational facility proved a boon to the training program when the rocket and drug abuse classes were held there. Provided with the AN/PIQ-5 public address system by the battalion communications section and the chairs from the enlisted men's club and with the training aids brought along by the instructors, the outdoor stage was a very acceptable outdoor classroom. The one disadvantage was a lack of shade, which can be rectified by use of a tent fly or GP tent with the sides rolled up.

Double duty also became the order of the day as the Officer/SNCO Club became a classroom for the sensor class given to officers and SNCO's. With the tables pushed aside, chairs arranged in rows, and a portable easel to support a flip chart, the class was presented in a fairly professional setting. Equipping the clubs with air conditioning and more chairs

of the self-stacking type would greatly enhance their secondary use as classroom facilities.

Officers, SNCO's, and NCO's became the guests of 7th Marines on 16, 17, and 18 June for their presentations on Decision Making. These classes too, having been presented in the officer's, SNCO's, and enlisted men's mess, are an example of dual utilization of physical facilities. A good representation of the battalion was present for this series of leadership lectures that proved to be most informative and stimulating.

After two months without holding an indoctrination course for new arrivals to Viet Nam, the battalion at last accumulated enough new personnel to schedule the course for the period 25 through 29 June. The classes were initiated in the Officer/SNCO Club with a welcome and course introduction by the battalion commander. After these preliminary remarks, the students were relocated to the battalion classroom to continue with the remainder of the syllabus. The range facilities of the 7th Marines were scheduled for Saturday 27 June for the familiarization firing of weapons. The final two days of the course were held in the battery positions of the units to which the personnel were assigned.

Operations in the 7th Marines AO were relatively active for infantry units but produced very few lucrative artillery targets during the entire month of June. On 8 June the enemy got his licks in once again by an attack on LZ ROSS at 0140 in which approximately 30 gas and HE 82mm mortar shells impacted inside the wire. Damage was relatively minor. One Sea Hut was destroyed and Cpl Joe F. Hendrix 2545967/0811, Btry I, received a minor shrapnel wound in the right arm pit. This attack was followed by the firing of a volley of rockets at 0614. Two of the six rockets fired landed outside the wire at ROSS, the remaining four impacted near Queson District headquarters, causing no damage or casualties. Crater analysis indicated that this attack was launched from an azimuth of 5150. Counter-rocket fire was delivered by Btry I within three minutes of impacting rounds.

A big payoff in enemy KIA's occurred in June as a result of missions fired for PF units in the Americal Division AO in the area southeast of LZ BALDY. A mission was fired by Btry H for Stars Tango D-46 in the early morning hours of 9 June which later yielded 22 KIA as a result of a sweep of the area by the PF's after daylight. Again on 18 June the PF's found and reported 15 enemy KIA's resulting from a mission fired by Btry H.

7th Marines launched a search and destroy operation on 13 June in hopes of locating the T 89th Sapper Battalion that decimated THAN MY on 11 June. To support this operation in its early stages in the Spider Lake area and the western end of Pagoda Valley, two platoons of Mortar Battery were emplaced on Hill 196 at 0900 on 13 June. Enemy contact was very light throughout the operation indicating that the T 89th had once

again managed to melt into the population. The operation terminated on 15 June and the two platoons of Mortar Battery returned to their positions on LZ BALDY at 0930 on 15 June. Mortar Battery further demonstrated its flexibility and mobility on 17 June by contributing one platoon to a provisional battery under the control of 1/11. These tubes returned to the battalion at LZ BALDY on 22 June at 1400.

More practice in heliborne artillery deployment was obtained by Battery G and Battery H on 24 June when the two batteries swapped positions between FSB RYDER and LZ BALDY. These batteries have become very proficient in this type of move as was demonstrated by the smoothness and efficiency with which it was accomplished.

An action that started in the evening of 26 June and continued throughout the night resulted in the first critical WIA in the battalion this month. Elements of 1/7 were operating Northwest of BALDY during the night of 26-27 June when they were taken under ground attack by a Sapper unit of unknown size. During a vicious grenade attack, the FO team radio operator, Cpl E. H. Salas, was wounded in the face, neck and lower extremities by fragments from a Chicom grenade. He was quickly medevaced to 1st Medical Battalion where his condition is listed as serious.

To assist in preventing the enemy from disrupting the Provincial elections held on 28 June, the S-2, Lt S. L. Matthews developed a Pre-emptive Fire Plan to interdict the enemy's routes of infiltration into the populated areas from the Que Son Mountains. In addition, OP Freedom Bird was manned throughout election day and night to assist in detecting enemy units intent upon attacking polling places. Whether the Pre-emptive fires were successful cannot be completely confirmed, but significantly, no enemy initiated incidents marred the elections.

The last days of the month proved to be some of the worst for the battalion as far as casualties were concerned. As his company was setting into its night defensive position on 29 June, Lt L. W. Standring, the FO for L/3/7, and his radio operator, Cpl E. L. Byrd were wounded by fragments from an enemy booby trap. Lt Standring was emergency-medevaced in serious condition while Cpl Byrd was routinely medevaced in fair condition.

With the CMHI scheduled for 18 and 19 June, this month was a month of intense preparatory activities and inspections. A battalion commander's motor transport inspection was scheduled on 6 June and executed by the battalion staff. The battalion commander personally conducted a motor-transport inspection on 13 June. During the period, battalion staff personnel also conducted preliminary inspections in supply and ordnance. By the time the CMHI team arrived on 18 June, the battalion was fairly well prepared for the inspection and generally was found satisfactory with discrepancies. Ordnance and engineer require additional work and will be re-inspected in mid July.

Calibration of all artillery pieces in the battalion was finally accomplished in June using a U. S. Army team at LZ BALDY and the calibration team from Headquarters Battery, 11th Marines at LZ ROSS and FSB RYDER. These results will allow redistribution of pieces within the battalion, which is planned for sometime in July.

June seemed to be traveling time for senior commanders in the 1st Mar Div TAOR. The month started off with a visit by MajGen C. F. Widdecke, the Commanding General, to Fire Support Base RYDER and Btry G on 2 June. The CG was back again on the 17th. This time, Gen Widdecke visited the IOD sites at FSB RYDER and Hill 425. The very next day, BrigGen Simmons came for his first look at the Battalion. Recently arrived in country to assume duties as the Assistant Division Commander, General Simmons was briefed at BALDY by LtCol Dickey, the Battalion Commander. Following the briefing, the Commanding Officer escorted the ADC on a tour of the Battalion's positions. In addition to BALDY, the ADC also toured LZ ROSS and the IOD site at Hill 425. MajGen Widdecke continued to show his interest in the Battalion and made a third visit to FSB RYDER on 24 June.

Due to an excessive number of dogs in and around the LZ BALDY complex, a "dog-catcher" program was initiated during June. All pets and stray dogs were rounded up, inoculated and tagged. A continuing effort in this area is expected to reduce the health hazard that these animals would otherwise present.

Under the watchful eye of Headquarters Battery Cysgt, SSgt R. A. Spencer, the Battalion's sector of LZ BALDY's perimeter is being rebuilt. New security bunkers equipped with drain pipes are being built to replace the bunkers presently in use. Due to a high water table, the old bunkers were rendered nearly untenable during periods of heavy rain. The new bunkers with their drain pipes, will allow the security personnel to stand their watches in a little more comfort and protection.

Lt S. L. Matthews, the Battalion S-2, was presented the Vietnamese Cross of Gallantry with Silver Star by the Battalion Commander, LtCol Dickey, on 21 June. Lt Matthews was cited for his actions as the Marine Artillery Liaison Officer to the 1st ARVN Armored Brigade during Operation DOUNG SON 3-70 from 5 Feb 1970 to 2 Mar 1970.

Lt D. G. Hovanisian was presented the Purple Heart Medal by the Battalion Commander on 23 June. Lt Hovanisian suffered fragmentation wounds on 5 June 1970 as a Forward Observer with the 1st Bn, 51st ARVN Regt.

b. Intelligence. The month of June was characterized by an apparent period of transition in the enemy's strategy. The month began with mortar and rocket attacks on LZ ROSS, FSB RYDER, and QUE SON DISTRICT HEADQUARTERS on the 8th and 10th. Both the coordinated mortar/rocket attack on ROSS on the 8th and the multi-target attacks on the 10th are variations on the tactic of standoff indirect fire attack, one of the most popular of the enemy's tactics.

On the 11th a well executed and well coordinated attack was made against the village of THANH MY (South end of BA REN Bridge). An indirect fire attack of more than 200 rounds of 82mm HE and WP landed in the village area, closely followed by an extensive sapper attack. During this time the PF and CUPP units in the area were pinned down and unable to protect the civilians, thus resulting in almost complete freedom of movement for the sappers. This attack was similar to but more successful than other attacks made against THANH DI H, QUE SON, and HOC BAI in the last two months.

On the 26th, B/1/7 was subjected to close range attacks using a

machine gun from a range of 5 meters on an ambush patrol and Chicom thrown from just outside the CP perimeter, resulting in 4 USMC KIA and 16 WIA. This type of attack, engaging a rifle company in the field at close range, has been rare in the past. The enemy has usually chosen not to engage Marine units unless forced to. Indications are that the attack was made by a sapper team, estimated between 5-30 men.

The above mentioned incidents and the frequency, composition, and targets of enemy activity during the month of June suggest the following conclusions:

(1) The THANH MY attack was made by a large, well trained unit, the T 89th Sapper Bn. The success of the attack, coupled with the fact that the enemy saw fit to commit an entire battalion to it indicate that the tactic will be used again. The tactic's advantages are capacity for large shock on the populace and minimum risk for the attackers. The disadvantage is the possibility of the tactic's backfiring if the populace refuse to be cowed by the threat of annihilation. This could result in the VC losing the tolerance and favor of the people. Unfortunately, there are many important but lightly defended villages in the TACR, any one of which is a relatively easy target for a mobile, well trained attack force.

(2) There have been numerous agent, interrogation, and counterintelligence reports during the middle of the month placing large numbers of enemy in the areas to the Southwest of LZ's BALDY and ROSS. Although some of the reports seem to be duplicatory, there does seem to be a number of units targeted toward the disruption of the pacification effort, specifically the attack of CUPP and PF units along the roads. This coupled with the attack on B/1/7 indicates a general trend on the enemy's part to reorganize his units into smaller and more mobile forces designed specifically for the disruption role. The success of such a unit's foray against B/1/7 suggest a significant threat to the smaller units.

Enemy activity in the near future will probably continue at a steady rate, rather than be subject to rise and falls according to the amount of lunar illumination and high threat periods. There are indications that the enemy intends to put steady pressure on the pacification effort using the terrorism and small unit attacks mentioned above. District guerrillas will continue to be central to the effort by employing booby traps and making attacks by fire on units in the field. Finally, indirect fire attacks will continue to be used primarily against the popular targets of ROSS, DUE SON and the small compounds in the TACR.

c. Organization and Operations. Firing batteries of the battalion continued to occupy positions at LZ BALDY, LZ ROSS, and FSB HYDER throughout the month of June. Battery K/4/11 and the 1st and 3rd Platoons of the 1st 8" Howitzer Battery (-) continued in their mission of reinforcing 3/11. Battery K/4/11 and the 3rd Platoon, 1st 8" Howitzer Battery are presently located at LZ ROSS while the 1st Platoon, 1st 8" Howitzer Battery is at LZ

BALDY. One 24 June Battery G and Battery H exchanged positions with Battery G returning to LZ BALDY and Battery H moving to FSB RYDER. The battalion FDC retains tactical and technical fire direction of the 105 battery on LZ BALDY, centralized tactical and decentralized technical fire direction of Mortar Battery. The 105 batteries at LZ ROSS and FSB RYDER are decentralized tactically and technically.

d. Training. A total of 82 hours of general military subjects training was conducted during the month of June. In addition, 70 hours of technical MOS training were held. Artillery gunnery and safety procedures were constantly being emphasized throughout all technical MOS and OJT training. An indoctrination training program was held in June for new replacements; indoctrination training at the battery level was carried out. The assignment of personnel from all batteries to the Land Mine Warfare School conducted by 1st Engineer Battalion produced a number of trained personnel.

e. Logistics, Equipment and Supply. During the month of June, 1,815,391 pounds of ammunition and supplies were airlifted to LZ ROSS and FSB RYDER. The central water system has been plagued with a number of problems. One is the lack of the number of pumps to handle the task efficiently, and the other is the lack of water fed into the man-made wells by natural veins. The central electrical system remains a boost to the security and living conditions. The beautification program is enjoying warranted success. In all, the commandment is one to be proud of.

f. Civil Action/Civil Affairs. This battalion has not been assigned a CAAOR, but conducts MEDCAP visits in MOC BAI (BT144458) and PHU HIEP (BT147457) villages as coordinated by the 7th Marines.

g. Psychs. Negative report.

h. Combined Action Company Program. Not applicable.

i. Medical. The Battalion Aid Station treated 157 outpatients. 9 MEDCAP visits were made during the month of June in MOC BAI and PHU HIEP villages, treating 360 Vietnamese patients, and 12 Vietnamese workers were treated at BAS. A total of 142 immunization shots were administered, 28 physicals given, 30 laboratory tests completed and 461 prescriptions filled.
