Summary

1. Significant Journal Entries

082000HApr66 3rd 155 Gun Battery chopped OPCON from 4th Battalion(-) 11th Marines(-) to 11th Marines(-). 4th Battalion(-), 11th Marines(-) retained OPCON of one platoon from 3rd 8" Howitzer Battery.

090700HApr66 Battery "M" deployed to Quang Ngai to support future operations. Battery "M" took four 155mm Howitzer Towed. They received two 155mm Howitzers, Towed, on loan from Danang. Battery "K" provided one officer and four gun sections to man four 155mm Howitzers,(SP), M109 in Battery "M"'s previous position.

111215HApr66 Deployed two Forward Observer teams, each consisting of one officer and one enlisted man from Headquarters Battery, to participate in Operation Nevada.

151800HApr66 Received OPCON of "C" Platoon, 3rd 8" Howitzer Battery.

171200HApr66 Battery "K" relieved Battery "M" in position at Quang Ngai. Battery "M" returned to original position.

171700HApr66 Sent one officer, four enlisted FDC personnel, and one security squad from Headquarters Battery, and two gun sections and four FDC personnel from Battery "M" to Battery "K"'s position to man four 155mm Howitzers(SP), M109.

202215HApr66 Deployed one Forward Observer team, consisting of one officer and one enlisted man from Headquarters Battery, to participate in Operation Hot Springs. Augmented Battery "K" in Quang Ngai position by sending two gun sections from Battery "M".

211800HApr66 Deployed one Forward Observer Team consisting of one Staff NCO and one enlisted man from Headquarters Battery to participate in Operation Hot Springs.

251000HApr66 Deployed one Forward Observer Team consisting of one Staff NCO and one enlisted man from Headquarters Battery to participate in Operation Wyoming.

251600HApr66 Battery "M" provided one officer, four FDC personnel, and two gun sections to man weapons in Battery "K"'s position while Battery "K" participated in Operation Wyoming. Headquarters Battery provided one squad for security of Battery "K"'s position.

2. Operations Summary

a. During the period of 29 March 1966 through 30 April 1966, the battalion supported operations of the 1st Marine Division. Specific operations were supported by units and personnel of this battalion as indicated in the Significant Journal Entries.

b. The battalion has exercised tactical fire direction of all units under its operational control, and technical fire direction of Battery "M", and "C" Platoon, 3rd 8" Howitzer Battery. When Battery "M" deployed to Quang Ngai, the battalion relinquished tactical and technical fire direction.

c. From 9 April 1966 to 22 April 1966 a battery of 155mm Howitzers, Towed, was manned by personnel of this battalion at Quang Ngai. This provisional battery supported Operation Nevada and Operation Hot Springs.

d. During the period from 29 March 1966 through 30 April 1966, the battalion fired 282 missions as follows:

Subj: Addition to Amplifying report on incident at 4th Battalion,
11th Marines at 0130 on 11 September 1966.

1. On 17 October 1966, the Battalion Commander was informed by Dai Uy GIAI, District Chief, Ly Tin District, that ARVN intelligence sources have disclosed an increase in the number of Viet Cong killed in action by this Battalion during the attack of 11 September 1966. Vietnamese sources have stated that four dead VC were observed being carried on bamboo poles during the VC withdrawal. This brings the revised VC Casualty count to 5 VC KIA (confirmed) and 8 VC WIA (probable).
