PART II
NARRATIVE SUMMARY

During the period 1-31 May, the battalion continued to support operations of the 1st Marine Division (Rein) in the Danang TAOR. Battery "L" displaced from Chu Lai to Danang by sea transport arriving on 1 June. The battalion and its batteries have the following missions:

4th Battalion	G/S 1st Marine Division (Rein)
Battery "K"	Modified mission G/S, Rein, 3d Bn, 11th Marines
Battery "L"	Modified mission G/S, Rein, 1st Bn, 11th Marines
Battery "M"	Modified mission G/S, Rein, 3d Bn, 11th Marines

The battalion furnished personnel to man 11th Marines observation post "FALCON" (AT93247805) used as counter mortar/counter rocket observation post. The battalion provided artillery support from primary positions for Operations conducted within and adjacent to the TAOR. Two FO teams were provided to support ARVN forces in conjunction with Operation UNION. One forward observer accompanied a 1st Reconnaissance Battalion insert (Dateline) from 20-25 May in support of the Reconnaissance effort. Battery "K" reverted OPCON this Headquarters from 3/11 on 1 May 1967. During the month the battalion fired 1,562 missions, with a total of 10,502 rounds.

2. Intelligence. (See Appendix 2)

a. Daily perimeter patrols and scheduled listening posts were conducted throughout the month.

b. A Vietnamese village chief reported the location of three mines to the Commanding Officer of Battery "K" on the main road adjacent to the position area.

3. Training.

a. Normal training during the period was limited because of the required improvement of newly occupied positions.

b. Preliminary instruction was presented to selected battalion personnel on the M-16 rifle by the FMFPAC contact instruction team on 12 May 1967.

c. A training inspection was conducted by the FMFPAC Inspection Team on 29 May 1967.

4. Logistics, Equipment and Supply. (See Appendix 4)

a. Approximately 69% of the total requisitions submitted since arrival in Vietnam have been filled.

b. The current deadline status of motor transport equipment is 33%. Eleven are deadlined for 2d echelon only awaiting parts; twenty-two are deadlined for a combination of 2d and 3d echelon work.

5. Civic Action/Civil Affairs.

a. Due to the displacement of the Battalion from Chu Lai to the Danang TAOR the Battalion S-5's functions during the period 1-31 May consisted of a liaison visit to the 1st Marine Division G-5 to obtain information in regards to our new Civic Action area of responsibility.

b. The Battalion was assigned the village of Hoa Loc and the specific hamlets of Dai La, Phu Ha, Xuan Loc and Phu Thung Xa.

c. One liaison visit was also made with the Commanding Officer of the 2d Battalion, 7th Marines for the purpose of coordination of effort in respect to Civic Action.
