NARRATIVE SUMMARY

During the period 1-30 June, the battalion continued to support operations of the 1st Marine Division (Rein) in the Danang TAOR. Battery "M" displaced two guns to Battery "K" position 130930 June arriving in Battery "K" position at 131042 June. Battery "M" displaced two guns to Battery "L" position at 160657 June arrived Battery "L" position at 161645 June. Battery "M" guns returned to Battery "M" position from Battery "K" position on 171420 June arrived at Battery "M" position at 171622 June.

Headquarters Battery supported Battery "K" with FDC personnel during period that Battery "M" guns were in Battery "K" position. The battalion provided artillery support from primary positions conducted within the TAOR. The battalion is maintaining the 11th Marines Observation Post "FALCON" (AT93247805) which is used as a counter mortar/rocket observation post. The battalion provided artillery support from primary positions for Operations conducted within the TAOR. One FO team of personnel from Battery "M" was attached to the 21st ARVN Ranger Bn and 6th ARVN Ranger Regt (-) for Operation CALHOUN, a combined Marine and ARVN Operation on 250600H June. One FO team from Headquarters Battery was attached to the 39 Ranger Bn for Operation CALHOUN on 250600H. Both teams returned from the operation on 291600H June. Battery "K" fired two missions in support of 3/11, Operation ARIZONA. Battery "L" provided artillery support from primary position to the elements of 1st Marines. During the month the battalion fired 1257 missions, expending a total of 11, 315 rounds.

2. Intelligence. (See Appendix 2)

- a. Daily perimeter patrols were conducted throughout the month.
- b. On 140930H Vietnamese children turned over 2 81mm Mortar rounds over to occupants of HQ/4/11 vehicle. A reward was refused.
- c. On 171120H Vietnamese children turned over 1 dud 105mm round to the Executive Officer of 4/11.
- d. 11th Marines Regiment informed 4/11 of possible attack on Battery "M" on or about 27 June, possibly 4 July. Information in 11th Marines Regiment Intsums #173-67 and #175-67. The Battery was informed and appropriate measures taken.

3. Training

a. Normal training and certain technical training has been conducted in the battalion with the goal of increasing firing efficiency.

b. Officer and Staff training was conducted on the M16 rifle on 23 and 24 June. Class room instruction from 0830 to 1130 and firing of the weapon with emphasis on clearing stoppages was conducted from 1300 to 1530 on each day.

c. General Military Subjects test have been administered at the battery level for evaluation of training program.

4. Logistics, Equipment and Supply. (See Appendix 4)

a. Approximately 71% of the total of 30156 items requisitions have been filled since arrival in Vietnam.

b. The current deadline status of motor transport equipment is 19.6%. Nine are deadlined for 2nd echelon only awaiting repair parts; ten are deadlined for 3rd echelon work.

5. Civic Action/Civil Affairs.

a. The Battalion Civic Action area of Responsibility is the village of Hoa Loc consisting of the Seven Hamlets of Dai La, Xuan Loc, Phu Thuong, Thon Phu Ha, Loc Hoa, Khe Lam and Phu Thuong Phi.

b. Med Caps were initiated and are now conducted three times per week in the village. The initial attendance has been relatively small but it is felt this will increase as it becomes more widely known. That small Med Caps are being held on a scheduled basis.

c. The building of the market place was voted down by the villages and a Maternity Hospital will be built in its place. The planned completion of the Hospital is 15 September 1967. The village has one mid wife at this time and it is contemplated that a vigorous training program will commence in order to provide for a minimum of two more.

- 072330H K/4/11 motor pool outpost reported noises near wire S.W. slope Hill 65 (AT579579).
- 100240H Headquarters Battalion, 1st FSR reports that approximately 6 VC attacked 2 Vietnamese guard shacks in the village of Nam-O (AT934831) attack took place just north of Battery "M".
- 140935H Headquarters, 4/11 vehicle was proceeding down road, noticed 2 children. Children gave 82mm mortar round to occupants of 4/11 vehicle. Children then ran into rice paddy and returned with second 82mm round (AT942657). Children refused offer of reward and ran off. Ammo turned over to I/3/1 which was located in vicinity. Incident took place on road to Battery "K".
- 171120H 4/11 Executive Officer noticed children by side of road trying to flag down a passing vehicle.
