NARRATIVE SUMMARY

During the period 1-31 January, the Battalion continued to support operations of the 1st Marine Division (Rein), in the Danang TAOR.

The 2nd Provisional 155 Howitzer Battery (Towed) came under administrative control of the Battalion at 1200H on 9 January 1968. The battery remains under the operational control of Americal Division and continues to occupy its position on Hill 63.

On 13 January, Battery "L" chopped OPCON/ADCON to 1st Field Artillery Group. Also on 13 January 1968, 4th Battalion, 11th Marines assumed responsibility for coordination and control of the 6 observation posts having observation in the southern portion of the Danang "rocket belt." On this same day the Battalion began providing personnel and equipment to man OP Tiger at grid AT 98967083.

The Battalion command post was again displaced from its temporary cantonment at AT 989713 to permanent cantonment at AT 988718. The move began on 28 January and was completed on 29 January at 1800. (Reference: CG, 1st MarDiv msg 281503Z Jan 68). This completed the battalions participation in Operation CHECKERS. During the month, 3,831 missions were fired and a total of 12,053 rounds expended.

2. Intelligence

a. Daily perimeter patrols and nightly ambushes/listening posts were conducted throughout the month.

b. The battalion assumed control of observation in the southern portion of the Danang rocket belt. The observations of six flash observation posts are recorded and target locations determined by graphical intersection. The nature of the sightings and the locations obtained are passed on to the Regimental FDC for evaluation and, in the case of a hostile weapons location, a decision to attack the target by fire.

c. During the month of January there has been a marked increase in guerrilla activity in the Southern Danang TAC.

3. Training

a. Normal training and certain technical training has been conducted in the Battalion with the goal of increasing firing efficiency.

b. Added emphasis has been placed on weapon safety procedures and upon defense against chemical attack.

4. Logistics, Equipment, and Supply

a. Approximately 91% of 19,366 requisitions have been filled since arrival in Vietnam. 17,531 requisitions are completed.

b. The current deadline status of motor transport equipment is 13%. There are two vehicles down for 2d echelon maintenance and seven vehicles down for 3d echelon maintenance.

5. Civic Action/Civil Affairs

a. The Battalion increased its activity in the hamlet of Phu Hoa. A program for the conduct of MEDCAP's was established. Plans were also made for starting construction projects which include a maternity clinic and improvements to the school building and grounds.

a. Battery "K" at grid AT 879579 ^{REPORTS} received 6 mortar rounds, all in I 3/11 position. Bridge and unit in area came under moderate to heavy small arms and mortar fire. 100% alert was initiated. "K" fired on several counter mortar targets reported by 3/7. Illumination of the area showed negative results. DSC

b. At 070330H 1/5 C.P. began taking incoming mortar fire. Battery "L" position received approximately 7 recoilless rifle rounds and small arms fire. At 0500 1/5 again received incoming mortar fire. No damage to any vehicle or any weapons. Battery "L" at grid ZC 078986 fired 1 round illumination and 7 HE direct fire. Battery "L" destroyed enemy recoilless rifle site. Returned small arms fire from 0330 to 0530.

c. Battery "L-X" at grid AT 833990 received approximately 15 Anti-Tank rockets (B-40) from the west. Battery "L-X" shot .50cal at flashes. Howitzers number 308438 and 313562 received direct hits.

d. At 071030 Battery "L" received 10 incoming mortar rounds of unknown caliber.

e. At 072215H Battery "M" at grid AT 919802 received approximately 24 rockets within their C.P. and small arms fire from approximately 6 locations. 2 persons were sighted 75 meters from the wire. At 0140 Mike 6 reported that the rockets were 122mm. Battery "M" fired counter rocket targets, expending approximately 260 rounds HE, 100 rounds .50caliber and 70 rounds M-16.

f. At 101915H Battery "L-X" at grid AT 833998 received incoming rockets from the high ground to the west. While was the same position rockets were fired from the last time. One living bunker received a direct hit, but is still up. Direct fire and small arms fire was returned. One secondary explosion was seen and incoming fire ceased.

g. At 102245H Battery "L" at grid ZC 078986 received 4 incoming mortar rounds and small arms fire. Battery "L" fired self-illumination and returned small arms fire. D/2/11 fired counter mortar fire. 1/5 fired 106 recoilless rifle.

h. At 112215H Battery "L" at grid ZC 078986 received 3 incoming mortar rounds. Negative casualties and damage. Counter mortar plan fired by D/2/11 and 1/5.

i. At 120705H Battery "L" at grid ZC 078986 received approximately 50 incoming mortar rounds. Negative damage. 3 USMC KIA occurred at 1/5's messhall when round exploded on mess hall table. KIA's received shrapnel wounds in upper torso.

j. At 121655H Battery "L" at grid ZC 078986 received approximately 6 rounds of incoming mortars. Negative damage or casualties. Rounds landed in defensive wire of Battery "L". D/2/11 and 1/5 fired counter mortar plan.

k. At 300145H Battery "M" at grid AT 919802 received 15 122mm rocket rounds. 1 M107 and 1 M-37 damaged.

l. At 300145H Comm Support Company, 7th Comm Bn, reported receiving incoming small arms fire and satchel charges at grid AT 989713.

m. At 300500H Battery "K" at grid AT 879579 received 6-7 mortar rounds at base of hill on west side of hill below post #5. Sounded 100% alert. Could not tell from which direction the rounds were coming.

n. At 310345H Battery "K" at grid AT 879579 received 15 82mm mortar rounds on the west side of hill by post #5. 100% alert sounded. Battery "K" fired counter mortar plan plus missions received from 3/7 FSCC. At 0530 Battery "K" received 1 additional mortar round.
