2. Sequential Listing of Significant Eventsa. Personnel

(1) Joined 12 USMC Officers, 123 enlisted and 1 USN Officer. 9 USMC Officers, 116 USMC enlisted, 4 USN Officers and 5 USN enlisted rotated to CONUS. (2) Shortages

(a) There is a critical shortage of personnel in MOS 0239. Within the regiment at present there are 3 of 5 authorized by the T/O, by

April there will be 2 of 5 (40%).

(b) Officer attrition will also cause a serious personnel shortage. If replacements are not forthcoming in proportion to losses by the end of June, company grade officer strength will be 82 on hand of 186 T/O - for 44% of T/O.

b. Intelligence

(1) The assignment of four Vietnamese interpreters has added to the effectiveness of unit reconnaissance and security patrols.

(2) Indoctrination briefing and lectures for incoming personnel. Special security briefing for personnel returning to CONUS.

(3) Unit training has been on Counter Battery/Counter Mortar crater analysis.

c. Training. During the month of February at the request of the Commanding Officer, 3d Reconnaissance Battalion, an FO school for each platoon of the battalion commenced. Approximately 65% of the battalion received schooling on observed fire procedures during this reporting period.

d. Communications. Nothing of significance occurred during this reporting period.

f. Logistics. During the month of February the following happenings of significance occurred in Headquarters Battery, 12th Marines.

(1) The strongback program is now complete with only about 25% of the total number (39) still requiring doors and steps.

(2) There continued to be a significant decrease in the motor transport deadline rate during the period. As of 25 February the deadline rate was 8%. This is a reduction of 8% as compared with the period ending 28 January.
