b. Intelligence

(1) The assignment of five (5) more interpreters has added to the overall effectiveness of units reconnaissance and security patrols.

(2) There has been a marked increase in small arms harrassing fire in the vicinity of Alpha Battery, 1st Bn, 11th Mar (AT 9279). Echo Battery

2/12 patrol killed one VC tax collector and confiscated the tax stamps and certificates in addition to 1200 piasters. Arty AO reports continue to indicate an increase in VC diggings in the South and Southwest portion of the TAOR and an increase in VC automatic weapons fire directed at reconnaissance aircraft. Aerial photos of all battalion and battery positions were taken and analyzed to increase the effectiveness of defenses. Precision registrations by artillery AO's were conducted for 8" Howitzer and 155mm Gun Batteries.

(3) English language classes are continuing three times a week for two hours each evening in Da Son (AT 9276). English language class held every Saturday morning Da Mon (BF 0671). Bath tub of concrete and stone was constructed with help of villagers in the village of Da Mon. St Patricks Day party given by people of Da Son for Marines.

(4) Twenty-four (24) Hometown News Releases were forwarded to the Division ISO. In addition five (5) feature articles were released to the news media.

(5) Unit intelligence training has been on the correct and timely use of intelligence spot reporting.

c. Training. During the reporting period the regiment trained all members of the Division Scout Sniper School and the entire Force Recon Company in FO procedures. Additionally the Regiment graduated eleven (11) 12th Marine students from the three week FO School conducted by 3/12 at Phu Bai. Twelve (12) students graduated from a Special Weapons course on Okinawa.

d. Communications

(1) During this reporting period continued emphasis was placed on improving and upgrading the overall regimental communication system. Construction of the new regimental communication center bunker and switch-board bunker was completed with full operation commencing on 17 Mar 1966. Completion of sandbag reinforcement is expected to be completed in early April.

(2) Due to the shifting of the 3d Battalion, 12th Marines to Phu Bai and the return of the Headquarters Battery, 4th Battalion, 12th Marines to the Da Nang enclave, a realignment of the covered KW-7 circuit was accomplished between the Da Nang-Phu Bai enclaves.

(3) Staff visits were made to all artillery units in the Da Nang and Phu Bai enclaves. Extensive ground reconnaissance was continued in conjunction with selection of potential wire routes and radio relay sites to support future requirements.


