b. Intelligence

(1) There were 15 VC killed in the vicinity of Battery "A", 1st Bn, 12th Marines (AT 9297) during the 18 April attack on that position. An additional 11 VC were killed (BC) during the exfiltration. Occasional S/A fire is still received in this vicinity. At the same time the attack was made on Battery "A", 30 to 50 rounds of 60mm Mortar hit in or near the perimeter of Battery "K", 4th Bn, 12th Marines. In conjunction with the above, the 12th Marines road between Battery "A" and Battery "K" was mined.

(2) A marked increase in VC activity has occurred in Elephant Valley (AT 8983 to ZC 1984).

(3) Twenty-two incidents of batteries receiving S/A fire were reported during this period.

(4) Unit training has been emphasizing accurate, timely, and complete spot reporting and follow-up reports.

(5) Air Observation: Artillery AO's continued to register batteries, evaluate results of H&I fires, and take aerial photos of all units. Artillery AO's have participated in night mortar suppression flights during critical periods of darkness. The effectiveness of supporting arms for Rough Rider has been increased by new techniques used by the Artillery AO's flying cover for the convoy.

c. Civil Affairs. Sunday afternoon movies are being shown in Da Son (AT 960765). English language classes are continuing in Da Son and in Da Mon (BT 063723). The Commanding Officer presented 25 gifts to the top students of Da Son school. The village elders presented the Commanding Officer with a painting to show their appreciation. A ground-breaking ceremony for a hamlet market was attended by civic action personnel.

d. ISO. Twenty feature articles and 33 Fleet Home Town News Releases were forwarded to Division ISO.

e. Training. During the month of April, at the request of the Commanding Officer, 3d Reconnaissance Battalion, the regiment continued

to conduct FO Schools for small unit leaders. The Regimental S-3 began conducting visits to the batteries and battalions for the purpose of reviewing gunnery procedures. The goal of these visits is improving the regiment's posture on Fire Direction and Fire Planning procedures in order to continue to maintain quick and accurate fire in support of the ground gaining arms.

f. Communications

(1) During this reporting period, continued emphasis was placed on improving and upgrading the regimental communications system.

(a) Four (4) new wire trunk lines were installed over the Hill 327 ridge line complex to improve the headquarters 2/12 - 4/12 wire system.

(b) Combined radio relay teams from the Division Communication Company and this headquarters activated a four channel radio relay circuit from Hq Battery, 4th Bn, 12th Mar (AT 943364) to Battery L, 4th Bn, 12th Mar (AT 988672) on 17 April. The circuit employs AN/MRC-62 equipment on low power with knife-edge refraction from Hill 327. Channel utilization provides for 12th Marines - 2/12 - 4/12 - Battery L fire direction and alternate division routing to the 9th Marines.

(c) A sole user artillery planning channel from 12th Marine FDC (DaNang) to 3/12 FDC (Phu Bai) was activated 20 April, utilizing one channel of the 3d MarDiv - 4th Marines AN/TSC-15 shot.

(2) The covered (KW-7) SSB (AN/MRC-83) command circuit from 12th Marines to 3/12 at Phu Bai continued to provide excellent service during this period. On three occasions this circuit passed traffic to the 4th Marines and Task Force Foxtrot when division circuits experienced outage and/or overload.

(3) On 23 April, the Regimental Communications Platoon assumed responsibility for providing artillery communication support to the Air Base Defense Battalion (currently 3/3).

(4) Personnel and equipment support were provided to 2/12 for operation GEORGIA and to 1st 8" How Btry(SP) for support of deep reconnaissance operations and to 3/12 for operation VIRGINIA.

(5) On 24 April, this headquarters received and placed in service one 60 KW generator for camp power as part of the contonement program. One PU 482/U generator (30KW) was reassigned to 2/12 for their requirements.

(6) Communication support for the civil action platoon at coord (BT 075735) and rear Zone Bravo day/night patrols continued.

(7) A new radio relay/observation post bunker was completed on Hill 244 for future operations when required.

(8) On 30 April, the first increment of 40 AN/PRC-9A radio sets was received and distributed to subordinate units in accordance with FY 65-66 R & E program.

NARRATIVE SUMMARY OF 18 APRIL 1966  
VC ATTACK ON BATTERIES A-1-11 and K-4-12

AT 180145H Kilo Battery (AT922792) started receiving incoming 60mm mortar rounds and small arms fire. Firing lasted until approximately 0500H. About 30-50-mortar rounds were received during this period. Kilo Battery returned fire with small arms and one M-109 in direct fire (3-155mm rounds). The Battery received 5 WIA (slightly wounded).

Commencing the same time (0145H) Alpha North Battery was under heavy attack from an estimated VC company (original estimate was 40-50 VC). The VC commenced a simultaneous attack from the North, East and West. The Northeast corner of the perimeter was penetrated almost immediately and the outpost overrun. The VC entered the wire by cutting and with bangalore torpedoes. All trunk lines were also cut, but radio communications were maintained. An aerial observer was on station and was directed to the position. At 0310H a med evac was requested and by 0320H it was completed. By 0442H all serious wounded (16) were evacuated (one died enroute). The 4 KIA remained in the position and were removed during daylight.

The VC were lightly clad in shorts only and carried fragmentation grenades, satchel charges, 30 caliber rifles, 7.62. assault rifles (AK 47) and Antitank Grenade Launchers (RP6-2). A total of 15 VC were killed (body count) in the position.

During the same period the Main Supply Route running between the two batteries was mined. At 180800H an earth mover detonated a mine on the road coord (AT942778) leading to the artillery positions. One more mine was found in the road at Coord (922792).

Patrols swept the area to the north of these positions during the day of the 18th with negative results.
