NARRATIVE SUMMARY
1 April

The battalion began the month with operational control of Battery F-2/12, Battery A-1/40, and Battery C-1/40. From 0030 to 0440 Battery F-2/12 fired one mission and Battery K-4/12 fired 2 missions of illumination for L-3/3 as they made their way to their defensive positions. From 0710 to 1200 Battery A-1/40 fired 6 missions and Battery F-2/12 fired 10 missions as prep fires and recens by fire in the YD 0966/YD 0865 area in support of L-3/3, 1/4 and 3/4 LNO. From 1300 to 1500 Battery F-2/12 fired 7 missions as prep fires in the YD 1565/ YD 1564 area in support of 3/4 LNO. From 1700 to 1900 Battery A-1/40 fired 3 missions and Battery C-1/40 fired 3 missions as defensive concentrations in support of 3/9 and 3/3. At 1930 Battery A-1/40, Battery F-2/12, and Battery K-4/12 massed fires on a suspected enemy battalion based on an intelligence report from 3rd Mar 24. From 1945 to 2115 Battery C-1/40 fired 7 missions on suspected enemy positions in the XD 9560 area in support of 3/3 LNO. From 2135 to 2215 Battery K-4/12 fired 2 missions on a suspected enemy battalion based on an intelligence report from 3rd Mar 24. The battalion fired 39 unobserved missions in support of 1/4, 3/4, 3/3, and 3/9 throughout the day.

2 April

From 0437 to 0455 Battery A-1/40 fired 2 missions called for by 3rd Mar 24 in support of a med-evac at YD 091515 resulting in good illumination, area well covered. From 0946 to 1010 Battery A-1/40 fired 3 prep fires in the YD 0862 area in support of L-3/3. At 1025 Battery K-4/12 fired on 25 enemy in a tree line in support of recon patrol Para TITLE II resulting in 2 KIA (conf) and 8 KIA (prob). From 2100 to 2100 Battery C-1/40 fired 8 missions on suspected enemy positions in the XD 0658 area in support of M-3/3 and 3/3 LNO. From 2300 to 2345 Battery A-1/40 fired 6 missions and Battery B-1/40 fired 2 missions on suspected enemy mortar positions in support of 3/9 LNO. The battalion lost operational control of Battery F-2/12 and assumed operational control of Battery B-1/40, who laid in Battery F-2/12 position in Cam Lo. The battalion fired 20 observed missions and 175 unobserved mission in support of 3/3 and 3/9 throughout the day.

3 April

From 0017 to 0305 Battery A-1/40, Battery C-1/40, and Battery M-4/12 each fired 1 mission on a known enemy position with bunkers and fighting holes at XD 969598 called for by 3rd Mar 24. From 0723 to 0735 Battery A-1/40 and Battery B-1/40 saturated an area target at YD 104614 again called for by 3rd Mar 24.

From 1100 to 1600 Battery A-1/40 fired 3 missions and Battery B-1/40 fired 2 missions as spotting rounds for recon patrol PAGE TITLE III. From 1600 to 1900 Battery C-1/40 fired 4 missions as spotter rounds and defensive concentrations in support of recon patrol PUNCTUATE II. From 1900 to 2106 Battery C-1/40 fired 8 missions on suspected enemy positions in support of 3/3 LNO. From 2230 to 2240 Battery A-1/40 fired 3 missions on suspected enemy positions in support of 3/9 LNO and 3rd Mar 24. The battalion fired 19 observed and 243 unobserved missions in support of 3/3 and 3/9 throughout the day.

4 April

From 0001 to 0800 Battery C-1/40 fired a continuous mission on enemy movement in support of recon patrol PEERAGE I, expending 74 HE throughout the night. From 0422 to 0555 Battery C-1/40 fired 7 missions on suspected enemy positions in support of 3/3 LNO. From 0600 to 0848 Battery C-1/40 fired 7 missions as prep fires in support of M-3/3. At 0945 Battery C-1/40 began a mission in support of recon patrol PEERAGE I, continuing their support until 1445 resulting in 781 HE expended and 10 KIA (prob). From 1115 to 1600 Battery C-1/40 fired 9 missions as prep fires in support of a patrol from M-3/3. From 1900 to 2015 Battery C-1/40 fired 6 missions on suspected enemy positions called for by the 3/3 LNO. The battalion fired 30 observed missions and 337 unobserved missions throughout the day.

5 April

From 0045 to 0138 Battery B-1/40 fired 5 missions on enemy troop locations based on intelligence report and called for by the 12th Marines. From 0250 to 0323 Battery B-1/40 fired 4 missions on suspected enemy infiltration routes in support of M-3/3. From 0753 to 0820 Battery C-1/40 fired 3 missions as recons by fire in the XD 9650 area in support of I-3/3. From 1150 to 1700 Battery A-1/40 and Battery B-1/40 both fired a continuous defensive mission in support of recon patrol PERSPECTIVE II resulting in beautiful coverage, no further movement seen or heard. From 1800 to 1900 Battery B-1/40 fired 4 missions on suspected enemy positions in support of L-3/3 and 3/3 LNO. From 2110 to 2400 Battery C-1/40 fired 7 missions on suspected enemy mortar and rocket positions called for by the 3/3 LNO. The battalion fired 29 observed missions and 185 unobserved missions throughout the day in support of 3/3 and 3/9. From 0012 to 0448 Battery C-1/40 fired 7 missions on suspected enemy mortar and rocket positions in the XD 9149/XD 9148 area called for by the 3/3 LNO. From 0710 to 0820 Battery C-1/40 fired 3 missions on suspected enemy positions in support of 3/3 LNO. The battalion fired 19 observed and 243 unobserved missions in support of 3/3 and 3/9 throughout the day.

tery C-1/40 fired 4 missions in the XD 9250 area in support of I-3/3. At 1115 Battery A-1/40 fired 1 mission on 10 enemy in a tree line (YD 087609) in support of I-3/9 resulting in 10 KIA (prob). From 1140 to 1225 Battery A-1/40 fired 3 missions on suspected enemy movement (YD 0859) in support of I-3/9, resulting in good coverage, negative surveillance on enemy movement. At 1300 the battalion assumed opcon of Battery G-3/12, who arrived on the plateau to relieve Battery A-1/40. At 1530 Battery A-1/40 received the march order and returned to Dang Ha. The battalion also lost opcon of Battery B-1/40 as that unit left their position in Cam Lo and returned to their parent unit in Dang Ha. From 1740 to 2140 Battery C-1/40 fired 14 missions expending 500 rounds, on suspected enemy positions called for by M-3/3. The battalion fired 25 observed missions and 19 unobserved missions in support of 3/3 and 3/9 throughout the day.

7 April

From 0715 to 0928 Battery C-1/40 fired 2 missions as prep fire in support of M-3/3 in the XD 9658 area. From 1008 to 1104 Battery G-3/12 fired 2 missions as recons by fire in support of I-3/9 resulting in good coverage of both targets. From 1225 to 1250 Battery C-1/40 fired 2 missions on enemy positions with bunkers, supporting recon patrol PUNCTUATE I resulting in good coverage of both positions. From 1630 to 1840 Battery C-1/40 fired 2 missions on suspected enemy positions in support of I-3/3, resulting in good effect on both targets. From 1905 to 2005 Battery C-1/40 fired 5 missions on suspected enemy positions in support of M-3/3 and 3/3 LNO. From 2015 to 2040 Battery G-3/12 fired 2 missions on enemy movement reported by the adviser to the ARVN unit in Cam Lo resulting in good coverage of the target area. The battalion fired 20 observed missions and 6 unobserved missions in support of 3/3 and 3/9 throughout the day.

8 April

From 0150 to 0205 Battery G-3/12 fired 2 missions on suspected enemy positions based on intelligence report forwarded from 12th Marine Headquarters. From 1300 to 1334 Battery C-1/40 fired 1 mission expending 120 HE as a prep fire in support of recon patrol PAGE TITLE II. From 1910 to 1930 Battery G-3/12 and Battery M-4/12 again participated in a practice of the camp counter mortar plan. From 1930 to 2000 Battery G-3/12 fired 3 missions as defensive concentrations in support of I-3/9 resulting in good effect, all rounds on target. From 1849 to 1854 Battery C-1/40 fired 2 missions on suspected enemy positions in support of I-3/3, resulting in good effect on both targets. At 2200 Battery G-3/12 fired 1 mission, expending 72 HE on an estimated enemy company, reported by Cam Lo advisor; the area was well covered, but an accurate surveillance was unavailable. The battalion fired 13 observed missions and 129 unobserved missions throughout the day in support of 3/3 and 3/9.

9 April

From 0024 to 0704 Battery C-1/40 fired 4 missions on suspected enemy positions in the XD 9948 area in support of 3/3 LNO. From 0825 to 0855 Battery C-1/40 fired 3 missions on suspected and known enemy areas in support of M-3/3, resulting in rounds on target for all missions. From 1300 to 1400 Battery C-1/40 fired 2 missions on suspected enemy positions in support of L-3/3 and M-3/3. From 1700 to 1900 Battery C-1/40 continued its support of 3/3 by firing 9 missions on suspected enemy mortar and rocket positions in support of L-, K-, and M-3/3. At 1900 the battalion participated in a counter mortar drill with Battery G-3/12 and Battery M-4/12 each firing sectors in the counter mortar plan. A simulated mortar position was fired on by Battery G-3/12 after completion of its assigned sector. Reaction time was satisfactory by all participating units. From 1900 to 2200 Battery C-1/40 fired 10 missions on suspected enemy positions in a proposed operational area called for by the 3/3 LNO. From 2220 to 2245 Battery G-3/12 fired 3 missions on possible enemy mortar positions in the YD 1253 area in support of 3/9 LNO. The battalion fired 39 observed missions and 296 unobserved missions in support of 3/3 and 3/9 throughout the day.

10 April

From 0100 to 0135 Battery G-3/12 fired 3 missions on suspected enemy positions based on intelligence report passed down by the 3rd Marine Division Headquarters. At 0205 Battery G-3/12 fired 1 mission on suspected enemy movement at YD 074572 expending 23 WP and 49 HE, observed from the Camp CARROLL defense perimeter resulting in 2 known secondary explosions. At 0520 unexplained rounds impacted near the camp perimeter, and Battery G-3/12 and Battery M-4/12 fired designated sectors from the camp counter mortar plan. At 0832 recon patrol PEEAGE II made contact at XD 923507, and Battery C-1/40 began a continuous mission in support. The mission lasted until 1500 and resulted in 10 KIA (prob) and the successful extraction of the patrol. From 1235 to 1420 Battery G-3/12 fired in 4 defensive concentrations in the YD 0750 area in support of L-3/9. At 1425 Battery G-3/12 fired 1 mission on enemy in a defensive position, adjusted by 3rd Marine Division AO resulting in outstanding coverage of the target area. From 1900 to 1930 the battalion again participated in a rehearsal of the camp countermortar plan, with Battery G-3/12 and Battery M-4/12 firing selected sectors of the plan. From 2103 to 2128 Battery C-1/40 fired 7 missions on lights on a ridge at XD 991605 in support of K-3/3 resulting in good effect on the area, lights out.

11 April

From 0950 to 1200 Battery C-1/40 fired 7 missions on suspected enemy positions in a proposed operational area in support of 3/3 LNO. At 1300 3 companies of 3/3 and a command group were lifted into the operational area as Battery M-4/12 fired 4 missions and Battery C-1/40 fired 13 missions as prep fires in the area to the southwest of the Rock-pile/Razorback complex. From 1550 to 1725 Battery C-1/40 fired 3 missions as recons by fire in the XD 0948 area, in support of L-3/9. From 1820 to 1957 Battery C-1/40 fired 5 missions as defensive concentrations in the XD 9348 area in support of J and L-3/3. The battalion fired 15 observed missions and 180 unobserved missions throughout the day in support of 3/3 and 3/9.

12 April

From 0038 to 0745 Battery C-1/40 fired 8 missions on suspected enemy positions and assembly areas in support of I and L-3/3. Throughout the morning Battery G-3/12 fired 4 practice missions in the YD 1258 area called for by Mortar Battery 3/12 in the XD 2039 area, with reinforcing fire from general support artillery. There was no positive surveillance. From 1540 to 1639 Battery C-1/40 fired 439 HE as a prep fire at XD 743476 in support of 3/3 LNO. From 1858 to 2036 Battery C-1/40 fired 5 missions as recons by fire in the operational area, in support of L-3/3. At 2010 Mortar Battery 3/12 fired an illumination mission on suspected enemy activity at YD 175405 in support of K-3/3 resulting in good lighting, no movement observed. The battalion fired 23 observed missions and 159 unobserved missions throughout the day in support of 3/3 and 3/9.

13 April

From 0927 to 0955 Battery C-1/40 fired 1 mission on 6 enemy moving through a tree line in support of M-3/3 resulting in good coverage of the target area, no further movement observed. At 0720 Battery C-1/40 displaced a platoon to Ca Lu in support of the current sweep by 3/3. At 1200 Battery C-1/40 began firing automatic weapons firing in the vicinity of XD 96064710. The mission was sent to the forward platoon at 1210, while Battery C-1/40 began firing on a suspected enemy mortar position (XD 955593), called for by M-3/3 as they received approximately 6 incoming rounds. The forward platoon ended their missions at 1230, with good coverage, and Battery C-1/40 ended their mission at 1220 with good area coverage, incoming ceased. From 1850 to 1920 Battery G-3/12 fired in 2 defensive concentrations in support of I-3/9. At 2115 Battery G-3/12, Battery M-4/12, Battery K-4/12, and Battery B-1/40 fired TOT on a suspected enemy battalion, based on intelligence data reported by the advisor at Cam Lo. From 2130 to 2310 Battery C-1/40 fired 2 missions on suspected enemy positions in support of M-3/3. The battalion fired 13 observed missions and 331 unobserved missions in support of 3/9 and 3/3 throughout the day.

14 April

At 0830 Battery G 3/12 fired 1 mission on a suspected enemy OP at YD 046513 in support of L/3/9, resulting in excellent coverage of the target area. At 1000 Battery C 1/40 displaced its forward platoon back to battery position at Thon Son Lam. From 1755 to 1915 Battery C 1/40 fired 4 missions on suspected enemy positions in support of I/3/3 and M/3/3. From 1928 to 1949 Battery G 3/12 fired in 3 defensive concentrations in support of I/3/9 in the YD 1256 area resulting in all rounds on target. The battalion fired 21 observed missions and 366 unobserved missions in support of 3/9 and 3/3 throughout the day.

15 April

During the morning a contingent from Co C 3rd Recon Battalion was given a tour of 2/94 Battalion FDC prior to a service practice shoot fired by Battery G 3/12 throughout the afternoon. From 1809 to 1912 Battery C 1/40 fired 4 missions on suspected enemy positions in support of I/3/3 and M/3/3. At 2000 Battery G 3/12 fired one HE mission on a suspected enemy platoon, in support of the Army advisor from Cam lo, resulting in rounds on target, no further movement observed. From 2000 to 2323 Battery C 1/40 fired five more missions on suspected enemy positions in the area around Thon Son Lam in support of M/3/3 and the 3/3 LNO. The Battalion fired 14 observed missions and 339 unobserved missions in support of 3/3 and 3/9 throughout the day.

16 April

From 0002 to 0615 Battery C 1/40 fired 32 missions, expending 291 HE on suspected enemy positions in support of M 3/3 and 3/3 LNO. From 0830 to 1020 Battery G 3/12 fired 3 practice missions in support of L/3/9. From 1700 to 1910, Battery C 1/40 fired 8 more missions on suspected enemy positions in support of I/3/3 and 3/3 LNO. The Battalion fired 23 observed missions in support of 3/3 and 3/9 throughout the day.

17 April

From 0840 to 0850 Battery G 3/12 fired a practice mission in support of L/3/9. From 1450 to 1512, Battery K/4/12 reinforced the Battalion on a suspected enemy company in the YD 164645 area, in support of 3/9 LNO. From 1805 to 1825, Battery C 1/40 fired 2 missions on suspected enemy positions in the XD 9550 area in support of M/3/3. The Battalion fired 3 observed and 174 unobserved missions, throughout the day, in support of 3/9 and 3/3.

18 April

From 1840 to 1917 Battery C 1/40 fired 3 missions on suspected enemy positions in the XD 9759 area in support of I/3/3 and M/3/3. At 2130 Battery C 1/40 fired 1 mission on lights on a hill, observed by 3/3 LNO, resulting in excellent coverage of the target area, lights out. The Battalion fired 3 observed missions 173 unobserved missions in support of 3/9 and 3/3 throughout the day.

19 April

From 1030 to 1055 Battery C 1/40 fired on 1 enemy on a ridge line (XD 965578) in support of I3/3 resulting in rounds on target, no further movement observed. From 1050 to 1135 Battery G fired 1 mission on a suspected enemy position in the XD 0253 area in support of 3rd Marines LNO. From 1210 to 1440 Battery C 1/40 fired 2 more missions on suspected assembly areas and mortar positions in support of I/3/9. From 1845 to 1925 Battery C 1/40 fired two missions on suspected enemy positions, in the XD 9050 area in support of M/3/3. The Battalion fired 15 observed missions and 159 unobserved missions in support of 3/9 and 3/3 throughout the day. Operation PRAIRIE III ended at 2400 this date.

20 April

The Battalion assumed operational control of Battery F/2/12 at Khe Sanh. This move was made necessary as the 3rd Marines AOR was extended to the west as Operation PRAIRIE IV began. At 0605 Battery C 1/40 fired a recon by fire on a suspected enemy position in support of I/3/3. From 1030 to 1220 Battery F 2/12 fired 2 missions on enemy movement in the XD 9346 area in support of recon patrol RATTLER, resulting in 1 WIA (CONF), 4 KIA (PROB). From 1300 to 1500 Battery F 2/12 fired 7 missions as recons by fire in support of BP 12. From 0700 to 1355 Mortar Battery 3/12 fired 19 missions as recons by fire and prep fires in support of K/3/9 in the Ba Long area. At 1250 Battery M 4/12 displaced two guns to D-5 to support the relief of K/3/9 in the Ba Long area. The platoon is under the operational control of this Battalion. From 1310 to 1425 Battery F 2/12 fired 2 missions on enemy movement in the XD 7346 area in support of recon patrol RATTLER, resulting in excellent coverage of both targets, no further movement observed. From 1800 to 2000 Battery G 3/12 fired 5 missions as defensive concentrations in support of I/3/9. From 1845 to 1910 Battery C 1/40 fired 3 missions on suspected enemy positions in support of I/3/9. From 1910 to 1940 Mortar Battery 3/12 fired in 3 defensive concentrations in support of K/3/9 in the Ba Long area. From 1925 to 1955 Battery F 2/12 fired in 3 defensive

concentrations in support of recon patrol HAWK. From 2100 to 2149 Battery F 2/12 fired two missions on lights observed at YD 187488, in support of B/1/9 resulting in good effect on target, lights extinguished. The Battalion fired 58 observed missions and 217 unobserved missions in support of 3/9 and 3/3 throughout the day.

21 April

From 0725 to 0815, the platoon of Battery M 4/12 at D-5 fired 4 missions as recons by fire in the YD 1243 area in support of 1/3/9 as that unit moved toward a relief of K/3/9 at Ba Long. From 0745 to 0845 Mortar Battery 3/12 fired 4 missions as recons by fire in support of K/3/9 in the YD 1942 area. From 1415 to 1455 Battery C 1/40 fired two missions reinforcing Battery M 4/12 in the YD 8951 area in support of recon patrol PERSPECTIVE II. From 1625 to 1640, Battery F 2/12 fired 1 mission on enemy sniper fire in support of Khe Sanh AO resulting in good coverage of the target area. From 1655 to 1923 Battery C 1/40 fired 4 missions on suspected enemy positions in the XD 9559 area in support of 1/3/3. From 2045 to 2340 Battery M 4/12 (FWD D-5) fired 4 missions and Mortar Battery 3/12 fired 5 missions on suspected enemy positions in support of K/3/9 in the XD 2041 area. The Battalion fired 27 observed missions and 240 unobserved missions in support of 3/3 and 3/9 throughout the day.

22 April

CONFIDENTIAL

At 0255 Battery C 1/40 fired a mission on enemy voices around recon patrol PERSPECTIVE II in the XD 8850 area resulting in screaming heard and voices ceased. (unknown number of WIA (PROB). From 0800 to 0905 Battery M 4/12 (FWD D-5) fired 3 missions on suspected enemy positions in support of K/3/9 in the Ba Long area. From 0934 to 1000 Battery C 1/40 fired 1 mission on 9 enemy in support of recon patrol PERSPECTIVE II resulting in 3 KIA (CONF). From 0930 to 1028 Battery M 4/12 (FWD D-5) fired 2 missions and Mortar Battery 3/12 fired 2 missions on suspected enemy positions in the Ba Long area in support of K/3/9. From 1105 to 1405 Mortar Battery 3/12 fired 2 missions and Battery M 4/12 (FWD D-5) fired 3 missions on suspected enemy movement in support of K/3/9 in the Ba Long area. At 1500 M/3/9 was helo lifted into XD 8851 area to link up with recon patrol PERSPECTIVE II and Battery C 1/40 fired 6 missions and Battery F 2/12 fired 5 missions as prep fires for that company operation. From 1515 to 1640 Battery F 2/12 fired 1 mission on 10 enemy at XD 830 478 in support of recon patrol SHARK resulting in 4 KIA (PROB). From 2145 to 2300 Battery F 2/12 fired 2 missions on suspected enemy positions in support of M/3/3 in XD 8849 area. The Battalion fired 40 observed missions and 281 unobserved missions throughout the day in support of 3/3 and 3/9. During the day the platoon of Battery M 4/12 displaced from D-5 to Camp Carroll; no longer under the operational control of 1/12.

23 April

From 0715 to 0735 Battery G 3/12 fired 2 missions as recons by fire in support of a patrol from M/3/9. From 0940 to 1425 Battery C 1/40 fired 2 missions and Battery F 2/12 fired 5 missions on suspected enemy positions in support of M/3/3 in the XD 8850 area. From 1515 to 1707 Battery C 1/40 fired 2 missions and Battery M 4/12 fired 1 mission on suspected enemy movement in the XD 8852 area in support of M/3/3. From 1732 to 1836 Battery G 3/12 fired 1 mission on suspected enemy movement in a tree line at YD 135523 in support of L/3/9 resulting in good coverage, no further movement observed. From 1855 to 1955 Battery C 1/40 fired 4 missions on suspected enemy positions in support of L/3/3 and M/3/3. From 2130 to 2145 Battery G 3/12 fired 1 mission on suspected enemy movement at YD 041575 in support of M/3/9 resulting in excellent coverage of the target area, no further movement observed. The Battalion fired 28 observed missions and 223 unobserved missions in support of 3/3 and 3/9 throughout the day.

24 April

From 0002 to 0655 Battery C 1/40 fired 10 missions on suspected enemy positions in the XD 8852 area in support of M/3/3. From 0700 to 1000 Battery G 3/12 fired 4 missions as recons by fire in support of a patrol from M/3/9 resulting in good effect on target on all missions. From 1240 to 1345 Battery F 2/12 fired 2 missions on enemy in the open (XD 776519) in support of recon patrol SHARK resulting in 5 KIA (PROB) and 2 secondary explosions. From 1310 to 1600 Battery F 2/12 fired 2 missions on enemy dug in (XD 993457) in support of B/1/9 and a Khe Sanh AO with a negative surveillance for both missions. From 1200 to 1630 Battery C 1/40 fired 4 missions as recons by fire on suspected enemy positions in the XD 8751 area in support of M/3/3. From 1630 to 1705 Battery G 3/12 fired 2 missions on suspected troop concentrations in the XD 1153 and XD 1351 areas based on intelligence reports forwarded by the 3rd Marines LNO. From 1935 to 2000 Battery C 1/40 fired 2 missions on suspected enemy positions in the XD 9857 area in support of L/3/3. The Battalion fired 32 observed and 6 unobserved missions in support of 3/9 and 3/3 throughout the day.

25 April

From 0325 to 0935 Battery F 2/12 fired 2 missions on enemy troop movement in the XD 8044 area in support of B/1/9. During the morning K/3/3 and a command group from 3/3 were helo-lifted to the area west of Khe Sanh (XD 8044). The command group took control of B/1/9 forming a composite battalion (-) in that area. From 1325 to 1615 Battery F 2/12 fired 3 missions as recons by fire in the XD 7944 area in support of 3/3 LNO and B/1/9.

From 1645 to 1755 Battery F 2/12 fired 2 missions on enemy mortars and automatic weapons fire in the XD 8044 area in support of 3/3 LNO. From 1900 to 1930 Battery K 4/12 fired 1 mission on an anti-aircraft site observed by 3rd MarDiv AO, resulting in 2 KIA (PROB). From 1900 to 1915 Mortar Battery 3/12 fired in 2 defensive concentrations for I/3/9 in the Ba Long area. From 1900 to 1945 Battery F 2/12 fired 6 missions on enemy avenues of escape in the XD 8044 area in support of 3/3 LNO. The Battalion fired 24 observed missions and 28 Harassment and Interdiction missions throughout the day in support of 3/9 and 3/3.

26 April

From 0130 to 0555 Battery F 2/12 fired 5 missions as counter-mortar fire and blocking fires in support of K/3/3 and 3/3 LNO in the XD 7943 area, expending 500 rounds on the various missions. On 2 April a rough rider convoy was organized for the purpose of moving Battery F 2/12 from Cam Lo to Khe Sanh, replacing Battery I 3/12 in that position. Battery C 1/40 displaced a platoon to CA Lu to support the convoy and Battery B 1/40 sent

3 guns to Cam Lo to replace Battery F 2/12. The convoy successfully moved Battery F 2/12 to Khe Sanh and returned Battery I 3/12 to Dong Ha. On 3 April the platoon from Battery C 1/40 returned from Ca Lu to Thon Son Lam. On 6 April Battery G 3/12 arrived at Camp Carroll and Battery A 1/40 displaced to Dong Ha, reverting to operational control of its parent unit. The 3 guns of Battery B 1/40 at Cam Lo also returned to their parent unit at Dong Ha, reverting to that unit's operational control. On 8 April, the Battalion held an F0 school for a detachment from 3rd Recon Bn. The personnel were led through an operational FDC in the morning and participated in live practice missions, fired by Battery G 3/12, in the afternoon. On 13 April a platoon from Battery C 1/40 displaced from Thon Son Lam to Ca Lu to support a 3/3 operation. On 14 April Battery G 3/12 moved into position previously occupied by Battery C 2/94 and assumed that unit's responsibilities in the Camp Carroll defensive perimeter. Also on this date the platoon from Battery C 1/40 displaced back to Thon Son Lam. On 19 April Operation PR AIRIE III ended and Operation PR AIRIE IV began. On 20 April the Battalion again assumed the operational control of Battery F 2/12 at Khe Sanh. Also on this date Battery M 4/12 displaced 2 guns to D-5 to support the relief of K/3/9 by I/3/3 in the Ba Long area. On 22 April Battery M 4/12 returned the platoon at D-5 to Camp Carroll. On 26 April another rough rider was organized to transport Battery B 1/40 to Khe Sanh, to be supported by the displacement of a platoon of Battery C 1/40 to Ca Lu. The convoy reached Ca Lu but was unable to proceed any further due to non trafficability of the road past that point. On 27 April Battery B 1/12 was air lifted into Khe Sanh. Battery B 1/40 aborted the attempt to proceed to Khe Sanh and relieved Battery C 1/40 at Thon Son Lam. On 28 April as Battery C 1/40 returned to the operational control of its parent unit at Dong Ha. On 30 April, a calibration team arrived at Camp Carroll and performed a sky screen calibration of Battery G 3/12.

5. LOGISTICS

During this month, the battalion was provided with electrical power. The battalion working spaces were wired and a PU-239, 20 KW generator was installed by 11th Engineers. As a result of this electrical power, the messhall received refrigerated bulk milk dispensers.

The requirements for bunker material for the battalion were again forwarded to Division. Continued improvement of the battalion defensive perimeter has been hampered by a lack of 8 foot stakes and the lack of a TD-15 tractor.

6. ORDNANCE

Due to lack of 3d echelon spare parts at support maintenance facilities, it has become difficult to effectively decrease the deadlining of the 105mm howitzers. Specific areas of necessary replacement parts include recoil mechanisms and gun tubes.

7. MEDICAL

During the month 310 patients were treated at the battalion sick bay. Of these, 302 were treated and returned to duty while 8 were evacuated to higher medical headquarters.

There were no immunization given during the reporting period. There were 3 preventive maintenance and sanitation inspections performed with satisfactory results in each case. The general health of the battalion continues to be very good.

8. MOTOR TRANSPORT

The vehicles in the battalion travelled a total of 31,435 miles during the reporting period. There were 39 preventive maintenance quarterly/annuals and 51 individual repairs performed during the month. There were 2 modifications performed on M-422's. Four 2½ ton trucks and 2 M-422 ½ ton trucks sent to FLSU for repairs and the battalion received 2 M-422's back from that activity.

Critical parts include batteries for 2½ ton trucks, electrolite, hot patches, inner tubes, M37 radiators, and bell-cranks and bushings for the M-38 and M-422 vehicles.

9. WEATHER

Continued clear weather enabled 3d Marines to continue to increase its operational commitments. The aerial observer coverage of the 3d Marine ACR continued to increase during this period of good visibility.

10. TRAINING
