PART IINARRATIVE SUMMARY

During June, 1st Battalion, 12th Marines concurrent with operation Lancaster II, provided direct artillery fire for the forward maneuver element of Task Force Hotel on operation Robin South. Reinforcing fires were delivered, as requested, by Task Force Hotel.

On 1 June, Camp Carroll received approximately five rounds of incoming. The battalion suffered no casualties or damage.

On 2 June, chopped OPCON of C/1/12 as of 021445H. Assumed OPCON of E/2/12 as of 021500H and chopped OPCON of W/2/11 as of 021500H.

On 4 June, assumed OPCON of D/2/12 as of 041400H.

On 5 June, A/1/12 displaced to L2 Robin with the Command Group of HQ/1/12 and occupied L2 Robin as of 051045H. K/4/12 and D/2/12 fired on 20 NVA in the open expending 167 rounds including 16 Firecracker resulting in 9 KIA. D/2/12 fired 12 rounds of Firecracker on 10 NVA in open resulting in 14 KIA.

On 6 June, chopped OPCON of E/2/12, D/2/12, K/4/12 and CMR (USA) as of 061200H. A/1/12 fired defensive fires in support of 4th Marines against a ground attack resulting in 20 KIA.

On 7 June, A/1/12 fired 22 Firecracker on 10 NVA in open resulting in 1 KIA.

On 9 June, assumed OPCON of C/1/12 as of 090935H. C/1/12 fired for an air observer resulting in 6 KIA. 1st 8 inch platoon assumed mission of reinforcing 1/12. A/1/12 fired 36 Firecracker with surveillance of good coverage.

On 10 June, Camp Carroll received 2 rounds of incoming, (75 mm). The battalion suffered no damage or casualties.

On 11 June, A/1/12 fired 18 Firecracker on active mortars resulting in mortars silenced. At 0230 C/1/12 fired 37 Beehive and 4 Firecracker direct fire against an enemy ground attack resulting in 28 KIA. C/1/12 suffered 4 KIA and 21 WIA MEDEVACS.

On 12 June, LZ Robin received 12 rounds of incoming (82 mm). HQ battery suffered 1 KIA and A/1/12 suffered 1 minor WIA.

On 13 June, Camp Carroll received 1 round of incoming, (75 mm). The battalion suffered no damage or casualties. Assumed OPCON of 1 platoon of F/2/12 as of 181830H. A/1/12 displaced to LZ Torch 130915H. Tango 1/11 assumed mission of reinforcing 1/12.

On 14 June, T/1/11 fired on NVA in open resulting in 6 KIA. F/2/11 fired on suspected OP resulting in 1 KIA. A/1/12 fired 3 Firecracker on 7 NVA in open resulting in 1 KIA.

On 15 June, T/1/11 fired 33 Firecracker on active mortars resulting in mortars silenced. 1st 8 inch platoon fired on enemy mortars resulting in 10 KIA. C/1/12 fired on enemy movement resulting in 4 KIA. A/1/12 fired on enemy contact resulting in 26 KIA. A/1/12 fired 12 Firecracker on active mortars resulting in mortars silenced. C/1/12 fired 20 Firecracker on enemy movement resulting in excellent coverage of target.

On 16 June, C/1/12 fired 15 Firecracker on NVA in open resulting in excellent coverage.

7. EQUIPMENT

a. During June, battalion vehicles transported 478 passengers and 51,800 tons of cargo over a distance of 3,487 miles.

b. Driver instruction classes were conducted. 3 Marines received a drivers license.

c. An ice machine was obtained for the messhall. The machine is presently being used to produce the battalion ice ration.

d. 5 105 howitzer tires and one panoramic telescope were damaged by shell fragments. The panoramic telescope was repaired in the field.

e. Three 105 howitzers were evacuated to FLSG-B, two for 6 month maintenance, and one for repair of a sight mount.

f. The battalion received 38 M151 quarter ton trucks.

g. The battalion turned in 22 M422A1 quarter ton trucks as an excess, one M422A1 remains to be turned in.

h. The battalion received six 2 1/2 ton cargo trucks M25A2C in accordance with FY1968 R&E Program.

i. The spare parts for the M422A1 were pulled from the warehouse and are ready for turn-in.

j. Jungle utilities have been extremely difficult to obtain and we anticipate this problem again when we requisition clothing at the end of the month.

8. LOGISTICS

a. The battalion was resupplied primarily by convey from Dong Ha Combat Base.

b. The logistic effort this month was centered around support of firing batteries in the field. The majority of the support consisted of ammunition, food and water resupply. During the period from 6-19 June, more than 470 tons of cargo was airlifted to the batteries located at forward fire support bases.

c. Support of the regimental sized operation also permitted the battalion to conduct mount-out practice and gain valuable experience in helicopter displacement.

9. CIVIC ACTION.

a. There were no MEDCAPS during June due to operational commitments.

b. The laundry in Hung Phu II and the sand bag projects were started and proved to be favorable.

c. Relationships between this battalion and the refugees of Cam Lo were most favorable. This is evidenced by the intelligence information obtained.

d. One member of this battalion attended the Division Personal Response School.

a. Two Marines were tried by special court-martial, and 2 by summary court-martial during June.

b. A total of 79 Marines were promoted: 26 to sergeant; 25 to corporal; 28 to lance corporal and 1 to private first class.

c. A total of 6 extensions of overseas tour were approved.

- a. During the month of June, Camp Carroll was subjected to H&I artillery fire. The artillery was identified to be 75 mm.
- b. The new counter fire programs were employed and proved to be quite successful.
- c. Daily intelligence and weather briefings were conducted for the battery commands and the battalion staff.

13. COMMUNICATIONS.

- a. Wire lines were laid to 4th Marines FSCC, 1/3 COC, and 4th Marines switchboard.
- b. Communications were excellent throughout Operation Robin South, with the exception of some atmospheric disturbance in the early evening hours.
- c. The message center processed 613 messages during the month: 588 incoming and 35 outgoing.
- d. The electronics maintenance section processed 47 pieces of communications equipment, 26 of which were evacuated to FLSG-B for repair.

18. MEDICAL. During June the aid stations of this battalion treated 187 Marines and 2 Naval personnel. There were 6 friendly KIA and 34 friendly WIA, of the 34 WIA 16 were MEDEVAC patients. A total of 273 immunizations were given. There were no first-aid or VD lectures given due to operational commitments. Three persons were bitten by rats and treated with Rabies Vaccine. The general health of the battalion is considered good.
