1. In accordance with references (a) and (b) the following report is submitted:

a. Organizational data including attachments:

(1) Designation/Location: 2d Battalion, 12th Marines, 3d Marine Division (Rein), FMF, Da Nang Sector, South Viet Nam

(a) Battery F, 2d Battalion, 12th Marines remains detached OPCON to 3d Battalion, 9th Marines for extended operations in the AN HDA area.

(b) Battery E, 2d Battalion, 12th Marines remains detached OPCON and ADCON to 3d Battalion, 12th Marines for operations in the DONG HA area.

(c) Mortar Battery, 2d Battalion, 12th Marines was detached OPCON and ADCON to 4th Battalion, 12th Marines on 28 September 1966.

(d) Battery D, 2d Battalion, 12th Marines was detached ADCON to 1st Battalion, 9th Marines on 18 September 1966 and OPCON to BLT 1/9 on 28 September 1966 for return to Okinawa.

(e) Battery A, 1st Battalion, 13th Marines was attached OPCON and ADCON to the 2d Battalion, 12th Marines on 28 September 1966.

(2) Period covered: 1-30 September 1966.

b. Sequential listing of significant events especially as they relate to:

(1) Personnel. The battalion was at 86% T/O strength at the end of the reporting period. Shortages that hinder the mission of the battalion exist in MOS 0121, 0846, 1345, 3041, 3349, 3371, and 3531. There were four battle casualties, one of which was med-evacuated. A total of 23 Marines participated in the R&R program.

(2) Administration. Administrative control of Battery D, 2d Battalion, 12th Marines was passed to the 1st Battalion, 9th Marines at 1200 hrs on 18 September 1966. Administrative control of Battery A, 1st Battalion, 13th Marines was assumed at 1800 hrs on 28 September 1966. Securing orders for personnel due to rotate to CONUS the first of the following month continues to be a major problem.

(3) Intelligence. During September patrols were conducted at an average of two per week. For the most part they were routine with no enemy contact. On two occasions what appeared to be direction markers or aiming posts were discovered and destroyed by patrols. A total of three VCS were apprehended during September. One VCS was picked up after being observed collecting taxes from the villagers going to market for several days. The suspect was forwarded to ITT where he provided a quantity of information on local VC and was released. Two VCS were picked up by a patrol and brought back to the CP, after local questioning and document check they were determined not to be VC and were released. One Vietnamese civilian was brought into the CP late in the evening suffering from serious fragmentation wounds, he died awaiting a Med Evac helicopter.

Lt. Ronald G. BURNSTEEL relieved Lt. William A. SCHARNITZKY as intelligence officer. Captain BURNSTEEL promoted to his present rank.

A new security SOP was published and a change 1 to security SOP was also published. A new visitor control bill was also published.

Received an updated O.O.B. for south Vietnam that indicated a total of five north Vietnamese Divisions and two V. C. Divisions located in south Vietnam.

Rallier's report of possible attack on an artillery battalion C.P. was received and disseminated to all batteries, extra security measures were enforced during the expected period of attack.

1:25,000 photo maps were distributed to Fox Battery F.O.'s. Covered incidents and events of previous week and information of V.C. tactics and techniques.

(4) Training. Training continues to be initiated in conjunction with operational commitments. Small unit patrols provide an excellent means to gain proficiency in current tactical trends. Alert drills are conducted on an average of twice per week in order to improve the defense posture of the command.

(5) Operations. Operation MACON continued throughout the month of September. Battery F, 2d Battalion, 12th Marines supported this operation from their original firing position (AT 875473). Extracts from the S-3 journal enclosure (2), indicate significant missions fired during the operation. 2,629 rounds were expended in support of Operation MACON and enemy casualties reported were 30 KIA (conf) 59 KIA (prob) and 2 WIA. The battalion fired a total of 119 observed missions, 17 unobserved missions, and 902 H&I missions in support of 9th Marines during September, expending 5,090 rounds of 105mm ammunition and 408 rounds of 155mm ammunition. Enemy casualties other than those inflicted during operations were 26 KIA (conf) 27 KIA (prob) and 10 WIA (prob). In addition, 73 KIA (conf) and 165 KIA (prob) were credited as being KEMTOWS of which 2d Battalion, 12th Marines was considered the major supporting arm.

(6) Command and Control. The command post location and mission of the 2d Battalion, 12th Marines remains the same.

(7) Communications/Electronics. The battalion communications section issued PRC-25 and test equipment to Mortar Battery, 2d Battalion, 12th Marines. Received two technicians (3841). This brings our Tech Shop up to just two technicians short. Received a T/O strength NGF liaison team and spot team with all T/E equipment. Prepared all old VHF radio equipment for turn-in.

(8) Logistics. The logistics situation within the command remains satisfactory except for the continued shortage of 3d echelon repair parts. The over-all deadline rate is 10%, however the M-35 truck deadline rate is 36%. The high deadline rate for M-35 trucks is caused by the lack of 3d echelon parts. The supply of 2d echelon parts has improved but there is still a shortage of batteries for the M-35s and M-422A1s. The command exchanged four M-105 trailers for new ones. The cantonment area for Headquarters Battery and the battalion headquarters was completed except for the enlisted shower. Communications maintenance continues to be satisfactory.

(9) Civil Affairs. Civic affairs during September were mostly daily routine reports. Civil Affairs personnel attended a Census Grievance Committee briefing and Civil Affairs conference at Division Headquarters. Twenty pounds of rice were presented a little girl and her sister; they have no parents and live by themselves. DONG XI (See), a small Vietnamese boy who lost his lower left leg in a mine incident on 8 August, spent a week living with Chief Corpsman DICKENS for observation after returning from USOM Hospital. One other Vietnamese girl still in USOM from same mine incident which occurred vicinity of coordinates AT 988646 on 8 August 1966. On 29 September a Vietnamese holiday TRE EM, mid-autumn festival; a party was held jointly by this headquarters and Lima Battery, 4th Battalion, 12th Marines for LE SON (1) and (2) and HA DONG. The party was held at LE DONG school (P.S. 12) AT 995645. Approximately 700 children attended and were presented with 300 gift packages, 50 gallons of kool-aid, 1300 home-made cookies, 60 pounds of moon cakes and special cookies, 30 pounds of candy, 2 crates of apples, and one crate of oranges. Liaison with S-2, 1/9 was made and 1,000 pounds of captured rice and corn were acquired and distributed to villagers of HA DONG and LE SON (1) and (2). Total distributed food-stuffs and clothing distributed by this headquarters during September were: 1,765 pounds of food; 74 pounds of clothing, 725 bars of soap, \$3,400 (VN) piastres, and 402 pounds of miscellaneous supplies. Medical treatment was given to 1,119 persons during September.

The chaplain conducted 20 Divine Services and 1 memorial service, counseled 15 marines, held four lectures, making 39 visits to the firing batteries; and attended two conferences at Division and III MAF. He also visited W.E.C. and Sacred Heart orphanages distributing food, clothing, personal comfort items and provided financial aid. He organized the men of Headquarters Battery, 2d Battalion, 12th Marines to provide funds to send a Vietnamese girl to school.
