PART II

NARRATIVE SUMMARY

During April the Second Battalion, 12th Marines fired a total of 1,186 observed missions, 4,188 unobserved missions, and 4,221 H&I missions in support of the 9th Marines. Ammunition expenditures were 27,126 rounds of 105mm, 7,090 rounds of 155mm, and 7,103 rounds of 107mm.

Enemy casualties inflicted during April were 72 KIA and 29 WIA. In addition there were 4 secondary explosions and 17 bunkers and 1 automatic weapon destroyed.

SEQUENTIAL LISTING OF SIGNIFICANT EVENTS

1. Combat Missions Assigned. Direct support of 9th Marines
2. Significant Operations Conducted. Operations Kentucky and Highrise
3. Casualties Inflicted on the Enemy. 72 KIA and 29 WIA
4. Casualties Sustained. 1 KIA (Officer), 4 KIA (Enlisted), 3 WIA (Officer) and 14 WIA (Enlisted).
5. Logistics. Complete logistic support was furnished for four organic batteries. Class V resupply and ordnance repair were furnished to two OPCON batteries. A total of 51,319 rounds of artillery ammunition were moved by truck convoy and helicopter this month. Motor transport deadline remains high at 46.6%. The primary cause is very slow return of vehicles from external repair facilities. Ordnance cleaning materials remain in critically short supply. A 500 man messhall was put into use. A 60 K.W. generator was received and all messhall equipment is in operation. A water well was put into use and fresh water is now being piped through the camp. A new cement decked shower is in use and hot showers are now available to all Marines of the command.
6. Civic Action. Second Battalion, 12th Marines directed the primary civic affairs effort in April toward assisting the 2200 refugees that have been resettled in Can Hau Village. Working with an Army medical officer from the 108th Field Artillery Group, the battalion provided medical care to 602 Vietnamese civilians. Approximately 2800 sheets of tin, an allotment of 10 sheets per family were distributed for roofing in the refugee hamlets. In Thet Trang, the Vietnamese are digging two wells and the battalion is supporting this public improvement project by providing cement.

7. Personnel. The battalion was 83% T/O strength at the end of the reporting period. Shortages exist in MOS's 0122, 0239, 0848, 0849 and 2531. Forty-four Marines participated in R&R program during March.

8. Intelligence. Enemy initiated incidents for the first three weeks of April showed a marked reduction from the previous month. This may be due to the fact the enemy has sustained heavy losses during the past weeks. Supply, replacements and training seem to be the largest problem the enemy now faces. However, during the last week of April the number of enemy initiated artillery and ground engagements has risen sharply. This may be an indication that the second phase of the winter-spring offensive is about to start. The second phase would be similiar to the Tet offensive with attacks on larger cities and population centers followed by an immediate attempt to control Quang Tri and Thua Thien provinces in order to establish a position of strength from which to negotiate. There are also numerous agent reports of a possible 3d phase of the winter-spring offensive. Ground contact during the period remained light. The only major contacts occurred on 23 and 25 April when 1st Battalion, 4th Marines engaged company-sized NVA units to the east and west of Con Thien. In the future the enemy retains the capability to attack by fire and launch possible ground attacks against the outposts along the DMZ.

9. Communication. A covered teletype circuit was installed between 2d Battalion, 12th Marines and 12th Marine Regiment. This circuit gives the battalion the capability to receive and transmit classified message traffic at any hour of the day, eliminates inconvenient message traffic by vehicles to regiment and provides on the job training for 2542 and other communications personnel. The personnel situation improved considerably during April with the arrival of eight 2531 field radio operators into the battalion.

10. Training. During April emphasis was placed on fam firing of individual and crew served weapons and ambush and patrolling techniques. All batteries conducted live-fire, high-angle practice missions and two batteries repeated the direct fire training as conducted during the previous month. Ten battalion officers including all battery commanders attended formal instruction on 1st echelon motor transport maintenance provided by the battalion motor transport section. Division contact teams provided extensive fam firing and instruction of individual and crew served weapons. A contact team was employed to instruct Headquarters Battery personnel in ambush and patrolling techniques. A Battalion contact team provided instruction to the NBC monitor/survey and decontamination teams of all organic batteries. Out-of-country formal schooling consisted of Ammunition Technician School, Infantry Weapons Repair School, Non-Commissioned Officers School, Military Justice School, and Embarkation School which were attended by a total of seven battalion personnel. In-country formal schooling consisted of Personal Response School, Communications Secret/Crypto School and Supply School and were attended by three personnel from the battalion.
