PART II

During November, the 3d Battalion, 12th Marines continued in direct support of the 4th Marine Regiment. The 4th Marines maintained security for hill 674, hill 51, and Camp Evans, while continuing to interdict enemy supply and communications.

Operation NEOSHO started on 1 November and continued throughout the month. Operation GRANITE, which was run in conjunction with 1st ARVN Division forces around hill 674 and the VC/NVA Base area 114, terminated on 6 November.

Captain D. DAVIS arrived at Camp Evans on 5 November to give formal schooling on the M-18, Gun Direction Computer (FADAC). The school lasted five days during which two operators were trained.

Command of the Battalion changed hands during a ceremony held on 9 November. LtCol D. B. BARKER was relieved by Major Roger W. GREER, former Battalion Executive Officer. Major G. E. ELLIOTT was assigned as Executive Officer while he continued to function as the Battalion S-3.

The M-16 rifle was issued to the personnel of this Battalion on 14 November. An extensive training program was established to provide each individual with instruction on care, cleaning, and functioning of the M-16. In addition, familiarization firing was conducted, utilizing 400 rounds per man, to ensure each man was familiar with and had zeroed his weapon.

The third major operation for the month, Operation Cove, commenced on 17 November in the canopy to the southeast of Phu Loc (ZD 083004). Battery "G" was displaced to grid ZD 129011 to support the operation. The displacement was made in two phases; a motor march to Phu Bai (YD 885148) on 17 November followed by a helilift to ZD 129011 on 18 November. Command Group "B", headed by Major G. E. ELLIOTT displaced on 17 November to hill 132 (ZD 108009) to control and coordinate artillery and naval gunfire support for Phase I and Phase II of the operation. Phase I was completed on 21 November. However, Phase II was cancelled in its entirety. Battery "G" came under mortar attack during operation Cove, receiving forty 82mm rounds in the battery position. Counter-mortar fire was delivered, silencing the mortars. No personnel casualties were sustained and minor damage to one radio antenna was the only material damage.

On 19 November, Major D. E. VOWELL joined the Battalion as S-3 Officer and 1st Lt W. K. LAW joined as the assistant S-3 Officer.

A Liaison team was placed with the ARVN battery at Hai Lang (YD 415479) on 24 November to provide for additional artillery support of the 3d Battalion, 26th Marines operating in the My Chanh area (YD 460369).

The Battalion published it's second newsletter during November and plans were made for a special Christmas-New Year issue.

Throughout the month, the 3d Battalion continued to provide artillery support for convoys along National Route #1. In addition, counter-mortar fires were planned and delivered in support of ARVN forces at Phong Dien (YD 528345) and PK-17 (YD 647282).

As the month of November closed, the 3d Battalion, 12th Marines continued in its direct support role of the 4th Marine Regiment on Operation NEOSHO.

5. Equipment. Only 9% of the Battalion's motor transports prime movers are on deadline. Six of the vehicles are down for 3d and 4th echelon maintenance. One 155mm Howitzer is deadlined awaiting a new recoil system, tube and jack parts. The maintenance situation for other types of equipment remains good.

6. Logistics. The overall Logistics situation remains good although some authorized allowance shortages of major items of equipment still exist. During the reporting period this battalion commenced issuing M-16 rifles and recovering M-14 rifles. Total issue and recovery has not yet been completed. Seventeen (17) GP tents were received during the month. A sufficient amount of bunker material was received to build a new Battalion FDC bunker. 1070 bags of cement are still on order to improve gun positions. A total of 32 AN/PRC-25 Radio Sets are inoperable because of lack of handsets.

a. Food Services. The Battalion served 60% "A" rations, 30% "B" rations and 10% "C" rations during the month.

b. Medical. There were 323 outpatients treated by the Battalion Aid Station during the month. The Battalion had no KIA's, WIA's or personnel hospitalized during the reporting period.

7. Administration

a. Morale has maintained its high level due to 100% participation in R&R opportunities. Also several out of country stand-by quotas were utilized. Training of new administration personnel is being carried out in compliance with the training schedule.

b. A total of 3 Commanding Officer's Non-Judicial punishments were held during the month for the following violations:

(1) Article 92 UCMJ - 1

(2) Article 134 UCMJ - 2

There were no summary, special, or general courts-martial during this period.

c. Administrative procedures are being accomplished in an efficient manner. The respective batteries are coordinating their administrative work with that of the battalion and the results are quite effective.

8. Personnel. The average strength for the month was 85% of the authorized manning level. The Battalion is currently operating at 83% of the manning level. The battalion joined 5 Marine Officers, 68 Marine enlisted, and one Navy enlisted. Four Marine Officers, 35 Marine enlisted, and 2 Navy enlisted were transferred or rotated.

9. Intelligence

a. Enemy Activity. The activity has centered around the Cobi Than Tan Valley and "The Street Without Joy". The enemy forces seemed to be moving toward the more populated areas.

The Viet Cong forces have also tried to come in under the cover of darkness to mortar Phong Dien district headquarters on three separate occasions.

b. Enemy Intentions. The enemy seems to want to move toward the more populated areas for the winter months in order to get enough food to eat, to have a warm dry place to rest, and to reassert their hold on the people.

c. Administration. The revised counter-mortar/rocket plan was finished.

10. Communications-Electronics

a. During November the communication section continued to support the Battalion located at Camp Evans.

b. Comm provided two liaison teams for Operation Neosho, one at Phong Dien, the other at Hai Lang.

c. Communication for Operation Neosho has been very good.

d. Operation Cove proved to be a challenge for the comm section. The battalion had to provide assets for two FDC's and three FSCC's. The final result was excellent communications in an area covering over fifty miles.

e. The Communication section rewired the Battalion FDC.

f. Radio Central was relocated in FDC and the RC-292's were resited in close proximity to the FDC.

g. A bunker was built around the switchboard and operators area to provide better protection in case of attack.

h. A preventive maintenance program of painting and water proofing communication equipment has been initiated in preparation for the monsoons.

1 November

The Naval Gunfire team on hill 674 called fire on one VC in open at YD 557247. At 1340H Battery "H" expended 20 rounds of HE resulting in 1 KIA (probable).

Battery "H" expended 4 rounds of WP and 12 rounds of HE on 3 VC in open at 1710H. Elements of 3/26 called this mission in at YD 549292. No surveillance was given on this mission.

2 November

At 1530H the 1st Provisional 155mm Howitzer Battery reported that they were laid and ready to fire from YD 536316.

3 November

No significant missions were fired during this 24 hour period.

4 November

Elements of 3/26 requested fire on VC in tree line at YD 546289. At 1820H Battery "H" expended 4 rounds of WP and 18 rounds of HE with negative surveillance.

At 0945H Battery "G" reported that they were laid and ready to fire from YD 536323.

5 November

Capt. DAVIS arrived to give formal schooling on the M-18 gun computer.

6 November

The Naval Gunfire team on hill 674 requested a fire mission on 5 VC at YD 556237. Battery "H" at 1215H expended 5 rounds of WP and 24 rounds of HE resulting in 2 KIA's (probable)

OPERATION NEOSHO7 November

COMPANY CAR (recon) called fire on 5 camp fires at 0730H. Battery "H" expended 2 rounds of WP and 12 rounds of HE at YD 542242. Good shooting was the only surveillance.

8 November

At 0800H Battery "H" and the 2nd Provisional 155mm Howitzer Battery displaced to the forward artillery position at YD 633249.

At 1700H the Naval Gunfire team requested fire on 3 VC in open at YD 552255. Battery "G" expended 28 rounds of HE with negative surveillance.

At 1500H Battery "H" and the 2nd Provisional Howitzer Battery reported that they were laid and ready to fire at YD 633249.

Battery "G" at 1740H expended 14 rounds of HE, fuzes mixed at 6 VC. Elements of 3/26 called this mission in at YD 557308. Good Coverage of target was the surveillance.

9 November

At 1100H Major Roger W. GREER took over command of 3d Battalion, 12th Marines from LtCol D.B. BARKER.

Recon called fire on a VC machine gun position at YD 509 258. At 1015H the 1st Provisional 155mm Howitzer Battery expended 1 round of WP and 45 rounds of HE. No surveillance was given for this mission.

At YD 55712540 7VC in tree line were spotted by the Naval Gunfire team on hill 674. At 1730H Battery "G" expended 14 rounds of HE and good coverage of target was the surveillance.

10 November

Elements of 3/26 requested fire on VC moving through a village at YD 555296. At 1050H Battery "H" expended 50 rounds of HE with negative surveillance.

Between the hours of 1635H and 1805H Battery "G" and the 1st Provisional 155mm Howitzer expended 11 rounds of WP and 45 rounds of HE at 100 NVA in open at YD 559243. PAROSAL (recon) called this mission in and gave 2 KIA's (confirmed) as the surveillance.

11 November

The XO at 1300H departed the CP for the forward artillery position.

12 November

Elements of 1/4 reported that they were receiving AK-47 sniper fire from YD 577232. At 1300H the 1st Provisional 155mm Howitzer Battery expended 2 rounds of WP and 4 rounds of HE. Sniper cease was the only surveillance given.

13 November

No significant missions were fired during this 24 hour period.

14 November

BARKWOOD WHISKEY (AO) requested fire on VC in open at YD 531456. The 2nd Provisional 155mm Howitzer Battery at 1350H expended 19 rounds of HE. The surveillance was 5 NVA bunkers destroyed.

At 1325H Battery "H" expended 2 rounds of WP and 24 rounds of HE on 5 bunkers at YD 536257. SCAR FACE 41, (AO) called in this mission and gave 2 bunkers destroyed and 1 damaged as the surveillance.

At YD 473341 2 VC were spotted on a hill top by elements of 1/4. Battery "H" at 0815H expended 4 rounds of WP and 30 rounds of HE with negative surveillance.

BARKWOK BRAVO (AO) requested fire on 3 huts at YD 568 253. At 1335H 14 rounds of HE was expended by Battery "H". The surveillance was 1 hut destroyed.

The Battalion ExO departed for Phu Bai and then to the forward artillery position at 1500H in connection with operation Cove.

17 November

At 1710H Battery "H" expended 9 rounds of WP and 66 rounds of HE on 150 VC in open. PARASOL (recon) called this mission in at YD 572243 and gave 35 KIA's (probable) as the surveillance.

At YD 596245 20 VC in tree line were spotted by PARASOL (recon). Battery "H" at 1825H expended 2 rounds of WP and 13 rounds of HE with negative surveillance.

Elements of 3/26 called fire on 20 VC in a rice paddy at 2250H. Battery "H" responded by expending 24 rounds of HE at YD 365281. No surveillance was reported.

G-3-12 displaced to Hue Phu Bai in connection with Operation Cove at 0800H.

OPERATIONS

During November Third Battalion, Twelfth Marines took part in three combat operations against Communist forces in Quang Tri and Thua Thien Provinces, RVN.

Early in the month Operation Fremont was terminated and Operation Neosho began in the Camp Evans area with the continued search and destroy operations cutting VC/NVA supply lines.

During the month elements of the battalion moved out of Camp Evans to support other operations while other units remained at Evans to continue to fire support for Neosho.

Battery G and Battery P displaced to a forward position west of Camp Evans for approximately a week to support Operation Granite, an infantry sweep through the jungles of the Annamite Mountains near our encampment. Later in the month Battery G moved south to support Operation Cove. Personnel such as communicators, surveyors, drivers and fire direction center men from Headquarters and "H" and "T" Batteries were attached to the operational units for support.

Enemy mortars hit the Battalion's positions twice during the month but no casualties were sustained and gun crews reacted immediately to return fire.

Infantrymen and forward observers from the battalion reported excellent firing on all of the operations.

After a short leave, Lt. Col. Barker, along with his family, will report for duty with Headquarters, Fleet Marine Force Pacific in Hawaii.

4. Location. The TAOR, located in the Thua Thien Province, was bounded on the North by a line from ZC 156000 to ZC 110 000; on the West by a line from ZC 110000 to ZC 074986 along the Bach Ma road to ZC 055900; on the South by a line from ZC 005900 to ZC 160900; on the East by a line from ZC 160900 to ZC 160097 along a tributary of the Song Bu Lu (River) to ZC 156000.

7. Intelligence. Enemy presence within the area of Operation Cove was reported to consist of two main force battalions, a local force company and an engineer company. The composite available strength of these units was believed to be approaching 800 personnel.

During the operation the enemy utilized 60mm mortars to attack elements of the 1st Battalion 4th Marines. In addition, the artillery position received forty (40) 82mm mortar rounds. The pattern of enemy action seemed to have as its design the harassment and delay of our units. Sniper fire was received on several occasions by the units in the field and several sightings of enemy in groups of two (2) and three (3) were made.

The attack on the artillery position was believed to have been initiated from a position along the river bank ZD 150035. Several sampans in that vicinity were taken under attack by Marine fixed wing aircraft. Numerous fighting holes and bunkers were discovered within the area of operations.

The northeast monsoon was anticipated to be in effect during the operation, but the weather remained fair throughout the major portion of the time units were deployed.

8. Concept of Operation. Provide artillery support for operations in vicinity of Phu Loc (Vic ZD 085008) for search and destroy mission using 2 Battalions (-). One battalion in blocking position and one battalion will push Northwest in search of the enemy.

9. Mission. Provide fire support for 4th Marines to include close artillery support of troops, interdiction and destruction of enemy rear areas and active counter battery/mortar fires.

10. Execution

a. See enclosure (1) for daily chronology of significant events.

b. Survey. The survey for Operation Cove was conducted by the battalion survey team. The battery center was a map spot. The direction was scaled off the map using the map spotted battery center and the block house on hill 130, YD 117014. The survey/S-3 section provided security for the sweep team each morning.

11. Results. Total confirmed enemy KIA was 0 and the total probable KIA was 0

12. Communications-Electronics

a. Communications for Operation Cove presented a real challenge. The battalion was tasked with providing communication stations at Camp Evans, Phu Bai, and hill 130, South of Phu Loc.

b. The battalion provided communications equipment for three FSCC's and two FDC's.

c. A covered circuit was employed between all stations, on an "as required" basis.

d. Transmission and reception were much better than anticipated. Stations could communicate from Phu Loc to Camp Evans a distance of over 50 miles on a PRC-25 with a whip antenna.

e. Availability of handsets for the PRC-25 was the major problem encountered. They continue to be in short supply, and transmitter elements are unavailable for repair purposes. New handsets are on order.

f. Transmission security and proper communication procedure is essential at all echelons. Proper instruction and strict supervision is a must. This is a continuing problem with the constant turnover of personnel in Vietnam.

13. Supply

a. Class II requirements were filled by the Battalion Supply which is located at Phu Bai. Class I, III, IV, and V requests were screened and consolidated by the Battalion Logistics Chief who then directed the convoys to the appropriate areas to draw the supplies. This arrangement worked satisfactorily.

b. Although the forward units subsisted on MCI meals, supplementary foods were issued to the units. Excellent cooperation was received from the Division Food Services Officer. These supplementary items provided a good morale booster while adding to the nutritional value of the meals.

c. The artillery units initially carried a basic allowance plus two days of ammunition, two days of MCI and POL, and sufficient Class IV for the basic requirements. These amounts proved adequate



14. Commanders Analysis

a. Logistical support from the Phu Bai Combat Base could have been more efficiently accomplished if the using artillery units had received preauthorization to draw needed supplies. Originally, it was established that the S-4 Representative would make direct liaison with FLSG "A" for authorization to draw supplies but it was determined during the operation that this process was not as rapid as expected. It is recommended that future operations set up prearranged authorization with FLSG "A" to facilitate logistical support.

b. The tactical scheme of maneuver was such that the artillery was not notified of the exact time commencement of the hololift of the operation, until just prior to its beginning, hence the Fire Direction Center was not ready to fire until fifteen minutes after the heliborne arrival of the howitzers and troops.

It is recommended that where security of the scheme of maneuver of the artillery is of such essence that the battery occupies position at the commencement of troop operations, the artillery commander be advised in order that essential technical gunnery application procedures may be initiated in time to be employed at the outset of an operation.

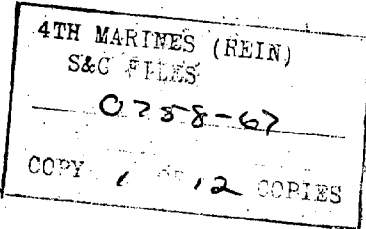

7. Intelligence. The weather was sunny and the temperatures ranged between 75 degrees to 85 degrees with little humidity. After a careful study of the objective area through current ISUMS, special area studies, agent reports, aerial recon photos, and local intelligence sources, a target list was drawn up to be fired as prep fires, H&I fires, and counter-mortar/rocket targets. Based on the timely passage of information by the battalion liaison officers to the firing batteries, the batteries were able to mass their fires most effectively on suspected targets as well as targets of opportunity.

8. Concept of Operation. 3rd Bn, 12th Marines, provided direct support to the 4th Marines search and destroy operation in the vicinity of Hill 674, concurrently providing general support for the 1st ARVN Division conducting a similar operation east of Hill 674.

9. Mission. 3rd Bn, 12th Marines, while continuing the present supporting missions, provided direct support and general support reinforcing fires for the 4th Marines and for the 1st ARVN Division forces conducting combat operations in the VC/NVA Base Area 114.

10. Execution

a. See Enclosure (1) for a daily chronology of significant events.

b. Survey. The Battalion Survey section conducted a position area survey for Operation Granite. A map spot was used for the starting coordinates. The starting azimuth was scaled off a map using the map spot and hill 674. The S-3 section/survey section provided security for the engineer sweep team each morning.

11. Results. Total confirmed enemy KIA was 11 and the total probable KIA was 5.

12. Communications-Electronics

a. Generally, communications for Operation Granite were good.

b. Some difficulty was encountered at the beginning of the operation due to improper siting of RC-292's, but this was rectified.

c. A manual retransmission team was inserted on Hill 674. This unit provided continuous communication to the forward position and to the tactical FDC at Camp Evans. The team relayed fire missions for units on the reverse side of Hill 674.

d. Wire to the forward position was cut by H&I's fired by our mortars. This was repaired in the morning by a wire team from battalion.

e. A radio relay team was used to back up all wire circuits. Minor difficulties were encountered due to a lack of backup generators for the equipment.

f. A KY-8 was set up at the forward position and at the battalion CP. This circuit worked very well.

13. Supply

a. Batteries initially displaced with;

(1) Basic allowance and two days of ammo.

(2) Two days of MCI rations.

(3) One day supply of water.

(4) Required barbed wire, engineer stakes and sandbags.

(5) Water, rations and required ammo were provided for the infantry security element. Supply support was adequate and no significant shortages existed. Resupply was accomplished by daily convoys utilizing organic vehicles.

b. Some maintenance problems were experienced. Proper gun pits and ammo storage areas could not be constructed because of a deadlined TD-15 tractor. 155mm Howitzers were deadlined at various times because of worn Obterator Plugs and spindles. Two 155mm Howitzer could not participate in the operation because they were deadlined for Recoil Systems.

At YD 505224 elements of 1/4 spotted NVA in bunkers and trenchlines. At 1425H the 1st Provisional 155mm Howitzer Battery expended 67 rounds of HE. Rounds on target was the surveillance reported for this mission.

At YD 505225 Batteries "A", "G" and the 1st Provisional 155mm Howitzer Battery expended 63 rounds of 155 HE and 204 rounds of 105 HE at NVA bunkers and trenchlines. Elements of 1/4 called this mission in at 2340H and gave outstanding effect on target as the surveillance.

Elements of 1/3 reported that they were receiving fire from YD 45812204. Battery "G" expended 2 rounds of WP and 28 rounds of HE at 0955H. Negative surveillance was reported for this mission.
