PART II

The month of May began with the 3d Battalion, 12th Marines continuing the three simultaneous missions of direct support of the 3d Marines on Operation Napoleon/Saline in the Cua Viet area, direct support for the defense of the Quang Tri Airfield Complex, and direct support for the 26th Marine Regiment on Operation Rice.

The S-2 and S-3 sections along with the necessary communications and operations personnel, were displaced 3 May to the 3d Marines Headquarters at Cua Viet. The S-2 and S-3 sections joined Command Group "A" which consisted of the Commanding Officer, the Battalion Liaison Officer with the necessary FSCC personnel and a tactical Fire Direction Center. It was during this period the battle for Dai Do was in progress.

It was felt the primary mission of the 3d Battalion, 12th Marines, that of direct support of the 3d Marine Regiment, would be better controlled by establishing a centralized FDC. The tactical FDC was transferred from the 3d Marines COC Bunker to the 3d Battalion, 12th Marines FDC Bunker. A tactical and technical FDC was organized. During the period of the battle for Dai Do, there were three 105 Howitzer batteries, one LVT H-6 Platoon, one 155 Howitzer battery consisting of two howitzers, one 4.2 battery, and one 155 Gun platoon which was general support-reinforcing to 3d Battalion, 12th Marines. All of these batteries were immediately responsive to the 3d Marine Regiment for Operation Napoleon/Saline.

The 3d Battalion, 12th Marines played a significant supporting arms role in the battle of Dai Do. During the course of the heavy fighting an additional 105 Howitzer battery, "D" Battery, the 3d of the 82d was airlifted into the Mai Xai Thi area YD 287672. The 3d Battalion, 12th Marines assumed operational control of "D" Battery on 10 May. "D" Battery was assigned the mission of direct support for the 3d of the 21st Infantry Battalion. Because of the distance between the battery and the Battalion FDC, "D" Battery maintained a decentralized technical FDC. The 3d Battalion, 12th Marines retained tactical control of the battery so that its fires could be effectively directed within the 3d Marine Regiment's AO. "D" Battery was chopped 17 May and airlifted to the South.

During the month of May the 3d Battalion, 12th Marines, in direct support of Operation Napoleon/Saline, expended 36,443 pounds which accounted for 340 confirmed enemy kills. Operation Rice which began 1 May and ended 17 May received 275 pounds fired in its support from the 3d Battalion, 12th Marines. During the period 18 May to 31 May the 3d Battalion, 12th Marines expended 1,491 rounds in general support-reinforcing for the 1st Air Cavalry Division. The 1st Air Cavalry Division is employed in Operation Jeb Stuart III.

The 1st Platoon of the 1st Armored Amphibian Company, located in the Cua Viet area rotated by echelon back to DaNang. They were replaced by the 3d Platoon of the 1st Armored Amphibian Company on 19 May. The move was accomplished so that the full fire power of the platoon was always available for fire missions.

On 3 May "A" Battery, 1st of the 40th was chopped to 1st Battalion, 13th Marines.

The 3d Battalion, 12th Marines was relieved on 7 May of its mission of direct support for the Defense of the Quang Tri Airfield Complex with the arrival of Headquarters Battery, 1st Battalion, 13th Marines from Khe Sanh. The 3d Battalion, 12th Marines continued to effect a smooth transition for the 1st Battalion, 13th Marines by augmenting the 1st Battalion, 13th Marines fires for the 26th Marines and the Quang Tri Complex.

On 17 May the direct support roles of 3d Battalion, 12th Marines changed. Operation Rice ended 17 May when the 26th Marines moved south to the Danang area. The 1st Air Cavalry Division moved into the vicinity of Operation Rice. The 3d Battalion, 12th Marines was assigned the role of general support-reinforcing 1st Air Cavalry Division in Operation Jeb Stuart III on 17 May.

On the same day two 155 Howitzers from the 2d Provisional 155 Howitzer Battery were chopped to the 1st Provisional 155 Howitzer Battery. The 1st Provisional 155 Howitzer Battery with four 155 Howitzers was chopped to 1st Battalion, 13th Marines. The 1st Battalion, 13th Marines with its organic "A" and "C" Batteries along with the 1st Provisional 155 Howitzer Battery were air lifted to the Danang area in order to provide artillery support for the 26th Marines.

The 18th of May "B" Battery, 1st Battalion, 13th Marines and "W" Battery, 1st Battalion, 13th Marines came under operational control of 3d Battalion, 12th Marines. The two batteries were utilized in the mission of direct support of the Defense of the Quang Tri Airfield Complex.

The 18th of May the Fire Direction Center in the Quang Tri Complex was organized once again as a technical and a tactical FDC for the direct support role of the Defense of the Quang Tri Airfield Complex. An FSCC team was organized to provide Fire Support Coordination in the Division Rear SOC Bunker for the Quang Tri area. Also on this day, a detachment of the 240th Field Artillery Group Counter Mortar Radar came under operational control of the 3d Battalion, 12th Marines.

On 27 May "H" Battery, 3d Battalion, 12th Marines came under operational control of the 3d Battalion, 12th Marines. Hotel Battery located in the C-1 area, is presently employed in the Battalion's direct support role of the 3d Marines in Operation Napoleon/Saline. The same day, "B" Battery, 1st Battalion, 13th Marines was chopped to 2d Battalion, 12th Marines.

Significant personnel changes occurred during the month of May. Major W.D. ISBELL joined the 3d Battalion, 12th Marines 15 May. He assumed the duties as the Battalion Executive Officer on 24 May. Major ISBELL replaced Major D.E. VOWELL who rotated to CONUS. 1stLt R.W. SHUGART was assigned as the Battalion Intelligence Officer vice 1stLt C.P. JAMESON who returned to CONUS. Capt R.G. HOLLIDAY became the S-3 on 8 May replacing Capt S.B. GRIMES who returned to CONUS. 1stLt J.H. MURPHY stepped up to the position of the Assistant S-3. Capt F.H. WITTLE relieved Major J.C. DEEMER as the Battalion Liaison Officer on 24 May. Major DEEMER also rotated to CONUS.

5. Equipment. The TD-15 that was deadlined has been given code "H" letter. Thirteen (13) of the battalion's prime movers are deadlined: 12 for 3d echelon repairs. The battalion's maintenance situation continues to stay at a good level. Throughout the month constant checks by the cognizant battalion staff members and backing by the battery commanders continues to strengthen the 1st echelon maintenance program.

General Logistics. General logistics support remains T/E combat essential equipment shortages continue to be a key problem area. Communications equipment are the most urgently needed items. Appropriate supply action has been initiated in all cases.

The battalion continues to operate in two main areas: Quang Tri and Cua Viet. The main logistics effort is located in Quang Tri with mainly ammunition being processed and handled for the opcon units in Cua Viet. The battalion logistics chief is handling the Cua Viet section with the S-4 controlling the over-all operation in Quang Tri. Lack of river and air transportation at times hinders a totally smooth running operation.

The battalion still has adcon of G-3-12 located at Khe Sanh and the 1st Provisional 155 Howitzer Battery now operating in the Danang area. A regular courier service is established between both units and normal supplies are constantly being fed to the units.

a. Food Services. The battalion has served 90% "A" rations, 7% "B" rations, and 3% "C" rations during the reporting period. The battalion was operating two messhalls at the end of this month. A night bakery has been established in the Hq Battery galley producing pastry items daily for the entire battalion.

Fresh foods have increased in their availability at Division Food Services.

b. Medical. There were 308 out patients treated by BAS during the month. The battalion had 20 WIA's and 1 KIA during the month.

7. Administration. There was no Commanding Officer's Non-Judicial Punishment awarded during the month of May. There were no courts-martial.

8. Personnel. The average strength for the month was 88% of the manning level. During the month the battalion joined 4 Marine officers and 20 enlisted Marines. There were 5 officers rotated or transferred. There were 21 enlisted Marines either transferred or rotated.

Intelligence

a. Enemy Activity. In early May Allied units engaged elements of two NVA Divisions in the Napolean/Saline Area. A number of missions could account for the presence of this large enemy force, the more probable being the interdiction of the Cua Viet River, and reinforcement for an attack on Dong Ha. The enemy was decisively defeated and driven north. However, numerous sightings of small groups of enemy continuo, and fighting in this area continues.

Camp Kistler continued to receive sporadic enemy artillery fire from positions north of the Ben Hai River.

b. Enemy Intentions. In the northernmost part of I Corps, limited probes in force by NVA elements are expected to continue. The mission of these actions will be to tie down Allied forces by maintaining contact, yet refusing to be drawn into a major engagement in circumstances unfavorable to them. Uppermost in the mind of the enemy is the demonstration of his ability to inflict casualties on American units, thus enhancing his position for any peace negotiations.

In the Quang Tri-Ai Tu Area, the enemy hopes to force allied forces into a defensive role around Allied installations and heavily populated areas, thereby taking them away from the protection of the harvesting of rice. Interdiction of Allied installations by supporting arms can also be expected.

c. Administration. The initial counter-mortar/counter rocket plan was drawn up for Camp Kistler.

10. Communications-Electronics

a. During the month of May, the battalion supported both the Third Marine Division Rear located at Quang-Tri and the Third Marine Regiment located at Cua Viet.

b. The Battalion displaced its FDC from Quang-Tri to its forward position at Cua Viet. FDC operations in Quang-Tri area were turned over to India Battery. Transitions were effected smoothly and professionally.

EARLY FLOWER "B" (FO for B 1/40) requested fire on NVA in open at YD 267704. At 1040H the LVT H-6 Platoon expended 2 rounds of WP and 22 rounds of HE. Four (4) KIA's (confirmed) was the surveillance.

Elements of 3/21 requested fire on NVA in open at YD 268704. At 1725H "C" Battery expended 3 rounds of HC Smk and 77 rounds of HE. The surveillance of this mission was negative.

At 1645H elements of 2/4 reported that they were receiving automatic weapons fire from YD 253631. "I" Battery 3/12 expended 1 round of WP and 517 rounds of HE which resulted in negative surveillance.

"I" Battery 3/12 at 0055H expended 105 rounds of HE on NVA in open. Elements of 2/4 called this mission in at YD 25496299. Negative surveillance was reported for this mission.
