PART II

NARRATIVE SUMMARY1. General Overview of all Activities.

During the month of July the 3d Battalion, 12th Marines continued to provide direct support artillery for the 4th Marine Regiment. The battalion operated from Vandegrift Combat Base, Calu, and Fire Support Bases Russell, Sandy and Gates.

2. Mission Assigned.

From 1 July through 31 July 1969 the 3d Battalion, 12th Marines continued in its assigned mission of direct support of the 4th Marine Regiment.

3. Operations Summary.

Operation Herkimer Mountain continued until 1800 on 16 July. At that time Operation Herkimer Mountain terminated and Operation Georgia Tar commenced. On 3 July Operation Arlington Canyon commenced and continued throughout the month. To provide adequate support to the 4th Marine Regiment one additional battery was assigned OPCON to 3/12 during the month. This battery was Battery "F", 2nd Battalion, 12th Marines at Calu, 9-23 July 1969.

A Naval Gunfire Team from 3/12 manned an observation post at Con Thien from from 15 through 22 July 1969.

4. Results of Operation.

During the month of July the 3d Battalion, 12th Marines was credited with 6 confirmed NVA KIA. The battalion suffered 0 KIA's, 0 MIA's and 0 WIA's. The battalion was also credited with 41 bunkers destroyed, 35 secondary explosions, and 2 enemy pack animals killed.

5. Intelligence Summary.

Contact during the month was limited to small unit engagements and no incidents of sustained contact were noted. Vandegrift Combat Base was subject to light, sporadic rocket attacks during the first week of July. Damage was light and there were no further incidents

after the first week. All rockets came from the west-northwest. Heavy counter rocket fire was fired on all known and suspected positions. There were 2 incidents of mortar attacks on VCB in mid July. All rounds landed well outside the perimeter. Artillery and fixed wing were brought to bear on the enemy position, after which infantry units were sent into the area. No further incidents occurred.

6. Logistics.

The motor transport situation remained satisfactory throughout the month of July, with a 12% deadline rate at the end of the reporting period. Nine of the thirteen vehicles deadlined required second echelon repair.

The ordnance situation was satisfactory, with no major problem areas in the evacuation and repair of ordnance equipment.

The overall shortages of combat essential equipment is approximately 11%. These shortages have not severely affected the battalion's operating capabilities during reporting period and supply action on all shortages is pending with valid status held. The overall type II supply situation is satisfactory with minor problem areas.

Resupply of the fire bases continued from the Vandegrift LSA with no major problem areas for the month of July. Approximately 37,000 rounds of 105mm and 2,600 rounds of 155mm ammunition were helilifted to the fire support bases while the mortar battery continued to be resupplied from the Quang Tri ASP.

The battalion messhalls at Quang Tri and Vandegrift fed approximately 70% "A" rations and 30% "B" rations. The messhall at Vandegrift continued to prepare hot meals for the fire support bases and send them out daily, tactical situation and weather permitting.

7. Communication - Electronics.

The major effort during the month of July consisted of maintaining all fire direction and conduct of fire nets required by the battalion FDC. Fire direction nets were maintained between Vandegrift Combat Base and firing batteries at Vandegrift, Fire Support Bases: Sandy (renamed Scotch), Russell, Cates and Calu. Conduct of fire nets were maintained for all supported units and the FSCC of the 4th Marines.

All nets were VHF/FM. Directional antennas (AS-2236) or elevated ground plane antennas (RC-292) were used, depending on the specific requirements of each net. Regimental FSCC circuits were maintained by double remoting FDC radios. During the 4th Marines move to their

new CP, these radios were triple remoted to effect displacement with excellent results.

Administrative traffic was passed from and to all units by radio through the Vandegrift/Quang Tri Command Net on VHF/FM radio.

8. Personnel and Administration.

During the month of July the battalion strength averaged 99.7% of the manning level. Nine Marine Officers and seventy Marine enlisted joined the battalion. Three Marine Officers and eighty four Marine enlisted were rotated or transferred.

There were ten Commanding Officer's Non-judicial Punishments awarded for violation of Articles 134, 92, 113 and 121.

9. Training.

During the month, training was carried out in both general military and Vietnam oriented subjects. Training in compliance with COATIP requirements was also accomplished. A major part of the training accomplished was OJT.

At 0551H on 2 July Battery "H", 3/12 fired 60 rounds of shell HE on grid XD924627. The nature of target was a prep fire and the surveillance was 1 secondary explosion.

At 0902H on 2 July Battery "K", 4/12 fired 8 rounds of shell HE on grid XD826638. The nature of target was a bunker complex. The surveillance was 1 secondary explosion and 1 bunker destroyed.

At 1920H on 2 July Battery "H", 3/12 fired 93 rounds of shell HE on grid XD947648. The nature of target was a .50 cal position/bunkers/trails. The surveillance was 5 secondary explosions.

At 2204H on 2 July Battery "G", 3/12 fired 97 rounds of shell HE on grid YD011514. The nature of target was Recon Team Oak Tree in contact. Negative surveillance was given.

At 0001H on 3 July Operation Arlington Canyon began.

At 1645H on 3 July Battery "H", 3/12 fired 78 rounds of shell HE and 36 rounds of shell "firecracker" on active mortars at grid XD932654. The surveillance was mortars silenced. The mission was fired in support of 2/4.

At 1740H on 4 July Battery "H", 3/12 fired 70 rounds of shell HE on grid XD865625. The nature of target was 15 NVA. Negative surveillance was given. The mission was fired in support of 2/4.

At 1208H on 5 July Platoon "A" of the 1st 8" Battery fired 20 rounds of shell HE on grid XD896675. The nature of the target

was enemy bunkers. The surveillance was 3 bunkers destroyed. The mission was fired in the DMZ and was observed by an AO.

At 0724H on 6 July Battery "H", 3/12 and Battery "K", 4/12 fired 398 rounds of shell HE on grid XD920616. The nature of target was active small arms fire. There was negative surveillance given. The mission was fired in support of 2/4.

At 1102H on 7 July Battery "H", 3/12 fired 116 rounds of shell HE on active mortars at grid XD930649. The surveillance was mortars silenced. The mission was fired in support of 2/4.

At 0830H on 8 July Battery "K", 4/12 fired 12 rounds of shell HE on grid XD932654. The nature of target was a .50 cal position and heavy trail activity. The surveillance was 2 large secondary explosions.

At 1609H on 8 July Platoon "A" of the 1st 8" Battery fired 24 rounds of shell HE on grid XD893630. The nature of target was bunkers and fighting holes. The surveillance was 9 bunkers destroyed and 1 secondary explosion.

At 1700H on 9 July the 3d Battalion, 12th Marines assumed operational control of Battery "F", 2nd Battalion, 12th Marines at Caiu.

At 1400H on 10 July Battery "G", 3/12 displaced from VCB to FSB Sandy.

At 1403H on 10 July Battery "K", 4/12, Battery "I", 3/12 and the 1st Provisional 155mm Battery, 3/12 fired a total of 413 rounds of shell HE on grid XD908472. The nature of target was NVA surrounding the Recon Team Oak Tree. The mission was adjusted by an AO and the surveillance was 3 NVA KIA confirmed.

At 1121H on 11 July Battery "H", 3/12 fired 50 rounds of shell HE on grid XD840540. The nature of target was a suspected enemy infiltration route. The surveillance was 7 secondary explosions.

At 1340H on 11 July Battery "I", 3/12 fired 78 rounds of shell HE on grid XD887512. The nature of target was active enemy small arms fire. The surveillance was small arms fire ceased.

At 1556H on 12 July Battery "H", 3/12 fired 18 rounds of shell

HE on bunkers at grid XD897646. The surveillance was 1 bunker destroyed. This mission was fired into the DMZ.

At 1725H on 12 July Battery "I", 3/12 fired 48 rounds of shell HE on a bunker complex at grid XD896485. The surveillance was 2 bunkers destroyed.

At 0730H on 13 July Battery "I", 3/12, Platoon "C" of the 5th 175mm Gun Battery and the 1st 155mm Provisional Battery, 3/12 fired a total of 413 rounds of shell mixed on moving lights on the Khe Sanh airstrip at grid XD853418. The surveillance was 15 small fires, 5 large fires and 10 secondary explosions.

At 2144H on 15 July the 1st 155mm Provisional Battery fired 40 rounds of shell HE on grid XD854417. The nature of target was moving lights on the Khe Sanh airstrip. The surveillance was 4 secondary explosions.

At 0829H on 17 July Battery "H", 3/12 fired 92 rounds of shell HE on 3 NVA at grid XD894620. The mission was fired in support of 2/4 and there was negative surveillance given.

At 0518H on 19 July Battery "F", 2/12 fired 30 rounds of shell HE on grid YD069430. The nature of target was a prep fire. It was fired in support of 3/9. The surveillance was 2 NVA KIA confirmed.

At 1350H on 20 July Battery "H", 3/12 fired 56 rounds of shell HE on grid XD837604. The nature of target was trails/bunkers. The surveillance was 3 bunkers destroyed.

At 1852H on 20 July Battery "I", 3/12 along with the 1st Provisional 155mm Howitzer Battery fired a total of 832 rounds of shell HE on 15-45 NVA in the open at grid XD878362. The mission was fired in support of the Recon Team Little Gull. The surveillance was limited to screams coming from the area since Little Gull's commander would not let them go into the area for surveillance.

At 1057H on 23 July the 1st Provisional 155mm Howitzer Battery fired 40 rounds of shell HE on an NVA base camp at grid XD853358. The mission was fired in support of the Recon Team Garden Valley. There was negative surveillance.

At 1300H on 23 July Battery "F", 2/12 stands down from combat. Ref: CG 3d Mar Div msg. 191420Z Jul 69.

At 1855H on 25 July Battery "G", 3/12 fired 8 rounds of shell HE on night defensive fire at grid YD08004053. The surveillance was 2 water buffalo confirmed. The mission was fired in support of the 2nd ARVN.

At 1301H on 28 July Battery "H", 3/12 fired 50 rounds of shell HE on grid XD897620. The nature of target was 1 NVA in the open. There was negative surveillance given.

At 1446H on 29 July Battery "H", 3/12 and Battery "K", 4/12 fired a total of 189 rounds of shell HE on 3 NVA in the open at grid XD900638. The surveillance was excellent coverage of target.

At 1930H on 30 July the 1st Provisional 155mm Battery fired 17 rounds of shell HE on 2 NVA moving west at grid XD842491. The mission was fired for 3/4 and the surveillance was 2 probable KIA's.
