## PART II

NARRATIVE SUMMARY1. General Overview of all Activities.

During the month of August the 3d Battalion, 12th Marines continued to provide direct support artillery for the 4th Marine Regiment. The battalion operated out of Vandegrift Combat Base, Calu, and Fire Support Bases Russell and Cates.

2. Mission Assigned.

From 1 August through 31 August 1969 the 3d Battalion, 12th Marines continued in its assigned mission of direct support of the 4th Marine Regiment.

3. Operations Summary.

Operations Georgia Tar and Arlington Canyon continued through the month of August. A realignment of the 4th Marines AD necessitated by the redeployment of the 9th Marines to Okinawa, required that "G" Battery, 3/12 be displaced from Calu to Vandegrift Combat Base on 15 August 1969.

A Naval Gunfire Team from 3d Battalion, 12th Marines manned an observation post at Gio Linh 19 through 20 August. During this time the team observed 17 missions for a total of 289 rounds.

4. Results of Operation.

During the month of August the 3d Battalion, 12th Marines was credited with 7 NVA KIA confirmed. The battalion suffered 0 KIA's, 0 MIA's and 2 WIA's. The battalion was also credited with 61 bunkers destroyed, 45 secondary explosions and 1 mortar position destroyed.

5. Intelligence Summary.

Contact during the month was limited to small unit engagements and no incidents of sustained contact were experienced. Vandegrift Combat Base was subject to 4 sporadic rocket attacks averaging 6 - 10 rockets per attack. Damage was light with 1 jeep destroyed, 1 damaged and 20 WIA's. All rockets came from the west-northwest. Heavy counter rocket fire was fired on all known and suspected positions.

Weather for the month of August was generally hot and dry with only sporadic periods of rain. These periods were neither detrimental to the logistic support of the fire support bases nor to the air or ground observers.

#### 6. Logistics.

The motor transport situation remained satisfactory throughout the month of August, with a 10% deadline rate at the end of the reporting period. One of the eleven vehicles deadlined required second echelon maintenance.

The overall shortages of combat essential equipment is approximately 11%. These shortages have not severely affected the battalion's operating capabilities during the reporting period and supply action on all shortages is pending with valid status held. The overall type II supply situation is satisfactory with minor problem areas.

Resupply of the fire bases from Vandegrift LSA continued with no major problem areas for the month of August.

The displacement of the battalion rear to Camp Romanelli was accomplished with no notable problems. The new position proved adequate in areas of billeting, facilities and bunkers. Extensive improvements have been made on the defensive perimeter and are being continued.

The battalion messhall at Vandegrift Combat Base served approximately 70% "A" rations and 30% "B" rations.

Personnel of the battalion messhall rear were placed on duty in the 4th Battalion, 12th Marines messhall at Camp Romanelli.

The Vandegrift messhall continued to prepare hot meals for the fire support bases and to send them out daily, weather and tactical situation permitting.

#### 7. Communication - Electronics.

The major effort during the month of August consisted of maintaining all fire direction and conduct of fire nets required by the battalion FDC. Fire direction nets were maintained between Vandegrift Combat Base and firing batteries at Vandegrift, Calu and Fire Support Bases: Russell and Cates. Conduct of fire nets were maintained for all supported units and the FSCC of the 4th Marines.

All nets were VHF/FM. Directional antennas (M-1236) or elevated ground plane antennas (RC-292) were used, depending on the specific requirements of each net. Regimental PSCC circuits were maintained by double remoting EDC radars.

Administrative traffic was passed from and to all units by radio through the Vandegrift/Dong Ha Command Net on VHF/FM radio.

**8. Personnel and Administration.**

During the month of August the battalion strength averaged 98% of the manning level. Eighty-four Marine enlisted and one Navy Officer joined the battalion. Three Marine Officers, seventy-six Marine enlisted, one Navy Officer and three Navy enlisted were rotated or transferred.

There were four Commanding Officer's Non-judicial Punishments awarded for violation of Articles 88, 113 and 134 of the UCMJ.

**9. Training.**

During the month, training was carried out in both general military and Vietnam oriented subjects. Training in compliance with COATIP requirements was also accomplished. A major part of the training accomplished was QJT.
