CONFIDENTIAL1 August

Maj. R. W. HEESCH arrived and assumed the duties of Battalion S-3, relieving Capt. K. G. PATTERSON.

The Howtar Battery displaced to a forward position at (YD 883134) and conducted a service practice shoot.

2 August

The Howtar Battery displaced to (YD 883134) and conducted a service practice shoot.

4 August

At 0255 H, I Battery fired six rounds of shell illuminating upon the request of the village chief of PHU BAI village. Good effect on target.

7 August

At 0230 H, I Battery fired two rounds of illumination for popular forces. Good effect was reported.

The Howtar Battery displaced to FP #1 (YD 88134), where they conducted a service practice.

8 August

M Battery displaced to (YD 877123) and the Howtar Battery displaced to (YD 875122) in conduct of service practice missions.

9 August

The Howtar Battery displaced to (YD 883134) and conducted a service practice shoot.

10 August

Counter mortar drills were held between 2200H, and 2330 H. The object of these drills, initiated by 3d Bn, 4th Marines FSCC, is to test the reaction time of 4th Battalion's FDC and cannon batteries in bringing fire to bear on hostile mortars. Results were satisfactory for all units.

4th Battalion assumed control of the OP's on Hill 225 (YD 848086), and 180 (YD 855133). A service practice involving both batteries was conducted.

16 August

I Battery displaced to FP #1 (YD 875122) and conducted a service practice shoot.

17 August

I Battery fired smoke rounds on concentrations for the defense of the village of AN NONG (YD 928105). The rounds were adjusted by the village chief and Capt. D. N. HARMAN, CO of I Battery. Six concentrations were adjusted and are on call for the village chief.

CONFIDENTIAL20 August

At 2020 H, ARVN requested fire on a VC Company at (YD 863255). Ten rounds of HE and two rounds of illumination were fired by M Battery. Good effect was reported.

At 1830 H, I Battery fired 24 rounds of WP on VC in a hut at (YD 789 106). Effect was reported to be on target by the FO with Recon, who had requested the fire.

23 August

The FO with "C" Recon requested fire on ten VC in the open, coordinates (YD 799073), at 0725 H. M Battery fired 17 rounds and excellent effect on target was reported by the FO.

I Battery was displaced to FP #6 (YD 887123) and M Battery displaced two guns to (YD 875122) in support of the 3d Battalion, 4th Marines' operation Jungle Feet. Although no contact was made on the operation, the 4th Battalion expended 369 rounds in establishing a barrier of fire.

28 August

The FO with L Company, 3/4, requested fire on VC in the open at (YD 824075) at 0730 H. Twenty-four rounds of HE were fired by I Battery and good effect was reported on the target.

The base defense fire plan and the counter mortar plan were published by the battalion.

SUMMARY

During the month of August, the battalion expended 4727 rounds in support of the 3d Battalion, 4th Marines. 3028 rounds were fired on 292 area missions, 1430 rounds were fired on 855 H & I missions, and 269 rounds were expended on 17 registrations.
