## PART II

### Narrative Summary

At 312400H January 1967 the 107mm Mortar Battery, 2d Battalion, 12th Marines was chopped to BLT 1/3. As of the first of February the 4th Battalion was exercising operational control of E/2/12, C/1/13, the 1st 155mm Gun Btry, the 1st Provisional 155 Howitzer Battery (towed) and the 2d Provisional 155 Howitzer Battery (towed). Administrative control was exercised over E/2/12, C/1/13, K/4/12, and M/4/12. The 1st and 2d Provisional 155 Howitzer Batteries administratively functioned as detachments of Headquarters Battery, 4th Battalion.

On 5 February the Battalion assumed OPCON/ADCON of D/2/12 and the 107mm Mortar Battery, 1/12. These batteries had been chopped from BLT 1/9.

On 10 February the Battalion assumed ADCON of the 1st 155 Gun Battery and as of this date exercised both ADCON and OPCON of this Battery.

On the morning of 13 February the 107mm Mortar Battery 1/12 displaced to the DONG HA Area and was chopped ADCON/OPCON to 1/12 effective 131500H Feb 67. At 130000H C/1/13 was chopped OPCON to 3/12 and, concurrently, the mission of the 2d Provisional Battery became GS/Reinforcing 3/12.

In preparation for operation CHINOOK II D/2/12 was chopped ADCON/OPCON to 3/12 and displaced to the CHINOOK Area of Operations on 15 February. Also on this date C/1/13 was chopped ADCON to 3/12.

On the morning of 16 February the four 155 howitzers (towed) of the 2d Provisional Battery displaced from PK-17 to the CHINOOK Area. The platoon of 8" howitzers attached to the 2d Provisional Battery remained at PK-17 (YD 645279). As Operation CHINOOK II commenced on 17 February 3/12 exercised control of C/1/13 and D/2/12 and was reinforced by the 2d Provisional 155 Howitzer Battery.

As the 4th Battalion continued to function as senior artillery headquarters in the PHU BAI TAOR. Batteries under operational control of the battalion were E/2/12, the 1st 155 Gun Battery, and the 1st and 2d Provisional 155 Howitzer Batteries.

## e. New techniques employed.

This Battalion has installed a prototype modification to the 155mm Howitzer (towed) to permit rapid shifting and enhance the 360 degree capability of the weapon. Test and evaluation is currently underway.

## f. Logistics.

1. General - On 5 February, this organization assumed ADCON of 107mm Mortar Battery 1/12 and D/2/12. ADCON of 107mm Mortar Battery 1/12 was relinquished 13 February 1967. ADCON of D/2/12 and C/1/13 was chopped to 3d Battalion, 12th Marines on 15 February 1967. On 10 February, this organization assumed ADCON of the 1st 155mm Gun Battery. Currently, 4/12 has ADCON of five medium artillery batteries; K/4/12, M/4/12, 1st 155mm Gun Battery, and 1st and 2d Provisional Detachments; one light artillery battery (E/2/12) and Headquarters Battery 4/12.

2. Supply - The overall supply situation is satisfactory. Items of equipment on requisition for units of this organization include:

- (1) Three - Generator Set PU-482M
- (2) One - Generator Set PU-348 A/G
- (3) Four - Tractor, Full Tracked, TD-15
- (4) Three - Truck, Cargo, 2 1/2 Ton M-35
- (5) Two - Truck, Cargo, 3/4 Ton M-37

3. Maintenance - Six month maintenance has been completed on the 155mm Towed Howitzers. Two howitzers are being utilized as float weapons to back up the two 4-gun provisional batteries. Maintenance of the 155 Towed Howitzer has improved during the month of February. The overall deadline rate for ordnance is 5%.

4. Food Services - Headquarters 4/12 and 1st Provisional 155mm Howitzer Detachment messed at 3d Reconnaissance Battalion Mess Hall. The 2d Provisional 155mm Howitzer Detachment, E/2/12, K/4/12, and M/4/12 are operating their own messes. Expected completion date of Hq/4/12 Mess Hall is 15 March 1967.

5. Cantonment - Cantonment for the Artillery Headquarters at PHU BAI has been approved. The Artillery cantonment will consist of 8 1/2-16' x 32' units, eight burn-barrel heads and three 16' x 32' shower units. Twenty-four units were constructed during February. Building will commence in the area occupied by E/2/12 when the Headquarters Area is complete.

6. Bunkers - request for 43 bunkers has been approved by Division Engineers. Three standard 18' observation towers for perimeter security have been requested. Both orders are pending on availability of material.

7. Water - All batteries transport water to their positions. The Division Water Point has been relocated in the immediate vicinity of the 6th Cantonment and is to become operational during March.

g. Civic Action.

One officer attended a two day seminar on Personal Response during February. A Personal Response Contact Team is scheduled to visit all batteries in March.

h. Administration.

This Battalion currently has ADCON of E/2/12, K/4/12, M/4/12, Hq/4/12, and the 1st 155 Gun Battery. The 1st and 2d Provisional Batteries function as detachments of Hq Btry/4/12.

031100H - 1st 155 Gun Btry sentry at main gate reported receiving 1 rd sniper fire (YD 895126). Round came from tree line south of the battery's position. No action was taken.

041345H - 1st Prov 155 How Btry supported Recon Patrol NIGHT STICKER #2 from 290935 to 041345H. 3 missions were fired resulting in 2 KIA (Conf), 4 KIA (Prob); 26 HE, 10 WP.

041500H - 2d Prov 155 How Btry supported Recon Patrol NETTLERASH #1 from 290800 to 041500H. During this period 20 missions were fired resulting in 1 KIA (Conf), 10 KIA (Prob), 5 WIA (Conf), and 2 WIA (Prob). 351 rounds were expended.
