Narrative Summary

As of the first of September, the 4th Battalion was exercising operational control of B/1/13, L(-)/4/12 and the 1st 155mm Gun Battery (-)(Rein). Administrative control was exercised over B/1/13, K/4/13, L/4/12 and the 1st 155mm Gun Battery.

On 1 September, the PHU BAI Vital Area received approximately 76 incoming 82mm mortar rounds. All three batteries under the operational control of this Battalion returned counter-mortar fires. The attack originated from grid YD 883111 and subsequent surveillance credited this Battalion with 5 KIA(C) and 7 KIA (P). The Battalion sustained 12 minor WIA and slight damage to two buildings.

Operational control of the 2d Platoon, L/4/12 was returned to this Battalion from 1st FAG on 10 September.

A platoon of the 1st 155mm Gun Battery was displaced to GIA LE (YD 829151) on 9 September to support the withdrawal of forces from operation CUMBERLAND. The platoon remained at GIA LE for the rest of the month to provide support for the 3d Recon Battalion and to support the forces protecting the class 60 bridge and Rock Crusher at YD 756135. In addition, a liaison team was sent to NAM HOA (YD 762129) on 15 September to assist in coordinating supporting fires from the ARVN 105mm Battery (2 guns) located there.

On 14 September, OPCON of the 3d Platoon, L/4/12 was chopped to this Battalion from G/4/12. This brought all six of L/4/12's guns to their primary position at PHU BAI (YD 888128) for the first time since 24 June.

ADCON of M/4/12 was returned to this Battalion from 1/12 on 13 September.

September was marked by intensive preparation for the forthcoming monsoon season and continued emphasis on improvement of defenses. New fighting holes were dug, sandbags were replaced, and the wire along the perimeter was replaced, repaired, and reinforced. More effective coordination of defenses with adjacent units was effected along the Battalion's portion of the perimeter.

As the month of September closed, the 4th Battalion continued to function as the senior artillery headquarters in the PHU BAI TAOR. B/1/13, L/4/12 and the 1st 155mm Gun Battery remained under the operational control of the battalion.

e. Logistics

(1) Logistical Situation. Currently, 4/12 has ADCON of four medium artillery batteries; K/4/13, L/4/12, M/4/12, 1st 155 Gun Btry, one light artillery; B/1/13, and Headquarters Battery 4/12. 4/12 assumed ADCON of M/4/12 during the last reporting period.

(2) Supply. The overall supply situation is satisfactory. Major items of equipment on requisition for this organization include:

- (a) One - Generator Set PU-482/M
- (b) One - Generator Set PU-348/G
- (c) One - Generator Set PE-214
- (d) One - Trk, Cargo, 3/4 Ton, M-37
- (e) Two - Trk, Utility, M422

(3) Food Services. The 4/12 Mess Hall provides messing facilities for Headquarters Battery, B/1/13, L/4/12, 3/12 (Rear), and 1st Field Artillery Group.

(4) Cantonment. Construction of access road from Headquarters Battery 4/12 to Btry "L" 4/12 is scheduled for completion by 20 October 1967. Construction of the concrete ramp for the Butler Building in Headquarters 4/12 Command Post Area has not started.

(5) Water. All batteries truck water to their postitions.

(6) Motor Transport. Motor Transport 1st and 2d echelon maintenance is satisfactory. Third echelon maintenance is poor due to the shortage of repair parts at FLSG "A".

(7) Artillery Maintenance. Artillery maintenance will not support operational objectives due to the shortage of repair parts.

(8) Emarkation. All batteries are submitting changes in their embarkation data to this battalion monthly.

(9) Civic Action. During the month of September, work continued in the market place to put on a roof and a cement floor. The villagers are very enthusiastic about the project and it is a true community effort.

Capt J.P. ATHERTON relieved Capt C.M. DAVIS as Battalion Civic Action Officer on 4 September and established liaison with the village chief.

On 17 and 30 September, the villagers were transported to PHU BAI to visit, repair, and remove graves. This action was well received by the older villagers.

Weekly MED-CAPS continued to be held and a total of 750 Vietnamese were treated.
