## PART II

## NARRATIVE SUMMARY

July was an exceptionally active month for 4/12. Generally, the battalion was again reconstituted into a single tactical unit and employed in the classical role of general support artillery. Having four full 155mm howitzer batteries under single command was a new experience for artillery in the 3d Marine Division, and the concept, working well, has been amplified and given further employment.

July started with the grouping under a single command the batteries "K", "L", and "M" of the 4th Battalion, 12th Regiment, and Battery "K" of the 4th Battalion, 13th Regiment for a special operation of six days duration (2-7 July), OPERATION THOR (Phase I), necessitating the deployment of the Battalion (+) to forward positions along the TRACE, fronting the DMZ and North Vietnam. The objective of this operation which combined the capabilities of 175mm guns, and 155mm and 8" howitzers under the single command of the 108th Artillery Group (U.S.A.) was the destruction/neutralization of enemy field and anti-aircraft artillery within the DMZ and North Vietnam. This mission was accomplished in a satisfactory manner.

Upon completion of OPERATION THOR (Phase I), K/4/12 and K/4/13 were detached from 4/12 for a period of approximately six days until preparations for OPERATION LANCASTER II JULY began, when both batteries were again assigned OPCON to 4/12. At this time, also, the 2nd Platoon, 1st 8" Howitzer Battery was placed under tactical control of 4/12. During the last week of July, the 2nd Platoon, 5th 155mm Gun Battery was similarly placed under tactical control of 4/12.

Most significantly in the month of July, then, has been the reversion to a concept of using general support artillery in a general support role, rather than attaching separate 155mm howitzer batteries to the various direct support artillery battalions. Of only slightly lesser importance has been the frequent displacements of the various batteries of 4/12, thus capitalizing on the self-propelled capabilities of the M109 howitzer and enhancing the opportunity to mass the fires of two or more batteries.

Units of 4/12 displaced during the month as follows:

K/4/12 (ADCON to 9th MAB) began the month at CAMP CARROLL, OPCON to 1/12, but was placed under OPCON of 4/12 and displaced to CON THIEU on 2 July for OPERATION THOR (Phase I). Upon completion of the operation, K/4/12 returned to CAMP CARROLL on 8 July and reverted to OPCON of 1/12. As preparations for OPERATION LANCASTER II JULY began, K/4/12

was again placed OPCON to 4/12 on 15 July. One platoon of the battery displaced to the ROCKPILE on 26 July, and returned from the ROCKPILE on 30 July. K/4/12 displaced as a battery to MAI LOC on 31 July, in preparation for OPERATION CANTON II.

L/ 4/12 reverted from OPCON to TASK FORCE HOTEL at LZ HAWK to OPCON to 4/12 and returned to DONG HA on 1 July. On 2 July, L/4/12 displaced to A-3 for OPERATION THOR (Phase I) and returned to DONG HA on 8 July, leaving one platoon at Die Marker site C-1. An additional platoon of L/4/12 displaced from DONG HA to C-1 on 27 July.

M/4/12, throughout the month ADCON and OPCON to 4/12 initially had one platoon at C-1 and two platoons at DONG HA. The battery displaced in its entirety to GIO LINH on 2 July for OPERATION THOR (Phase I), and upon completion of the operation, returned to DONG HA. In anticipation of OPERATION LANCASTER II JULY, three howitzers of M/4/12 displaced to CAMP CARROLL and three howitzers displaced to the ROCKPILE on 14 July. On 23 July, the three howitzers at CAMP CARROLL displaced to the ROCKPILE, putting all of M/4/12 in one location. As the month ended, M/4/12 was preparing to move into a selected position at CA LU to fire in support of OPERATION CANTON II.

B/1/13 (ADCON to 4/12, OPCON to 2/12) began the month at Die Marker site C-2, displaced to Die Marker site C-3, returned to C-2, then moved to QUANG TRI in preparation to going afloat as part of the SLP.

K/4/13 began the month at Die Marker site C-2, (ADCON to 4/12 and OPCON to 2/12). K/4/13 became OPCON to 4/12 on 2 July upon displacing to CON THIEU for OPERATION THOR (Phase I). Upon completion of the operation, on 8 July K/4/13 returned to C-2 and reverted to OPCON to 2/12. On 10 July, in anticipation of OPERATION LANCASTER II JULY, K/4/13 again became OPCON to 4/12. Throughout the remainder of the month, K/4/13 remained at C-2, under OPCON of 4/12.

2nd Platoon, 1st 8" Howitzer Battery, located at the ROCKPILE, was assigned the mission of reinforcing 4/12 on 14 July; the status of the platoon remained unchanged throughout the remainder of the month.

2nd Platoon, 5th 155mm Gun Battery was assigned the mission of reinforcing 4/12 on 26 July; the platoon remained at CAMP CARROLL in this status until the end of the month.

7. EQUIPMENT

The major items of equipment received during the month of July were 6 M54A2C 5-ton trucks. Two of these vehicles went to K/4/13; the other four vehicles were utilized to fill T/E shortages of 4 M35 2½-ton trucks within 4/12.

During July, 4/12 continued to use two M109 155mm howitzers made available as "float" weapons by the U.S. Army. These temporarily-loaned weapons made possible a greater degree of flexibility in the maintenance program and a higher degree of operational readiness in the M109 howitzers than could have otherwise been achieved.

8. LOGISTICS

During the month of July, 4/12 was faced with the logistical problem of supplying batteries that were located variously at DONG HA, CAMP CARROLL, MAI LOC, C-1, C-2, the ROCK-PILE, CONTHIEN, GIO LINH, and A-3. The task was accomplished expeditiously with 18,173 155mm howitzer projectiles being transported from the ammunition supply points at QUANG TRI and DONG HA to the batteries.

Throughout the month, greenbag powder remained an NIS item, necessitating the use of low-charge whitebag powder for close-in missions.

During OPERATION THOR (Phase I) contact teams were sent to the batteries to provide assistance, and this method allowed 24 of 24 howitzers to fire throughout the operation. While the battalion has been engaged in OPERATION LANCASTER II

## PART II

COMMANDERS NARRATIVE

During the month of July 1968, "K" Battery, 4th Battalion, 12th Marines supported 1st Battalion, 12th Marines, 3rd Battalion, 12th Marines, and 4th Battalion, 12th Marines in operations LANCASTER II, HIGH RISE, KENTUCKY, THOR, SCOTLAND II and DUAL BLADE. From the 2-8 of July "K" Battery, 4th Battalion, 12th Marines was under the operational control of 4th Battalion, 12th Marines in support of operation THOR at Con Thein. During the operation "K" Battery, 4th Battalion, 12th Marines fired approximately 2700 rounds. On the 3rd of July we fired our 50,000th round since coming back in country in September into North Vietnam.

On 12 July 1968 "K" Battery, 4th Battalion, 12th Marines received a photo and a letter from an Army AO who had observed a mission for us on 20 June in which we had destroyed two 130mm guns in the DMZ.

On 26 to 30 July two guns from "K" Battery, 4th Battalion, 12th Marines went to the Rock Pile for support of an operation to the north.

On 31 July "K" Battery, 4th Battalion, 12th Marines moved to a position South of Mai Loc for an operation in the Ba Long Valley.

As of 31 July "K" Battery, 4th Battalion, 12th Marines had 4 guns in action and one gun down for an engine. We have not received a replacement for the howitzer destroyed on 19 Feb as yet. As of 31 July we had 4 five tons and 3 two and  $\frac{1}{2}$  ton trucks operational. Two 5 tons and one 2 and  $\frac{1}{2}$  ton trucks were down for second echelon maintenance. We are presently awaiting replacement of all 5 tons and 2 and  $\frac{1}{2}$  tons.

SEQUENCE OF EVENTS

2 July 1968 While moving into position at Con Thein "K" Battery, 4th Battalion, 12th Marines received approximately 6 rounds of 82mm mortar fire. Negative damage or casualties. "K" Battery, 4th Battalion, 12th Marines went under operational control of 4th Battalion, 12th Marines.

3 July 1968 "K" Battery, 4th Battalion, 12th Marines fired its 50,000th round into North Vietnam since returning to Vietnam in September.

5 July 1968 "K" Battery, 4th Battalion, 12th Marines received 2 rounds of 60mm mortar fire in position resulting in negative casualties or damage.

7 July 1968 "K" Battery, 4th Battalion, 12th Marines received approximately 20 rounds of mixed 107 and 122 rocket fire. Negative damage or casualties.

8 July 1968 "K" Battery, 4th Battalion, 12th Marines went under operational control of 1st Battalion, 12th Marines.

10 July 1968 "K" Battery, 4th Battalion, 12th Marines went under operational control of 3rd Battalion, 12th Marines.

15 July 1968 "K" Battery, 4th Battalion, 12th Marines went under operational control of 4th Battalion, 12th Marines.

26 July 1968 Two guns went to the Rock Pile in support of operation LANCASTER II.

30 July 1968 The two guns from the Rock Pile returned. One gun down for an engine. 4 guns in action.

31 July 1968 "K" Battery, 4th Battalion, 12th Marines moved to a position South of Mai Loc to support an operation in the Ba Long Valley.
