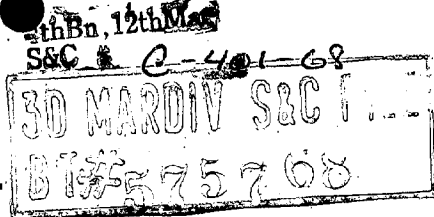

## PART II

NARRATIVE SUMMARY

During September, the 4th Battalion, 12th Marines was assigned the primary mission of General Support of 3d Marine Division. Again, it provided "Quick-Fire Channels" to four Direct Support Battalions (1/12, 2/12, 3/12, and 5/4). These unofficial reinforcing roles again accounted for an increased number of observed missions, with minimum response time and consequently, a greater degree of damage inflicted on the enemy. Direct Support fires were also furnished to 113 Reconnaissance teams.

The battalion continued to control the tactical fires of the 2nd Platoon, 1st 8" Howitzer Battery located at the ROCKPILE and later LZ PETE; the 2nd Platoon, 5th 155 Gun Battery, at CAMP CARROLL and later the ROCKPILE; and the 8" Platoon of the 5th 155 Gun Battery, at CA LU. The General Support fires for the 3d Marine Division in the Lancaster II (3d & 9th Marines) and Scotland II (4th and 9th Marines) AO's were controlled by 4th Battalion, 12th Marines.

The tactical and technical fire direction of the three organic batteries were again centrally controlled in the Battalion FDC at CAMP CARROLL. This again provided the battalion with the capability for instantaneous massing of fires over a wide front.

On the 12th, OPCON of the 1st Provisional Howitzer Battery Towed was chopped to 1/12. Subsequently, on the 14th, the 8" Platoon at the ROCKPILE moved to LZ PETE and was assigned the mission of reinforcing 2/12, as was the 2nd Platoon of the 155 Gun Battery when it moved to the ROCKPILE.

By the end of the month, the battalion controlled the tactical fires of four firing units and technical fires of three. Nevertheless, General Support fires for the entire Division were provided in the usual timely and accurate manner.

2. The following significant entries are excerpts from the S-3 Work Sheet (Record of Missions):

- 011155H - "K" fired 4 WP and 321 HE on tunnels at 058666 for Recon Team (Whitty Ordeal) resulting in 59 secondary explosions.
- 011745H - 1st Prov Btry and "K" fired 44 HE on active rockets for Whitty Ordeal resulting in 2 secondary explosions.
- 011945H - 1st Prov Btry and "M" fired 6 WP and 231 HE on active rockets and anti-aircraft position for Whitty Ordeal resulting in "over 100 secondary explosions, 15-20 large fireballs 25-50m in the air looking like an oilwell on fire."
- 020815H - "K" fired 93 HE danger close defensive fires for Recon Team (Badminton) at 035642 resulting in 50 possible KIA's. (Team stated that "arms and legs flew into the air" but unable to give confirmed body count - figure not included in totals for casualties inflicted).
- 02123CH - "K" fired 8 WP and 48 HE on suspected radio relay site for Badminton resulting in antenna destroyed.
- 031243H - "M" fired 4 WP and 23 HE on suspected enemy position for M 3/9 at 052648 resulting in 6 bunkers destroyed.
- 081916H - "M" fired 3 WP and 243 HE on active artillery at 989667 for C 1/3 resulting in 6 secondary explosions.
- 101215H - "K" fired 2 WP and 243 HE on enemy position for B 1/3 at 946624 resulting in 5 secondary explosions.
- 120757H - "K" fired 1 WP and 114 HE on prep fires for C 1/3 at 943613 resulting in 2 KIA's and one bunker destroyed.
- 130835H - "M" fired 2 WP and 42 HE on prep fires for F 2/26 at 911619 resulting in "Beaucoup KIA's." (Not added to casualties inflicted totals).
- 131236H - "L" fired 23 HE on enemy position for Recon Team (Hungarian) at 238548 resulting in one secondary explosion.
- 131351H - "M" fired 4 WP and 58 HE on NVA for G 2/26 at 913606 resulting in 2 WIA.
- 14021CH - "M" fired 24 HE on harbor site for G 2/26 at 91856140 resulting in 6 WIA.

- 141930H - "K" fired 27 HE on active mortar for L 3/3 at 936612 resulting in one secondary explosion.
- 142020H - "M" fired 6 HE on movement for E 2/26 at 90226253 resulting in 4 WIA's.
- 191215H - "M" fired 2 WP and 104 HE on active mortars for C 1/3 at 929540 resulting in excellent coverage and 5 bunkers destroyed.
- 191900H - "L" fired 12 HE on 3 NVA in bunkers for Recon Team (Hungarian) at 243488 resulting in 2 bunkers destroyed.
- 200855H - "K" fired 1 WP and 76 HE on bunkers for AO (Smitty) at 994648 resulting in 5 bunkers destroyed.
- 241831H - "L" fired 25 HE on active mortars for Recon Team Andrew at 236544 resulting in four secondary explosions.
- 262123H - "K" and "L" fired 25 HE on active mortars for Recon Team (Mailtruck) at 158511. Team stated "movement ceased, good shooting, really appreciate it."
