

NARRATIVE SUMMARY


In the month of March, the 4th Battalion, 12th Marines consisted of the following units: Battery "K", 4th Battalion, 12th Marines, Battery "L", 4th Battalion, 12th Marines, Battery "M", 4th Battalion, 12th Marines, and 3d Provisional 155mm Towed Howitzer Battery. All units were technically controlled from a centralized FDC at DONG HA.

The primary mission of 4th Battalion, 12th Marines remained as general support of the 3d Marine Division. Modification of this mission included Battery "L's" continued reinforcement of 3d Battalion, 12th Marines. On 2 March the battalion was given the mission of direct support of Task Force CLEARWATER. The battalion continued its support of Combined Action Platoons, QUANG TRI and DONG HA Combat Bases.

From 7 March to 27 March, Battery "K", 4th Battalion, 12th Marines located at C-1, was in direct support of an ARVN battalion/USMC tank company, Operation IAMSON 171, PMASE V, south of the mouth of BEN HAI River. The battalion supplied an FO team for this operation. Battery "K", 4th Battalion, 12th Marines also continued its support of reconnaissance teams operating in the DMZ.

Battery "M", 4th Battalion, 12th Marines located at C-2 had the mission of direct support of reconnaissance teams located in and south of the DMZ; in addition, on 23 March Battery "M" was in direct support of Operation MONTANA MAULER conducted by C Troop, 3d of the 5th Cavalry. This direct support status for Battery "M", 4th Battalion, 12th Marines lasted through 30th March. On the 16th of March the battalion was given a reinforcing mission for the 5th Battalion, 4th Artillery in the MIA LOC area. This mission was accomplished by Battery "M", 4th Battalion, 12th Marines (-) located at DONG HA. On the 24th of March due to an AO change the battalion assumed a reinforcing role for 2d Battalion, 12th Marines in the same area.

Battery "L", 4th Battalion, 12th Marines located at Fire Support Base ELLIOTT continued to be the workhorse of the battalion firing 16,061 rounds during the month. In addition to their reinforcing 3/12 they also were in direct support of the MONTANA MAULER Operation.



During the period 29-30 March a considerable shuffle took place within the units of the battalion; Battery "L", 4th Battalion, 12th Marines moved from Fire Support Base ELLIOTT to DONG HA, Battery "K", 4th Battalion, 12th Marines moved from C-1 to Fire Support Base ELLIOTT and Battery "M", 4th Battalion, 12th Marines moved from DONG HA to C-1. These moves were accomplished without the loss of fire support from any of the bases. On 31 March Battery "M", 4th Battalion, 12th Marines at C-2 returned to its parent unit at C-1.

During the month the battalion developed and had constructed concrete firing pads at DONG HA and at C-2. Further construction will be done at C-1 and Fire Support Base ELLIOTT next month. These pads provide a stable level plane for a conduct of fire. Furthermore, these pads prevent any piece displacement due to firing. The blueprints and the photos of these pads are in the CMC copy under supporting documents. The negatives will be retained on file with the command.

6. MEDCAP VISITS

- a. On 4 March 1969, the village of DONG XUAH, hamlet of TRUC KHE was visited and 140 patients were treated for respiratory ailments due to recent cold and damp weather.
- b. On 8 March 1969, DONG XUAH, hamlet of TRUC KHE was visited again. The villagers were very receptive to the MEDCAP team. An estimated 75 patients were treated. Some of the illnesses encountered were eye, ear and upper respiratory infections; impetigo; and dysentery.
- c. On 20 March 1969, DONG KUAH, hamlet of TRUC KHE was visited once again. This visit was the 4th Battalion's third to the village. There was some evidence of improvement in the health of the villagers. Approximately 50 villagers were treated.
- d. On 24 March 1969, DONG XUAH, hamlet of TRUC KHE was visited and a total of 73 patients were examined and treated in a three hour period. Of the diseases encountered, respiratory and skin diseases continued to be the most prevalent. A great deal of improvement has been noted since the team's initial visit on 4 March 1969. It appeared that the villagers were making use of the drugs being dispensed by the medical team on each visit, and satisfactory results, both medically and from a "People to People" standpoint, are quite evident.
- e. On 31 March 1969, DONG XUAH, hamlet of TRUC KHE was visited for the fourth time by the 4/12 MEDCAP team. A total of 45 patients were seen. The majority of the complaints encountered were of respiratory tract and skin diseases. Much improvement was noted in the cleanliness of the people and of the hamlet area.
