

PART II

NARRATIVE SUMMARY

In the month of April the 4th Battalion, 12th Marines consisted of the following units: Battery "K", 4th Battalion, 12th Marines, Battery "L", 4th Battalion, 12th Marines, Battery "M", 4th Battalion, 12th Marines, 3d Provisional 155mm Towed Howitzer Battery, and the 2nd Provisional 155mm Towed Howitzer Battery. All units were technically controlled from a centralized FDC at DONG HA.

The primary mission of the 4th Battalion, 12th Marines remained as general support of the 3d Marine Division. Modification of this mission included Battery "K's" continued reinforcement of 3d Battalion, 12th Marines and Battery "L's" reinforcement of 2nd Battalion, 12th Marines. The battalion continued to be in direct support of Task Force CLEARWATER, Combined Action Platoons, QUANG TRI and DONG HA Combat Base.

Battery "K" located at Fire Support Base ELLIOTT was the workhorse of the battalion, firing 9,882 rounds during the month. In addition to their reinforcing 3d Battalion, 12th Marines, the battery was also in direct support of Operation MONTANA MAULER, which did not end until the 4th of April. On the 21st of April Battery "K" was again firing into the same area, north of Fire Support Base FULLER, in support of a 2nd ARVN Operation in the area.

Battery "L" located at C-2 had the mission of direct support of reconnaissance teams located in, and south, of the DMZ; in addition, on 21 April Battery "L" was in direct support of an ARVN regiment/USMC tank company operation, northwest of C-2. This direct support status lasted through the 30th of April. The battalion supplied an FO, Cpl SUMNER, to the tank company for this operation.

Battery "L" (-) located at DONG HA provided reinforcing fires for 2d Battalion, 12th Marines in the MAI LOC area and continued its direct support of the QUANG TRI and DONG HA Combat Bases.

Battery "M" located at C-1 had the mission of direct support of reconnaissance teams located in the DMZ and of Task Force CLEARWATER.

On the 12th of April three of Battery "M's" howitzers, under the Battery Executive Officer, Lt. M. SHIELDS, displaced from C-1 to DONG HA, where they picked up the battery FDC personnel



in preparation for a move on the 13th to the old KHE SANH position. This move was made to provide direct support for Task Force REMAGEN, an Army mechanized unit operating in the area.

During the 16 days (13 April to 29 April), that Mike Forward, as the unit was known, was in support of Task Force REMAGEN it displaced a total of five (5) times covering in excess of 120 miles of cross country terrain. All of these displacements were accomplished with the very minimum of maintenance problems due to the excellent work of SSgt REICHLEY, Battery "M's" maintenance chief.

Communications were initially a major problem. But on the 14th a directional antenna was erected, and using a PRC 25 communications with battalion FDC were established. This enabled battalion FDC to run a check chart on nearly all of the missions fired by Mike Forward.

During the period while Mike Forward was in the KHE SANH area, the battalion had a fire capability extending from the Lactian border on the west to the Gulf of Tonkin in the east, better than 67,000 meters.

On the 8th of April the battalion chopped OPCON of the 3d Provisional, 155mm Howitzer Battery to the 3d Battalion, 12th Marines. During the period the battery was OPCON to the battalion it received some 30 hours of FDC instruction as well as firing battery instruction and was again in a satisfactory operational status upon its departure.

On the 25th of April, the battalion assumed OPCON of the 2nd Provisional, 155mm Howitzer Battery. This unit had just returned from FSB ALPINE and was initially given a well deserved four days R & R at CUA VIET.

The month of April also saw the battalion FDC and Batteries "K" and "L" inspected by the XXIV Corps inspection team. The results of these inspections were quite satisfactory as no unit received a rating of less than satisfactory.
