**PART II
NARRATIVE SUMMARY**

During the month of August the Battalion remained in General Support of the 1st Marine Division. The Battalion supported a 7th Marines operation code named IMPERIAL LAKE in the Que Son Mountain area during the period 30-31 August 1970.

Battery K's mission remained Reinforcing, 3rd Battalion, 11th Marines. The Battery registered two enemy KIA's during the month.

Battery L remained in General Support, with the exception of during the period 30-31 August, when it was displaced from the Northern Artillery Cantonment to An Hoa and reassigned the mission of Reinforcing, 3rd Battalion, 11th Marines for Operation IMPERIAL LAKE. The Battery registered three enemy KIA's during the month.

Battery M remained in General Support-Reinforcing, 2nd Battalion, 11th Marines until 12 August 1970, at which time they were displaced from An Hoa to Baldy and reassigned the mission of General Support, Reinforcing, 3rd Battalion, 11th Marines. The Battery continued to answer calls for fire support for reconnaissance units and observation posts located in the southern portion of the 1st Marine Division TAO until the displacement from An Hoa. Battery M supported Operation IMPERIAL LAKE during the period 30-31 August 1970. A total of 19 KIA's were registered during the month of August.

Headquarters Battery provided a security detachment during the 30-31 August 1970 to Hill 250 for the purpose of providing perimeter defense to a 11th Marines IOD Team.

During the month of August, units of the Battalion fired a total of 1,628 missions, expending 18,474 rounds in support of the following units:

(1) During the month of August 1970, the Battalion S-2 made eight liaison trips to the Regimental S-2 and four liaison trips to Division G-2. For the purpose of training and inspection, Counter Rocket O.P.'s Tiger, Hawk, Lou, Laugh, and Crowsnest were visited.

(2) A total of 4,300 \$VN was expended for the purchase of ordnance turned in through the Volunteer Informants Program.

h. Organization and Operations.

(1) The Battalion remained in General Support of the 1st Marine Division throughout the month.

(2) Organization for combat at the time of the reporting period was:

Battery K-Reinforcing 3/11
 Battery L-Reinforcing 3/11
 Battery M-General Support, Reinforcing 3/11

(3) An inspection team from the Regimental S-3 inspected the 4th Battalion's Operation Section on 3 August. The results were outstanding.

(4) The Battalion Fire Direction Center assumed technical control of Battery M on 9 August.

(5) On 12 August Battery M displaced from An Hoa Combat Base to LZ Baldy and was reassigned to a General Support, Reinforcing role for 3rd Battalion, 11th Marines.

(6) The Battalion Fire Direction Center returned technical fire control back to Battery M at 1100 on 13 August 1970.

(7) On 30 August Battery L displaced to An Hoa Combat Base and was assigned the mission of Reinforcing 3rd Battalion, 11th Marines in support of Operation IMPERIAL TACKLE.

i. Training.

(1) Normal GNS and MOS training was conducted as operational commitments permitted.

(2) The Regimental S-3 Inspection Team also inspected the 4th Battalion's training. The results were outstanding.

(1) During the month of August the deadline rate remained at an acceptable level. No significant parts shortages were experienced.

(2) Currently there are 4,580 requisitions pending and 791 of these are priority 02 and 05. During the month of August, 906 documents were submitted and a total of 382 were completed.
