COMMANDER'S NARRATIVE

On 1 April 1967, First Lieutenant Ha Tien Chuong, Vietnamese Marine Corps, completed a two week On-The-Job Training Program in Artillery Staff Procedures conducted by this battalion. During the training, he was briefed by and observed the duties of all Staff and Special Staff Officers of the Battalion.

From 4-7 April 1967, this Battalion participated in Exercise "Beach Baron One". In conjunction with this Exercise, this Battalion submitted to the Commanding General, 9th Marine Amphibious Brigade a Recommended Standing Operating Procedure for a Provisional Field Artillery Headquarters to be employed in Controlling The Artillery Elements Of Two Special Landing Forces

On 11 April, 1967, Lt (JG) R.K. HENRY and a Short Fire Control Party went TAD to Subic Bay for training in Naval Gunfire Procedures.
