PART IINARRATIVE SUMMARY

During the period 1-30 June 1969, 1st Battalion, 13th Marines continued under the operational control of 11th Marines while command less opcon remained with Commanding General, 9th MAB. 1st Battalion, 13th Marines continued to be assigned the tactical mission of direct support of 26th Marines. Besides supporting 26th Marines, the battalion fired in support of 11th Marines FO schools and supported the 11th Marines counter-rocket program, the convoy defense program and the Northern Sector Defense Command.

Organization and composition of the battalion remained essentially the same as it had been at the end of May. The only significant change occurred when Battery "C", 1/13 relieved Battery "B", 1/13. This was due to the rotation of the float BLTs composing SLF Bravo when BLT 2/26 relieved BLT 3/26 and consequently the supporting batteries were changed. Mortar Battery, 1/13 remained afloat and was simply attached to BLT 2/26 vice BLT 3/26. This occurred during the period 10-12 June. Detachment, Mortar Battery, 3/11 remained under the operational control of 1/13 and provided artillery support in the Hai Van Pass area.

Activity in the form of artillery support remained at a very low level throughout the month with few observed missions being conducted. Only three significant observed missions were fired. On the night of 14 June, the battalion was credited with 35 probable KIAs as a result of fire on intelligence targets conducted during the night. On 15 June, the battalion fired 400 rounds at 33 enemy soldiers detected on night observation devices in the vicinity of grid AT 902 845. A sweep the next morning revealed only several items of miscellaneous gear. On 17 June, C/1/13 fired 80 rounds of VT at 20 VC in the open resulting in one enemy KIA and numerous blood trails. Otherwise, the majority of rounds were fired on harassing, interdiction, intelligence and rocket suppression targets.

On June 6 personnel from the Naval Gunfire Team at Subic Bay, RPI reported aboard following deactivation of Team. Personnel were assigned to the Regimental Liaison Section and used to complete the NGF Team assigned to BLT 2/26.

On 16 June, Colonel Haywood, newly assigned Commanding Officer of 26th Marines, visited the battalion and was briefed on the status of the battalion, unit locations and method of operation.

On 28 June, LtCol D. E. GRAGAN relieved LtCol J. B. CANTIENY as Commanding Officer, 1st Battalion, 13th Marines at a Change of Command Ceremony conducted at the 26th Marines helopad.

Administration and operation of the battalion remained normal throughout the month. The personnel situation improved considerably with an influx of personnel of several MOS' in which the battalion was short.

Received surveillance of one enemy KIA from mission fired at Grid AT 898 827 on 10 June.
- 13 June - Received surveillance of two probable enemy KIAs from mission fired at grid AT 917 883.
- 15 June - Received surveillance of 2 Chi Coms and 1 poncho recovered following mission fired on estimated 33 VC at grid AT 902 845.
- 16 June - Colonel HAYWOOD, CO 26th Marines, visited and briefed at 1/13.
- 17 June - Received surveillance of one enemy KIA, numerous blood trails, several bags of rice and miscellaneous gear following mission fired at grid 905 825 by C/1/13.
- 18 June - Presented one-hour class on FADAC at 26th Marines Staff and Officer School.
- 20 June - Received agent report of 35 enemy KIAs (probable) from missions fired at grids AT 860 863 and AT 858 858 night of 14 June.
- 28 June - Lieutenant Colonel D. E. GRAGAN relieved Lieutenant Colonel J. B. CANTIENY as CO, 1/13.

Received surveillance of one enemy KIA(Confirmed)from mission fired at grid AT 910 822.
