PART II

NARRATIVE SUMMARY

During the month of April, K Battery, 4th Battalion, 13th Marines was in general support of the 5th Marines and in direct³ of recon inserts operating in the An Hoa area. During the month, the battery remained under the command, less opcon, of 1st Battalion, 13th Marines. The battery remains under the operational control of 2nd Battalion, 11th Marines. During this reporting period the battery participated in operation "Muskogee Meadows".

Fire missions for the period were unobserved for the most part. The battery participated in the An Hoa counter rocket/mortar plan during periods of incoming. Other missions included observed, harrassing and interdiction, intelligence targets and prep fires. A significant mission was fired for recon resulting in 21 KIA's and 5 PKIA's.

Throughout the month the battery continued to improve its position. More emphasis has been placed on training and regular training sessions are now being held in each section along with battery size classes.

On 7 April operation "Muskogee Meadows" was commenced. The operation was held in conjunction with the local rice harvest. The operation ended 20 April without any significant action.

On 15 April Gun # 4, 374656, was exchanged with a float gun due to a faulty equilibrater system. This month the battery started the quarterly maintenance of guns.

Throughout the month of April the An Hoa Combat Base was subjected to 9 enemy rocket and mortar attacks. The battery did not sustain any damages. During the periods of incoming the battery returned counter rocket/mortar fire.
