LOGISTICS

1. General. During the month of November, this Battalion was engaged in Operation Pawnee III. Logistics functions were conducted without unusual difficulty except that re-supply was impossible for several days at a time to companies operating in remote areas due to the adverse weather of the monsoon season which prevented re-supply by helicopter. No vehicle was available to this Battalion during this period which could negotiate swampy and/or jungle terrain.

A Battalion supply point was established in the vicinity of the Battalion CP in which generally a two-day level of Class I, III, and IV was maintained. Class II and V supplies were maintained to satisfy an anticipated immediate need.

The supply point was re-supplied daily from the Phu Bai complex on daily requests of the Battalion S-4 to the Logistics Chief who remained in the Battalion Administrative rear at Phu Bai.

Companies were re-supplied from the Battalion Supply Point by helicopter when available, and otherwise by a combination of truck movement and man-pack when the company remained at their patrol bases.

2. Supply. Normal supply activities were conducted during this period. The Reconciliation of Obligations was conducted during this month.

3. Maintenance. Normal maintenance functions were conducted during this month. Increased difficulty was experienced in obtaining spare parts for the truck, cargo, utility, M274A2, resulting in a present deadline rate of about 1/3.

4. Transportation. A total of ten (10) trucks, M-35's were to be attached to this Battalion for Operation Pawnee III. Because of deadlines this Battalion had available only eight or nine trucks. However, tactical moves and re-supply were conducted without difficulty.

5. Constructions. This Battalion utilized a tractor, wheeled, industrial, MRS-100, to improve the road granting access to the Battalion CP and for clearing fields of fire in one of the company's patrol bases. The MRS-100 proved to be minimal satisfactory due to the very hilly and rocky terrain. Because of bridge width and weight capacity on the highway serving as the MSR, no other type tractor could be delivered to this CP.

6. Messing. In addition to continual operation of the Battalion mess at Phu Bai, two field messes were established. One was established at a company patrol base, and the other at the Battalion supply point. The latter served the Battalion Headquarters and three companies. No refrigeration was available in the field, however, daily delivery of the food stuffs by truck alleviated the problem of storage.

7. Embarkation. All embarkation data for the Battalion was up-dated and corrected during this period.

8. Ordance and Ammunition. Two malfunctions with the cartridge 40mm HE round occurred when the projectiles lodged in the bore of the Launcher, grenade, M-79. Both rounds were of different lots. Appropriate reports were submitted. No injuries to personnel or damage to property or equipment resulted from the malfunctions.

9. Water. Fresh water was made available by filtering from a stream in the supply point. A field shower unit was also installed. Equipment and personnel were provided by the Engineer Support Company, 3rd Engineer Battalion. Water supply was adequate.

1. Two trucks to be on stand-by at resupply location for rapid movement of reserve plt any place within the operating area.
