## PART II

## NARRATIVE SUMMARY

Second Battalion, Twenty-Sixth Marines participated in two major operations during the month of December. Operation Pawnee III, continuing since 29 October, remained in effect until 24 December 1966, when the Battalion came under operational control of the Fourth Marine Regiment to participate in Operation Chinook.

Both operations were of a search and destroy nature. However, operation Pawnee III had the additional mission of providing security for the LOC's within the area of operation. This additional mission became of primary importance during December when it became obvious that local Popular and Regional Forces were inadequate for providing security for the many road and rail bridges throughout the area. As a result, the Battalion forces were deployed as security to widely separated bridges. This restricted the offensive capability for the remainder of Operation Pawnee III.

The Battalion operated throughout the month of December with only three rifle companies. Nevertheless, extensive patrolling was accomplished throughout the area of operation.

Since undertaking Operation Chinook, the Battalion has been operating in an offensive capacity in conjunction with the Third Battalion, Twenty-Sixth Marines under the control of the Fourth Marines. Company and platoon sized units have conducted heavy patrolling and set numerous ambushes. Operations of larger than company level have been severely limited by inclement weather.

Weather proved to be the most decisive factor affecting the Battalion during the month of December. Monsoonal rains flooded lowlands, thereby hindering patrol activity and channeled movement. Air support was severely restricted; fixed wing close air support was impossible and helicopter support, both resupply and medevac, could many times operate on only an emergency basis. The health and comfort of the

Marines operating in the field was a constant problem. Immersion foot and similar incapacitators produced many more Marine casualties than did enemy fire. Finally, the persistent adverse weather conditions made itself felt at the tactical planning level. Troop movements by air, rapid overland deployment, and logistical reinforcement by helicopter could rarely be counted on.

Morale and the combat efficiency of the Battalion's Marines remain high. Equipment has shown considerable wear, largely as a result of weather. Replenishment of many combat-essential items of equipment has been less than satisfactory.

## TRAINING

A total of 163 TPQ-10 sorties provided extensive coverage of possible and determined enemy positions. At 1900 on 13 December four 250 pound bombs were dropped into the village of THON PHU GIA 1800 meters short of the assigned TPQ-10 target, resulting in the death of five civilians and destruction of two homes. All subsequent TPQ's were plotted with a 3000 meter safety factor.

## LOGISTICS

1. Supply. During the month of December 1966 the supply situation within this Battalion has been relatively unchanged from previous reports. On hand quantities of end items is good but fills on requisitions for replenishment items has been very poor. Although the critical shortage of rifles 7.62mm M-14 has been alleviated, there still exists a critical shortage of individual equipment, resulting in about 130 persons in the Battalion who cannot be committed to field work for lack of equipment.

2. Resupply. The method of resupply during Operation Pawnee III relied largely on trucks with helicopter backup.

During December 1966, Operation Pawnee III was terminated and the Battalion immediately was deployed in Operation Chinook. In the latter, which became a Regimental Operation upon commitment of this Battalion, this Battalion had attached, a detachment of Shore Party to provide a Logistic Support Activity. However, this LSA was resupplied through the LSA at the 3d Battalion, 26th Marines which was in the vicinity and did not have direct support from FLSU #2. For this reason, and because the tactical situation of this Battalion precluded the maintaining of a large dump, the Shore Party Detachment was reduced in strength to a 10 man HST.

3. Transportation.

a. Organic transportation was good except for an excessive deadline rate.

b. The Platoon (-) of 3d Motor Transport attached during Operation Pawnee III remained adequate. No element of Motor Transport is attached to this Battalion for Operation Chinook. Transportation support is provided by Regiment and has been adequate.

4. Maintenance.

a. Maintenance of the organic Motor Transport is poor, especially as regards the cargo carrier, utility M-274A2. Of a T/E of 30 M-274A2, a total of 13 are on deadline, five of which are 3d echelon and eight of which are on 2d echelon deadline. The lack of spare parts for this vehicle remains unchanged and is the cause of the excessive deadline rate.

b. Maintenance of all other items of equipment remains good.

6. Cantonments. The administrative rear of this Battalion remains in cantonment at Phu Bai. In addition to housing the administrative personnel, the cantonment area serves as a storage area for the Battalion supplies and equipment not committed to the field, an area of medical treatment for not so seriously ill or injured so as to require evacuation, a reception and departure area for personnel joining and leaving the Battalion, and an area for rehabilitation of the Battalion between operations.





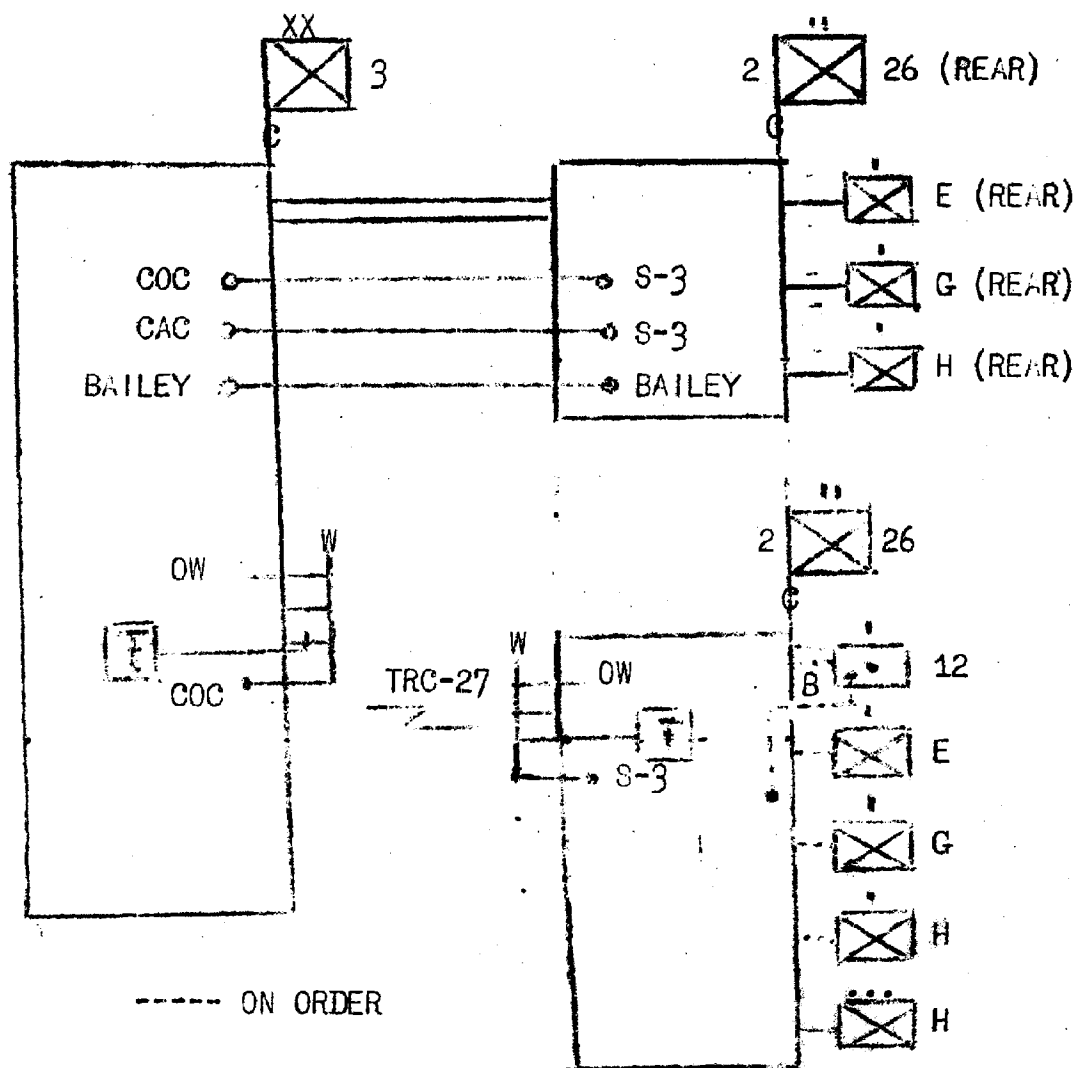

6. Supporting Forces:

(a) Artillery Support

(1) Battery "B" 1st Battalion, 12th Marines was in direct support of the Battalion. Due to the extent of the TAOR, one platoon was located near the eastern end of the TAOR, and the rest of the battery located near the west central area, providing artillery support through the Battalion AO. Artillery response to fire missions was excellent; the only difficulty which existed at times was awaiting clearance for fires from Division FSCC. Harrassing and interdicting fires were conducted at night, except during the last two weeks, when they were on a round the clock basis and provided excellent coverage.

(2) Two ARVN artillery platoons were located in the Battalion AO, one at Phu Loc District Headquarters and one at Mia Gia Pass at the eastern end of the TAOR, where the separate platoon of Battery "B" was also located. A liaison team from the Battalion S-3 was located at District Headquarters and obtained artillery support for the Battalion once during the initial phase of the operation. The only problem that was demonstrated at this time was the inadequacy of ARVN communications and their lack of experience in adjusting fires. The liaison team also coordinated ARVN fires within the AO.

(b) Naval Gunfire

(1) Naval Gunfire was made available to the Battalion twice during the operation. On one occasion targets fired upon were suspected VC base camp and observation posts. An aerial observer was made available to adjust fire. Due to communications problems, cease fire due to helicopters and the aerial observer running out of fuel, only four out of ten missions were fired. On the other occasion Naval Gunfire was used to cover advancing troops during a Battalion sweep and was instrumental in suppressing the enemy ambushes.

(c) Air Support

(1) Air support was provided by the 1st Marine Aircraft Wing and an Army AO unit (designation unknown) at Phu Bai. Helicopter support was performed by HMM 163 at Phu Bai with gunships supplied by VMO 1 and VMO 6.

(2) During the months of November and December HMM 163 responded to sixteen calls for MEDAVACs. All MEDEVACS were completed,

several under extremely adverse weather conditions. During the same period HMM 163 flew ten recon insertions and ten extractions for 3d Plt, Company "B", 3d Recon Battalion who were attached to the Battalion. Three extractions were cancelled due to bad weather, the rest were completed.

(3) During the initial days of the operation 3d MarDiv DA5C provided four flights of aircraft for use by the battalion. All aircraft were utilized. On 3 Nov 66 ten sorties were flown with 95% target coverage and 2 KBMA (Conf) plus 28 KBMA (Prob).

(4) Throughout the operation Army AOs from Phu Bai, assisted the battalion by recon flights of suspected enemy positions and spotting for artillery and Naval Gunfire. Their performance was excellent.

(5) During December the Battalion submitted numerous TPQ-10 targets. For the last two weeks of the operation 10-15 per day were requested. On 13 Dec 66 at 1900H a bomb load was dropped 1800 meters short, and hit a village at AU 824011 resulting in 5 civilians killed and 3 wounded. Cause is unknown.

(d) Ontos

(1) The 2d Plt, Company "B", 3d AT Battalion was provided in direct support of the battalion the last week of the operation. Due to flooded conditions and lack of road networks through the AO the utilization of the Ontos was extremely limited. Ontos were utilized primarily as additional fire support for the battalion and also as a mechanized reaction force for the battalion.

7. Intelligence. The source of the intelligence was G-2 (OB), 3rd MAR DIV on information summarized.

a. The following was anticipated prior to the operation:

(1) Estimate. One V.C. Main Force Company.

(2) Location. Phu Loc District, area centered by grid coordinate, ZC 0402, ZD 0494, ZD 1194, Thua Thien Province border line to AT 8591, At 8955, along coast to AU 8208, ZC 1607, ZC 1207, ZC 0402.

(3) Disposition. Cell, arrow, and company size units operating in Loc Thuy and Loc Tu village areas, and along MSR #1.

(4) Situation. Main Force Company expanding control of known V.C. operational area. (C. 118 Local Force Company in Phu Loc District.)

b. The following was found as operation was conducted:

(1) V.C. Strength. One Local Force Company with sapper element.

(2) V.C. Situation. Unknown.

(3) V.C. Units identified. None.

(4) Significant intelligence. None.

c. Terrain Features.

(1). Cover and Concealment. There was limited cover and concealment in low land areas along MSR #1 and beach areas. All mountainous areas provided an abundance of cover and concealment with thick vegetation from three feet to six feet in height and 30' to 60' trees.

(2). Obstacles. Lowland areas provided no obstacles but thick vegetation and mountains limited movement and vision.

(3). Critical Terrain Features. Song Bu Lu, Lang Co Bridge, Hills # 32, #212, # 348, #363, #258, # 88, and # 148 for movement, observation, and control.

(4). Avenues of Approach. Cau Dai, Dam Lap An, Song Bu Lu, all beach areas, Bach Ma Road, Loc Tri Basin, Thuy Yen and Thuy Cam hamlets, Thuy Duong hamlet.

(5). Weather. Weather had no effect on the operations.

d. CA/Psy. War. A total of ten Med Caps and 3 leaflet deliveries were made in the TOAR.

8. Mission. Commencing 290800H Oct 66, 2nd Battalion (-) (Rein), 26th Marines, conducts search and destroy operations in assigned area to destroy enemy units, installations and influence and increase security of railroad and national route # 1 to prevent interdiction by enemy units. Coordinate ARVN/USMC efforts to assure integrity of lines of communications in operating areas.

9. Concept of Operation. 2nd Battalion, (-) (Rein), 26th Marines moves by motor march to the Phu Loc Area, established three (3) company TAOR's, Conducts search and destroy operations in conjunction with local district and sector forces in operating area. Extensive patrolling and ambushes will be conducted to deny enemy forces freedom of movement and to prevent interdiction of lines of communication. On order, conduct motorized patrols in support of scheduled Rough Rider convoys.

Rifle Companies established patrol bases, as indicated on enclosure (1) and Btry "B" established firing positions, one in the vicinity of the Battalion C.P. Due to the large TAOR, one platoon of Battery "B" was employed with a platoon of ARVN artillery at the forward position, (AT 832999).

A supply point was established in the vicinity of the Battalion C.P. The Det. Co. B, 9th MT Bn. was based at the supply point from which all resupply missions were conducted.

3d Plt. Co. "B" 3d Recon Bn. conducted patrols and ambushes in assigned areas to observe, engage, and/or capture the enemy whenever possible.

10. Execution. At 280830H Oct. 66, 3d Marine Division Frag Order 424-66 (Operation Pawnee III) was received at this headquarters. At 290800H Oct. 66, the first elements of the battalion departed for the operating area. All units established defensive positions and conducted local security. There were no significant incidents.

At 311250H Oct 66, an aerial observer reported ten to fifteen V.C. at coordinates AU 826040. An air strike was called and observed by the A/O which resulted in six enemy KIA (Prob).

At 011635H Nov 66, a recon team observed 17 V.C. at Coordinates AU 825065 moving in a south western direction. An artillery fire mission was called which resulted in 12 VC KIA (Prob).

At 011745H 66, a recon team observed 10 V.C. at coordinates AU 819059 moving toward the south-east. An artillery fire mission was called which resulted in 10 V.C. KIA (Prob).

At 011830H Nov 66, a recon team observed two VC at coordinates AU 827073 moving toward the southeast. An Artillery fire mission was called which resulted in 2 VC KIA (Prob).

At 020915H Nov 66, a recon team observed 12 VC moving northeast and north. When first observed, the VC were wearing black pajamas, but changed into green uniforms while under observation. An artillery fire mission was called in which resulted in 5 VC KIA (Prob).

At 021105H Nov 66, a recon team observed 5 VC moving northeast at coordinates AU 823046. An artillery fire mission was called which resulted in 2 VC KIA (Conf).

At 021310, a recon team observed 3 VC moving toward the northwest at coordinates AU 824076. An artillery fire mission was called in which resulted in 3 VC KIA (Prob).

At 021645H Nov 66, a recon team observed 1 VC at coordinates AU 820060 moving northwest. An artillery fire mission was called in which resulted in 1 VC KIA (Prob).

At 021825H Nov 66, a recon team observed 6 VC at coordinates AU 823046. An artillery fire mission was called in which resulted in 1 VC KIA (Prob).

At 021840H Nov 66, a recon team observed 4 VC along the river at coordinates AU 825046. An artillery fire mission was called in which resulted in 1 VC KIA (Prob).

At 030635H Nov 66, a recon team observed 12 VC at coordinates AU 823649. An artillery fire mission was called in which resulted in 2 VC KIA (Conf).

At 030740H Nov 66, a recon team observed 10 VC at coordinates AU 823649 moving west in a boat on the river. An artillery fire mission was called in which resulted in 7 VC KIA (Conf).

A battalion search and destroy operation commenced at 030600H Nov 66. The concept of this operation was to have one company (-) conduct a sweep of the operational area; one company (-) and one platoon to take blocking positions with the Battalion Command Group to go with the blocking company initially.

At 030820H Nov 66 Company G received automatic small arms fire from coordinates ZD 201056. The company returned small arms fire from a range of approximately 75 meters which resulted in 1 VC KIA (Conf); one automatic weapon and some documents were captured and were delivered to the Battalion S-2.

At 031105H Nov 66 a platoon of Company H acting as a blocking force received approximately 50 rounds of small arms fire at coordinates AU 835043, a range of approximately 50 meters, which resulted in 1 USMC WIA. The small arms fire was returned with negative results. The USMC WIA was MedEvaced.

At 031120 Nov 66, Company H blocking force engaged 10 VC at coordinates AU 835043 resulting in 3 VC KIA (Conf).

At 031130 Nov 66 The FAC spotted 10 VC at coordinates AU 827057. An air strike was called which resulted in 2 VC KIA (Conf) and 5 VC KIA (Prob).

At 031215H Nov 66 Company H blocking force received heavy small arms fire at coordinates AU 835043. An air strike was called in which resulted in 7 VC KIA (Prob).

At 031230H Nov 66, an additional platoon was alerted and moved to the operating area thus giving the operation a total of three companies (-) and the Battalion Command Group.

At 031815H Nov 66, Company H received 100 to 200 rounds of small arms fire from an unknown number of VC at coordinates AU 837041, at a range of approximately 100 meters. Results were 1 USMC KIA. The small arms fire was returned with the VC breaking contact and withdrawing in a northeasterly direction.

At 041740H Nov 66, Company E detonated one frag grenade mine resulting in 1 USMC WIA. WIA was MedEvaced.

At 041745H Nov 66 Company G made contact with approximately 10 VC at a range of approximately 75 meters. Small arms fire was exchanged and an artillery mission was called. Results of contact, 1 USMC WIA, and 4 VC KIA (conf).

From 5 Nov through 12 Nov 66, there were no significant contacts, although patrols and night ambushes were conducted daily.

At 131300H Nov 66, a company G platoon and recon patrol it was assisting received sniper fire from the vicinity of ZC 153974 resulting in 1 ARVN KIA and 1 USMC WIA. The USMC WIA was medevaced and an artillery fire mission was called with negative results.

On 14 and 15 Nov 66, there were no significant events.

At 161120H Nov 66 Comp any G received small arms fire at ZC 159977 from approximately 3 VC at a range of approximately 50 meters, resulting in 1 USMC WIA. An artillery fire mission was called with negative results. At approximately 1430H Company G received more small arms fire. Small arms fire was returned which resulted in 1 VC KIA (conf), 1 VC WIA and 2 automatic weapons captured.

At 171220H Nov 66 Comp any G received small arms fire which resulted in 2 USMC WIA. USMC WIA's were medevaced.

At 181930H Nov 66 PF's from Phu Loc ambushed a VC squad at ZD002037 resulting in 2 VC KIA (conf) and 2 automatic weapons captured.

At 200050H Nov 66 Redon Co, 1st ARVN Div reported that an unknown number of VC delivered small arms fire at regional forces guarding a bridge at ZD 197011. Small arms fire was returned, the area was illuminated and the VC withdrew. ARVN Forces received 1 WIA.

At 211430H Nov 66 a Company E patrol shot and wounded 1 VC when he attempted to flee the patrol at AU 837035, the VC later died of wounds.

At 231250H Nov 66 Army AO reported two boats off loading supplies and VC moving inland at AU 828069. The AO called an air strike which resulted in 2 boats being sunk. A platoon from Company E was helo-lifted to the area and found food, military equipment and medicine. There was no evidence of VC casualties. One other platoon from Company E was helo-lifted to the area and two platoons each from Company H and G and the Battalion Command group were helo-lifted to the area. Company E observed two VC enter a cave but were unable to extract them. The cave was blown and resulted in 2 VC KIA (prob).

A sweep of the peninsula from approximately the 06 grid line North was conducted with negative results. The sweep continued for 4 days and the area was thoroughly checked for caves and tunnels with 2 minor caves being found containing miscellaneous personal effects, food and a small number of Chicom grenades. Three coast guard Junk Fleet ships were stationed off the peninsula during this sweep, to prevent evacuation or reinforcing by sea. One supporting fire mission was requested and fired by this fleet.

At 301030H Nov 66 a recon team apprehended 2 VC suspects at ZC 117992.

At 011330H Dec 66 Company G apprehended nine VC suspects in the vicinity of ZC145996 and ZC152998, during a battalion size search and destroy operation. The suspects were delivered to Phu Loc District headquarters.

At 031410H Dec66 Company H received heavy automatic weapons fire and approximately 12 rounds of 57 MM recoilless rifle from the high ground overlooking the company position in the vicinity of ZDO59019. Heavy clouds hid the area from which the fire was received. Small arms fire was returned, 81 mm mortar fire and 106 MM recoilless rifle were delivered on the suspected enemy positions. The small arms fire continued sporadically for approximately fifteen minutes. An artillery fire mission was also called, two platoons of Company G and a command group under the battalion Executive Officer were dispatched for possible commitment. A reinforced platoon from Company H searched the area from which the fire was received, with negative contact, however a small amount of unfired and misfired 57 MM recoilless rifle ammunition, expended small arms cases and mortar cannisters were found. Company H sustained seven WIA as a result of the action, five of which were MEDEVACED. The remaining two were treated and returned to duty.

At 061750H Dec66 a patrol from Company G encountered six VC in the vicinity of ZC198987. The VC were engaged with small arms at a range of approximately 75 meters. One VC was seen to fall, however a search revealed no body.

At 081000H Dec66 Company G while searching for a suspected VC base camp in the vicinity of ZC119963, made contact with two VC at a range of approximately 20 meters. One VC was killed and the other wounded. One enemy carbine was captured.

At 081055H Dec66 during the search mentioned above Company G again made contact with four VC in the vicinity of ZC141972, at a range of approximately 75 meters. One VC was killed and one bolt action rifle was captured.

At 081220H Dec66 while continuing the search for the VC base camp Company G encountered approximately seven VC in the vicinity of ZC119954, at a range of approximately 50 meters, 1 VC KIA (conf) VC fled to the valley floor. An artillery fire mission was called with excellent coverage.

At 081055H Dec66 in the vicinity of ZDO77014, Company H apprehended two VC suspects which were delivered to Phu Loc District Headquarters.

At 081258H Dec66 Company G received automatic small arms fire while checking the area after the artillery fire mission resulting in two USMC WIA which were Med Evaced after considerable difficulty due to the weather and the high and tightly woven canopy. One MedEvac later died as a result of a cardiac arrest.

At 090730H highway security patrol reported highway bridge at ZDO99006 had been blown. Phu Loc District Headquarters indicated that the bridge was blown at approximately 0300. A span of 82 feet was blown.

On 101300H the battalion assumed opcon of Company F which had been opcon to 2d Bn, 9th Mar, and chopped Opcon of Company E to 2d Bn, 9th Mar.

On 11Dec66 units of the battalion moved to the following coordinates to furnish additional security for key bridges within the TAOR: AT887956, ZD198010, ZD153010, ZDO99007, ZDO38026 and ZDO87007.

At 111115H Company G apprehended two VC suspects, delivered to Phu Loc District Headquarters.

At 111845H Dec66 in the vicinity of ZD187055, Company F apprehended two VC suspects. Suspects were delivered to Phu Loc District Headquarters.

At 131900H Dec 66 Company F reported, and confirmed by "B" Battery forward, that a bomb from TPQ-10 drop had missed its target and landed in a village in the vicinity of AU 824001. A rifle platoon, the Battalion S-3, the Battalion Surgeon, and corpsmen were dispatched to the scene to investigate damages. A flare ship was assigned for illumination of the area during the search. Three civilians were Medevaced: one woman with a shrapnel wound in the shoulder, one child with a cheek laceration, and one woman with an apparent epileptic seizure. Two houses were completely destroyed, and an unknown number of chickens, ducks, and pigs were killed. Five civilians were killed. Solatium payments were made to victims and relatives of victims.

At 141505H Dec 66 a recon team encountered and killed two VC on a trail at coordinates ZC 059951.

At 151250H Dec 66 a recon team in the vicinity of ZC 206977 apprehended a VC deserter. At 1515H the recon team apprehended another VC suspect; both individuals were evacuated by helicopter to ITT.

160900H Dec 66 Company G apprehended one VC suspect. Suspect was delivered to Phu Loc District Headquarters.

At 172248H Dec 66 Company G squad ambush spotted two boats moving southwest at coordinates ZD 159027. The boats were taken under fire and illumination was requested and the area was searched. The two boats were sunk and three VC were killed (prob).

At 182122H Dec 66 Company F squad ambush at coordinates ZD 192002 encountered ten VC. Small arms fire was exchanged and four VC were seen to fall. Four VC killed (prob).

At 232030H Dec 66 Company G spotted lights on a river at coordinates 154014. A squad was dispatched and investigated and found a boat on the bank. Small arms fire was received and two VC were sighted. The small arms fire was returned. One VC fell into the water and floated past the squad. 1 VC killed (conf). The other VC was wounded and fled to the north, northwest.

At 241200H Dec 66 the operation was secured with no further contact.

# 11. Results.

a. Friendly losses: USMC 1 KIA, 19 WIA, ARVN 1 KIA, 1 WIA.

b. Enemy losses: 2 KBMA (conf), 28 KBMA (prob), 30 KBGF (conf), 32 KBGF (prob), 23 VCS, 1 VCC.

c. Weapons captured: individual weapons: 6, crew served: none.

d. All areas were searched following controlled air strikes. The areas were not searched after TPQ-10 strikes due to other commitments of the units at these times and the inaccessability of the target areas.

12. Administrative Matters. Administrative plans were adequate. The following comments in specific areas apply:

a. Supply. Unit distribution was utilized to the companies, re-supplying them from a Battalion Supply Point established in the vicinity of the Battalion C.P. The Battalion supply point was supplied from the FLSA #2 through the Battalion Administrative Rear located at Phu Bai. A two day level of classes I, III, and V supplies was maintained in the Battalion and, because of the distance between units, at the company supply points, except when anticipated needs for a particular item were greater.

Resupply to the Battalion Supply Point was handled by trucks, M-35, attached to the Battalion for the operation. Two companies were located in areas not accessible by trucks. These companies were resupplied daily by helicopters. The two day level of supplies at these companies provided necessary rations when weather did not permit routine resupply by helicopter.

Resupply during extended operations away from the base camps required use of helicopters because of the lack of roads and negotiable terrain. During periods of inclement weather resupply by helicopter was not possible.

ANGST was attached which handled the helicopter resupply at the Battalion Supply Point.

On two occasions, bridges were blown between the AO and Phu Bai. During the periods of reconstruction, necessary supplies were assembled in the administrative rear area, from where they were helo-lifted to the Battalion and company landing zones.

Combat loads of individuals consisted of T/O weapons, basic allowance of ammunition, body armor, helmet, and from one to four MCI's, depending on the particular operation. No difficulties were experienced.

b. Maintenance. Because transportation to the administrative rear was relatively easy and frequent, most of the maintenance effort was performed in the rear. One mechanic, one armorer, and several communication technicians were in the forward C.P.

These personnel insured that proper preventative maintenance was performed on equipment and they performed limited 2d echelon maintenance. All equipment which had to be evacuated was evacuated through these personnel.

c. Treatment of casualties and evacuation and hospitalization. MEDEVACS were conducted with a minimum of difficulty, except on one occasion when, because of the high and thick canopy, considerable difficulty was encountered. Response to requests was excellent.

A Battalion Aid Station was established in the forward C.P. However, all casualties except very minor illnesses or injuries were evacuated to "A" Company, 3d Med Battalion or to the Battalion's Administrative Rear Aid Station.

d. Transportation. One platoon, minus, of Company "B", 3d MT Bn was attached to the Battalion for the operation. These trucks were utilized for tactical movements, resupply, and for necessary household requirements in the administrative rear. Transportation was adequate.

e. Communications. Radio relay support during the operation was outstanding and exceeded 95 per cent dependability. Even during the latter part of the operation, when frequent generator problems arose, it was excellent.

During the early stages of the operation, the TAR net operated by DASC was very unsatisfactory. It was necessary on numerous occasions to call by phone to establish contact by radio. This resulted in much lost time in requesting support for MEDEVACS and air support. At times it was so poor that it was necessary to call by phone to keep them on the air to complete a mission. The operation of this net was brought to the attention of the Division Comm-Elect Officer on at least three occasions and during the final weeks of the operation, these problems did clear up and communications were satisfactory.

The radio set AN/PRC-25 continued to be extremely dependable under the most adverse weather conditions. The only problem occurred with the set was a breakdown of mike elements in handset H-138.

f. Medical Evaluation. Operation Pawnee III did not present any new medical problems. The most common problems were maceration and immersion foot. The most serious cases were evacuated to the administrative rear aid station where two seventeen bed wards were established to specifically treat these disorders. Patients were returned to duty after seven to fourteen days, depending on the severity of the case.

A secondary problem was that of pyoderma, secondary to scratches and insect bites. In most cases local cleansing and cacitracin ointment did effect a cure. Because of this, the use of Bicillin was started which was found to give very good results.

The MedCap program was moderately successful, but was hampered by the almost complete lack of medical supplies.

13. Special Equipment and Techniques. No comments.

14. Commanders Evaluation: 2dBn, 26thMar, fulfilled the basic mission of Operation Pawnee III which was destroying enemy units and installations, influence and increase security of the railroad and NR #1 and prevent interdiction by the enemy units. As the operation progressed it became evident that more emphasis had to be placed on LOC security at the expense of aggressively seeking and routing out the enemy in his base camps. At first Phu Loc District forces were responsible for immediate security for bridges and the railroad. U.S. Forces were placed in positions where they could add influence to the LOC security but were largely concerned with conducting wide search and destroy patrols. However, district forces did not fulfill their protective role adequately and two main highway bridges were destroyed, one 200 meters from District Headquarters while PFs were guarding it. As a result of this particular incident, 2/26 was ordered to place reinforced platoons in the vicinity of the key bridges in the TAOR. This relocation completely eliminated the battalion's capability to seek out and destroy the enemy in his camps.

The battalion conducted the operation with only three of its four rifle companies, which also hampered its offensive capabilities. The TAOR was so large that it was difficult to mass forces without sacrificing security throughout the other parts of the TAOR and denying the battalion any sizable reaction force. The battalion received numerous reports of sighting of sizable enemy units in southern areas of the TAOR but the battalion was unable to exploit these reports due to the emphasis on LOC security. All in all it is felt the battalion accomplished its mission but more tangible results would have resulted had the battalion had more freedom of movement.

15. Recommendations:

a. It is believed that there is still a sizable enemy force operating within the Pawnee III operating area. Further battalion sized operations in the area are recommended.

b. That any battalion going into the area should be a full four company battalion.

c. That if feasible LOC security be left to Vietnamese forces, and that action be taken to recommend an increase in the RF/PF forces in the Phu Loc District. There are too many vulnerable places along the highway and railroad for the current size of the district forces.

d. That following the monsoon, offensive operations be conducted in the southern mountain areas of the Pawnee III operating area to rout the enemy from his base camps.

e. That MedEvac helicopters operating in heavily canopied areas be equipped with a fifty or sixty foot hoist cable, instead of a thirty foot cable.

f. That all MedEvac helicopters carry a basket.
