PART II

NARRATIVE SUMMARY

During this period the battalion has operated in a split configuration continuously, Operation Gulf, a battalion (-) (Rein) search and clear operation was conducted along the upper reaches of the Song Ou Do in Elephant Valley. The abrupt termination of Operation Gulf on 7 March was followed by deployment of a Command Group and three companies to Dong Ha on 8 March and commitment to Operation Prairie II and III,

The Battalion Executive Officer command group maintained responsibility for the northern portion of the DaNang TAOR with Co "F" and Co "D", 1st Bn, 26th Marines. Security of vital installations and continued emphasis on denying VC use of the Song Ou Do and adjacent trail network for supply and infiltration was accomplished by saturation patrolling day and night.

The civil affairs program was continued with good results. Noteworthy was the intelligence voluntarily supplied by village chiefs which resulted in the capture or destruction of VC supplies, documents and weapons.

1. Enemy Situation at the beginning of the period.

a. DaNang Area. Enemy activity was passive in nature. The VC were avoiding contact and no daylight sightings were made.

b. Cam Lo Area. The enemy appeared to be hiding and observing friendly activity.

4. Significant trends during period.

a. DaNang and Cam Lo none.

5. Enemy Situation at the end of the period.

a. Da Nang: Enemy activity began to increase as compared to the same period for the preceeding month.

b. Cam Lo: The enemy seems to be avoiding contact with friendly units. On the occasions when patrols encountered the enemy contact was broken almost immediately.

6. Weather.

a. Da Nang - No adverse conditions.

b. Cam Lo - There were two or three days of ground fog restricting visibility to two or three miles, clearing by 0900H. High temperatures and humidity coupled with a lack of water in some areas, and the nature of the terrain were causes for adverse operating conditions.

a. The enemy was avoiding daylight contact and limited their activities to probing friendly defensive positions under cover of darkness.

4. Significant trends during the period.

a. On 12 March 67, the first day light sighting of the enemy in this area was made. From then until the 21st of March a total of 3 actual daylight sightings were made, and reports of a 36 man VC unit operating within the Battalion TACF was received from villagers.

5. Enemy Situation at end of Period.

a. From the 21st of March contacts became less frequent. But this is attributed to the fact that moon light extended throughout most of the night and would have made night movement easy to detect. Enemy activity was limited to infiltration of personnel during hours of darkness.

6. Weather.

a. Fog/maze restricted employment of helicopters on several days, but usually cleared by early afternoon.

1. OPERATIONS

a. Mission Assigned: During the month of March the battalion's mission was two fold due to the movement north of a command group and three rifle companies. The remaining command group with Company F Reinforced by Company D, 1st Bn, 26th Mar was assigned the following missions:

(1) Establish and maintain a reconnaissance screen throughout assigned TAOR and in OA's when assigned.

(2) Conduct unilateral offensive operations within assigned TAOR and in OA's as directed.

(3) Conduct unilateral and/or coordinated offensive operations in Division Area of responsibility as directed.

(4) Be prepared to conduct unilateral and/or coordinated offensive operations throughout I Corps Tactical Zone as directed.

(5) Occupy and defend assigned TAOR.

(6) Be prepared to deploy anywhere in RVN by the most expeditious means within indicated time from first warning order:

(a) One Reinforced Rifle Company within four (4) hours.

(b) One Reinforced Battalion (minus above company) within six (6) hours.

(7) Be prepared to counterattack against possible enemy penetration into Regimental TAOR.

(8) Conduct coordinated U.S./GVN operations including a concentrated and sustained civic action program within TAOR in support of Revolutionary development.

(9) Conduct coordinated U.S./GVN psychological warfare program within TAOR.

(10) Control and Maintain Routes of Communication within TAOR.

b. The Command Group and Companies E, G and H had the following missions:

(1) To Reinforce the 3d Marine Division Forward and to conduct operations as directed.

c. Major Operations Conducted: The battalion participated in Operation Prairie II, Prairie III and Gulf.

Sniper training was conducted at Headquarters Company, 9th Marines. The Battalion sent eleven (11) enlisted marines to the school. LOGISTICS

1. Logistics

a. Supply

(1) During the month of March the overall supply posture of and items was good. Some shortages still exist in 2d echelon repair parts for truck, utility M-274A2.

(2) During most of March three companies and a command group participated in Operation Prairie II in the Dong Ha area. Resupply was conducted by HST teams through an LSA and by truck convoy from Dong Ha. The remaining elements of the battalion carried on normal resupply by truck.

(3) Sufficient quantities of In-Kind Issue clothing, lightweight jungle clothing and individual equipment were received to alleviate shortages which have existed for sometime.

b. Maintenance

(1) Availability of spare parts improved during March. In general 2d echelon maintenance was good on all combat essential items.

c. Food Services

(1) Messing facilities at the battalion rear elements at DaNang remained the same with field messes attached to each company.

(a) Ice cream was served twice weekly.

(b) Doughnuts were drawn from 1st FSR Bakery twice weekly.

(2) Messing facilities for elements of the battalion engaged in Prairie II consisted mostly of MCI's with one hot meal daily whenever units were located in the base camp area.

d. Transportation and Road

(1) The battalion rear echelon continued to receive six trucks (6x6) for daily resupply.

(2) The forward elements of the battalion received one truck (6x6) for daily resupply.

(3) Twenty-four (6x6) trucks with trailers were utilized to move the battalion command group and three rifle companies to the DaNang airfield prior to the move to Dong Ha. Twenty-four trucks were also used to return this group to the battalion command post upon its return to DaNang.

e. Water

(1) Potable water for the battalion was drawn from the 7th Engineer's water point near the battalion command post. Companies in the field continued to resupply by M-107 water tanks.

f. Motor Transport

(1) Organic vehicles of the battalion were used for administrative and tactical runs during the month while the daily household trucks (4x6) were used solely for resupply.

(2) One M-422A1 is on 2d echelon deadline and one is on 3rd echelon deadline. One M-274A2 is on 3rd echelon deadline and three are on 2d echelon deadline.

g. Embarkation

(1) The embarkation status of the battalion remains the same. Formal embarkation training for additional members of the battalion was interrupted by operational commitments.

h. Hospitalization and Evacuation

(1) Daily sick call was held at the battalion aid station for rear elements. Serious injuries were evacuated to 1st Medical Battalion by vehicle or helicopter.

(2) Forward elements of the battalion relied on medical care in the field by attached corpsmen and the battalion surgeon. Serious evacuation cases were moved by helicopter to 3rd Medical Battalion.

6. Supporting Forcesa. Artillery

(1) Battery B, 1st Bn, 13th Marines was in direct support and remained in a fixed firing position (AT 922785) throughout the operation. They remained prepared to engage "on call" and counter mortar targets in support of the advance of the mechanized column and to protect the battalions lines of communication. No fire missions were required.

(2) 1st 8" Howitzer Battery was in general support of the Battalion from a fixed firing position (AT 922785). They were prepared to provide reinforcing fires throughout the eastern half of the area of operations and were primarily oriented toward providing defensive fires in support of artillery units displaced forward in the operation area (AT 822857).

(3) 3d Platoon, 1st Armored Amphibian Company was in direct support and moved with the armored column to occupy a firing position at (AT 822857). From this position they were scheduled to provide HLZ preparatory fires in support of the heliborne landings in HLZ's Buzzard and Bluejay. Following the HLZ prep fires, this unit would provide on call fires throughout the area of operations. This unit could not attain firing battery in time to provide the HLZ prep fires and the mission was reassigned to fixed wing aircraft. They fired only one fire mission which was direct fire against a small VC force in close proximity to their firing position. Target coverage was good, however a search of the area produced inconclusive results.

(4) 2d Platoon, Battery L, 4th Battalion, 12th Marines was in direct support and moved with the armored column to occupy a firing position with the LVTH-6's. They were prepared to add reinforcing fires to targets throughout the area of operations. No fire missions were required.

b. Tanks

(1) 2d Platoon, Company B, 1st Tank Battalion, in direct support provided the spearhead for the attacking armored column, protected re-supply convoys, lines of communication, and augmented the perimeter defending the forward artillery firing position (AT 822857).

(2) Dozer Tanks with the 2d Platoon conducted operations with engineer support to improve Highway 545. Constructing bypasses and clearing earth slides the road was made passable for tracked vehicles between (ZC 900822) and (ZC 196842).

(3) Limited Tank reconnaissance revealed that most of the streams within the area of operations are fordable and that Tanks can generally attain sufficient freedom of movement throughout the lower areas to maintain continuous support of advancing infantry. The bridge at (AT 197843) is damaged and is not passable for armor, however a ford approximately 50 meters to the north permitted easy bypass to allow tank penetration to (ZC 196842) during Operation Gulf.

c. Air Support

(1) At the commencement of the operation an 18 man radio relay team was helicopter transported to Dong Den (AT 837826) to insure a positive communication link between all elements participating in the operation.

(2) Four hours after the operation began, Company E (Rein) was simultaneously helolifted into two HLZ's: Buzzard (ZC 130847) and Bluejay (ZC 196838). This maneuver was delayed for HLZ prefires which were, by necessity, reassigned from artillery to fixed wing aircraft. The entire lift required two hours.

(3) One helicopter Med-Evac was called during the period and completed in 35 minutes.

(4) Fixed wing aircraft were on station to provide protection for the helicopter borne force. The inability of artillery to provide HLZ prefires necessitated a request for aircraft to execute HLZ prep. Aircraft on station were not equipped with a suitable ordnance load and DASC assigned the mission to other aircraft. Aircraft prep on the target HLZ's commenced 20 minutes after the initial request.

(5) During the first four hours of the operation UH-1E gunships served as TAC (A) for the HLZ prep and provided visual reconnaissance throughout the area of operations with negative sightings.

(6) Aerial observers flew daily reconnaissance over the area of operations with negative sightings.

7. Intelligence

a. Terrain. Mountains on either side of the valley are extremely steep with a dense canopy up to 200 ft. The underbrush is heavy in the low areas but generally clears beyond the third or fourth contour line. Vegetation is a mixture of jungle growth, cane, and elephant grass about 10 ft. in height.

~~b. Trafficability~~

(1) River banks and trails are generally trafficable for wheel and tracked vehicles. Most river dikes were low enough to cross without difficulty.

(2) River depths vary from 1½ to 8 ft. Bottoms are predominantly rock. Numerous fording sites were found that would permit crossing without fording equipment, however during the monsoon the swollen streams probably require fording equipment.

(3) All bridges are passable for foot traffic, but most would require major repair for vehicle traffic.

(a) The bridge at (ZC 196843) is a pony truss, with steel supports and wood decking. Wheeled vehicles can probably use this bridge as is, but repairs would be necessary for heavier equipment/vehicles. Approximate width is 13 feet.

c. Recommendations by Tank Unit Leader.

(1) That further operations have two heavy sections and one blade tank assigned.

(2) That additional long cables be taken.

(3) That an engineer team be attached to the tank unit leader to perform clearing operations.

d. Enemy Activity

(1) No contact was made with VC/NVA units. One distant sighting was made of three VC moving up a hill and 60/81mm mortars were called in with good target coverage, a search of area produced inconclusive results.

(2) One landmine was encountered, resulting in a tank track being blown and four friendly WIA, one Med Evac.

(3) Evidence of VC movement through this area (i.e., Chicom grenade in dry river bed, and previous sightings by Recon teams) indicates this is probably used as a small unit infiltration route into the Danang area.

8. Mission. Commencing at 040700 March 67, 2d Bn, 26th Marines (-)(Rein) conducts search and destroy operations in area bounded on the north by F-W grid line (AT 89), on the east by N-S grid line (AT 90), on the south by F-W grid line (AT 82) and on the west by N-S grid line (ZC 12) to locate and capture or destroy enemy forces, equipment and supplies.

9. Concept of Operation. Commencing at 040700H Mar 67, one company (Rein) attacks west along the axis of Song Cu De Valley in assigned ZOA. This force will advance in an armored column supported by tanks and amtracs and will contain one plt LVTH-6s and one plt of 155 self propelled howitzers which will establish an advance artillery position to provide fire support for the helicopter borne force. Commencing at 041100H Mar 67 one company (Rein) lands by helicopter in designated HLZ's and attacks east and north east to establish blocking positions in assigned ZOA. See Enclosure (1) (Concept of Operation).

At 030830Z my Frag Order 42-67 was released. At 031400H a briefing of all assigned units was conducted at the Bn Command Post.

01 March 67

0700 Command Group and Company H crossed line of departure attacking west on route of Air Force Road Runner via mechanized column.

Two HH-46H helicopters lifted radio relay team (18 pers) from Bn CP (AT 940784) to Tong Den (AT 937826).

The communication plan established by the Battalion Communication Officer provided adequate response to operational requirements.

f. Medical Evaluation. There were no medical problems encountered on this operation.

13. Special Equipment and Techniques


(a) Radio Communication

The area of operation precluded direct FM radio transmission with Battalion (Rear) and between all units of the operation. Anticipating difficulties in maintaining radio contact, a radio relay team was equipped and prepared to maintain communication on the Bn TAC Net and on the Artillery conduct of fire net between all elements involved in the operation. This relay team was helolifted to Dong Den (AT 937826) at the commencement of the operation and permitted an orderly and continuous communications link. Traffic between the units engaged was transmitted via FM radio and to prevent undue traffic on the Bn T-c Net, communications between Bn (Rear) and the Relay Team was effected via HF circuits.

Commanders Analysis. From previous contacts prior to the operation, it is believed that there is probably a VC unit of platoon size that operates east of grid line 81 in Elephant Valley. Early termination of the operation precluded a thorough search of the area of operations west of that point. However, patrols and searches that were conducted produced no evidence of significant activity in the area.

It is felt that this operation demonstrated to the VC that we can and will move back into the mountains, thereby making him feel less secure.

15. Recommendation. That continued patrol action and company size operations be conducted in the area. Future Battalion size operations in this area are not considered appropriate unless recon sightings or other information indicate major VC activity.
