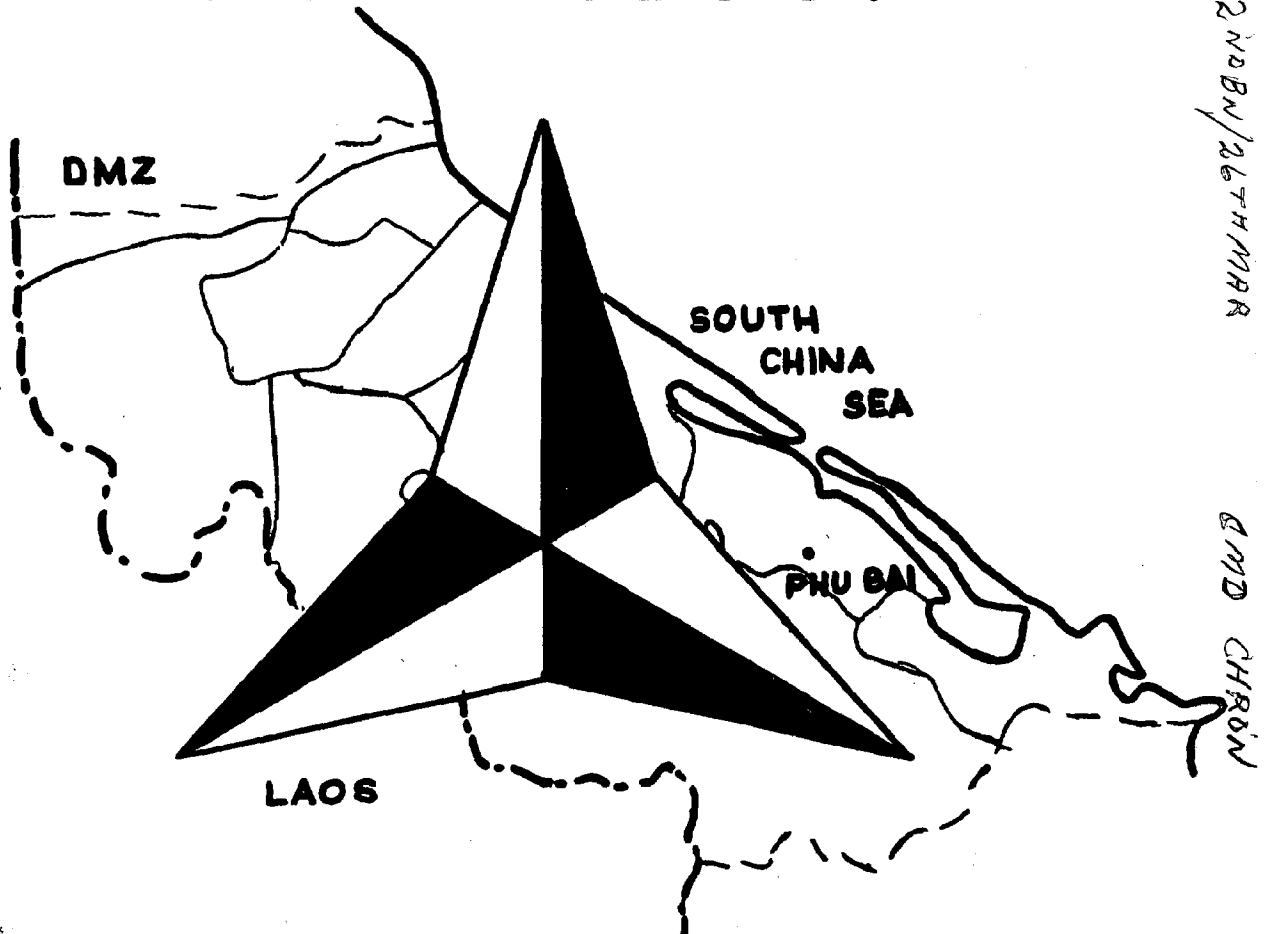

PART II

NARRATIVE SUMMARY

During the month of May the Battalion participated in Operation Lancaster II in the 4th Marines' AO and Operation Kentucky in the 9th Marines' AO.

Throughout a majority of the Battalion's participation in Operation Lancaster II the rifle companies were employed as follows: one company occupied the defensive perimeter at Camp Carroll; one company provided security for Khe Gio bridge (YD 027562) and Route 9 from YD 003565 to YD 060569; one company provided security for Route 9 from YD 060569 to YD 115582, occupying positions at "Mikes" Hill (YD 073573) and Hill 37 (YD 089578); and one company was under OPCON of 3d Battalion, 9th Marines' AO, with a mission to defend Thon Son Lam (YD 985552).

The two rifle companies securing Route 9 patrolled and ambushed extensively in their zone of action. Each company maintained one platoon as a swing platoon. The swing platoons patrolled the entire company zone of action, establishing Patrol Bases and conducting mutually supporting ambushes. Squad and Platoon (-) size patrols and ambushes were conducted by the units occupying Khe Gio Bridge, "Mikes" Hill and Hill 37.

The company manning the defensive perimeter of Camp Carroll continuously improved the defensive wire, cleared fields of fire and rebuilt living bunkers and fighting positions.

The Battalion was also assigned the task of installing hand SID's and operating the MICROTALS within the 4th Marines AO. Hill 37 was chosen as the site for employment of the MICROTALS. Three areas located astride a known enemy infiltration route were designated as lucrative areas for the SID's. Two attempts were made to emplant the SID's, one daylight and the other at night. In both instances contact was made with the NVA. Also, in both attempts the MICROTALS did not receive the SID signal and they were subsequently returned to Regiment for examination and repair.

The period from 22 to 27 May saw the Battalion shifted from 4th Marines' OPCON to 9th Marines' OPCON. The Battalion was assigned responsibility for the defense of Con Thien (A-4), C-2 and A-3. One rifle company occupied each position, while the fourth company reinforced A-3 and A-4 with one rifle platoon, respectively. The remaining platoon occupied a defensive position at C-2 Bridge (YD 128668) which included an important water point.

At the end of the month the Battalion was deployed as follows: Company "F" and one platoon from Company "E" occupied and defended A-3 (YD 172721); Company "G" occupied and defended C-2 (YD 113644); Company "H" and Company E(-) occupied and defended A-4, Con Thien (YD 116701); the remaining platoon of Company "E" occupied and defended C-2A position (YD 130669). Since these were all Dyemarker positions, extensive use was made of such devices as the PPS-5 Anti-personnel radar, night observation device and searchlight.

## PART III

SEQUENTIAL LISTING OF SIGNIFICANT EVENTS

1. MISSION. During the period 1 to 31 May the Battalion was assigned the following missions:

a. 1 - 27 May (Operation Lancaster II)

(1) Provide for the defense and maintain security for Camp Carroll.

(2) Conduct search and destroy operations to include aggressive small-unit day and night activities to locate and destroy enemy forces in AO.

(3) Be prepared to provide Sparrow Hawk on 15 minute alert.

(4) Be prepared to provide rough rider and road mine-sweep security on order.

(5) Responsibility for security of Route 9 from 3d Battalion, 9th Marines boundary to 4th Marines/9th Marines boundary.

b. 27 - 31 May (Operation Kentucky)

(1) Provide for the defense of A-3; A-4; C-2 and C-2A.

(2) Dismantle Yankee Station (YD 113686) and reduce C-2A (YD 129670) and Hill 28 (YD 171730) to platoon size positions.

(3) Protect LOC (Route 561) within AO, denying enemy opportunity to interdict LOC by mines or ambushes. Conduct daily road mine sweeps from A-4 to C-2.

2. Significant Events

01 May At 011130H a patrol from 3d Platoon, Company "H" 2/26 found a Confidential list of Division frequencies in vicinity of coordinates YD 092583. List was turned in to 2/26 S-2 section.

02 May At 021815H 1 round of 75 pack howitzer impacted in vicinity of coordinates YD 063549 resulting in 1 KIA (USA), 2 WIA (USA). Round came from unknown location.

03 May At 031115H received 15 to 20 rounds of incoming 82mm mortars in vicinity of YD 074574 resulting in 2 WIA's (1 medevaced). Flashes were observed in vicinity of YD 066589. 81mm mortars and artillery fired at suspected mortar site at coordinates YD 066589 with good coverage. Enemy mortars ceased firing.

11 May At 110820H minesweep received 5 to 7 rounds of 60mm mortars in vicinity of coordinate YD 073570 and approximately 20 rounds of 82mm mortars in vicinity of YD 070572 resulting in 7 USMC receiving minor wounds. No medevacs were required. Artillery, 60mm mortars and 40mm guns (Dusters) fired missions on enemy coordinates YD 065590 and 070585 with good coverage.

12 May At 121450H H/2/26 reported 6 incoming 82mm mortar rounds in vicinity of coordinate YD 086588 resulting in 1 USMC WIA (medevaced). Mortar was observed at coordinate YD 088598 manned by 7 NVA. 17 May At 171905 an accidental discharge of an M-16 rifle resulted in the death of Lance Corporal PARRIS, J. Jr., 2359448. L/Cpl BYERS, R. V., while exchanging his M-16 rifle for a rifle with a chrome plated bore, accidentally pulled the trigger of his own rifle and shot L/Cpl PARRIS thru the neck. L/Cpl BYERS claims that he forgot to clear his weapon on return from rough rider detail. L/Cpl PARRIS was medevaced at 1950H and was dead on arrival at Dong Ha at 2015H.

18 May At 181200H to 181610H 1st Plt, H/2/26 received 4 incoming 82mm mortars in vic of YD 099600 while implanting SID's. While moving out of the impact area the patrol had to cross the Cam Lo River in vic of YD 088-588. As the patrol was crossing the river they received additional 82mm mortar rds and sporadic small arms fire. As the remainder of the platoon crossed the river one of the men was hit by shrapnel or small arms and was swept away by the strong current. Another Marine tried to help but was also struck by shrapnel or small arms and went under with the other Marine. Both men were listed as MIA. 3 WIAs (2 medevaced) were sustained. A search was conducted for the 2 missing Marines.

Two enemy were seen to go down. Swept area with negative results. During fire fight 2 Marines were wounded. Both were medevaced. Ambush was set in general area of contact with negative results.

VN civilians claim 1 NVA had been KIA. Also claim that NVA come to their village to collect rice. Treated 1 VN civilian wounded on 18 May 1968.

20 May At 200142H a patrol was placing and testing sensor equipment in vicinity of coord YD 098598 when 2 NVA appeared within 10 to 15 feet. The NVA were immediately taken under fire with small arms. The NVA were seen to fall and subsequently seen by the Marines. 4 or 5 more NVA took the patrol under fire with small arms, and chicom grenades and attempted to flank and encircle the patrol. The patrol withdrew across the Cam Lo River and broke contact. The NVA pursued by fire. The patrol layed down a base of fire from the opposite side of the river and suppressed all enemy fire. 2 USMC WIA (1 medevac & 1 minor) and one piece of test equipment was missing. 2 NVA (C) KIA.

(3) Postal Services: Mail is initially sorted in the Administrative Rear and sent by convoy and helicopter by mail courier to the receiving activities, where it is turned over to the unit mail clerks.

(4) Post Exchange: Post exchange facilities for the Administrative Rear area are quite adequate. Post Exchange facilities at the forward area at Camp Carroll were considered adequate with two operating PX's. Since the relocation of the Battalion to the Con Thien area, exchange facilities have been limited. A exchange truck makes runs when they can be scheduled.

(5) Special Services: Special Services has provided cribbage boards, games playing cards, writing kits and ice chests to the forward area. In addition, beverages have been and will continue to be provided.

4. Intelligence

a. Enemy situation at the beginning of the period. The accepted location of the 64th Regiment, 320th Division, was north of the Cam Lo River in the vicinity of Dong Ha Mountain (YD 019594). This unit is supported by either the 64th or 52nd Artillery Regiments or both. The 27th Independent Battalion Headquarters continues to operate out of its known base camp in the vicinity of YD 1351. The Cam Lo Local Force Company operating area is accepted as being within the 2d Battalion 26th Marines' AO. Although no hard evidence is available, it is believed that the 27th Independent Battalion and the Cam Lo Local Force Company continued their mission of guiding NVA units

from the DMZ, through Cam Lo District and into the Base Camp 101 area. The enemy forces within the 2d Battalion, 26th Marines AO continued with limited offensive actions in the form of harassing artillery and mortar fire.

b. Enemy initiated incidents.

(1) Contacts - The enemy initiated five ground contacts against the 2d Battalion, 26th Marines, three of which were supported by 82mm mortars.

(2) Sniper Fire - The enemy forces employed snipers against 2/26 on 3 occasions.

(3) Mortar/Artillery/Rocket Fire - The 2d Battalion, 26th Marines received a total of 284 rounds during the reporting period. Below listed is a breakdown by AO, and type received.

(4) Vietnamese Nationals volunteering information. One instance of a Vietnamese volunteering information which led to the capture of 125 pounds of TNT. Another instance occurred in which a civilian pointed out the location of an enemy ammunition cache.

c. Summary of enemy casualties, POW's and captured equipment.

d. No significant trends were noted.

e. Enemy situation at the end of the reporting period. Elements of the 320th NVA Division are known to be operating in and around the 2d Battalion, 26th Marines AO. These units are supported by artillery and rocket units which are either organic to or in general support. These units include elements of the 54th, 84th and 164th Regiments. Another known unit is the K400 or Gio Linh Local Force Company which operates along Highway 1 east of A-3. It also appears that the 812th Regiment of the 324 B Division has moved north from the Hue area and is operating in the area southeast of A-4 in vicinity of YD 1688. The enemy employed harassing indirect fire weapons against C-2 and A-3, while fire against A-4 (Con Thien) was minimal.

f. Weather. The weather during the reporting period was highly conducive to friendly activities as it allowed maximum utilization of air. The days were characterized by clear weather and wind gusts up to 30 knots.

(2) The 106 RR and 81mm Mortar platoon conducted training including: care and cleaning gun drill (day and night), types of ammunition and fuzes, mapping, field fortifications, 81mm mortar in offensive combat, camouflage, M-16 and plotting board.

(3) A representative from G-3 training conducted on position M-16 training to include FAM firing, zeroing of newly issued rifles to companies "H", "F" and "E"(-). A class in quick firing for the M-16 rifle was also held.

e. Fire Support

(1) During the period 1-27 May 1968, artillery support was provided by the 1st Battalion, 12th Marines at Camp Carroll.

(a) There were 39 HE missions fired in support of the Battalion.

(b) There were no illumination missions fired in support of the Battalion.

(c) There were 457 H&I targets attacked at the Battalion's request.

(d) There were 2 significant missions fired in support of the Battalion.

1. At 191445H Company "H"'s Forward Observer called a fire mission on active mortars at grid 092599, resulting in one secondary explosion.

2. At 121430H, Company "H"'s Forward Observer called a fire mission on active mortars at grid YD 088596 resulting in one destroyed mortar tube.

(2) During this period two sections of the 81mm Mortar Platoon were employed at Camp Carroll. One section was located at Khe Gio Bridge in support of Company's "G" and "E" and one section was located at Hill 37 in support of Company "H".

(a) There were 28 HE missions fired in support of the Battalion.

(b) There were 3 illumination missions fired in support of the Battalion.

(c) There were 12 WP missions fired in support of the Battalion.

(d) 171 H&I targets were attacked.

(e) There were 3 significant missions fired in support of the Battalion.

1. The 81mm mortar section at Hill 37 fired 15 rounds of HE and 3 rounds of WP at an enemy mortar position and crew at grid YD 083596 and was credited with destruction of the mortar and an uncertain amount of enemy casualties.

2. At 191350H the 4th section of the 81mm mortar platoon on Hill 37 fired 20 rounds of HE and 10 rounds of WP at enemy mortar position at grid YD 093598 and caused numerous secondary explosions.

(5) During this period two sections and one squad of the 81mm mortar platoon remained in general support from A-4 (YD 116698), while one section was in direct support at C-2 (YD 134644) and one squad in direct support at the C-2 bridge (YD 134670).

(6) During this period the 106 Recoilless rifle platoon remained in direct support of the rifle companies manning defensive positions at A-4 and C-2.

f. Air Support

(1) Resupply: 18000 pounds of resupply lifted to Battalion's positions.

(2) Troop Movement: A lift of a reinforced company was conducted from TSL to A-3.

(3) Direct Air Support: There were 3 DAS missions flown in support of the Battalion.

(4) TPQ-10: 37 targets were requested; number of targets hit is unknown.

(5) Observation: 11 missions were flown for personnel of the Battalion to conduct aerial reconnaissances.

(6) Medevacs: 31 personnel were medevaced by helicopter.

6. Logistics

a. Source of Supply and Maintenance

(1) The source of supply while at Camp Carroll was through the Battalion rear at Quang Tri and FLSG"B" at Dong Ha. Supplies and equipment were then moved by convoy to Camp Carroll and distributed to the units in the field. Second echelon maintenance was performed at Camp Carroll and at Quang Tri following the Battalions deployment to the Kentucky AO. Items for 3d and higher echelon were retrograded by convoy to the Battalion rear at Quang Tri and to FLSG"B". No difficulties were experienced in the system, only in the procurement of transportation.

(2) Supply

(a) Status of Supplies

1. Class I. The Battalion maintained a level of five days "C" rations on hand based on an average of 950 rations. "S" rations were maintained at an average level of  $4 \frac{2}{3}$  days for an average supported strength of 450 as were "R" rations at a level of  $1 \frac{1}{3}$  days.

2. Class II. A 5 day operational level of Class II was maintained at Camp Carroll for those items deemed necessary. The remainder were maintained at the Battalion rear at Quang Tri.

3. Class III. MoGas and Diesel were maintained by Camp Carroll. Bulk lubricants were obtained from the Battalion rear at Quang Tri.

4. Class IV. No specified level of Class IV was maintained, however the Battalion at Camp Carroll built up a sufficient on hand supply to meet the needs of the Battalion.

5. Class V. A basic allowance plus 15 days was maintained of all required Class V items.

6. Miscellaneous. All on hand supplies except for Class II were left at Camp Carroll for use by the relieving Battalion. Currently an inventory of supplies is being conducted at the areas occupied by the Battalion since moving to Quang Tri. Levels of supplies will be as directed by Commanding Officer, 9th Marines.

(b) Resupply. All resupply was accomplished by vehicle while at Camp Carroll except for Company "F", OpCon to 3/9, which was resupplied by helicopter with Class II from Camp Carroll. Resupply improved steadily from the time the Battalion arrived at Camp Carroll until it departed. Resupply of the Battalion and its units located in the A-3, Con Thien, and C-2 areas, will be conducted by road and helicopter from the Battalion rear at Quang Tri.

(3) Evacuation and Hospitalization. Vehicles & helicopters were used to evacuate the casualties from the field and from Camp Carroll. The serious and those not serious but inaccessible to vehicles were evacuated by helicopter to Camp Carroll or to Dong Ha as each case warranted. The serious cases at Camp Carroll were medevaced by helicopter to Dong Ha. No problems were encountered while at Camp Carroll and none have been experienced thus far while the Battalion has been located at Con Thien, C-2 and A-3.

(4) Transportation

(a) Surface. While at Camp Carroll the Battalion moved approximately 1000 cube and 12 tons per day by vehicle.

(b) Air. Very little use was made of transportation by air with the exception of moving certain Class II items, mail and personnel to F/2/26 which was OpCon to 3/9.

7. Civil Affairs. No Civil Affairs activity was conducted during this period.

8. Communications. During the past month communications support was provided for Operations Lancaster II and Kentucky. Also technical assistance was provided for Project 972.

a. Wire. Wire communications was employed at A-4 and Camp Carroll, with the Battalion Command Post, to the companies and organic supporting arms. An effort was made at Camp Carroll to improve the existing wire system within the Battalion Command Post. New wire was installed and old wire was removed.

b. Radio

(1) Constant radio communications has been maintained on the Battalion, Regimental and supporting arms nets.

(2) A covered circuit has been installed between the Battalion CP at A-4 and the Regimental CP at Dong Ha. Upon initial installation, problems were experienced with H-mode cables.

(3) The Tactical Air Control Party continued using VHF and UHF radios in support of the Battalion.

c. Radio Relay. Radio Relay was not needed for communication between the Battalion and Regiment CP's at Camp Carroll. At A-4, a AN/TRC-27 terminal is available to provide communications to the Regimental CP at Dong Ha.

d. Message Center. A total of 879 messages were processed during the month of May.

e. Maintenance and Supply

(1) Batteries were charged and technical assistance was provided in support of Project 972.

(2) At the present time, AN/PRC-25 accessories and TA-1 phones are critically short and have been placed on the highest priority possible.

6. Intelligence.

a. Enemy situation at the beginning of the period. Elements of the 320th NVA Division were located north of the Cam Lo River in the vicinity of Dong Ha Mountain (YD 012592). They were supported by elements of either the 64th or 52nd Artillery Regiments, or both. The 27th Independent Battalion Headquarters and one to two companies were located in a known base camp area in the vicinity of YD 1351. The Cam Lo Local Force Company operating area was accepted as being within the 2d Battalion, 26th Marines' AO. Although no hard evidence was available it was believed that the 27th Independent Battalion and the Cam Lo Local Force Company continued their mission of guiding enemy units through the DMZ and Cam Lo District area. This estimate of the enemy situation was based upon current order of battle holdings, URSs and a study of incidents which had occurred during the previous 2 months.

b. Enemy Situation during Operation. Camp Carroll received sporadic enemy artillery and rocket attacks, including 75mm pack howitzer and 120mm rockets, from the area north of Dong Ha Mountain. Company H elements at Mikes Hill (YD 074574) were sporadically attacked with 82mm Mortars. From contacts by Company H and from a compilation of numerous intelligence reports it was ascertained that:

(1) There was a buildup of enemy troops north of the Cam Lo River in the Van Quat Xa area (YD 0960).

(2) Elements of at least one VC company were intermingled with the inhabitants of Quat Xa (YD 0960) and the Cam Lo Re-settlement Village (YD 1259).

(3) Infiltrating units used the villages in the area as a haven in their movement through the Cam Lo area.

(4) The enemy units were very careful to avoid any significant ground contact. Instead they employed artillery, rockets and 82mm mortars to engage friendly units.

c. No positive unit identification was made.

d. It was noted that the enemy utilized the sound of friendly artillery to cover the use of their own indirect fire weapons.

e. Terrain. The 2d Battalion, 26th Marines' AO was characterized by two dominant terrain features. The first of these was the Camp Carroll plateau (YD 0654) and the second Dong Ha Mountain and its adjoining ridgelines. The Cam Lo River and Highway 9 were the two major east-west features. An important north-south cultural feature was Highway 558. Other significant terrain features which were important due to their observation of Highways 9 and 558 and because of their visual command over movement throughout the AO were Hill 37 (YD 089579), Mike's Hill (YD 078574), OP 250 (YD 0685550, and OP North (YD 059558). Cover and concealment throughout the AO was excellent except in the open areas in the Cua Valley.

f. Weather. The weather throughout the period was highly conducive to friendly activities due to the clear weather conditions which permitted maximum use of friendly air. During the day the weather was characterized by high temperatures and wind gusts up to 30 knots.

g. The indigenous personnel in the Cam Lo resettlement area appeared to be highly receptive to Civil Affairs although the populated areas are known to be VC/NVA havens. There were two incidents of civilians volunteering information which led to the discovery of enemy caches.

#### 7. Mission

a. Provide for the defense and maintain security for Camp Carroll.

b. Conduct Search and Destroy operations to include aggressive small-unit day and night activities to locate and destroy enemy forces in the AO.

c. Be prepared to provide Sparrow Hawk on 15 minute alert.

d. Be prepared to provide rough rider and road minesweep security on order.

e. On order assume responsibility for security of Route 9 from 3d Battalion, 9th Marines boundary to 4th Marines/9th Marines boundary.

f. Install hand SID's along known enemy infiltration routes in the 4th Marines' AO. Operate the microtale from Hill 37 (YD 089578).

8. Concept of Operation. The concept at the commencement of the Battalion's participation in Operation Lancaster II was to defend Camp Carroll with two rifle companies; assign one company to provide security for Khe Gio Bridge (YD 026561) and Route 9 from YD 003565 to YD 060569; and to employ one company to conduct search and destroy operations, primarily in the Cua Valley.

This concept was altered upon the receipt of the mission to provide security at "Mikes" Hill (YD 074573) and Hill 37 (YD 089578)

and to provide security along Route 9 from YD 060569 to YD 089578.

The concept of operation for the employment of the two road security companies was to conduct aggressive patrol and ambush operations and to occupy a minimum of static positions.

When Company F was chopped to 3d Battalion, 9th Marines for security at Thon Son Lam (XD 985552), the forces of Camp Carroll were reduced to one rifle company. Maximum use was then made of resident supporting forces to assist in the defense of Camp Carroll.

9. Execution. Upon arrival at Camp Carroll on 18 April, the commencement of the Battalion's participation in Operation Lancaster II, Companies E and F were assigned to the defense of Camp Carroll. Companies G and H initially occupied a billeting area within the camp itself.

On 20 April, Company G was assigned to provide security for Khe Gio Bridge and Route 9 from YD 003565 to YD 060569. At darkness on the night of 23 April, Company H commenced what was to be a three day search and destroy operation in the CUA VALLEY. After two nights and one day in the field, the company was diverted to Hill 37 and relieved Company E, 2d Battalion, 9th Marines of responsibility for security of Route 9 from YD 060569 to YD 089578.

The two companies assigned security for Route 9 occupied Khe Gio Bridge, the bridge at YD 042565, Mikes Hill and Hill 37. The concept was to maintain as few static positions as possible while conducting aggressive patrol and saturation ambush operations. Each Company established a swing platoon. The swing platoons operated throughout the company's zone of action conducting search and destroy/clearing patrols and ambushes. In conjunction with these activities the forces assigned to static positions conducted platoon minus and squad size patrols and reinforced squad ambushes.

On 26 April 68 the 4th Marines Scout Snipers attached to Company H found 55 bodies at YD 089577. All bodies appeared to have gunshot wounds.

A Company H patrol, on 28 April, discovered parts of approximately 10 to 15 bodies at YD 072575.

On 30 April Company F was chopped to 3d Battalion, 9th Marines for the defense of Thon Son Lam (XD 985552). Company F remained under the operational control of 3d Battalion, 9th Marines until the end of the Battalion's participation in Operation Lancaster II.

The Battalion enforced the CO, 4th Marines' policy regarding vehicular traffic along Route 9. Only scheduled convoys or convoys with at least two vehicles, an FO and FAC, and proper security were allowed to travel along Route 9. Two checkpoints were established, one at the Khe Gio Bridge and the other at the southern base of Hill 37. Unauthorized vehicles were stopped, reported to 4th Marines COC and then turned back.

On 10 May the minesweep sweeping Route 9 east from Hill 37 to Cam Lo Village was guided to a road culvert containing approximately 125 lbs of explosives by a small VN boy. The explosives were removed and destroyed and the VN boy was rewarded with 1350 Piasters by the Battalion S-2.

Also on the same day, a patrol from Company H found 12 82mm mortar rounds with fuzes, a US field protective mask, one bottle of albumin serum and an intravenous kit. The cache was disclosed to the patrol by a small VN boy who immediately ran away.

On 15 May the Battalion was assigned the task of recommending areas for installation of hand SID's and a microtale. A plan was submitted to and approved by the Regimental Commander to place the hand SID's in three or four areas along a known enemy infiltration routes near YD 098597, YD 105598 and YD 115565. Hill 37 was chosen as the location for the microtale. The first area to be seeded was north of THON QUAT XA at YD 099598. On 18 May a Company H patrol crossed the Cam Lo River to emplace the SID's. During this attempt, however, it was discovered that the microtale did not receive the signal. While north of the river the patrol was attacked by 82mm mortar and sniper fire. A second patrol was conducted the night of 20 May. Again the microtale would not received the SID's signal. As the patrol was returning it engaged several NVA, killed two and then withdrew across the river to the platoons' supporting position.

Company H was alerted at 221100H May to be prepared for deployment to Con Thien. The move was commenced at 1500 and Company H was chopped to 3d Marine Div at 221900H. Company E then assumed responsibility for the security of Route 9 in the Battalion's AO. One platoon from Company F was returned from Thon Son Lam to the Battalion's control on the same date to provide additional forces within the Battalion's AO.

On 25 May, Company B, 1st Battalion, 4th Marines arrived by motor convoy at Camp Carroll and was chopped to the Battalion. Company G, utilizing the vehicles that brought in Company B, was transported to C-2 (YD 135644) and chopped to the 9th Marines. The following day Company F was helilifted from both Camp Carroll and Thon Son Lam to A-3 (YD 173720) and was chopped to the 9th Marines.

On 27 May the remainder of the Battalion, including H&S Company and Company E, moved by motor convoy to Con Thien and was chopped to the 9th Marines at 1500.

#### 10. Results

##### a. Friendly

- (1) KIA 4
- (2) WIA (medevac) 13
- (3) WIA (minor) 27
- (4) DOW 0

##### b. Enemy

- (1) KIA(C) 76
- (2) Material Captured or Destroyed: 125 lbs of TNT destroyed, 12 82mm mortar rounds and a small amount of enemy 782 gear.

#### 11. Administrative Matters

##### a. Supply

- (1) All resupply for the Battalion forward positions at Khe Gio Bridge and Hill 37 was delivered by vehicle from Camp Carroll.
- (2) Sufficient ammunition was on position at the Khe Gio Bridge and Hill 37 to provide ample Class V backup.
- (3) Units operating away from Camp Carroll and both forward bases did not require resupply in the field.

b. Maintenance. Organic facilities for 2d echelon repair of weapons, vehicles, and communications equipment were located at Camp Carroll which permitted expeditious repair when the necessary parts were available.

##### c. Treatment of Casualties, Evacuation and Hospitalization

- (1) A Battalion Aid Station with excellent facilities was located at Camp Carroll. The facilities were utilized by casualties sustained at or in close proximity to Camp Carroll.
- (2) All casualties sustained during search and destroy operations were evacuated by helicopter to Co D, 3d Medical Battalion at Dong Ha.

## d. Transportation

(1) Organic vehicles were utilized for command and control, reconnaissance, and inter unit resupply.

(2) 9th Motor Transport Battalion provided truck support for exterior resupply, trash collection and other requirements.

## e. Communication

(1) Covered Circuit. A covered circuit was not necessary at Camp Carroll due to the proximity of the Battalion CP to the Regimental CP.

(2) Wire. Wire was extensively employed within the Battalion Command Post and to the companies on the perimeter. In addition to the switchboards employed within the Battalion CP, one SB-22 was installed at each company CP position at Camp Carroll.

(3) Dyemarker equipment. 1 AN/PPS-5, 2 AN/PPS-6s and 2 NODs were employed by the Battalion. Battery charging and technical assistance for the equipment was provided by the Battalion and Regimental radar technicians.

f. Medical Evaluation. During Operation Lancaster II the BAS was located at Camp Carroll. The BAS maintained medical support for our units in the field by maintaining a ward and clinical lab for both in-patient and out-patient care. A small rear BAS was maintained and the majority of medical supplies were located at Quang Tri. There were no major problems in the resupply of medical material to the BAS at Camp Carroll. There were no significant medical trends.

12. Special Equipment and Techniques

## a. Equipment

(1) Microtale. A representative from the Division G-3 section worked with the Battalion to assist in installation and use of hand SID's and the microtale when the Battalion was assigned the task of employing these electronic devices. Two separate attempts were made to place the hand SID's approximately 2200m from the microtale. The microtale was not able to detect the hand SID signal beyond several hundred meters. All devices were turned in for examination and repair.

13. Commander's Analysis. The Battalion's participation in Operation Lancaster II consisted primarily of the conduct of defensive and security type operations. While two companies were assigned to the defense of Camp Carroll, emphasis was placed on improving fighting



positions, clearing fields of fire and improving artificial obstacles. Work progressed rapidly at first but slowed when one company was chopped to 3d Battalion, 9th Marines, reducing the forces available for the defense of Camp Carroll to one rifle company and resident supporting forces. Providing for the security of Route 9 was the Battalion's other major mission. It was my intention to tie down as few forces as possible at static defensive positions, and to remain as flexible, mobile and aggressive as possible. Thus the concept, mentioned above, of utilizing one swing platoon from each company and the conduct of maximum patrolling and ambushing operations was employed. It is impossible to determine the degree of success of this concept in deterring enemy interdiction of the LOC. However, there were no major incidents along Route 9 in the Battalion's AO during the period 18 April to 27 May.

#### 14. Recommendations

- a. That forces committed to the task of providing security for a major LOC conduct multiple patrol and ambush operations and maintain as few static positions as is practicable.
- b. That resident supporting units be utilized to the maximum extent possible to provide security for fixed bases in order to free infantry units for field operations.
- c. That adequate engineer equipment, bulldozers, front end loaders, and back hoes, be provided to clear and maintain fields of fire and to improve and rehabilitate defensive positions.


