PART II

NARRATIVE SUMMARY

During the reporting period, the 2nd Battalion, 26th Marines was still established in the northernmost sector of the Division TAOR, the Area of Operations including HAI VAN PASS.

The Battalion Rear Command Post remained at the ROCKCRUSHER (AT 942749) throughout the period. The Battalion Forward Command Post remained at Hill 724 (AT 944920) until 15 February 1970, at which time they moved to the ROCKCRUSHER (AT 942749). Company E maintained its command post at LIEN CHIEU ESS DEPOT (AT 937867). Company F located its command post at LANG CO BRIDGE (AT 886955) until 15 February 1970. Company G located its command post at Hill 724 (AT 944920) until 22 February 1970. Company H located its command post at Hill 88 (AU 807017) until 15 February 1970.

The reporting period was marked by the relocation of Company F to the ROCKCRUSHER and further assigned OPCON to the 1st Battalion, 26th Marines at Hill 10 (AT 922694). Company F remained OPCON to the 1st Battalion, 26th Marines from 17 February to 21 February 1970, at which time they returned to the ROCKCRUSHER for standdown. Company H was airlifted to Hill 34 on the 15 February 1970 and remained there until 22 February 1970 at which time 1st Platoon was assigned to Hill 724 (AT 944920). Company G returned to the Bn. C.P. (AT 942749) on 22 February and started its standdown.

The Battalion's activities, in furtherance of its defensive mission, were marked by continuous small unit patrolling and ambushing.

On 21 February the 2nd Battalion, 26th Marines started its standdown.

The close of the reporting period found the Battalion had administratively reduced Companies F and G to zero strength and were anticipating reducing Companies E and H in anticipation of deactivation in CONUS.

The 2nd Battalion, 26th Marines participated in no major combat operations during the reporting period.

b. Command Relations

During the reporting period, the Battalion was under operational and administrative control of the 1st Marine Division and 26th Marine Regiment.

Provide security for lines of communications in the assigned Area of Operations in cooperation and coordination with Regional Forces, LOS BANOS Fire Support Base, and the LIEN CHIEU ESSO DEPOT; and conduct Category I Operations in populated areas as part of the Accelerated Pacification Campaign.

f. NBC Warfare

No NBC devices were used by or against the Battalion during the reporting period.

2. INTELLIGENCE

a. Enemy Situation

- (1) At the beginning and during this reporting period, the enemy avoided contact with all friendly forces. The VC/NVA continuously moved small units of the Phu Loc Armed Battalion and the C-31st NVA Company to key locations, thus preventing any large contact. At the same time, this created an overall threat in all areas within the TAOR.
- (2) No significant contact was generated by the enemy during this reporting period, however, many caves, a few rice caches, and harbor sites were located and destroyed.

b. Enemy Initiated Incidents

- (1) On 2 February 1970, a patrol from Fox Company received sniper fire, and sustained one WIA. The patrol returned to their original position with the WIA. On their return to the patrol site, they received one hand grenade. This action took place at grid (884930).
- (2) On 4 February 1970, a patrol from Fox Company on an ambush site heard enemy movement and exploded four Claymore Mines. They heard increased movement at coordinates (898930) and called for a fire mission. Another fire team was sent to join them and both units swept the area. They found a total of three enemy KIA's and indications of a squad of VC/NVA in the area.
- (3) On 7 February 1970, a reconnaissance patrol contacted Hotel Company and reported six male and 1 female enemy in the vicinity of coordinates (832067). A grave was located at the site and a body without its head was found. Hotel Company sent a reinforced squad to the area. Enroute to the grave, this squad found one male and one female in a cave. The female escaped, but the male surrendered. The prisoner told Hotel Company that 30 more VC wanted to surrender. They returned to Hotel Company's position and interrogated the prisoner. Returned to position with loud speaker and ITT interrogation report. Continued to search area and prisoner attempted to entice others to surrender. Negative results.

- (1) The enemy trends have changed very little from the last period, except for the fact that he moved only small groups as is previously mentioned.

e. Weather Conditions

- (1) During the reporting period, the weather was favorable from the friendly operational standpoint.

3. SEQUENTIAL LISTING OF SIGNIFICANT EVENTS

- 1 February At 0820, 3rd Plat., Co. F at AT 896956 were returning from RF compound when they opened gate and booby trapped M-26 exploded. RF had put out M-26 the night before and failed to inform 3rd Plat. 2 men were wounded and MEDIVACED by helicopter.
- 1 February At 0055, 3rd Sqd., 3rd Plat., Co. E spotted light flashing (AT 923872). Fired one (1) round M-79, light quit flashing. Checked area with negative results.
- 1 February At 2345, Co. H reported that Restless Tide Bravo saw 2 or 3 characters 25 to 35 meters in front of their position (AT 832998). They threw one (1) M-26 and it struck a tree and fell approximately 10 meters in front of their position. One man was struck in head, chest and leg by M-26 shrapnel. Injured man was MEDIVACED.
- 2 February At 0150, 1st Sqd., 2d Plat., Co. E reported continuous movement between the lower and northern corner of the Esso Plant (AT 938864). Possibly 1 or 2 enemy. Echo moved portion of reaction squad into position between plant and tower; fired CS gas and swept area with negative results.
- 2 February At 0230, 2d Plat., Co. E while sweeping (AT 937864) East-Northeast of Esso Depot to locate reported movement, a trip flare was tripped and a member of the internal plant security fired his M-16 and wounded 1 Marine. Medical aid was dispatched immediately but WIA died of wounds.
- 2 February At 0500, 3rd Plat., Co. F reported seeing three enemy at water tower at the railroad (AT 887953). Fired 6 (six) M-79 HE rounds. Swept area with negative results.
- 2 February At 1300, 1st Sqd., 3rd Plat., Co. F observed 2 NVA walking down the trail towards their position coming from (AT 884930). The NVA fired 2 shots at the position and fled to the West. One USMC was WIA. In returning the WIA to CP, they received 3 M-26 grenades. Returned fire with 30 rds. and checked area with negative results.

- 2 February At 1400, S-2 Scouts spotted 2 enemy (AU 864006). Enemy went into bushes and two other enemy joined them. Artillery was called in on the enemy and the area was searched with negative results.
- 2 February At 2105, 3rd Plat., Co. E observed flashing light (AT 924883). The light was moving East. A 81mm mortar mission was called in. Area was swept with negative results.
- 3 February At 0800, 2d Battalion, 26th Marines went into C-2 category (personnel).
- 3 February At 0945, Co. E reported 2 enemy (AT 939870). Enemy appeared to be checking E Co. defensive positions. They were wearing khaki uniforms. E Co. fired 60mm into area. Swept area and received one sniper round. Further search noted negative results.
- 3 February At 1500, Co. F observed enemy bunker and harbor site (AT 906932). F Co. kept harbor site under observation and had negative sightings.
- 3 February At 2130, 1st Ft, 1st Sqd., 3rd Plat., Co. F while set in an ambush site saw movement (AT 897932) and opened fire with small arms and 4 claymores killing 2 enemy. The unit received enemy fire and called in Artillery. Unit also requested Shadow. Gunship had good coverage of area. After Gunship ceased fire, more movement was heard and unit opened fire again killing one more enemy. Further sweep of area resulted in negative results.
- 4 February At 1245, 1st Sqd., 3rd Plat., Co F spotted 2 enemy at (AT 901929) and called in 81mm fire mission. Had good coverage of target. Swept area with negative results.
- 5 February At 0300, 81's IP spotted 11 enemy moving in front of their position, opened up with small arms. Swept area with negative results.
- 5 February At 1300, 2d Sqd., 1st Plat., Co. H apprehended suspicious man (AU 809018). Man had false ID card and lied about his age. Turned VCS over to Regiment IIT team and determined that suspect was a confirmed VC.

- 5 February At 1958, Battalion Scouts spotted 24 enemy carrying small arms and what appeared to be 2 mortar tubes (AU 812047). Scouts called in 48 rds. of artillery. Further sweep of area netted negative results.
- 5 February At 2225, 1st Sqd., 3d Plat., Co F spotted three lights (AT 888942) and called artillery fire mission. Swept area with negative results.
- 6 February At 1525, 1st Sqd., 3d Plat., Co. F found what appeared to be enemy rocket launcher (AT 872927). Fire mission was called in with good coverage. Area was swept with negative results.
- 7 February At 0945, Co. H dispatched mobile reaction force from a request by a Recon insert. Reaction force observed 1 male and 1 female (AU 832067). H Co. captured 1 VC male and while searching area found caves where enemy were sleeping. Further sweep ended with finding fresh grave with one male body with black shirt wrapped in plastic. Head was blown off. Appeared to have been hit by artillery.
- 9 February At 1240, 1st Sqd., 3d Plat., Co. F observed 1 enemy running SW over ridgeline (AT 884936) wearing dark clothing. 81mm mission was fired. Area swept with negative results.
- 12 February At 1625, 1st Sqd., 3d Plat., Co. F spotted 1 enemy who appeared to be on some sort of watch (AT 866933). Fired 81mm mission, checked area with negative results.
- 14 February At 2045, 1st Sqd., 3d Plat., Co F spotted 5 enemy moving to the SW (AT 880950). Enemy fired approximately 30 rounds at F 3-1 with no effect. 81mm mission was called in. Area was swept with negative results.
- 15 February At 0900, Prov. Battery, 1st Bn., 13 Marines left Los Banos and proceeded to N.A.C. (AT 922795).
- 15 February At 0900, Co. H was airlifted from Los Banos to Hill 34 (AT 990712).
- 15 February At 1200, "B" Batry., 1st Bn., 13th Marines left Los Banos and proceeded to Hill 65 (AT 878577).

- 15 February At 1200, Co. F was relieved at Lang Co Bridge and moved to Battalion Rear CP (AT 942749).
- 15 February At 1300, Battalion Forward CP moved its position to Rockcrusher (AT 942749).
- 16 February At 2000, IP of Co. E heard enemy movement (AT 932869). 60mm Mission was called. Area was swept with negative results.
- 17 February At 1300, Co. F was sent OP CON to 1st Battalion, 26th Marines.
- 19 February At 1200, 2d Sqd., Co. G found human bones at (AT 925908). Bones appeared to be 6-12 months old.
- 20 February At 1300, 2d Sqd., Co. E found 5 inch dud Naval Gunfire round (AT 911886). Round was blown in place.
- 21 February At 0900, Co. F returned from OP CON to 2d Bn., 26th Marines.
- 21 February At 1300, Co. F returned to Bn. CP (AT 942749) and started deactivation.
- 22 February At 0900, 1st Plat., Co H moved from Hill 34 (AT 990712) to Hill 724 (AT 944920).
- 22 February At 1300, Co. G returned to Bn. CP (AT 942749) and started deactivation.
- 23 February At 1010, Co. F was administratively reduced to zero personnel strength.
- 24 February At 0900, Co. G was administratively reduced to zero personnel strength.
- 28 February At 1600, Two platoons of Co. H moved to Battalion Rear (942749) and started deactivation.

7. ADMINISTRATION

During the reporting period, all Company and Battalion Administrative Offices were located at the Battalion rear area in the vicinity of the Rockcrusher (AT 942749).

8. LOGISTICSa. Supply/resupply

During the period 1-28 February 1970, all Company supply and resupply was accomplished by truck. Supply to Companies was accomplished on a three day rotating cycle. Although during this period Battalion Supply was in the process of turning in equipment and invoicing gear to other units, little disruption in the normal functioning of supply was experienced.

b. Food/Water

During the period 1-14 February, three messhalls were in operation. One each at Hai Van, Dai La and Esso Plant. On 14 February the Hai Van messhall ceased operation and the Esso messhall took on the additional burden of feeding those personnel at Hai Van and Hill 358. The messhall at Esso was closed on 27 February after the evening meal leaving only the Dai La Pass messhall in operation. Those troops still remaining at positions without messhalls subsisted on MCI's supplemented by "B" rations and fruit juices. No significant problems were encountered in regards to the amount of water produced or delivered to Battalion positions.

c. Maintenance

During the period 1-28 February, all first/second echelon maintenance was completed by personnel of this command. Third/fourth echelon maintenance on equipment/vehicles was done by 1st FSR and FLC. No major maintenance problems were encountered during this reporting period.

d. Base Facilities

During the period 1-28 February, minor facility improvements were made. Normal maintenance and upkeep were accomplished. Hai Van Pass Cantonment, with the exception of a security platoon, was vacated on 15 February. On 27 February an 80 gallon Fast Recovery Oil Water Heater was installed in two troop showers.

9. NEW TECHNIQUES

- a. There were no new techniques learned this reporting period.

10. TRAINING

- a. During the first five days of February, zeroing of the M16s was conducted at Companies E, F, G, H locations.
- b. This training and zeroing was under the direction of a representative of the S-3 section, assisted by an armor who had sufficient spare parts available to make on the spot weapons repair.
- c. This was accomplished in order to assure the command that all weapons were not only functional as they should but that one shot kills could be achieved by each man due to an established zero. Giving each man more confidence during the suspected TET offensive.
- d. Technical training was conducted at the platoon level in the 81mm Mortar Platoon, 106mm Recoilless Rifle Platoon, Communications Platoon, Service Platoon, and Flame Section.

11. CIVIC ACTION/PSYCHOLOGICAL WARFARE

a. Civil Affairs

- (1) During the period from 1 February to 15 February, six Med-Caps were held in the CAAOP, all being conducted in the village of Loc Hai. A total of 334 Vietnamese were treated. On the 15th of February, 2/26's CAAOR was withdrawn to Hai Van Pass, which eliminated any need for further Med-Caps in the CAAOR. Kin Lien, the only hamlet now in the CAAOR, receives medical aid from 1st Medical Battalion. Before 2/26's Med/Caps were eliminated, the medical personnel ensured that the local Vietnamese health workers were capable and informed on ways to draw medical supplies and methods of village personal hygiene.
- (2) Before the CAAOR change, S-5 distributed 150 school kits; 50 school kits to the orphanage in Loan Ly and 100 school kits to the Kin Lien school. 150 ammo boxes as well as a 50 lb. bag of rice distributed to the Loan Ly orphanage. Arrangements are being made to supply Kin Lien with cement and tin in order to construct a water well.
- (3) Twenty-one General Walt Scholarships were initiated this month for Loc Hai, only to be disapproved because the CAAOR was shortened, thus eliminating Loc Hai Village as a recipient. This S-5 is still attempting to enroll a thirteen year old boy in a reputable school that teaches English in Da Nang City.
- (4) Due to the pending withdrawal of 2/26, a reduction in force of messhall workers was effected. The Vietnamese workers were relieved and are being paid two weeks advance pay, according to IRO regulations.

b. Personal Response

One Personal Response class was given to new troops by the NCOIC during this period. Approximately twenty Marines were present for the class.

a. Psychological Operations

- (1) S-5's psychological warfare program dealt primarily with leaflet drops and tapes that coordinated with the leaflets. During TET, this CMAOR was saturated with leaflets calling for the VC/NVA to "Return Home", as directed by Regiment. Following TET, S-5 coordinated with S-2 in order to drop relevant leaflets on areas designated as suspected enemy unit movements. Since the hamlet of Kin Linh is the only hamlet in this CMAOR, all psychological operations were aimed at this location and it's surrounding area after 15 February 1970.
- (2) A P.O.W. was captured by Hill 88 and later became a Chieu Hoi. This S-5 accompanied the Chieu Hoi when he volunteered to lead Marines to his base camp. Although, only evidence of V.C. inhabitation was found, S-5 had intended to exploit any possible Chieu Hoi's had the operation been successful.
- (3) This S-5 has also been responsible for the apprehension of two Vietnamese dope peddlers in this Battalion rear area. They both were taken to CID Headquarters where they were relieved from 2/26 custody.

12. COMMUNICATIONS

a. Radio

- (1) From 1 February until 15 February, the radio section provided personnel and equipment for two (2) Battalion Command Posts, forward and rear. Communications personnel and equipment were also provided for four (4) letter companies and the 81 mm mortar platoon.
- (2) During the period the radio section set up a COC in the Battalion Rear in preparation for the removal of the Forward Command Post from Hai Van Pass.

b. Wire

- (1) The wire section continued to maintain internal wire communications for both Battalion Command Post, forward and rear, during the period 1 February to 15 February.

- (2) In preparation for the removal of the Forward Command Post from Hai Van Pass, the wire section set up wire communications to support the COC at the Battalion Rear. This included hotlines from the Battalion COC to Regiment COC, FSCC hotline, hotline from COC to Commanding Officer/Executive Officer office, hot line from COC to Battalion Guard Shack, and a common user from COC to Battalion Switchboard.
- (3) Upon withdrawal of Hotel Company from Hill 88 to Hill 34, a wire team installed an SB-22 and phone lines in support of Hotel Company at Hill 34.

c. Message Center

- (1) Twenty Six Marines continued guard for this Battalion. The Battalion Message Center continued to make three (3) courier runs daily to Twenty Six Marines.

d. Supply/Maintenance

- (1) Supply continued to function in accordance with current directives.
- (2) The maintenance section maintained normal operations throughout the period in support of Battalion Operations.

e. Significant Events

- (1) On 15 February 1970, the Battalion Forward Command Post was displaced from Hai Van Pass to the Rookerusher. Continuous communications were maintained throughout the operation with the Rear Command Post assuming net control as the Forward Command Post removed the communications equipment from the established nets.
- (2) On 12 February 1970, Captain D. PENDERGAST joined Second Battalion, 26th Marines as Communications Officer.

13. MEDICAL/DENTAL

a. Medical

- (1) The administration of the BAS has been handled by the administrative section of the aid station, using not only the facilities on hand, but also those of 26th Marines, and 1st Medical Battalion. Sick call was handled by the

Medical Officer and four hospital corpsman assigned those duties.

- (2) The mount-out supplies have been packed, inventoried, and transported to 1st Medical Battalion for our eventual disbanding of the Regiment.

(3) Personnel

- (a) Currently there is one medical officer attached to the Battalion. He is located in the Battalion rear BAS. Corpsman are distributed as follows:

b. Dental

- (1) The Battalion has been supported dentally by 1st Medical Battalion and 11th Motor Transport Battalion's Dental Clinics.

c. Transfers

- (1) Due also to our eventual disbandment, we have had many transfers. Lt. Andras, our forward BAS doctor, was transferred to 1st Recon Battalion. Lt. Pierce, our Chaplain, was transferred to 4th Battalion, 11th Marines. We also lost 2 1st Class corpsman, two 2d Class corpsman, 24 3d Class corpsman, and 5 Hospitalmen.

14. RELIGIOUS ACTIVITIES

(a) Personnel

- (1) Lt. John J. Pierce, CHC, USNR, is the Battalion Chaplain.
- (2) CPL John E. Maloney, USMC, is assigned as assistant and driver for the Chaplain.

(b) Services Conducted

- (1) Sunday Catholic Masses - 13 - with 197 attending and 176 receiving.
- (2) Weekday Catholic Masses - 28 - with 301 in attendance and 290 receiving.
- (3) Sunday and weekday Protestant services are provided in all 2d Battalion areas by Regimental Chaplain 26th Marine.

(c) Facilities

- (1) There is a chapel in the Battalion Rear area.
- (2) Transportation is available each day for travel throughout the Battalion area of operation.

(d) Counseling Forty three men were privately counseled.

(e) Significant Events

- (1) Catholic Mass was offered in Sacred Heart Church, Lang Co Ville, with 5 Marines and 71 Vietnamese in attendance.
- (2) Foods and other consumables were provided for Vietnamese villages on three different occasions.

(f) Other Activities

- (1) Chaplain PIERCE serves on the board of the Battalion Leadership committee. The committee's purpose is to aid the Commanding Officer in the solution of the ethnic, racial, and other problems.
- (2) Chaplain PIERCE gave the monthly day of recollection for area chaplains on two occasions at Da Nang and Saigon.

NARRATIVE SUMMARY

During the reporting period the 2nd Battalion, 26th Marines turned over its area of operation to the 3rd Battalion, 1st Marines and the letter companies E & H returned to the Battalion Rear Command Post at the ROCKCRUSHER (AT 942749). The Battalion is now operating with three companies - H&S, E and H. F & G companies have been administratively dropped. The Battalion was in a stand down posture in preparation for deactivation.

The Battalion was alerted to a two company, two day operation in the vicinity of OP RENO (883748) and moved out to their areas by truck the morning of 2 March 1970.

Both companies conducted day time patrols and night LPs and ambushes. Their primary mission was to locate suspected rocket sights and deny the use of infiltration routes to the east.

Company E returned to the ROCKCRUSHER Area on 4 March and continued with their stand down. Company H did the same on 6 March 1970.

Two companies of the 1st Battalion, 5th Marines moved in to the ROCKCRUSHER Area to assume the area security, while Companies E & H proceeded with their deactivation.

On 7 March, personnel of Companies E, H and some of H&S personnel were administratively dropped and transferred to the 7th Marines. This transfer of 503 Marines was accomplished by air and completed by 1645.

As of 7 March the only Marines of 2/26 remaining at the ROCKCRUSHER were 150 Keystone Bluejays personnel who are to return to CONUS via air and ship and those 31 key administrative personnel necessary to carry out the deactivation of the Battalion.

2. INTELLIGENCE

a. Enemy Situation

During the reporting period the enemy avoided contact with all friendly forces.

b. Enemy Initiated Incidents

On 4 March at 0630 Company E CP heard movement and spotted 7 enemy in thick brush 70 meters NW of their position AT 895715. They were taken under fire and an area search at first light revealed no bodies, but they did find 1 VC pack, 2 cans of fish, 2 large rice balls wrapped in plastic, 1 bag of corn meal, 1 bag of candy, 4 plastic explosive charges, 1 home made fuse and 1 pair of VC sandals.

The enemy trends have changed very little since last reported period. Reported movement is at night and in small groups.

e. Weather Conditions

During the reporting period the weather turned very warm, but was otherwise favorable from the friendly operational standpoint.
