PART II

NARRATIVE SUMMARY

During the month of June the enemy continued to utilize guerrilla tactics against the forces of this battalion. Mines and booby-traps continued to be a serious hazard throughout the T-10R. Eighty-one such devices were discovered by Marines and were destroyed in place. Another twenty-seven devices were detonated by troops in the field causing the majority of the battalion's casualties. However, the battalion's casualties for the month were 30% lower than the average of the preceding months (less Operation Allentown) due almost exclusively to the large percentage of mines and booby-traps which were discovered and destroyed before they could become casualty-producing agents.

3. TRAINING

a. All personnel assigned to the battalion, who were recent arrivals from CONUS, received a four day indoctrination/training period prior to assignment to field duty. Subjects covered included the M-16 rifle, PsyOps/civic action, intelligence gathering, personal response and administrative processing.

b. Headquarters and Service Company conducted a daily training schedule for personnel in garrison. The rifle company in reserve also conducted daily training to further enhance troop proficiency in the field.

c. The following listing delineates, by school, the number of personnel attending formal Schools during the month.

4. OPERATIONS

a. 3rd Battalion, 27th Marines TAOR (See Tab 1 to Enclosure (1))

b. Enemy

The enemy continued to utilize guerrilla tactics. Sniper and harassing type fires were received by platoons and squad sized units on 46 occasions. Among these 26 were classified as light contacts (1-50 rounds received), 7 moderate (50-100 rounds received), and 11 heavy (in excess of 100 rounds received). The enemy broke contact immediately after initiating the action making it extremely hard for friendly forces to pinpoint the source of fire. In only two instances did the enemy indicate a willingness to engage with the battalion's forces. In both cases, on the 15th and 24th, it was evident that the enemies' main intent was to destroy the tanks which were attached to the infantry forces.

from the battalion participated and 400 rounds were fired in support of the school. The training was well received and the ability to professionally call and adjust fire will provide immediate benefits in the field.

5. CIVIC AFFAIRS/PSYCHOLOGICAL OPERATIONS

a. The month of June was most active providing results of a positive nature. The rapport established between Vietnamese personnel and Marines of the 3rd Battalion, 27th Marines is ever increasing.

b. The establishment of weekly Personnel Response classes has proven beneficial in helping the Marines to understand the Vietnamese people's cultures, norms, and religious beliefs. The classes have also benefited the S-5 personnel in understanding the typical Marine's misunderstanding and dislikes regarding the local population.

c. Various projects were planned and completed during the month. Those having high-impact nature are described below.

(1) The completion of a community shower and well, located at the MedCap structure outside the main gate of this Command Post.

(2) A water drainage canal was constructed in HUAN QUA beneath the Tu Cam Road. This project was accomplished through the joint efforts of this Battalion's S-5 section, Share Party, and the local Vietnamese people.

d. Several MedCaps were held in the villages of CAM SA, VIEN DONG, and BINH KY. Daily MedCaps were held at TRA KHE (2), Tu Cam Bridge, and at the main gate of this Command Post. Members of S-5 section accompanied "I" Company and "K" Company on patrols to the CAM SA and VIEN DONG areas. On these occasions, verbal PsyOps were conducted with the villagers on various subjects. The S-5 also initiated its own patrols in several areas for the same purpose.

e. Verbal and written authorizations played a large part in the Civil Affairs program. A concession for a laundry was authorized to be located at the Tu Cam Bridge. The villagers in the THANH THUY village were authorized to congregate in groups of approximately one hundred in the THANH THUY market place. Permission was also granted for several families to relocate themselves and their houses with their hamlets.

f. During the month the Division Personnel Response team visited this Battalion on three occasions and gave lectures concerning the cultures, religions, and customs of the Republic of Vietnam.

5. This month concluded with an inspection by the Division C-5 sections. An outstanding rating was received. Most of the problem areas in Civil Affairs relations have been set and dealt with in an effective manner and a close communication with the indigenous personnel of this area continues.

6. MEDICAL

a. The Medical training program has returned to normal after Operation Alkermes. Company and Battalions alike are receiving instruction on self and body-wash as well as personal hygiene.

b. Although no formal sanitation inspection was conducted by Division personnel during the past month there has been a great improvement in the general sanitary conditions. Showers, toilet facilities and bathing have been repaired and replaced automatically as the need becomes evident.

7. LOGISTICS AND SUPPLY

a. The first quarterly inspection by the Division Material Management Assistance team was conducted on 19 June. All staff sections under the cognizance of the S-4 received "satisfactory" ratings with special credits going to "Y" Company for the administration and operation of their company supply.

b. Battalion Supply has been able to compile recording details for supply items thereby establishing Inventory Control Data based on in-country movements.

c. (1) The mess hall continued to operate with two field kitchens in addition to the base company. A total of 2400 meals were served daily between the three messes.

(2) An assistance team from the 1st Engineer Battalion completed the construction of a new refuse drainage system for the mess hall.

On 4 and 5 June, Co I, with an attached section of Antacs, moved from the Battalion C.P. to KHUE DONG (1) via (BT 055709). After establishing a company patrol base extensive day and night combat patrols and ambushes were conducted to find the enemy and locate a suspected enemy mortar position. A suspected mortar site was located but no enemy were found and Co I was returned to the Battalion C.P. on the afternoon of 5 June.

d. Small Unit Operations.

During the month the rifle companies spent ten days in each AOR; the Riviera, Desert and Tu Cau Areas. In this ten day period the companies conducted extensive day and night ambush and combat patrols. The rifle company providing Battalion Reserve had a continuing commitment to provide one platoon for Rough Riders Security, one platoon Option to 1st MP Battalion for POW Compound Security, and ambush patrols in the immediate vicinity of the Battalion C.P. (BT 070656). Twenty-two platoon size offensive sweeps were conducted during this period to keep the enemy off balance and to deny him a safe haven. Three Company size sweeps were also run on the 9th, 15th, and 18th of the month. On three occasions during the month Company minus size blocking forces were provided for allied unit sweeps; two for ARVN forces on the 18th and 24th and one for the ROKMC on the 15th.

e. Air Support

(1) Marine helicopters were used extensively during this period for the execution of MED EVAC'S. Response time is minimal and personnel in the field are becoming highly proficient in the art of utilising helicopters.

(2) Cargo carrying helicopters were utilized to resupply OP's, Crews Nest and TA-6 on a weekly basis. Both internal and external loads were utilized.

f. Artillery Support

(1) The majority of the Battalion's direct artillery support continued to be provided by F/2/13. An average of 25 Harassment and Interdictory fires were scheduled each night.

(2) From 24 to 29 June, an artillery forward observer school was conducted by 2nd Battalion, 75th Marines for platoon and squad leaders. 60 personnel





7. Supporting Forces

a. Artillery. Throughout the conduct of the operation, artillery support was utilized to a high degree. Prep fires, contact fire missions, night defensive fires and H&I fires were utilized on a daily basis. From 16 July to 22 July the majority of the battalion's forces were positioned within range of F/2/13's 105's. During this period of time F. Btry operated its own FDC in direct support of 3/27. On 23 July the majority of the battalion's forces displaced to the East out of range for F. Btry's howitzers. At this point two 155MM towed howitzers were attached to F. Btry and artillery support was coordinated through the centralized FDC at 2nd Bn, 13th Marines. A total of 3,907 rounds of combined 105MM, 155MM, 8 Inch and 175MM were fired by artillery units in support of 3/27. The majority of the artillery fires were of an "immediate request" type of mission. Reaction times were

minimal especially during the 16-22 July period, when Btry F directly supported 3/27. The 105MM support proved effective against personnel while the fires of the heavier weapons were used extensively against enemy trenches and bunkers.

b. Air. Fixed wing air strikes were run within the AOR on enemy fortifications and trenches. Extensive fixed wing strikes were run south of the AOR on enemy troop assembly areas and routes of movement. Observation aircraft support was outstanding with AO's being available throughout the daylight hours. With the exception of one pre-planned CBU strike all fixed wing air was fraged by the AO's with response time usually under 20 minutes. The CBU drop was directly on target and was controlled by a ground forward air controller. The effectiveness of this strike could not be physically ascertained, however, the target area was effectively denied to the enemy. Rotary wing air support was used for all medevacs and resupplies. Reaction time for medevacs was exceptionally rapid. All air requests were submitted on the TACP Local Net.

c. Naval Gunfire. On 27 July one naval gunfire support ship was made available for the battalion's use. During daylight hours 100 rounds of 5 inch 38 were fired by the ship and controlled by an attached Naval Gunfire Spot Team from 27th Marines. Targets were enemy bunker and trench complex areas South of the battalion's AOR. At 2015 a fire mission was assigned to naval gunfire for coverage of an area target. The first round of the salvo landed on target but the remaining 4 rounds walked into the Co K defensive perimeter vic BT 039546 causing 3 USMC WIA. Naval gunfire was not utilized again during the remainder of the operation.

8. Intelligence

a. Prior operation intelligence information was gained from enemy defensive position overlays supplied by III MAF and 1st Marine Division G-2 and from information received from 2/27 during their occupation of the assigned area prior to our arrival.

b. No estimate on enemy strength in the area was reported prior to the operation. Groups of from 4-15 VC were seen during the operation. There was no evidence, either through contact, captured equipment or documents that an organized NVA unit was operating in the area. One captured document revealed that the AK 25 (unknown unit) had occupied the area prior to our arrival. No sightings or contacts were made with AK 25.

c. There were twenty (20) SFD incidents during the period of operation. Of these, nine (9) were found without injury. LP's were probed occasionally with grenades and small arms fire but the enemy would break contact before our units could close.

d. There were numerous sightings of enemy movement in a North to South direction.

e. Vegetation consists of thickly wooded areas to wide open grass land. The wooded area provides good cover, concealment and observation positions, thus movement towards these treelines provides dangerous avenues of approach.

f. Terrain is flat with mostly grass and dried up paddy beds. The land has been used for farming rice and other vegetables.

9. Mission. To provide security for an extensive land clearing operation, to deny the enemy harbor sites on GO NOI Island and to disrupt and interdict the enemies lines of communication.

10. Concept of Operations. On 16 July 3/27 helilift from its base camp at LZ 413 to the 2/27 CP vic BT 010529 in a tactical helilift. Upon arrival in the objective area Co L provide security for the land clearing operation during daylight hours. During the hours of darkness Companies K and L provide battalion perimeter security. Companies I and M move to the East and North, respectively, establish patrol bases, conduct combat offensive sweeps, and establish daytime observation posts. Direct artillery support is provided by Battery F, 2nd Battalion, 13th Marines from Liberty Bridge. Artillery general support and reinforcing fires are provided by 2nd Battalion, 13th Marines. Detachment 1st Engineer Battalion provide personnel and equipment for the conduct of the land clearing operation. Detachment 1st Shore Party Battalion provide Helicopter Support Teams and operate the battalion LZ.

11. Execution. On 8 July 3/27 was alerted to make preparations for a deployment to GO NOI Island in support of the land clearing operation. On the 12th and 14th of July, VR flights were conducted over the objective area to familiarize key battalion personnel with the terrain. During both of these flights, brief stops were made at the 2/27 field CP. The Commanding Officer, Sergeant Major, S-3, Headquarters Commandant, Company Commanders and selected company officers participated in the VR's.

On 16 July at 0730 the battalion commenced helilift from LZ 413 to the 2/27 field CP. The order of movement was Co I, Co K, Command Group "B", Co L, Command Group "A" and Co M. Sporadic small arms fire was directed at LZ 413 and the low-flying helicopters. Surpressive fires were directed at suspected sniper positions by escort aircraft and personnel in bunkers around the sand berm at LZ 413. By 1145 the majority of the battalion's forces had completed the displacement and at 1200 3/27 assumed responsibility for the ALLEN BROOK AOR. 680 personnel and 16,000 pounds of equipment were transported during the helilift.

Simultaneous with the battalion's helilift to the objective area a detachment from H&S Co (-)(Rein), under the control of Major E. T. FITZGERALD, Battalion X.O., arrived at Liberty Bridge and established

a rear FSCC. The detachment consisted of FSCC personnel, a section of the H&S security platoon, and two sections of 81MM Mortars.

Upon arrival in the objective area Co L assumed security of the land clearing operation. Companies L, K and the H&S Security Platoon formed the battalion's perimeter at BT 012528. Company I established a patrol base at BT 019533. Company M established a patrol base at BT 018546. At 1805 vic BT 010528 Company K discovered 22 bangalore torpedos and 1 Springfield '03 rifle. Units conducted night LP and ambush activities with negative contact.

On 17 July units conducted scheduled daylight patrols and offensive sweeps. At 0630 the rear FSCC at Liberty Bridge found 1 NVA KIA by small arms the previous evening. M/3 Platoon offensive sweep vic BT 024552 received small arms harassing fire, called an artillery mission and checked the area with negative results. One Marine was hit with a stray fragment from the artillery mission and was medevaced. At 1500 L/1 conducted a recon of the new proposed Battalion CP site at BT 030532. While enroute to the new CP site a Marine discovered 60 electrical blasting caps and 8 rocket boosters. At 1600 the S-2 sniper team positioned on the railroad trestle vic BT 003525 observed 6 VC moving at BT 008518. The sniper fired, killing 1 VC. The others scattered into a treeline where an artillery mission was called. Snipers were unable to check the area due to the river barrier. Again at 1845 the sniper team observed 6-10 VC moving South vic BT 991530 and called an artillery fire mission. At 1900 L/2 observed 3 VC run into a hooch at BT 003518. A Marine artillery mission destroyed the hooch. 2 VC were observed as KIA. Units conducted scheduled nighttime patrols and LP's with negative contact. Recap for day: 1 USMC WIA, 1 NVA KIA, 3 VC KIA.

On 18 July at 0515H the Battalion Command Group, Company K (-), and Company L (-) moved North to vic BT 010542. K/2 moved North along the railroad trestle to the 540 grid. L/1 remained in position as Battalion Perimeter Security. Company I moved North to vic BT 026541. At about 0700 when all units except L/1 were North of the 540 grid a herbicide run between the 52 and 54 grid lines was made by USAF elements. Upon completion of the herbicide mission the battalion's units moved back to previously established positions and conducted daylight activities. I/3 found 1 NVA KIA in a shallow grave at BT 027548. At 1400 I/2 squad combat patrol engaged 4-6 VC moving South at BT 027532. Drag marks and 1 RPD light machine gun were found. A sniper team killed 1 VC at BT 008518. K/1 platoon sweep detonated an SFD causing 2 USMC WIA. Night positions were established with Company I at BT 025535, Company M at BT 003544 and Companies L, K and Command Group at BT 012528. At 1750 vic BT 004534 L/2 land clearing security platoon found a cache containing 200 ChiCom grenades and 20 box mines. The battalion perimeter received 10 rounds 82MM Mortar fire at 2130, however, no casualties were sustained. At 2100 I/3 squad ambush patrol received numerous incoming grenades. Called artillery, flareship, and dispatched relief platoon. 1 USMC WIA. Recap for day: 3 USMC WIA, 1 NVA KIA.

During the morning of 19 July, Companies I, K, and M conducted offensive operations in their assigned zones of responsibility. At 0900 vic BT 015548 the lead element of Company M was hit by friendly mortar fire causing 4 NBC. At 1145H the land clearing security platoon found a cache containing 100 batteries, 1 Chinese radio, 1 SKS Carbine and 1 Russian Carbine. All gear was returned to the Battalion S-2. L/1 on a platoon sweep vic AT 993543 discovered 1 M-14 rifle, 52 blasting caps, 20 fuze lighters and miscellaneous 782 gear in a bunker. Units established night positions at 1800. The Bn CP remained unchanged but Companies I and M established patrol bases at BT 022535 and BT 027554 respectively. At 1715 the S-2 scouts observed 6-10 VC at BT 017526 and called a fire mission. After the fire mission an AO checked the area and found numerous new trenches and bunkers. I/3 squad ambush patrol at BT 022526 observed 5 VC under illumination at 2050 and fired. At 2211H vic AT 994542 a Marine detonated a "firecracker" explosive device inflicting minor wounds. Recap for the day: 1 USMC WIA.

On 20 July the rifle companies conducted sweeps and patrols in assigned areas of responsibility. Company K assumed responsibility for the security of the land clearing operation, provided one platoon to permanently outpost the railroad trestle vic BT 003528, and provided security for the sniper team and 106RR Team positioned at BT 033524. M/3 platoon offensive sweep vic BT 036554 found a large number of bunkers, eight sets of enemy uniforms and 200 pounds of unmilled rice. At 1215 I/3 platoon offensive sweep observed 15 VC out of the battalion's AOR. A Marine artillery mission was called but personnel were unable to physically check the area. Company I discovered 1400 pounds rice and 800 pounds of corn in an abandoned hamlet vic BT 029533. The sniper team killed 1 VC vic BT 007518 at 1340H. At 1800 Company I established a patrol base at BT 014539. Company M established a base at BT 024552 for the conduct of night activities. At 1805 M/1 platoon offensive sweep vic BT 029551 found an ammunition cache containing 13 60MM rounds, 1 US claymore mine and miscellaneous small arms ammunition. The rear FSCC at Liberty Bridge engaged 6-8 VC at 2050 with negative results. Recap for the day: 1 VC KIA.

A second "Trail Dust" mission was run on 21 July at 0715. In preparation for the herbicide run the battalion consolidated its perimeter and cleared the area between the 53 and 55 grid lines. Company I returned to the battalion CP at 0645 to clear the "Trail Dust" operational area. At 0730 K/2 squad OP observed 20/30 VC moving South at AT 993517. An artillery mission was called but clearance could not be obtained due to "Trail Dust". At 0730 an unknown type explosion occurred within the battalion perimeter causing 5 USMC WIA. Investigation revealed that a CBU device from "Trail Dust" had apparently been accidentally dropped into the perimeter. Company I observed 20/30 enemy moving South of the battalion AOR. An artillery mission was called but Company I was unable to check the results due to the AOR boundary. Air strikes were also run on this area resulting in 3 VC KIA. The companies conducted daylight patrols and sweeps. S-2 Scout Section squad patrol found 2 VC KIA in the area of previous ambush contacts. Company M found 500 pounds of rice and 5 sampans vic BT 024552. At 1615 in M/1 platoon defensive position,

a Marine activated a SFD causing 2 USMC WIA. Evening activities were established with Companies K and L in the CP, Company M at BT 036548 and Company L at BT 010529. During the twilight hours OP's along the southern boundary of the AOR observed 15-18 VC in 3 sightings. Artillery and small arms were fired but the river barrier precluded a physical search of the area. Ranges of the sightings were from 800-1200 meters. Recap for the day: 7 USMC WIA, 2 VC KIA.

The daylight activities for 22 July consisted of sweeps, patrols and OP's. Company M CP vic BT 036548 received 20 rounds harassing fire at 0820H from 400 meters. SFD's were detonated by Marines at BT 014547, BT 011545, and BT 034553 inflicting 1 USMC KIA and 2 USMC WIA. During the afternoon and evening hours the sniper team and 106RR team on the trestle engaged 14 VC with small arms and 106RR beehive and HEAT resulting in 5 VC KIA, 1 NVA KIA. Night positions were established at dusk with Company I at BT 038532 and Company M at BT 031547. At dusk Company I observed 3 to 6 rockets fired from the 0352 grid in a southerly direction. 1/2 squad ambush patrol vic BT 022530 engaged a small enemy unit at close range at 2115H. A sweep of the area produced negative results. At 2130, vic BT 037534 a squad ambush from I/3 also engaged a squad sized enemy force at close range. There was a large volume of grenades thrown as well as small arms fire and a relief platoon was sent from Company I. Artillery was fired and a sweep of the area disclosed 5 VC KIA. 3 USMC were WIA in the action. The remainder of the pre-midnight hours remained calm. Daily recap: 1 USMC KIA, 5 USMC WIA, 10 VC KIA, 1 NVA KIA.

At about 0150H on 23 July the battalion perimeter received one burst of automatic weapons fire causing 1 USMC WIA. The echelonment of equipment and supplies to the new CP began at 0645 utilizing the engineer otters and organic mules. At 0730 one Marine providing security for the CP moved detonated an unknown type SFD resulting in 1 USMC WIA. The move continued until 1100 when the command elements of the CP Group opened the new CP at BT 030532. Company I assumed security for the land clearing operation and the OP on the railroad trestle at BT 033528. Company M moved to the new CP. Companies K and L moved to the East and North to initiate daylight activities. At 1430 a Marine detonated a large surprise firing device within the Company I defensive perimeter resulting in 4 USMC WIA. Between 1715 and 2000 the sniper and 106RR teams on the trestle made four separate sightings totaling 13 VC/NVA in the BT 0051 grid. On each occasion both small arms and 106RR beehive as well as HEAT rounds were fired at ranges of from 800-1200 meters. The results were 8 VC KIA, 3 NVA KIA. Night positions were established at dusk with the CP and Companies I and M at BT 030532, Company K at BT 020540 and Company L at BT 024552. Recap for the day: 6 USMC WIA, 8 VC KIA, 3 NVA KIA.

Land clearing operations continued on 24 July. At 0800 L/2 platoon offensive sweep found 1 NVA body in a shallow grave. At 1100 this same unit sustained 1 USMC WIA when a Marine detonated a large pressure type box mine. Another similar mine was found a short distance

from the first. K/1 platoon offensive sweep made contact at 200 meters with a small enemy force at BT 043548. Organic small arms were fired and a Marine artillery mission was called. A search of the contact area turned up 3 NVA KIA and 1 VC KIA, 2 SKS Carbines, 1 AK-47, helmets, packs and miscellaneous 782 gear and documents. Again during the late afternoon and early evening hours the BT 0151 grid became a hot spot for scout sniper and 106RR operations. A total of 18 VC were observed in 3 separate sightings. In each instance small arms and 106RR ammunition were fired inflicting 8 VC KIA. Units established night positions with Companies I and M in the Bn CP at BT 030532. Company K at BT 024545 and Company L at BT 022548. At 1830 the tank positions and mortar pits received 10 incoming 82MM mortar rounds from an enemy firing position estimated to be at BT 048534. The suspected enemy mortar site was taken under fire by 90MM and Marine artillery with unknown results; 11 USMC were WIA. No contact was established for the remainder of the 24th. Recap for the day: 12 USMC WIA, 4 NVA KIA, 9 VC KIA.

Contacts remained light and scattered on 25 July with squad patrols making sightings of small groups of VC moving on a North/South axis at ranges of 2000 to 3000 meters. Company I provided security for the land clearing operation. At 1145 L/2 squad OP observed 5-10 VC on northern bank of SONG KY LAM River out of the battalion's AOR. Scout/snipers fired with unknown results. At 1345 I/3 platoon security outpost on the railroad trestle vic BT 003528 observed an OV-10A aircraft shot down in flames at BT 010518, south of the battalion's AOR. At 1400 CG, 1st Mar Div directed that one letter company move to the crash site and search for survivors and the wreckage. At 1430 Company M departed with a heavy section of tanks and 2 LVTE-1's for a fording site vic BT 003520. After extensive prepping of treelines leading into the objective area by Marine air and artillery, Company M crossed the river at 1530 and reached the objective area at 1645. The bodies of the two crew members and miscellaneous small aircraft parts were recovered. By 1935 Company M had returned to the battalion AOR but the company established night positions vic BT 008528 to provide security for the 2 LVTE-1's which had become disabled. Companies I and K provided battalion perimeter security at BT 030532 and Company L established a patrol base at BT 012545. No casualties or enemy kills this day.

During the morning of 26 July Company M provided security for the return of the LVTE-1's to the battalion perimeter. The rifle companies conducted daylight operations with little contact. The sniper team on the railroad trestle took 5 VC under fire at vic BT 009511 with unknown results. At 1715 the land clearing security discovered a spider trap containing 1 M-16A1 rifle and 6 B-40 rocket rounds with boosters. Company K offensive sweep at BT 036546 engaged 7-10 VC at a range of 300 meters. Marine artillery and organic 81MM mortars were fired with excellent coverage. Night defensive positions were established with Companies I and M at the battalion CP, Company K at BT 037545 and Company L at BT 012544. No casualties or enemy kills this day.

On 27 July the companies conducted normal daylight operations with very light contact. One Marine from K/1 reported a superficial leg wound from an ambush the previous night and was evacuated. At 1400 L/3 platoon offensive sweep at BT 014548 discovered 1200 pounds of corn hidden in a hooch. Company K's night defensive position at BT 039546 received 20 rounds of automatic weapons fire from a range of 600 meters. An artillery mission was called and assigned to the naval gunfire support ship. The first round of the salvo was on target but the remaining 4 rounds walked into the company perimeter inflicting 3 USMC WIA. Companies I and M provided battalion perimeter security. Company L established a patrol base at BT 016546. Daily recap: 4 USMC WIA.

The rifle companies completed nighttime activities at dawn on 28 July with only Company K receiving one light probe during the night. Daylight activities consisted of platoon patrols, squad ambushes, and OP's. At 0850 M/1 squad ambush patrol observed 2 VC with weapons at BT 047528. While moving forward to check out the area the squad received fire from an estimated VC squad. A reaction platoon was dispatched to check out the area. Investigation revealed that all enemy fires came from the tree-line vic BT 045524, South of the AOR. At 1405 and 1440 K/1 and K/2 platoon defensive positions received small arms harassing fire from small groups of VC. Marine artillery and organic 81MM Mortars were fired with negative results. The land clearing operation uncovered spider holes at BT 018534 containing 10 2.75inch rockets, 20 ChiCom grenades and 45 pounds of composition "B" explosive. Night defensive positions were established with Companies I and M providing battalion perimeter security at BT 030532. Companies K and L established patrol bases at BT 048546, and BT 016546. No friendly casualties and no enemy kills this day.

Night activities concluded at dawn on 29 July with only K/2 squad ambush patrol having received a light probe at 0020 vic BT 048548. Companies commenced daylight activities and Company M assumed responsibility for the security of the land clearing operation. At 0900 three wounded VN nationals who had detonated an enemy SFD were medevaced at the Company L CP. During an I/2 platoon offensive sweep at 1105H one Marine detonated a homemade SFD and was medevaced. The battalion's scout section discovered the fuselage of a recently crashed CH-46A at BT 047546. The bodies and miscellaneous 782 equipment was found in the area. At 1600 a medevac helicopter extracted the bodies. The land clearing operation at BT 025537 uncovered an ammunition cache containing 70 M-79 rounds and 200 rounds of .30 caliber ammunition. Night positions were established with Companies I and M providing battalion perimeter security at BT 030532. Companies K and L established patrol bases at BT 051545 and BT 027550. Company I commenced to prepare for a retrograde move to 3/27 Rear at LZ 413. Daily recap: 1 USMC WIA.

At 0900 on 30 July Company I commenced a helilift from the ALLEN BROOK area to LZ 413 where Company I's OpCon was temporarily chopped to 1st Bn, 27th Marines. The remaining three rifle companies conducted daylight activities with Company L sweeping from its patrol base to the battalion CP. At 1145 the sniper team on the trestle at BT 003524 killed

1 VC with small arms at a range of 1200 meters. The advance party from 2nd Bn, 7th Marines arrived at 1430 and departed at 1515 after a short liaison visit. A battery of howtars from the SLF arrived and was positioned within the battalion perimeter. At 1930 a Company K LP observed 2 VC running across a paddy. The LP fired small arms and a squad checked the area with negative results. The battalion made preparations for relief on the 31st. Night positions were established with Companies L and M providing battalion perimeter security at BT 030532. Company K established a patrol base at BT 051545. Daily recap: 1 VC KIA.

At daybreak on the 31st of July Company K commenced an offensive sweep from its night patrol base to the battalion perimeter. All companies and the Command Group commenced preparation for a relief in place. The 2/7 Command Group was helilifted into the CP area at 0900 and at 1000 a helilift commenced utilizing CH-53 and CH-46 aircraft to return the three remaining rifle companies and the battalion's Command Group to LZ 413. At 1200 the 3/27 FSCC rear at Liberty Bridge terminated its operation and commenced a motor march to LZ 413. The battalion Command Group departed BT 030532 on the last helicopter at 1315 having turned over operational control of the land clearing operation to 2nd Bn, 7th Marines. There were no friendly casualties and no enemy kills this day.

13. Administrative Matters

a. Throughout the conduct of the operation logistic support was excellent. The LSA was established at LZ 410 (27th Marines CP) and all resupply was transported by helicopter. The initial combat load

for the battalion's troops was a light marching pack and a unit of fire. Flak jackets were optional. Only first echelon and limited second echelon maintenance was performed on motor transport and ordnance items in the field. Items requiring maintenance or repair at a higher than limited second echelon level were evacuated to the LSA. A BIS was established by the Battalion Surgeon in the field CP for the treatment of minor casualties and the establishment of routine sick call. Communications throughout the exercise were excellent with the FSCC Rear at Liberty Bridge (11,000 meters distant). On several occasions interference from allied units necessitated changing the Battalion Tactical Net frequency. At no time was the offensive lost or a fire mission denied due to a lack of timely effective communications. A report of medical supplies usage data during the operation is contained in enclosure (2).

14. Special Equipment and Techniques

a. The following security precautions were effected to provide infantry support for the land clearing operation. A screen of company and platoon sized units was established around the center of the land clearing operation at a distance of 1500-3000 meters to provide long-range security. One platoon of infantry established a protective defensive perimeter around the clearing operation at a distance of 150-200 meters to discourage snipers and grenadiers. Finally, a third inner screen was established in the immediate vicinity of the bulldozers to provide close-in security. The officer in charge of land clearing security would position himself with the engineer officer-in-charge of the operating equipment to ensure that positive close liaison was established at all times.

b. Another technique which brought significant results was the employment of a 106RR with one of the battalion's sniper teams. Once an area can be located which is a known enemy route or LOC, the sniper team can fire and spot in conjunction with the 106RR. On several occasions the sniper would fire first striking one of the VC. When the enemy would group together to carry off the casualty, the 106RR would fire inflicting multiple kills.

15. Commanders Analysis

It is felt that this field deployment was a most successful and effective operation in support of the land clearing program. Security for the land clearing operation prevented a single engineer personnel or equipment casualty. The company and platoon sized patrol bases, patrols and outposts effectively prevented the enemy from concentrating for an offensive effort. Approximately 150 civilian personnel were encountered from the operating area. Although military transportation was not available to transport and relocate these refugees the personnel were highly encouraged to move to Liberty Bridge and to DIEN BAN District Headquarters where they would be relocated. Several aged Vietnamese were treated at the BIS and three VN civilians wounded by an

enemy SFD were medevaced by helicopter. There were no psychological warfare activities formally planned or conducted during the operation.

16. Recommendations. None.
