

THE EXTENSIVE OPERATIONS PLANNED FOR THE BA LONG VALLEY AND DAKRONG VALLEY WERE POSTPONED FOR AN INDEFINITE THE DUE TO THE INCREASED THREAT IN THE NORTHERN LANCASTER II A.O. BEFORE THE BA LONG OPERATION WAS POSTPONED, FIRE BASES HOLCOMB (YD118432) AND HENDERSON (YD080410) WERE PREPARED FOR USE.

THE NINTH MARINES HAVE CONTINUED TO PUSH INTO THAT PORTION OF THE BALLONG THAT FALLS WITHIN THEIR A.O. AND HAVE TWICE BEEN GIVEN EXTENSIONS TO THEIR A.O. TO CONTINUE WORK IN THIS VALLEY.

THERE HAS BEEN NO CONTACT IN THE BA LONG VALLEY, BUT ON TWO OCCASIONS AIR STRIKES RESULTED IN MANY SECONDARY EXPLOSIONS: (1) AT 110856H AUG. IN THE VICINITY OF YD 131417, 39 SECONDARIES WERE OBSERVED: (2) AT 1145H AUG AN AIR STRIKE AT THE SAME GRID RESULTED IN 52 SECONDARIES.

IN THE DA KRONG VALLEY, LZ'S PEACOCK, PIEGON AND PARROT WERE DEVELOPED BY AIR PREPS FOR THE FOURTH MARILES. ONE COMPANY OF 3/4 LANDED IN PEACOCK AND CONDUCTED LOCAL OPERATIONS FOR SEVERAL DAYS WITHOUT CONTACT.

ON 24AUG, K/3/4 OPERATED VIC 2 KILOMETERS EAST OF PEACOCK.

SEARCH AND DESTROY OPERATION #5 SCOTIAND II-10(U)

1. THIS MSG SUMMARIZES THE FIRST SEENOPERATION CONDUCTED IN OPERATION SCOTLARD II.

2. PIAN. ON ZIAPR, TWO MAR BNS ATTACK SOUTHWARD, ABREAST,
THROUGH AREAS OF KNOWN ENEMY CONCENTRATION ALONG A RIDGELINE
FOUR MILES SOUTHWEST OF KHE SANH. LANDING BY HELICOPTERS IN
TWO ZONES, ONE PREVIOUSLY SECURED BY ANOTHER MAR FORCE AND
ONE CONTESTED BY THE NVA, THE ASSAULT FORCES SEARCH THE RIDGES
AND SLOPES FOR ENEMY, THEIR BUNKERS AND FOOD OR AMMUNITION
STOCKS. ONE BN OF THE 2D BDE, 1ST ACD ESTAB BLOCKING PSNS
2000 METERS SOUTH OF THE OBJECTIVE AREA. EXTENSIVE USE OF
AIR STRIKES AND ARTY BEGINNING ON D-DAY MINUS TWO.

3. EXECUTION.

A. D-2 - EMPLOYING THE THREE 105MM HOWITZER AND ONE 155MM HOWITZER BATTERIES ASSIGNED TO THIS TASK FORCE, 348 ROUNDS OF ARTY WERE FIRED ON 58 SPECIFIC INTELLIGENCE TGTS TO DRIVE THE NVA FROM HIS BUNKERS AND DISRUPT POSSIBLE INFILTRATION.

AVIATION SUPT PROVIDED 23 TPQ STRIKES AND 62 VISUAL CLOSE AIR PAGE 1 OF TAGES

SUPT SORTIES BURING THE DAY. SUPPORTING AIR ATTACKS WERE CONDUCTED AS FAR WEST AS THE CO ROC AREA IN LAOS. DAYTIMB AERIAL OBSERVERS ADJUSTED ON VISUALLY ACQUIRED TOTS AND INHIBITED ENEMY MOVEMENT BY DAY. AIR CAUSED 14 SECONDARY EXPLOSIONS, DESTROYED 1 MORTAR PSN, 4 RKT PSNS, 14 BUNKERS, 4 STRUCTURES AND 10 FIGHTING HOLES.

- B. D.1 ARTY BATTERIES EXECUTED BTRY ONE ROUND EACH ON MORE THAN 50 TOTS ACQUIRED THROUGH INTELLIGENCE CHANNELS. A HEAVY PROGRAM OF H&I FIRES WAS CONTINUED. PREPARATION BY AIR INCREASED WITH 50 TPQ SORTIES FLOWN IN THE TASK FORCE AREA AND 20 CLOSE AIR SORTIES. DAMAGE TO THE ENEMY INCLUDED 3 SECONDARY EXPLOSIONS, 1 FIRE, DESTRUCTION OF 10 BUNKERS, 1 MORTAR PSN, AND 1 STRUCTURES.
- C. D-DAY AT SURFISE, THE WEATHER IN KHE SANH AND IN
 THE OBJECTIVE AREA DID NOT PERMIT AIRCRAFT OBERATIONS.
 CEILINGS WERE LESS THAN 100 FEET AND VISIBILITY LESS THAN
 ONE QUARTER MILE. TPQ AIR MSNS AND ARTY FIRES KEPT PRESSURE
 ON THE ENEMY.

BY 0930H, WEATHER WAS IMPROVING, BUT STILL BELOW OPERATING MINIMUMS. L HOUR WAS RESET AS 1300H. BY L-90, FIXED WING WERE ON STATION FOR AN HOUR-LONG PREPARATION OF THE LANDING LONE AND OBJECTIVE AREA. ARTY COVERED THE LZ FROM L-30 MINUTES TO 5 MINUTES BEFORE TOUCHDOWN WITH 283

THE LIFT OF THE FIRST
TWO WAVES WASCOMPLETED WITHOUT INCIDENT. AT 1332H, A TACTICAL
AIR CONTROLLER (AIRBORNE) REPORTED ENEMY MORTAR ROUNDS STRIKING
THE LZ. THE THIRD WAVE WAS HELD WHILE ARTY AND CLOSE AIR SUPT
ATTACKED THE SUSPECTED MORTARS. AFTER REPEATED ATTACKS
PRODUCING AT LEAST TWO SECONDARY EXPLOSIONS, THE MORTAR FIRE
WAS SILENCED AT 1520H AND THE THIRD WAVE LANDED. AT 1415H
AN D 1430H, B-52 STRIKES WERE DIRECTED AT PSNS NEAR RTE #9
AT THE LAOS BORDER.

D-DAY AIR SUPT TOTALED 41 CLOSE AIR/DEEP SUPT STRIKES 57 TPQ DROPS FOR BOMB DAMAGE ASSESSMENT OF 11 NVA KILLED, 17 SECONDARY EXPLOSIONS, 3 MORTAR PSNS, 2 RKT PSNS, AND 4 BUNKERS DESTROYED.

2D BN 3D MAR ENCOUNTERED ENEMY SMALL ARMS, MORTARS AND GRENADES BUT CONTINUED SWEEPING THE AREA. THE ENEMY, ESTIMATED AS COMPANY SIZED, DEFENDED STUBBORNLY. AFTER DRIVING HIM OUT, THE FIELD WAS SWEPT AND RECOVERY OF FRIENDLY KIA FROM THE PREVIOUS ACTION ON 19APR COMMENCED. THIRTY EIGHT BODIES WERE RECOVERED. IN ORDER TO BRING THEM IN, 2D BN 1ST MAR HAD TO CLEAR 20 ENEMY BUNKERS CONSTRUCTED OF DIRT AND LOGS.

THE GROUND ACTION SECURED OBJECTIVE #1 (XD 801406) AT 1450H AND OBJECTIVE #2 (XD 794398) AT 1655H.

D. <u>D+1</u> - S&D OPERATIONS CONTINUED THROUGHOUT THE PERIOD.

AIRCRAFT PROVIDED 26 CLOSE AIR SUPT/DIRECT AIR SUPT STRIKES AND

The first major engagement with the NVA forces to the south of KSB was a poorly executed ambush on the logistics convoy heading east along Route #9. This occurred at 1045H on 14 May. A small force of NVA attacked the convoy with RPGs and small arms fire. The security force immediately reacted and the reaction company H/2/3 at LZ HAWK responded with exceptional speed and skill. They attacked from two directions and the enemy fled. Oral orders were issued to pursue and exploit this action. "F" and "E" Companies 2/3 were committed. Several brief fire fights were encountered but the momentum of the Marines did not falter. The close team work by air, artillery, and ground accounted for 20 NVA/KIA and 1 wounded NVA POW. Positions were consolided for the night and at first light the attack was continued. "E" and "H" Companies 2/3 met strong resistance by the enemy fighting from well fortified positions but close air support using napalm enabled the Marines to assualt through the positions. The enemy had suffered 34 NVA killed. Meanwhile, F/2/3 met only small pockets of resistance. Additional search of the area gave evidence that the enemy had withdrawn from the area. 2d Battalion, 3d Marines pulled their forces back toward LZ HAWK and continued search operations. It is suspected that this action by the NVA must have been a reconnaissance in force.

No additional contacts were experienced until an early morning probe by an estimated NVA platoon on the 18th. They were repulsed by H/2/3 and a heavy concentrations of artillery fire near the friendly lines. Eight NVA were left dead outside the perimeter. The following morning another assault was attempted. Once again the combined Marine firepower devastated the enemy. Six NVA bodies were found and 1 wounded NVA officer was taken prisoner. Interrogation was not completed until late afternoon. A series of events, described in the following paragraph, plus his timely intelligence concerning the attack on KSB developed the order of battle as planned by the enemy.

On the same morning 190710H the minesweep force, a platoon of F/2/1, was carrying out its basic mission when attacked by a small NVA unit. Two RPGs were fired at the lead tanks. One tank was damaged and the other received damage to its .50 Caliber Machine Gun. The tanks and infantry opened fire killing 2 NVA. This engagement occurred about 1200 meters south of KSB on the access road. Continuing cautiously down the road, the force once again received heavy contact. Bitter fighting prevailed and the additional units of F/2/1 were sent to the scene. They immediately met stiff resistance. Reinforcements, "G" and "H" Companies 2/1, were dispatched from KSB and E/2/3 with tanks was sent from LZ HAWK to the east flank to envelops the well dug in NVA. The enemy started to withdraw to the south by Ku Bac. The Marine units continued to drive the enemy south using air strikes and artillery.

The Marine forces linked up and then consolidated. This action covered the better part of the day and the Commanding Officer of 1st Marines requested an additional battalion to defend KSB. 3d Battalion 9th Marines arrived to defend KSB proper. The results of this major fight were: 66 NVA/KIA, 8 friendly KIA, 34 WIA (EVAC), and 10 WIANE. The air component contributed as major factor in rooting out the enemy in their defensive positions.

As related earlier, the NVA prisoners gave timely intelligence. He state that a major attack would be conducted on KSB on the eve of 19 May." All indications by the daily activities plus the contacts described on 3d Battalion, 4th Marines summary of operations depicted the scheme. The main thrust would come from the south with adjacent units tying down the flanking forces of KSB. All units were put on 100% alert, 19 TPQs were conducted and 2 ARC LIGHTS dumped their payloads on Co Roc. This attack never materialized. A possible reason may be the premature findings of the enemy plus his resounding losses may have disrupted his plan of attack.

On the 20th all Marine units conducted thorough search operations. G/2/1 discovered 31 bodies and E/2/1 captured 2 POWs and found 6 more bodies. The enemy had definitely withdrawn from the area leaving behind many traces that they had suffered numerous casualties. No contacts were made for two more days but additional NVA bodies were found.

In retrospect, a coordinated attack was planned by a large NVA force. A smaller force of possible battalion had engaged 3d Battalion, 4th Marines to the west with the main effort to come from the south. The enemy was deployed in force and well equipped. They utilized bunkers, fighting holes and trench lines in their offensive thrust. The enemy soldier displayed determination but lacked basic skills, however, the ever apparent adeptness in use of mortar, rockets, and antimechanized weapons was felt.

The results of these contacts are: Enemy, 256 NVA/KIA, 3 POWs, Friendly, 22 KIA, 53 WIA (EVAC), and 45 WIANE.

Major contact by 3rd Bn, 4th Marines was precipitated by several patrol size confrontations. It appeared that the NVA was using 4 to 6 man teams to recon the terrain and determine the disposition of forces to west - southwest of Hills 689 and 552. 15 May activities resulted in the first major meeting. One platoon of L/3/4 engaged with a unit of NVA. The rest of L/3/4 units arrived and conducted an assault on the NVA unit. The NVA skillfully used mortars and rockets on the assaulting Marines but the combined Marine team of air, artillery and infantry seized the objective. The enemy left 6 comrades dead and large stocks of equipment, weapons and ammunition. Our loses were 4 KIA and 34 WIA (E).

On 16 May K/3/4 made initial contact with NVA forces attempting to close with the Marine forces around Khe Sanh. One platoon of K/3/4 was sent forward of Hill 689 to conduct a Combat Patrol early in the morning. At vicinity XD 792416 the platoon made contact with an NVA unit of unknown size. They were well dug in. All supporting arms, artillery and gunships were employed to destroy the enemy. A flame thrower team was asked for but the platoon could not force the enemy from their positions. The rest of K/3/4 was deployed to assault the finger of the ridgeline. They were immediately engaged in heavy exchange of small arms fire and mortar fire. After fierce fighting K/3/4 had obtained the forward positions of the NVA positions. Air strikes were conducted but the enemy pulled back to reverse slope defense. Upon assault the Marines met heavy volume of small arms fire, grenades and mortars. The battle continued through the day. Towards darkness the order was received to return to Hill 689. Breaking contact was difficult and the lead platoon did not get back to the consolidated position until 162200H. They left a MIA on the hill. For this particular enemy engagement K/3/4 suffered 10 WIA (E), 1 WIANE and 1 MIA. They had killed 11 NVA.

Companies "I" and "M" had returned OPCON to 3rd Bn, 4th Marines on the afternoon of the 16th after being deployed to the KENTUCKY AO. They were helo lifted to KSB and were moving out towards Hills 689 and 552. They received heavy mortar and small arms fire at vicinity XD 813404. The two companies expertly utilized all fire support available and assaulted through the enemy position

and consolidated on Hill 552. Results of this activity were 5 KIA, 17 WIA (E) and 3 WIANE. They accounted for 10 NVA/KIA.

Numerous spottings of additional NVA were reported throughout the day and night. Air and artillery missions were conducted. After appraisal of the daily activities it was considered that the NVA had at least a company reinforced in the immediate area plus reinforcements. Additional air strikes and artillery missions were conducted to prepare the area between Hills 552 and 689 and the ridgeline to the west of 689. Battalion objectives were assigned and after the pounding by supporting arms K/3/4 assaulted the old position of contact. "M" 3/4 attacked terrain surrounding Hills 689 and 552. No initial contact was made. K/3/4 found 1 NVA body but the area looked as if the NVA had departed the area taking their dead and wounded. Many blood trails and dragging marks indicated that the NVA had suffered many casualties. The MIA Marine was found. He was KIA. Later in the afternoon I/3/4 again found the enemy dug in on the reverse slope type defense. The supporting arms, air and artillery were effectively called in. The assault seized the objective. Sixteen Marines were WIA (E) but accounted for 22 NVA bodies.

Again during the hours of darkness the enemy probed 3/4 positions. Additional sightings of NVA were reported in the same general area of combat from previous days. TPQs and CAS/DAS strikes were conducted throughout the night and the entire morning of 18 May.

The same units returned to their old battlegrounds. This time there were no incidents. Several platoon size ambushes were left on avenues of approach but the enemy had broken contact.

On 19 May a platoon of I/3/4 moved out to search surrounding area of Hill 552. Contact was made with 6 NVA. Once again air strikes and artillery pounded the area of contact. I/3/4 units joined the platoon and swept through the area. Several NVA in spider holes engaged in small arms fire. After the objective was taken 38 enemy were accounted for. A continuation of the attack resulted in contact with more NVA in spider holes. After a short fierce fire fight, the Marines seized the area. Nineteen additional NVA bodies were accounted. Only 9 Marines were WIA (E).

Since this engagement the NVA apparently has withdrawn from the immediate area. It is most noteworthy that the NVA utilized supporting arms, mortars and rockets, with skill. They employed reverse slope defense with well constructed bunkers and spider holes. The enemy was well equipped and had sufficient quantities of ammunition. The results of 3rd Bn, 4th Marines actions: Friendly: 9 KIA, 107 WIA (E), 11 WIANE. Enemy: 107 KIA/NVA, 18 NVA/KBA, 3 POWs.

The 2nd Battalion of 3rd Marines assigned AO is generally to the east and south of KSB. Special emphasis in their AO has been placed on offensive activities to the south of Route #9 as a compulation and study of collected intellagence gives positive evidence that one NVA regiment and possibly two are staging and operating in this lower southern quadrant. Each day company size combat patrol have sightings of small NVA units at a distance but rue NVA normally avoided contact.

On the night of 27 Mere 12 NVA

On the night of 27 May the NVA changed their tactics. As usual Foxtrot Company 2nd Battalion 3rd Marines had conducted daylight patrolling late in the afternoon they consolidated on a defendable hill and made all preparations for night time combat operations. At 280230H May the NVA initiated a battle that raged for 16 hours. This first contact was a small group of fanatic NVA charging a northern listening post. They were carrying a satchel charge and yelling. The Marines opened fire and the NVA were stopped with the satched1 charge exploding in their hands; this killed all of them. Meanwhile, another light enemy probe came from the south. They were repulsed by small arms fire. These attempts must have been "feelers" as at 0300 the major attack by an estimated NVA Battalion commenced. Immediately the final protective fires opened up and the pre-planned artillery concentrations plotted around the perimeter were filled with massive volumes of artillery rounds. By 0415. Spooky with it's "mini-guns" and the flareship were on station supplimenting the organic fires. Spooky provided small arms fire to within 20 meters of friendly positions. The battle raged on and the NVA were successful in splitting one platoon from the company. The small unit leaders re-positioned their forces and continued to fight.

At first light an aerial observer and UHIE gunships were providing support. The gunship poured small arms fire into the enemy then fixed wing soared in with napalm and 250 pound bombs. Close coordination was required as bombs were being dropped as close as possible. Slowly but surely, the enemy was being defeated. They were splintered into small groups and supporting arms continued the attack. At 1045, Echo Company 2dBn 3dMar moved towards Foxtrot Company. They assualted through enemy resistence and joined Foxtrot Company perimeter. By now the enemy was reeling back and the supporting arms shifted their fires to avenues of regress. Fifteen more sorties by fixed wing were flown dropping tons of ordnance. The artillery continued to shell the enemy after the fixed wing had cleared the area.

By 1630, F/2/3 had pressed the attack along the radgeline forward of the original defensive positions. The enemy had been defeated in detail. One hundred seventy-six NVA bodies were found on the battle field but a detail search of the battle area was not conducted until the following day.

Foxtrot and Echo Companies consolidated into defensive positions for the night. No contact was made during the night but could hear the NVA trying to collect equipment and bodies. The supporting arms, artillery, and air (TPQ's) pursued the attack on possible harboring sites and trails.

The next morning the two companies made a detail sweep of all adjacent areas. Another fifty-four bodies were found with large quantities of weapons, equipment and ammunition. Each day a continual search is made of the surrounding areas so it is possible additional bodies and/or weapons may be found. There are many indications that the NVA suffered many casualties.

This action and success strongly validates the Marines' system and usage of all supporting arms to implement the ground units. The close coordination and training by all Marines concerned fully illustrates that this combination of effort is most effective.

A recap of this action: 230 NVA/KIA attacking one Marine infantry company, the artillery fired 4215 rounds on pre-planned and observed concentrations, and the air (fixed wing, gunships, and spooky) added tremendous fire power to within 20 meters of the friendly lines. Their ordnance figures for 26 sorties and on station time, 94,000 pounds, including many tanks of napalm and thousands of rounds fired from smaller caliber weapons. The friendly casualties were: 13 KIA, 44 WIA(Evac).

The intentions or goal of the NVA for this attack ## difficult to speculate. A large force was committed and the troops were well armed with new weapons, RPG's and multiple automatic weapons both light and heavy. It was experienced that the NVA did utilize their artillery from Co Roc on the fighting units plus some on Khe Sanh Base for the first time.

More enemy are in this area so this summary of activity is not necessarily final.
