

2. Narrative Summary

a. During the period 1-30 June 1965, Marine Wing Headquarters Group One conducted operations in support of 1st Marine Aircraft Wing (Adv) with respect to construction, organization, operation, administration, and maintenance of 1st Marine Aircraft Wing (Adv) Camp Facilities. During same period Marine Wing Headquarters Group One provided billeting for transient units and personnel as required, in addition to the billeting of permanent personnel.

b. On 28 June 1965, the majority of the staff officers, and supporting personnel of Marine Wing Headquarters Group One arrived at Danang from Iwakuni to commence permanent operations at Danang.

c. On 29 June 1965, Marine Wing Headquarters Group One commenced conducting all administrative control of subordinate units through newly established Headquarters at Danang.

d. During the period 1-30 June 1965, the subordinate units of this command conducted operations in support of 1st Marine Aircraft Wing (Adv) and III Marine Amphibious Force as listed in detail in Enclosures (2) through (4).
