



NARRATIVE SUMMARY

GENERAL

1. During the period 1 to 31 August 1965, Marine Wing Headquarters Group One continued to conduct operations in support of the 1st Marine Aircraft Wing with respect to Air Control and Air Defense. Beginning in early August, the Group commenced to assume responsibility for various permanent camp facilities from MAG-16. The Group continued to provide administrative, logistical, and maintenance support to subordinate units, and to the Wing with respect to camp facilities.

2. During the period 1 to 31 August 1965, Subordinate Units of the Marine Wing Headquarters Group One continued to conduct operations in support of 1st Marine Aircraft Wing and III MAF, as listed in detail in enclosures (2) through (4).

PERSONNEL

- 1. On 7 August 1965, LtCol E.I. LUPTON assumed command of MNHG-1, relieving Colonel A.L. JONES, who was reassigned to CG, FMFLANT, Norfolk, Va.
- 2. On 7 August 1965, Major R.R. CUNNINGHAM relieved LtCol E.I. LUPTON as Commanding Officer, MASS-2.
- 3. On 2 August 1965, LtCol R.R. MILLER relieved Major D.E. ROBERTS as Commanding Officer, MACS-7.
- 4. Strength increased from 1437 on 1 August 1965 to 2292 on 31 August 1965.

ADMINISTRATION

- 1. The Administrative Section of Marine Wing Headquarters Group One continued to provide administrative support as required for the Group and subordinate units.

MORALE/WELFARE PROGRAM

- 1. Special Services continued to provide athletic/recreation equipment to units and individuals within the Group. R&R to Hong Kong and Bangkok continued on an every-other day basis. Marines continued to utilize China Beach for daily swim call. Normal liberty in Danang continued except for the period 16-20 August during which time it was secured for security reasons.

2. 1st MAW clubs/lounges continued to provide off-duty recreation for the troops and officers.

CASUALTIES

1. There were no battle or non-battle casualties reported by MWHG-1 during the reporting period.
2. MWHG-1 had no battle casualties during the reporting period. MWHG-1 had 12 non-battle casualties during the reporting period.

INTELLIGENCE/COUNTERINTELLIGENCE

1. During the month of August two local intelligence lectures were given to members of H&HS-1. Division G-2 gave three classes to H&HS-1 personnel covering defenses established for the perimeter of Danang. Issued four final secret, four final top secret, twelve interim secret and 16 interim top secret security clearances to H&HS-1 personnel.

AIR OPERATIONS

1. MWHG-1 has no aircraft assigned. Negative

AIR DEFENSE

1. Ten meetings were held during August to formulate and publish the 1st MAW Air Traffic Control Plan and Air Defense Plan.

GROUND DEFENSE

1. Held two ground alerts during the month of August. Installed a Public Address system for disseminating ground alerts. Established hot line communications between MWHG-1 Command Post and Platoon positions. On 21 August the requirement for augmenting perimeter security established as sixteen men from MWHG-1. On 29 August, L Company 3rd Bn, Ninth Marines assumed perimeter security responsibility for TANGO Sector.

SPECIAL OPERATIONS

1. Air Control support for Operation "Starlight" was provided by elements of MASS-2 and MACS-9 during August.

ECM

1. Negative.

TRAINING

1. Training classes conducted during the month of August covered the M-14, .45 cal pistol, weapons safety and internal security.

NBC WARFARE

1. Commenced gas mask inspection of all gas masks in H&HS-1.
