NARRATIVE SUMMARY

- 1. During the period 1 January 30 June 1973, Marine Air Control Squadron-4 continued to operate at Marine Corps Air Station (H) Futema, Okinawa, Japan. The squadron maintained an AN/TYQ-2 (Tactical Air Operations Central), an AN/TYQ-3 (Tactical Data Communications Central), and an AN/TPS-34 radar set, and conducted ground-controlled intercept (GCI) training in conjunction with VMO-6, VF-117, VF-217, and VC-5.
- 2. Marine Air Control Squadron-4, Detachment "A" located at MCAS Iwakuni, Japan maintained an average strength of one officer and 17 enlisted men and was equipped with an AN/TPS-22 radar, an AN/UPS-1 radar and two AN/TYA-9 operator huts. The Detachment continued to provide advisory flight control for aircraft in the Iwakuni operating area and conducted GCI training.
- 3. Marine Air Control Squadron-4 Tactical Data Communication Central Detachment located at Son Tra, Danang, Republic of Vietnam, maintained an average strength of one officer and 18 enlisted men and was equipped with an AN/TYQ-3. The Detachment performed its primary mission as digital data interface between Air Force and Navy units engaged in combat operations in the Republic of Vietnam until 14 February. On 15 February the Detachment was relocated to Nakhon Phanom (NKP), Royal Thai Air Force Base, Thailand where it tested the capability of the 637El log periodic antenna to transmit and receive data from Navy Tactical Data Systems ships located in the Gulf of Tonkin. Upon completion of this test the Detachment moved to MCAS Iwakuni, Japan and on 12 March was permanently detached from this Squadron.
- 4. The program of supporting the U.S. Air Force in Thailand with air defense controllers ended 16 January. Due to an Air Force controller shortage, MACS-4 had provided augmentation for a period of eight months in which five officers supported the Gontrol and Reporting Centers located at Ubon, Udorn and Nakhom Phanom.
- 5. Additionally, support of the U.S. Navy in the Gulf of Tonkin with air defense controllers ended on 22 February. Again, due to Navy controller shortages, MACS-4 had provided controller augmentation to the ships of the 7th Fleet for a period of 19 months. Approximately 20 officers and Staff Non Commissioned Officers participated in this program.

- 6. During this reporting period, MACS-4 participated in Exercise Golden Dragon and Operation Pagasa I by providing small air control detachments. These detachments consisted of approximately 30 officers and men using an AN/UPS-1 radar, operating huts, communication equipment. The detachments were assigned the mission of providing a TACC(-) and a TACC for the aviation element of the Landing Force.
- 7. Throughout the reporting period MACS-4 has continued to participate in MTDS/NTDS Link 11 operations. Successful links were established with seven different ships of the 7th Fleet and, on 4 June, the first multiple station net for this squadron was established with the USS CORAL SEA and the USS WORDEN.
- 8. The Squadron continued to pursue an active and ever increasing role in support of the Human Affairs Policy of the Marine Corps. Included was training in the area of drug and alcoholic abuse.
