Part II: Narrative Summary of Significant Highlights Occurring during the reporting period.

1. During the period 1 - 30 April 1967, VMO-6 had 26 aircraft assigned and with 5 of these in PAR maintained an average daily availability of 15. 1455 hours and 3,476 sorties were flown in the accomplishment of 985 missions. 332 passengers were carried and 47 flights of fixed wing aircraft were controlled. During the month of April 11 confirmed and 4 probable KBA were accounted for bringing the total for the period 1 Sep 65 - 30 Apr 67 to 708

VMO-6 continued its role of MEDEVAC compiling the following statistics: 296 hours; 812 sorties; 200 missions; 355 MEDEVACS carried.

During the month 4 aircraft operated out of Phu Bai in Support of "Shining Brass", flying 419 sorties and 270 hours.

3. Narrative Summary of Ky Ha based activities:

1 Apr 67 Lt THATCHER flew BGen KIM to III MAF and to several points within the ROK TAOR.

Lt BUERGER flew BGen LAHUE to Budda Mountain and the ROK CP.

Capt CHIARAMONTE led a section escorting Mohair 4-1 flight for the Retraction of Cottage 14 at BT 352080. Two Mohair A/C hit by small arms and aw fire approaching the zone. Capt CHIARAMONTE controlled Penguin 24 and Swiss 069 on source of enemy fire. Relieved on station by Maj WALKER's section who provided a CAP until 2000.

2 Apr 67 Maj HENDRIX's section scored 7 VC KBA confirmed and 4 probable while providing fire support during an emergency MEDEVAC for Crepe Myrtle "K" at BS 770410.

Lt PETERSON flew BGen KIM and party to Budda Mountain and on a tour of the ROK TAOR.

3 Apr 67 Lt BODEN flew BGen KIM and Staff around the ROK TAOR.

Lt BALLENTINE had a busy afternoon as a TAC(A) in support of Operation Desoto. Controlled Penguin 18 and Miss Muffit 24 at BS 804323 in support of Crepe Myrtle "K". Also controlled Condole 051 at BS 683354 during the extraction of "Duckbill", Klondike also provided suppressive fire during the extraction.

4 Apr 67 Capt CHIARAMONTE flew BGen LAHUE to Nui Dang, BS 662755, LZ Marion, and returned him to the VIP pad

5 Apr 67 Capt SAUNDERS flew LGen SHIN and BGen KIM around the ROK TAOR.

The Squadron was saddened today by the loss of four (4) squadron mates killed in action. Captain's DEAN and SHADBURNE, Cpl SCRUGGS, and HMI PARKER of MABS-36 died when their UH-1E was destroyed by a large enemy mine in a landing zone near Nui Dang in support of Operation Desoto.

6 Apr 67 Capt RYAN flew MGen EUBANKS (USAF) to ROK CP and Budda Mountain and returned him to MAG-13.

Lt GARNER flew BGen LAHUE to Nui Dang and returned him to VIP pad.

7 Apr 67 During the retraction of "Hong Kong" at BT 255110 as escort for Mohair 6-1 Maj WALKERS Section received and returned automatic weapons fire from close proximity to the LZ. Controlled Penguin 3 and December 3 flights.

Capt BARTLEY flew BGen LAHUE to Hilltop and returned.

Lt BALLENTINE flew BGen KIM around the various CP's in the ROK TAOR.

8 Apr 67 Lt BARNARD flew BGen LAHUE to Nui Dang and returned him to VIP pad

9 Apr 67 Lt LEVY flew BGen KIM and Staff to Quang Ngai and various CP's in the ROK TAOR.

Capt WATER's section received light to heavy small arms fire from vicinity of BT 258108 during insertion of Donohue. Controlled Miss Muffet 3 flight on automatic weapons position and Penguin 03 flight on VC reported by Donohue after insert.

Capt CHIARAMONTE's Section escorted Mohair 5-13 to BT 250113 for Emergency extraction of "Donohue". Mohair, Klondike, Swiss, and Penguin aircraft all took fire from vicinity of pickup zone. After Klondike directed ordnance of Penguin 4 and Swiss 062 on source of fire, extraction was completed without incident.

10 Apr 67 Lt BODEN flew BGen KIM around the ROK TAOR.

11 Apr 67 Lt BODEN flew BGen KIM from I Corps pad to ROK CP.

12 Apr 67 Lt BODEN flew MGen CUSHMAN and party from Hilltop to III MAF POW Camp and LZ Railbird and returned them to III MAF Pad.

Lt BALLENTINE flew MGen BRICKER from Railbird to An Hoa and Nui Loc San and returned him to Danang.

Capt ROSS flew MGen BOUKER from LZ Marlin to III MAF and then to Hill Top.

13 Apr 67 Capt RANKIN flew MGen CUSHMAN and BGen LAHUE around the Chu Lai TAOR.

15 Apr 67 Capt RANKIN flew BGen LAHUE to several points around the Chu Lai and ROK TAOR's.

Capt RYAN flew LtGen CHAE, MGen LEE, BGen LEE, BGen CHUNG, and BGen KEELER from MAG-13 to ROK CP and later returned them to MAG-13.

Major WALKER's section escorted Mohair 5-10, 11 to BT 252066 for retraction of "Basketball". Fire was received and returned in Vicinity of pickup zone. Controlled Jersey Day 173 on sources of fire at BT 230075 and BT 253067.

16 Apr 67 Lt BODEN flew BGen KIM to several CP's in the ROK TAOR.

18 Apr 67 Lt BODEN flew BGen KIMM to MAG-13 and returned him to ROK CP.

20 Apr 67 Capt SAUNDERS flew BGen KIM around the ROK TAOR.

21 Apr 67 Lt BODEN flew BGen LAHUE and part of CINCPACFLT party around the Chu Lai TAOR and then to Hilltop Pad.

Major KELLEY received small arms fire from BT 185155 while escorting Clip Clop MEDEVAC to BT 177143 for a CIDG MEDEVAC. Suppressed fire on clearance from Tricky Misfit.

Major WALKER had a busy day as TAC(A) while escorting Buffalo City 2-6 and Clip Clop 1-8 flights for insertion of Connive 14 at BT 100295. Controlled Condole 055, Condole 056, Miss Muffet 18, Miss Muffet 19 on LZ prep. Klondike received and suppressed fire at BT 102304.

22 Apr 67 Capt CAVERLY's Section received small arms fire from BT 305038 while escorting Buffalo City 2-5 flight to same coordinates for insertion of "Basketball". Klondike returned fire and controlled strike by December 3. "Basketball" was then extracted and returned to LZ Quail. Later, proceeding to BS 450814 to retract "Bedpost", fire was received and suppressed at BS 450844 by Klondike and a strike by December 15 was controlled on the same coordinates.

Lt, PETERSON flew BGen KIM and Staff around the ROK TAOR.

23 Apr 67 Major WALKER flew a host of ROK Generals (BGen SUE, BGen KIN, BGen HO, BGen KIM) to various places around Chu Lai and the ROK TAOR.

24 Apr 67 Capt SAUNDERS flew BGen KIM from ROK CP to MAG-13 and returned to ROK CP.

25 Apr 67 Lt MURPHY flew MGen CUSHMAN and BGen KELLER from Chu Lai to Hilltop pad.

26 Apr 67 Lt BUERGER flew BGen LAHUE from VIP pad to Hill 29, III MAF Hilltop, Beach House, and returned him to VIP Pad.

Major HENDRIX's section had a busy morning of Recon insertions and extractions while escorting Buffalo City 2-3 flight. Inserted "Antifreeze" and extracted "Lefthook" at BS 418998. Inserted "Overpay" at BS 332987. Inserted "Crankcase" BT 127055. Extracted "Consulate" at Bt 027146. Inserted "Pottery" at BT 299045 and extracted "Basketball" from BT 277061. Received small arms fire from BT 280068 during extraction of "Basketball". "Hong Kong" extracted from BS 394771.

27 Apr 67 Lt BARNARD flew BGen LAHUE to BT 234315 and returned to Ky Ha.

Capt ANDREWS section escorted Bonnie Sue 1-1 flight to XD 728443 to insert "Breaker". Bonnie Sue 1-1 downed in LZ by heavy enemy fire. Klondike section suppressed fire while Bonnie Sue 1-1 evacuated crew and team.

28 Apr 67 While flying in support of Operation Beaver Cage Capt CHIARAMONTE spotted two (2) VC in the open, landed, captured the VC's and took them to Hill #2.

Earlier in the day Captain CHIARAMONTE's Section, operating from the SLF, escorted Safety Zone 1-1 flight to BT 195265 to insert "C" Company. Small arms fire received and suppressed at Bt 185265. Controlled strike by Miss Muffet flight on same coordinates.

29 Apr 67 Capt ARICK launched with the night Standby to escort Buffalo City 2-19 and Mohair 5-11 flights for emergency resupply of Arnica "F" at BT 018270. Small arms fire was received from BT 280252, BT 115292, BT 034275. The mission was completed at 0245 without incident.

Major KELLEY's MEDEVAC Slick received fire from BT 111229 while departing BT 096235 after picking up 3 WIA. The crew chief, LCpl FRIEND received shrapnel wounds in one leg.

Lt MURPHY flew BGen KIM from ROK CP to III MAF and returned to ROK CP.

30 Apr 67 Operating from the SLF Capt CHIARAMONTE's section escorted Safety Zone Flight to BT 132399 and BT 128382. Prepped LZ's with Miss Muffet Flight. After the ground forces had been inserted, Klondike received fire from BT 128382. Fire suppressed by Klondike and an additional fixed wing strike.

Maj GALLAGHER's section, operating out of Phu Bai received and returned fire at XD 800454 in support of Pygmaton LAE. Later escorting Sky Shadow flight to XD 785450, Klondike 16 took one hit from XD 793450.
