





### PART II Sequential Listings of Events

- a. Personnel. 4 Marine Corps Officers and 21 Marine Corps Enlisted were joined. 4 Marine Corps Officers and 40 Marine Corps Enlisted were transferred. 1 Navy Officer and 10 Navy Enlisted were joined. 11 Navy Enlisted were transferred. Following personnel were promoted to ranks indicated during the reporting period. GySgt 2; SSgt 5; Sgt 32; Cpl 38; LCpl 47; PFC 6. 2 men reenlisted for 6 years each, 2 two year extensions of enlistement and 1 extension of enlistment for 9 months. 4 men extended their tours in RVN as follows: 6 months-3, and 3 months-1.
- b. Administration. Annual audit of Service Records was initiated and corrective action is being taken.
- c. Morale/Welfare Programs. Sections within this squadron have been encouraged to have more section beach parties. Food and drink is furnished by Messhall and Special Services.
- d. Photo. The photo section accepted and completed 178 job request during the reporting period. 17 of these job request were received from units other than MAG-11 squadrons. 485 film exposures were used to complete the job requests.
- e. Ground Defense/Security. Security was extended by placing 4 men on an all-night security of aircraft on runway. The dog disposal program was stepped up due to rabid dog's in the area.


- f. Training. Each section holds OJT and specialized courses of instruction/application. MCI and USAFI courses are encouraged and progress is monitored by the Squadron Education NCO. All newly joined personnel are appraised of the benefits of educational improvement through correspondence practices.
- g. Motor Transport. The operational section filled 1,350 vehicle request traveling 57,908 miles. 17,300 passengers were carried, approximately 200 tons of cargo and 2,500 tons of ordnance were hauled. No vehicle accidents were reported. The maintenance section accepted 106 vehicles for repair and 67 were completed. 13 of 16 vehicle on deadline 1Sep66 are still on deadline. 9 quartely and 2 annual inspections were completed. There were no man hours lost due to shop accidents during September.

### h. Maintenance.

- (1) Plumbers and Water Point. A 4" pipe was installed and is operational to the MAG-ll water point from the Wing water point. This enables the water point to draw treated water into the cantonment. Pumped 1,887,000 gallons of water. Average 6 trouble calls daily.
- (2) <u>Electricians</u>. Electrical section completed following jobs:
  - (a) Rewiring of the EM Club.
- (b) Standby generator power for the Group S-2/3 operations center, sickbay bunker and security bunker.
- (c) Rehabilitation of Group and Marine Corps Supply areas.
  - (d) Insulator racks installed on all tinned roofs.
- (e) Communication Center now receiving commercial power.
- (3) Laundry. Two washers and one dryer averaged 18 hours of operation per day. 5,600 bundles of laundry were washed and dried. 12,000 sheets were washed at FLSG.
- (4) Equipment Section. 100 hours were spent answering trouble calls. 4 generators were shipped to rehabilation. Equipment performed the following hours:



j. Crash Crew and Fire Department. During the month of September this section responded to 7 fires. A 530-A structured Fire truck was acquired from Air Force salvage. Necessary additional equipment to assume proper operation is being procured. The fire inspector held an inspection of all MAG-11 Squadrons during September.

k. TAFDS. Issued 272,828 gallons of 115/145 fuel and 4,887, 505 gallons of JP-4 fuel during the reporting period.

1. LOX. Produced 15,180 gallons of liquid oxygen, received 4,250 gallons from the USAF and 1,000 gallons from Cubi Point. Issued 8,220 gallons to USMC Units; 9,210 to USAF and 1,000 gallons to Cam Ran Bay for a total of 18,420 gallons issued. A total of 233,885 cubic feet of gaseous oxygen was produced.

### m. Ordnance.

- (1) Received Class V(A) Munitions from the following ships.

  - (c) SS LAS VEGAS VOYAGE

- (2) Total bombs received during this period was 13,218 for a total of 4,677,400 pounds.
- (3) In addition we received 14,989 bomb fins, 8,820 fuzes, 3,206 igniters, 2,000 pounds of incindiary mix, 192 aircraft flares, 21,215 adapter boosters, 23,090 cartridge actuating devices, 920 rocket motors, 5,213 delay elements and 4,600 snakeye retaining rings.
- (4) During September this section belted and delivered 20, 092 rounds of 20MM ammunition to the squadrons of MAG-11, assembled and delivered 13,696 bombs along with all the items necessary to make a complete round, ie. fuze, booster, arming wire, suspension lugs etc.





- p. Food Services. The messhall fed 140 meals, produced 21,887 pounds of bread and prepared 750 gallons of ice cream. Reach-in type refers were moved into the mess decks to provide better refrigeration and service to the officers and men. Food was furnished for 20 parties.
- q. MOREST. The section installed two sets of M-21 arresting gear on the new runway. On 23 Sep 66 an F-4C (USAF) collided with the north arresting gear damaging the retrieve engine, tape and reel assembly. The damaged equipment was replaced. Preventive maintance was held on fresnel lens, runway positions were reinforced with 4X4 and sandbags.
