4. Important Visitors to the Command

On 15 February, Brigadier General SPRUANCE of the Delaware National Guard visited MAG-13. The General presented an Aviation Safety Brief for the officers of MAG-13. He then toured the catapult and arresting gear operations on the Air Station's cross wind runway.

**PART TWO: NARRATIVE SUMMARY**

Marine Aircraft Group-13 flew 1278 sorties for 1371.1 combat hours in February. 2501.273 tons of ordnance were dropped by this Group.

Operations supported included Kentucky, Lancaster, Scotland, Neosho, Khe Sanh, Houston, Tampa, Niagara, Wallowa, and the Ashau Valley Campaign. Missions flown included Close Air Support, Direct Air Support, BarCap, Visual Reconnaissance, Air-to-Air Intercept Practice Scramble, Talley Ho and TPQ.

Night and day TPQ-10 radar bombing missions were prevalent during this period due to reduced ceiling and visibility in I Corps. The predominance of ordnance and sorties went to the Khe Sanh area due to the massive NVA/VC build up in that area.

Significant BDA included 132 KBA confirmed, 30 KBA probable, 224 structures destroyed and 61 damaged. (Complete list in Para 9, PART THREE).

PART THREE: SIGNIFICANT EVENTS

1. Personnel. During the month of February, Marine Aircraft Group-13 had a loss of twenty-five (25) officers and one hundred and sixty-three (163) enlisted personnel due to rotation and transfers. During this same period nineteen (19) officers and one hundred and fifty-six (156) enlisted personnel reported to the Group for duty.

2. Administration. During the reporting period seventeen (17) enlisted personnel were promoted. By 29 February, MAG-13 had 90.2% participation in the Savings Bond Program.

3. Awards. There were one Distinguished Flying Cross and twenty (20) Air Medals received by members of this command during the month of February.

5. Civic Action. February saw an increase in Civic Action activities after the initiated phase of the TET VC offensive was over. Initially MAG-13 MedCap personnel were engaged in helping the victims of both VC atrocities and friendly artillery fires. Fortunately neither of MAG-13's Civic Action hamlets were hard hit by either type of trouble.

English classes have been started in Long Phu I by volunteers from VMFA-323. Interest in the hamlet classes is high with a large number of adults attending. Arrangements are being made to teach English in Long Phu 2 by volunteers from VMFA-115.

Vietnamese language classes are being taught at MAG-13's Little Red School House every Monday, Wednesday and Friday nights from 1900 to 2100. At present, over twenty (20) people are enrolled. The classes are being taught by one of MAG-13's interpreters.

MAG-13 and MAG-12 recently sponsored a Civic Action meeting in one of the Ky Lien Village meeting houses. All the Hamlet Chiefs, the Village Chief and the District Chief were invited as well as all the concerned Civic Action Officers. The meeting was a success with numerous problems coming to light which were

unknown to the Civic Action Officers. As a result MAG-13 is investigating a number of new projects. One is the re-digging of a canal drainage ditch which apparently was covered up during some past military operation in the area.

6. Intelligence. Briefing and debriefing of aircrews and orientations to new aircrews were conducted. Publication of the weekly S-2 "Tactical Brief" continued (See Supporting Documents, Part Four). The booklet "Who Are the Viet Cong" has been distributed on a continuing basis to all officers and SNCO's.

General Intelligence briefs are given each Thursday by the Group Intelligence Officer for Sergeants and below. Weekly Intelligence briefs are also given to the Group Guard dealing mainly with the Chu Lai THOR.

7. Industrial Relations. MAG-13 presently has 34 Local Nationalist Citizens (LNC) under employment.

8. Airfield Operations. All facilities are operational at West Field. The East field will be utilized as an emergency backup for jet aircraft in the event of a fouled deck on the West field.

The controlled take-offs and landings at Chu Lai totaled 33,366. The launch and recovery section arrested 949 aircraft of which 35 were declared emergencies.

10. Base Development. A bank of nine 50 KVA transformers was installed to power the Group Mess Hall. Expeditionary equipment continues to phase out as Garrison equipment becomes available.

MABS Utilities Section constructed three six foot revetment separators to provide for napalm separation from other ordnance in the flight line revetment areas.

Laundry service has increased to approximately 2000 lbs per day. The two new siggle trailer laundry units are now fully operational. MABS laundry continues to provide laundry service to MASS-3.

11. Morale/Welfare. MAG-13 church attendance remains high in Protestant, Catholic and Latter Day Saints services. The churches donated \$120.00 to the An Tan Protestant Orphanage. Chaplains SAMPLES and NOLAN attended the Wing Chaplain's meeting in DaNang and the Chu Lai area Chaplain's Meeting at AMERICAL during the month.

R&R continues to maintain high morale within this command. Nearly all quotas for R&R are fulfilled.

Scheduled movies and floor shows are well received and attended.

12. Training. Normal on-the-job/technical training continued within each unit of the Group. The following formal schools were utilized by MAG-13 in February:
